At a meeting of the Common Council of the Town of Fredericksburg at the Council Chamber convened this evening Feb'y 18th 1837 pursuant to notice from the Mayor

A memorial from the "Young Men's Society of the Town of Fred'g" through a Committee of the Society, was presented by the Mayor praying the use of the vacant lot on the Court House Square between the Fire Engine House and Mr Harrow's printing office, for the purpose of erecting a building on the same for the use of said Society; which memorial was, on motion, laid on the table for future consideration of the [Page 114] Council.

Ordered that the Mayor be associated with the Quarantine Master to take such precautionary steps in the unloading and discharging of a vessel now a the Quarantine ground having a case of small pox on board, so that the infection made not be spread.

George Cox, Benjamin R Hillyard & Jesse Curtis were appointed a committee to examine & settle the accounts of the Sergeant and Chamberlain and make report thereon to the next Council.

Ordered that the salaries of the police officers for the quarter ending the 3rd Monday in the month be paid by the Chamberlain.

On Motion the Council adjourned till Monday morning at 9 o'clock

"In pursuance of an order of Council made on the 17th day of March Inst, We the undersigned, appointed a Committee to examine and report upon the account of Arthur Goodwin Chamberlain of the Corporation do hereby certify that we have examined the same and find it correctly stated and supported by proper vouchers and that there is a balance in the hands of the Chamberlain amounting to ninety five dollars and thirty cents

"We the undersigned, a committee appointed to examine the Sergeant's account hereby certify that we have performed that duty and find the same correctly stated and the items all proper and that the same stands balanced.

The Sergeant returned insolvent lists amounting to two hundred and sixty eight dollars and fifty cents also a list of uncollected taxes amounting to forty nine dollars and thirty six cents and of uncollected rents amounting to three hundred and twenty one dollars and sixty three cents.

Ordered that a poll be now opened for the election of twelve men to serve as Common Council for the ensuing year.

This being the day appointed by law for the election of twelve men to serve as Common Council men until the 3rd Monday in March 1838 and till others shall be elected in their stead, a [Page 116] poll was

opened for that purpose and the freeholders and housekeepers of the Town having been duly notified of such election, met at the Council Chamber and deposited their ballots, and upon counting the same the largest number of votes were found to be given for the following persons, to wit:

Tuesday Evening, March 21st 1837

William Redd, Stephen J Blaydes, John Goolrick, Henry T Phillips, Peter Spilman, Fayette Johnston, George W Rothrock, John Buck, William Warren, Charles C Wellford and Jesse Curtis, members elect of the Common Council of the Town of Fredericksburg appeared at the Council Chamber and severally took the oath of office before the Mayor

On motion made and seconded the salary of the Mayor for the ensuing year was fixed at the sum of four hundred dollars.

The Council then proceeded to the election of a Mayor when John H Wallace was unanimously reelected, who toll the several oaths of office before Reuben T Thom, a Justice of the Peace for the County of Spotsylvania.

The Council elected Thomas F Knox a member of the Council to supply the vacancy occasioned by the election of John H Wallace, Mayor, who being notified thereof by the Messenger of the Council appeared, was qualified and took his seat at the Board.

William Redd was elected Recorder of the Corporation and took the several oaths of office before Reuben T Thom a Justice of the Peace for the County of Spotsylvania.

On motion the salaries of the following officers were fixed at the following sums per annum viz That of the [Page 117]

On motion a Commission of 10 pr cent on Taxes and 5 pr cent on Rents was allowed the Collector upon all collections.

On motion it was ordered that hereafter the sum of Thirty one and a quarter cents per hundred bushels for measuring be and the same is hereby allowed the Measurer of salt, Grain, Coal &c &c as a legal charge. [Page 118]

Arthur Goodwin John S Caldwell, John Goolrick, Bernard Cole, George Ayler, Matthew D Anderson and Linsey Pullen severally took the oaths of office before the Mayor.

The following standing committees were appointed by the Mayor

On Pumps; C C Wellford, S J Blaydes, William Warren, Thomas F Knox

The official bond of the Collector of Taxes, Rents &c in the penalty of five thousand dollars with Samuel Phillips and Henry T Phillips as securities was submitted to the Board approved and ordered to be filed by the Mayor.

The resignation (by letter) of Matthew D Anderson as Bellman was presented and accepted and On motion Jesse White was appointed Bellman and it was ordered that his salary commence from the 3rd Monday in March last

Present; Jesse Curtis—Common Councilman

An estimate of the receipts and expenditures of the Corporation for the current year was submitted to the Board and

An ordinance entitled "An ordinance imposing taxes for the year 1837" was passed in the following words, to wit;

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that the taxes on persons and property in the town aforesaid for the year 1837 shall be as follows viz; on all houses and lots at the rate of four dollars for every hundred dollars yearly rent or annual value thereof;

On every male white person above the age of 16 years one dollars and thirty cents;

On every slave above the age of 12 years one dollar and thirty cents;

On every free Negro and Mulattoe above the age of 16 years, one dollar and thirty cents;

On every pleasure carriage of any description, Cariole, Gig and Chariot of less value than one hundred dollars, two dollars

And on all above the value of one hundred dollars two per cent on the value thereof;

On every Horse, Mare, Mule, one dollar and fifty cents;

On every cart and dray license five dollars and

On every Waggon license eight dollars.

This ordinance shall be in force from and after its passage.

Ordered that an Inspector and Measurer of Lumber, Wood, Plank, Staves, Shingles, Bark &c be appointed to attend to the Rail Road Depot and that said Inspector & Measurer be governed by the ordinance now in existence on the subject of his duties and that he be allowed the same rates of charge for measuring &c &c that the Inspectors and Measurers at the Basin & Wharves are allowed.

On Motion John B Alexander was appointed Inspector [Page 120] and measurer at the Depot.

Whereas great inconvenience has resulted to the people of this Corporation from the want of small change owing to the suspension of specie payments by the Banks of the Commonwealth.

Therefore, Resolved, that a Committee be appointed to draw a petition or memorial asking of the Legislature the right on the part of the Corporation to issue its notes to afford change upon this suspension of specie payments by the Banks.

The Mayor appointed the following Committee in pursuance of the above resolution, viz; C C Wellford, John Buck & Geo W Rothrock, who are to report their proceedings to the Council on Saturday evening next week

The Mayor presented to the Board the proceedings of a meeting of the citizens on the subject of issue of small notes by the Corporation [Page 122] and stated that he had invited most of the Gentlemen of the Bar to attend the meeting of the Council for the purpose of obtaining their opinions as to the construction of the penal laws of the Commonwealth on the subject.

Mess'rs Marye, Morson, Patton, Seddon, Berry & Stevenson having given their opinions at length to the Council & Mr Morson having submitted in the course of his remarks, a paper or ticket, for the consideration of the Council, it was on motion of Mr Fayette Johnson,

Resolved, that Mess'rs Morson, Marye & Seddon be authorized to consult the most eminent counsel of the State they may elect, not exceeding three in number, on the subject of the legality of the issue, by the Corporation, of such paper or tickets of the description above named.

Ordered that the Chamberlain pay to the order of the above named gentleman a fee not exceeding \$20 each to be paid to the Counsel they may consult.

An ordinance to prevent hogs from running at large

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that from and after the 15th day of July 1837 it shall not be lawful for any hog to run at large within the limits of this Town, any former ordinance to the contrary notwithstanding. And it shall be the duty of the Constables to take up all hogs found running at large in the Town and sell the same at any public corner of the streets, to the highest bidder for ready money, one moiety whereof shall go to the Constable and the other shall be paid to the person or persons owning such hog at the time of its being taken up.

Be it further ordained that all ordinances and [Page 123] parts of ordinances coming within the purview of this ordinance be and the same are hereby repealed.

The vote on its passage being taken by Ayes & Noes

The Mayor presented to the Council the opinions of Chapman Johnson and B W Leigh, Esquires, on the subject of an emission of small notes by the Corporation, which being read by the Clerk the following preamble & resolution was passed and ordered to be published.

Whereas the Common Council, after giving the resolution of instructions from a meeting of the Citizens of Fredericksburg relative to emitting small notes for circulation as change, the consideration it merits and fully submitting the propriety of such a course to the most eminent professional gentlemen in the State have come to a determination that any issue in any form whatever, will be in direct violation of the law. Resolved, therefore, that while they regret the embarrassments of the country and the legal disability on the part of the Corporate authorities of the town to contribute towards the relief of the community, they will not take upon themselves the responsibility of a course involving not only a violation of the most highly penal laws of the State, but also, as they conceive a violation of their oaths of office.

Resolved that the Pump Committee locate a pump in the upper part of the town, if, in their opinion they think it expedient to do so and to draw on the Chamberlain for the necessary expenses thereof On motion the Council adjourned

An a/c of George Aler, or four dollars & fifty cents for killing dogs was passed and ordered to be paid. Also an account of Samuel Phillips, of five dollars for holding an inquest on the body of an infant found dead on the River shore & and account of John S Caldwell, of three dollars and fifteen cents for summoning an inquest on the body of said infant was passed & ordered to be paid by the Chamberlain.

A letter from Doctor R O Grayson, complaining of [Page 125] losses sustained by him in the weighing of hay at the public scales, by reason of the inaccuracy of the scales and praying indemnity at the hands of the Council, was submitted to the Council, whereupon it was, ordered that the Mayor communicate to Doctor Grayson the following resolution on the subject as reply to his letter.

Resolved that while the Council regret the loss sustained by Doctor Grayson in the weighing of his hay at the public scales, yet they cannot grant the request contained in his letter, because of the uncertainty of the amount of loss sustained by him and also because it has been stated at the Board that some few years back, the condition of the hay scales was such as to operate very much in favor of the sellor & against the purchaser, making the gain of the sellers during the period of such condition of the scales, more than an equivalent for the losses sustained by them lately; In addition to which the Council moreover say that the Committee of their body, whose duty it is to attend to any complaints or abuses about the weighing of Hay or the condition of the scales are always ready & willing to attend to and rectify them.
