The Mayor also stated to the Board, that in pursuance of the order of the council of the 5th Dec'r last, he had addressed a letter to the Principal Agent of the Mutual Assurance Society of Virginia on the subject embraced in said order but hand not as yet received any reply from the Agent.

An account of George R Peake for one dollar and fifty cents was passed and ordered to be paid.

Ordered that Jesse Curtis, George W Rothrock, H H Wallace & Alex K Phillips or any three of them be a committee to examine and settle the accounts of the Sergeant and Chamberlain & make report thereon to the Council on Monday morning next at 9 o'clock.

Ordered that the mode of conducting the election of Councilmen at the ensuing election be the same as at the last election.

Ordered that the Chamberlain of the Corporation pay to George Aler his bill (for wood &c) against the Corporation amounting to some five or six dollars, upon the same being verified by the affidavit of said Aler, as to its correctness.

Which accounts with the Reports of the Committee were ordered to be filed by the Clerk of the Council.

The Sergeant returned insolvent lists for the year as follows viz;

Of whites amounting to one hundred & seventy nine dollars & ninety cents;

Of free blacks & Mulattoes amounting to one hundred & forty two dollars and ninety three cents; Also a list of deferred taxes amounting to one hundred & seventy dollars & seventy seven cents And of deferred Rents two hundred & fifty dollars and eighty cents.

The Mayor returned an account of taxes received by him for affixing Corporation seal during the year, amounting to seven dollars & fifty cents, which is ordered to be paid to the Chamberlain & place to the credit of the Corporation in the Chamberlain's account for the next year.

This being the day fixed by law for the election of twelve men to serve as Common Councilmen until the 3rd Monday in March 1840 and until others are elected in their stead. A poll was opened for that purpose and the freeholders and housekeepers of the Town having been duly notified of such election met at the Council Chamber and deposited their ballots and upon counting the same the largest number of votes were found to be given for the following persons, to wit;

Tuesday evening March 19th 1839

Peter Spilman, H H Wallace, Jesse Curtis, S J Blaydes, A G Lucas, John Goolrick, George W Rothrock, A K Phillips, Thomas F Knox and C C Wellford, members elect of the Common Council of the Town of Fredericksburg meet at the Council Chamber and severally took the oath of office before the Mayor.

The Mayor presented to the board a letter from Fayette Johnston, a member elect of the Council, requesting to be excused from serving as a member thereof, which on motion was agreed to and the Council by ballot elected Wm A Jackson to supply his place, who being notified thereof, appeared, was qualified & took his seat.

On motion, the salary of the Mayor for the present year was fixed at four hundred dollars. The Council then proceeded to the election of a Mayor for the present year when Benjamin Clark was unanimously re-elected and took the several oaths of office before Robert Dickey, a Justice of the Peace for the Corporation of Fredericksburg.

The Council then balloted for a Recorder when H H Wallace was elected who also took the several oaths of office before the Mayor.

On motion the salaries of the following officers of the Corporation were fixed at the following sums, viz;

The Council then proceeded to the election of Officers for the present year when Arthur Goodwin was elected Clerk of the Council and Chamberlain of the Corporation; John S Caldwell police officer and Collector of Taxes & Rents; Bernard Cole and George Aler, assistant Police officers; John Metcalfe, Commissioner of the Revenue, Matthew D Anderson, Clerk of the Market; Jesse White, Bellman; John Goolrick Surveyor and Geographer of the Corporation; Samuel Phillips, Inspector and Measurer of Wood, Lumber &c &c at the Wharf; Bernard Cole, Inspector & Measurer of Wood, Lumber &c &c at the Basin; John B Alexander, Inspector and Measurer of Wood, Lumber &c &c at the Depot; Robert Parrott Guager and Matthew D Anderson, Measurer of Coal, Salt, Grain &c &c

Arthur Goodwin, John S Caldwell, Bernard Cole, George Aler, John Goolrick and Matthew D Anderson severally qualified to office before the Mayor.

The following standing Committees were appointed by the Mayor, viz;

On motion it was ordered that the tax on all dray & cart licenses issued between the 1st April and the 1st November 1839 shall be five dollars on all issued after the first of November 1839 & before the 1st April 1840 shall be three dollars. And on Waggon licenses issued between the 1st April & the 1st November 1839 eight dollars, on all [Page 152] issued after the 1st November 1839 & before the 1st April 1840 five dollars.

The Mayor stated the Council had been convened for the purpose of taking into consideration the propriety of adopting some regulations on the subject of renting the stalls in the Market house, the Committee on public property having stated that they were not rented at the usual time of letting in consequence of the lowness of the bids offered for them.

The Mayor presented to the board a letter from Mr John Goolrick tendering resignation of his seat as a member of the Council which being read, his resignation was accepted & the Council having balloted for a member to supply his place, Richard J Walker was unanimously elected.

Present, Thomas F Knox, S J Blaydes—Councilmen

Ordered that the Committee on Public Property enquire into the propriety of erecting Iron railing (with gates) across the several entries into the market space, and also ascertain the probable cost of such improvements & report thereon to the next meeting of the Council.

Ordered that the rent for the stalls in the Market House shall not be less than thirty dollars, each, for the present year ending the 31st March 1840, and that the Committee on Public Property be instructed to let the same out at public auction for a sum not less than thirty dollars each.

Richard J Walker elected to supply the vacancy occasioned by the resignation of Mr John Goolrick appeared was qualified and took his seat.

The Mayor presented the Board a letter from J Ruthefoord, Prin Agent of the Mutual Assurance Society of Virginia in reply to his (on the subject of said Society's contributing its aid towards defraying the expense of laying iron pipes in the Street) directed by an order of the Council of [blank] 1839, which was read and ordered to be filed.

A letter of Daniel Coakley praying to be refunded the amount of a fine imposed on him for a violation of the Market Ordinance was read and on Motion, ordered to lie on the table.

The following ordinance entitled "An Ordinance regulating the manner of renting the Butcher's Stalls in the Market House and for other purposes" was read and passed.

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that hereafter the Committee on Public Property shall, annually before renting out the butcher's stalls in the Market House fix the distance to which each stall with blocks, benches and other fixtures shall extend out from the side Wallace and also assess the amount of rent to be required for each stall for the year. And after such assessment, it shall be the duty of the Sergeant of the Corporation under the superintendence of said Committee to put up each stall at public auction to the highest bidder, taking the amount assessed upon each by said Committee as the lowest sum for which the same shall be rented for the year.

2. Be it further ordained that no Butcher shall rent more than [Page 154] two stalls in any one year, and that no butcher or other person besides those who have rented a stall or stalls for the year shall sell or expose for sale in the Market House or Market space, any meats or fish of the kinds hereinafter named, except upon the payment of the following rates, to wit:

For each slaughtered bullock, cow or steer twenty five cents

For each veal, mutton or lamb ten cents
And for each sturgeon ten cents

And if any butcher or other person occupying a stall or stalls rented by them shall thereat dispose of meats for the benefit of others, he or they shall be liable to pay for all meats sold at said stalls for the benefit of others, the same rates the owners thereof would have been liable to pay, if the same had been sold by them.

- 3. Be it further ordained that it shall be the duty of the Clerk of the Market daily to demand and receive from the persons liable for the payment of the same, the rates fixed in the preceding section and in the event of their failure or refusal to pay, the party so failing or refusing shall be liable to a fine of one dollar to be recovered by warrant, with costs, before the Mayor or any other Justice of the Peace of the Town aforesaid, which warrant shall be brought in the name of the Chamberlain of the Corporation.
- 4. Be it further ordained that all monies shall enure to the use of the Corporation and it shall be the further duty of the Clerk of the Market to keep a regular account of all such, and pay over the same quarterly to the Chamberlain of the Corporation; and as compensation for his services herein, he shall be allowed a commission of ten per cent on the amount collected.

This ordinance shall be in force from and after the 20th day of April 1839.

Richard J Walker was placed on the Committee on Public Property in the place of John Goolrick resigned.

The Clerk submitted to the board a letter from the Hon'ble Henry Clay on the subject named in the order of Council of the [blank] day of [blank] which being read, it was on motion

Ordered that the Mayor wait upon Mr Marye the agent of the holders of the lease of House on Commerce Street supposed to have reverted to the Corporation, & shew him said letter & ascertain what is his determination in relation to the surrender of said house to the Corporation.

The Mayor submitted to the Board a letter from the Principal Agent of the Mutual Assurance Society of Virginia on the subject of an appropriation by said Society toward aiding the Corporation in laying iron pipes for conducting water from the Basin along the Streets which was read and ordered to lie [Page 156] on the table.

Whereupon a motion was made that the Corporation pay said sum which was negative.

Ordered that the Chamberlain pay Jesse Wayte's bill for railing in the Mayor's office amounting to two dollars.

The official bond of the Sergeant of the Corporation with Sam'l Phillips & A K Phillips as securities was submitted to the Board, approved & ordered to be filed by the Mayor.

It being stated by the Mayor that information had been given him that Mr Francis W Taliaferro, in carrying his operations at his stone quarry a few miles below the Town is endangering the navigation of the River to a considerable extent, it was on motion

Ordered that H H Wallace and A K Phillips be a committee to examine into the fact, whether the operation at said quarry are likely to tend to the injury of the navigation of the River & in making said examination the Committee are requested to associate with them any two or more experienced individuals and make report to the Council as early as practicable

Whereas by an Act of Assembly entitled as aforesaid [Page 159] the Corporation of Fredericksburg is authorized to raise by Lottery a certain sum of money in said Act specified to have the streets of the town aforesaid, and whereas Wm D Green of the Town aforesaid has proposed to the Mayor & Commonalty that he would pay five hundred dollars for the privilege of drawing one scheme of said Lottery (to be drawn on or before the 31st December Instant) and moreover that he would execute a bond with good and sufficient security in the sum of sixty thousand dollars payable to the Mayor and Commonalty of the Town aforesaid, conditioned for the payment of all prizes in said scheme & also in the event of said

Lottery not being drawn for the refunding of all monies paid for tickets in said lottery to the purchasers of the same, and that he would deposit the money for all tickets sold in such lottery before the day of the drawing thereof in the Farmers Bank of Virginia to the credit of the Commissioners to be appointed by the Council for drawing said scheme.

Therefore, Resolved that the said Wm D Green, upon complying with the above specified terms and conditions (the securities to the said bond to be first approved by the Council) shall have the privilege of drawing one scheme in said Lottery.

Ordered that an account of Bernard Cole amounting to two dollars and twenty five cents for wood furnished the Mayor's office be paid by the Chamberlain
