The Mayor stated that at the instance of two of the members of the Council he had convened the Council to take into consideration again, the petition & ordinance presented to the Council at its last meeting, in relation to throwing water into the gutter of the streets, whereupon after some debate the following ordinance entitled an "Ordinance in relation to throwing washing water &c &c into the gutters of the Public Streets" was passed by the following vote, viz;

Ayes, Knox, Blaydes, Phillips, Jackson, Lucas, Rothrock, Walker, and Buck Noes, Spilman, Curtis, Wallace and Wellford 4

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that it shall not be lawful for the owner or occupier of any lot in said Town [Page 176] to pass or cause to be passed any washing water, dye water, dish water, or other dirty water, there form, into any gutter on the public streets and thence along or through such gutter by the house on any adjacent or neighboring lot against the consent of the owner or occupier of such house. And any person offending herein shall for every such offense forfeit and pay to the Mayor and Commonalty of said Town, the sum of two dollars to be recovered with costs, by warrant before any justice of the peace of said Corporation.

Be it further ordained that if any slave or servant shall offend herein by throwing any washing water, dye water, dish water or other dirty water into any gutter on the public streets, from the lot of his or her master or mistress without the consent of the owner or occupier of the adjacent or neighboring lot, as aforesaid, he or she for every such offense upon being convicted thereof shall receive ten lashes on his or her bare back unless the sum of one dollar be paid by the owner or employer of such slave for the use of the Corporation.

This ordinance shall be in force from and after the 25th day of July 1840

The following ordinance entitled

An ordinance amend the "Ordinance passed 20th February 1836, concerning nuisances" was read and passed.

Be it ordained by the Mayor and Commonalty of the Town of Fredericksburg that the Ordinance concerning nuisances, passed the 20th February 1836, be and the same is hereby amended in this to wit;

That the fines imposed by said ordinance be increased to the sum of five dollars for the commission of any offense therein named; and further that if any slave shall be convicted of any offense therein name before an justice of the peace of the said Corporation, he or she shall receive on his or her bare back, any number of lashes in the discretion of the justice of the peace before whom such conviction shall take place, provided the same do not exceed the number of twenty, unless his or her master or mistress shall pay the sum of five dollars for each and every offense.

Be it further ordained that all fines accruing for convictions under this ordinance shall enure as follows viz:

One half to the use of the informant, the other half [Page 177] to the use of the Corporation.

This ordinance shall be in force from and after its passage

On motion the Council adjourned Benj Clark, Mayor A Goodwin, CC

An acct of Jas West for iron tub for Public Measure \$5.37

The Mayor having stated that there was a vacancy in the office of Geographer and Surveyor of the Corporation by the death of John Goolrick Esqr, Mr John Minor was nominated and unanimously elected to fill the office of Geographer and Surveyor of the Corporation.

Present, Wm A Jackson—Common Councilman

A memorial of the Managers of the female Orphan asylum praying a repeal or a modification of the ordinance passed the 15th day of July 1840 concerning the throwing of dye water &c into the drains of the streets or that the Council would direct a blind drain to be laid down from the Orphan Asylum to the corner of the street at Patton's Ice house, was presented and it was on motion, ordered that the Street Committee be instructed without delay to receive proposals and cause immediately the construction of a secret brick, wood, or iron drain from the mouth of the cesspool at the Orphan Asylum to the corner of John M Patton's Ice House, and draw upon the Chamberlain for the amount of the expenditure.

On motion the Council adjourned
