Fredericksburg City Council Minutes 1850

At a meeting of the Common Council of the Town of Fredericksburg at the Council Chamber on the 4th February 1850.

Present, R B Semple, Mayor

G Gilman, Geo W Eve, P Hough, L J Huffman, Jas McGuire, Wm Allen, J Pritchard, J B Alexander, H Scott—Common Councilmen

Ordered that an account of Wm M Baggett for \$25, a memorandum of which was submitted to the Board on the 9th November 1849 and not then acted on, be paid by the Chamberlain, provided the same be certified to be correct by the Commissioners appointed by the Court to superintend the building of a Court house.

The following accounts were passed and ordered to be paid by the Chamberlain, viz; R B Semple's for wood purchased for the Poor during the last snow amounting to ten dollars Geo B Waite's, H S Doggett, R B Alexander, B Coles, and John Timberlake's for guarding the Town 5 nights each during the Christmas holidays, at \$1 each, per night amounting to the whole of twenty five dollars

Present, John Minor—Common Councilman; B S Herndon, Recorder

Mr Geo Ficklen of Fauquier appeared before the council in advocacy of a subscription of the Hazel Run and Mr John G Lane, of Rappahannock, on behalf of the Turnpike Company from Sperryville to Carter's Run on the Rappahannock River; both gentlemen having explained their views of the benefits likely to result from the completion of said improvements, the following resolution was submitted by John Minor, viz:

Resolved that notice be given through one or more of the Newspapers published in this town that a poll will be opened at the Mayor's office on the [blank] day of [blank] account to determine whether any steps shall be taken to obtain an Act of the Legislature enabling the Council to contribute to the completion of certain plans for Roads & Canals, the effect whereof seems to promise to add to the trade of the Town; that is to say a turnpike road from Sperryville to the mouth of Carter's Run and an [Page 389] improvement of the navigation of the Hazel River; and the construction of a plank road from Fredericksburg to the Valley of Virginia and a turnpike from Sperryville to the head of the proposed navigation of the Hazel River which resolution after some discussion was on motion of James McGuire laid on the table.

Ordered that the Mayor be requested to call a meeting of the Citizens of the Town as soon as he shall have procured a copy of the Act of Assembly chartering the Fredericksburg & Valley Plank Road, with the view of ascertaining the sentiment of the Citizens in relation to a subscription to the stock of either of the before named improvements.

Also ordered that the Mayor draught an ordinance restraining disorderly and improper conduct at exhibitions, shows, &c in the Town Hall or elsewhere within the limits of the Town.

On motion the Council then adjourned till tomorrow evening at 7 o'clock PM R B Semple, Mayor A Goodwin, CC

An ordinance to restrain disorderly and indecorous behavior at exhibitions &c &c was passed in the following words, viz;

Whereas it has been represented to the Mayor and Common Council of the Corporation of Fredericksburg that certain evil disposed and disorderly persons, some of whom are adults and others minors, have attended the public meetings held by the citizens and exhibitions and shows [Page 390] which are permitted by law; and that the said disorderly persons do, in various ways, by loud talking, singing, whistling and by other means disturb and interrupt the proceedings and by standing up before the audience exclude females as well as males from participation in the enjoyment of the representations and exhibitions, for which they assembled and in various other ways, annoy and disturb the harmony and good order of such assemblages, in violation of good behavior, all of which tend to a breach of the peace with the view to remedy these evils.

Be it ordained by the Mayor and Common Council of the Corporation of Fredericksburg that all persons who shall at any public meeting of the citizens or at any exhibition or show of any kind held within the limits of this Corporation willfully interrupt the same so as to annoy any portion of the persons attending them, or either of them, as specified in the annexed preamble, or willfully do any other act or thing calculated to annoy or disturb the enjoyment of others, or to violate or tending to violate peace of the Commonwealth shall upon conviction thereof before any justice of the peace, pay a fine not less than one, nor more than five dollars and also the costs of the said prosecution to be paid to the Chamberlain for the use of this Corporation and if the offender be a minor, judgment shall be given against his father or guardian, or master if bound as an apprentice, as the case may be who shall pay the said fine and costs. Be it further ordained that it shall be the duty of the Police Officers of this Corporation to attend such meetings exhibitions and shows and to suppress all riotous conduct tending to the violation of this ordinance, or breach of the peace and they are hereby required to take the offender before some justice of the peace for this Corporation that he or they may be dealt with according to law. This ordinance shall be in force from its passage.

The Committee appointed on the 7th December last to submit a scheme for issuing scrip for the Corporation debt submitted to the Board the form of the scrip or certificates to be issued by the Corporation and the form of an assignment [Page 391] also a copy of an Act of the Legislature entitled "an act to authorize the Corporation of Fredericksburg to fund the residue of its debt" passed January 23rd 1850, certified by George W Munford Clerk of the House of Delegates & Keeper of the Rolls of Virginia; Whereupon Mr C C Wellford offered the following resolutions, viz;

Resolved that proposals be published in the Newspapers of this town and in one in the City of Baltimore for a loan of \$30,000 for which script of the Corporation similar in form to that of the City of Richmond, shall be issued, said loan to bear interest not exceeding 6 per cent per annum payable semi-annually and to be redeemable as follows, viz; \$10,000 in ten years, \$10,000 in 20 years and \$10,000 in 30 years from the date of issue of scrip for the same; provided always that no part of said loan shall be negotiated under par, that is to say for less than dollar for dollar.

Resolved that when said loan or any part thereof be negotiated the proceeds be applied to the payment of the Bond of this Corporation to the Rappahannock Company and the debts due the Banks in this Town;

and that the Council will set aside a fund from year to year to be called a sinking fund, sufficient to pay the interest on said loan and to redeem the principal thereof at the respective period when the same is redeemable.

Mr John Pritchard moved as an amendment to said resolutions the following, viz; Resolved that a poll be opened to take the sense of the voters of the Town upon the question of selling the real estate belonging to the Corporation and applying the proceeds thereof to the extinguishment of the debt of the Corporation upon which amendment the vote being taken it was negative and then the Resolutions offered by Mr Wellford were adopted.

On motion that the Mayor appoint three members of this body to act as commissioners in advertising for and negotiating said loan, it was so ordered and Charles C Wellford, Hugh Scott, and Wm Allen were appointed said Commissioners and were requested to act without delay.

On motion that a select committee of three be [Page 392] appointed to take into consideration the condition generally of the corporation property and the propriety of selling the same or any part thereof with a view to the extinguishment of the debt due by the Corporation it was so ordered and the Mayor appointed Mess'rs H Scott, J McGuire, and John Pritchard who were directed report at the earliest period practicable.

Upon the application of sundry citizens of the town (who had subscribed of themselves, \$184 for the purpose of boring for water in the Town that an appropriation out of the funds of the Corporation in aid of said object be made; said appropriation together with the amount of individual subscription not to exceed \$400 and the same not be called for until the individual subscription is exhausted it was Ordered that the Chamberlain of the Corporation do pay out of the funds of the Corporation to the Treasurer to be appointed by a meeting of said subscribers, a sum not exceeding two hundred and sixteen dollars provided said individual subscription of \$184 shall have been exhausted; and it was further ordered that said parties in conducting their operations of boring for water be and they are hereby privileged to bore in any of the public wells of the Town

And then on motion the Council adjourned. R B Semple, Mayor A Goodwin, CC

The Mayor stated that he had convened the Council at the instance of several of its members for the purpose of adopting measure to receive the President of the United States as he passes through town tomorrow on his [Page 393] way to Richmond, whereupon on motion it was Resolved that the Mayor, Recorder and Mess'rs C C Wellford, J Minor and H Scott be and they are hereby appointed a committee to make all suitable and necessary preparations to receive the President of

the United States and tender him on behalf of the Corporate authorities and the citizens the hospitalities of the Town.

On motion ordered that the Mayor be and he is hereby directed to apply to the Executions of the State for a cannon (for the use of this town) of a larger caliber than the one owned by the Corporation, say a twelve pounder

Mr H Scott on behalf of the Committee appointed at the last meeting of the Council to investigate generally the condition of the Corporation property, and the propriety of selling the same or any part thereof for the purpose of extinguishing the Corporation debt, made a verbal report and submitted a written statement exhibiting the amounts of ground and annual rents received for the same, the names of the persons on whose lines the leased depend &c &c and recommending that no sale be had of any part thereof at the same time submitting a letter to the Council from Francis H Bell, containing sundry proposals for the purchase, leasing for life or a term of years or annually of the house on Commerce Street now occupied by him; Whereupon said report was concurred in, and it was on motion resolved that the Committee on Public Property be and they are hereby directed to rent the house occupied by Mr Bell upon the expiration of said Bell's lease for a sum of not less than one hundred dollars per annum.

And account of David Bradford for the sum of \$7.50 was passed to the extent of \$5.25, the item in said account of \$2.25 for interest being rejected.

The Mayor presented an account shewing the amt received by him for fines and tax on Corporate Seal for the year to be \$9.62, which sum was ordered to be paid over to the Chamberlain and passed to the credit of the Corporation.

The Salaries of the Police Officers were ordered to be paid, the Mayor having reported favorably as to the manner in which they had discharged their duties for the present quarter.

Mess'rs James McGuire, Geo W Eve and Hugh Scott were appointed a committee to state and settle with the accounts of the Collector of Taxes & Rents and of the Chamberlain of the Corporation and report to the Council on Monday Morning next at 9 o'clock.

A written proposition of Mess'rs Waite & Sener, in the following words and figures to wit; "To the Public Property Committee, Gentlemen, Wishing to increase the length of the house now occupied by us by adding an addition on the back, of 12 feet deep, one story high, or brick, besides some other repairs, such as ceiling the part that over we work in and other alterations such as we want to do so as to make it suitable for our business and give us more room (the cost to us will not be less than \$200.00) we are willing to do the above provided you will agree to let us have the refusal of said house for six years at the same rent now paid by us, that is seventy five dollars per years.

Was submitted to the Board by James McGuire, the chairman of the Committee on Public Property, and after due consideration was acceded to by the Council and the same was ordered to be entered at length on the minutes as evidence of the agreement between the Council and Mess'rs Waite & Sener. Mr Sener of said firm being present and assenting in behalf of said firm to be bound by the terms of their proposition.

A Memorial of Mrs Fayette Johnston on the subject of abating a nuisance near her dwelling but without the limits of the Town and asking a reimbursement of expenses already incurred by her, in trying to abate said nuisance, was presented to the Board by the Recorder and was, on motion, laid on the Table.

The attention of the Council being called to a proclamation of the Mayor, directing a poll to be opened at the annual election of Common Councilmen next Monday for the purpose of taking the sense of the voters of the Corporation in relation to a subscription on the part of the Corporation to the Fredericksburg and Valley Plank Road, and also the proceedings of a [Page 396] recent town meeting requesting the sense of the voters on the same subject and the Council deeming it necessary in order fully to test the sense of the voters, and also to arrive at any practical results, that in taking said poll a definite and certain amount of subscription should be voted for; it was on motion of James McGuire duly seconded and carried, agreed that said amount should be \$20,000. Whereupon it was ordered that the Clerk of the Council in taking the vote for Common Councilmen, on Monday morning next do also take the sense of the voters for and

against a subscription of \$20,000 on the part of the Corporation, to the Fredericksburg and Valley Plank Road.

On motion the Council then adjourned until Monday Morning next at 9 O'clock.

The Committee appointed to settle the accounts of the Collector of taxes & rents and the Chamberlain of the Corporation made the following reports, which were read, approved, and ordered to be entered on the minutes, viz;

On the Collector account. "undersigned, a committee appointed by the Common Council of the Town of Fredericksburg to examine the account of John S Caldwell, as collector of said Corporation, have performed that duty and certify that the above account is correctly stated and that the same is properly balanced and settled.

On the Chamberlain's account. "The undersigned appointed a committee to examine and settle the account of the Chamberlain of the Corporation of Fredericksburg for the fiscal year ending this day, respectfully report that they have performed that duty and find the debits therein supported by proper vouchers, and the credits therein correct, and that there is a balance in the hands of the Chamberlain of four hundred dollars and twelve cents as per preceding account.

Said accounts were then ordered to be place on file by the Clerk of the Council.

The Collector returned his lists of insolvents as follows, viz;

Of whites amounting to \$93.80 Of Blacks amounting to \$33.00

Which were also ordered to be filed and he likewise returned the following amount of deferred taxes and rents, viz;

Deferred Taxes \$156.34 Deferred Rents \$129.16

The Committee also made the following report, viz;

The Committee on examination of the account of the Chamberlain of the Corporation find the sum of nine dollars and sixty two cents, paid in by R B Semple, Mayor, for fines collected during the year. They would respectfully recommend to the Council that an ordinance be passed requiring the Police Officers to

pay in to the Chamberlain any fines or penalties as they may be collected so as that it can be stated in his account from whom said fines and penalties were collected. Whereupon the following ordinance was passed.

Be it ordained by the Mayor and Common Council [Page 398] of the Town of Fredericksburg that hereafter in all cased of collection of fines and penalties by the Police Officers for the violation of any bye-laws, ordinance, or police regulation of this Corporation where the same are imposed for the use and benefit of the Corporation it shall be and is hereby made the duty of the said Police Officers to pay over said fines or penalties to the Chamberlain of the Corporation for the time being immediately after collection, taking said Chamberlain's receipt therefor.

Mr W A Little appeared before the Council as representing many of the voters of the town and asking that a poll may be opened this day for a vote upon a Corporation subscription to the improvement of the Hazle River, in accordance with the authority conferred by an Act of the Legislature passed the 11th day of March 1850 entitled, "An Act to incorporate the Hopewell Gold Mining Company and for other purposes," under which said Act notice of taking said vote had been given; Whereupon a motion was made by C C Wellford that said poll be opened this day forthright which motion being amended by Mr John Pritchard so as to take said poll to day and vote being taken on said amendment and the same having passed, it was, ordered that the Clerk of the Council do open a poll this day for a vote, for and against a subscription on the part of the Corporation to stock for the improvement of the Hazle River, the voters to designate the amount of Stock to be subscribed for, at the time of voting.

This being the day fixed by law for the election of twelve men to serve as Common Councilmen for the Town of Fredericksburg, until the 3rd Monday in March 1851, and until others are elected in their stead, the freeholders and housekeepers met at the Council Chamber and deposited their ballots, and upon counting the same it was found that the largest number of votes were given for the following persons, to wit;

The first named twelve of whom were declared duly elected as Common Councilmen to serve until the third Monday in March 1851 and until others are elected in their stead.

The vote on a subscription on the part of the Corporation to the Fredericksburg and Valley Plank Road to the extent of \$20,000 under an order of the Council of the 14th Instant was

For subscription 265 Against subscription 13 Not voting 8 Whole number of votes 286

A very large majority of those voting for the subscription to the Hazle River being in favor of the sum of \$10,000.

On motion the Council then adjourned.

Wm Allen, H Scott, J McGuire, J B Alexander, B S Herndon, P Hough, J Pritchard, L J Huffman, J Sanford, G W Eve, J Minor, C C Wellford—Members elect of the Common Council of the Town of Fredericksburg met at the Council Chamber and severally took the oath of office before the Mayor.

On motion the salary of the Mayor was fixed at the sum of four hundred dollars for the present year.

The Council then proceeded to the election of a Mayor, when R B Semple was unanimously re-elected and took the oath of office and also the oaths of a Justice of the Peace, before Bev R Wellford, a Justice of the Peace for the Corporation of Fredericksburg.

The Council then went into an election of a Recorder, when B S Herndon was duly elected and [Page 400] took the oath of office and also the several oaths of a Justice of the Peace before the Mayor.

On motion the salaries of the following officers were fixed at the following sums per annum, viz;

The compensation of the Collector of taxes & Rents for the current year was fixed at 10 pr cent for collecting taxes and 5 pr cent for Rents.

On motion it was resolved that the Bellman have the use of the dwelling house on the Court House lot as compensation for ringing the Court House bell every night at 9 o'clock, or at such other hour as the Council may hereafter direct.

On motion ordered that the fixing of the Salaries of the Police Officers be postponed till the next meeting of the Council and that the present incumbents of said offices be continued in office at the present salaries until the further order of the Council.

The Council then proceeded to the election of officers of the Corporation for the current year, when the following persons were elected, viz;

A motion was made that the appointment of a Commissioner of the Revenue be postponed till the next meeting of the council and the vote being taken and being a tie, the Mayor gave the casting vote in the affirmative so it was carried.

A motion was made to prohibit smoking in the Council Chamber during the sessions of the Council [Page 401] and the vote being taken by ayes and noes was as follows, viz;

On motion it was Resolved that the Standing Committees be the same as last year so far as the old members are concerned, Mr J Sanford being substituted in the place of G Gilman late member.

On motion, Ordered that the Committee appointed to advertise for proposals for a Corporation loan be and they are hereby instructed to make an effort to raise any portion or the whole of the required amount, by issuing Bonds as scrip of the Corporation at not less than par, and for sum not less than \$100, in amount, and that said Bonds or scrip shall be in such form as the said Committee may approve and shall be executed by the Mayor under the seal of the Corporation and countersigned by the Chamberlain of the Corporation.

On motion ordered that an increase of twenty five per cent on the tax of last year be fixed as the tax of the present fiscal year on licenses to carts, drays, and wagons.

Ordered that tins be furnished at the expense of the Corporation to all drayman, cartmen, and wagoners who are subject to the payment of taxes, on which to No. of their drays, carts and wagons are to be legibly marked and attached to their respective drays, &c &c and that Geo W Eve and James McGuire be a committee to contract [Page 402] for and purchase said tins and deliver the same to the Commissioner of the Revenue to be given to the persons who may take out licenses; said tins to be attached to the drays, carts and wagons in such manner as the Committee may prescribe.

On motion it was ordered that the Clerk of the Council be instructed to receive bids from the several Newspaper publishers of the Town, for the printing of the ordinances &c &c of the Corporation, and to contract with the lowest bidder for the printing for the current year, reserving the right to rescind the contract in the event of an imperfect execution of the work &c &c on the part of the party so contracting.

A motion was made by H Scott that the Commissioner of the Revenue be directed to take a list of all taxable persons and property within the limits of the Town as established by the several acts of the Legislature, which motion was laid on the table for the future action of the Council.

The following motion submitted by John Minor viz;

Ordered that the tax on licenses for drays & carts, shall be nine dollars and twenty five cents; and that those draymen who take out such licenses shall be "ipso facto" discharged of their poll tax and the tax on their dray horses" was put to the vote and rejected by the following vote, viz;

An ordinance taxing Circus & Menagerie exhibitions was passed in the following words, viz; Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that hereafter a tax of five dollars shall be and the same is hereby imposed on each and every exhibition of a circus or menagerie, within the limits of the Town aforesaid. Said tax to be collected by the Collector of Taxes as other taxes are, provided always that when any such circus or menagerie shall be open for exhibition more than once in the same day, it shall be deemed and taken to be as one exhibition and be subject to a tax of five dollars only.

This ordinance shall be in force from and after its passage.

The council then proceeded to the election of a Commissioner of the Revenue, when John Metcalfe was re-elected.

The Clerk of the Council reported to the Board that he had invited proposals for publishing the ordinances &c of the Corporation from the publishers of the several paper of the Town and that each one made the same bid, and therefore under the order of the Council had no option in selecting the newspaper in which the same were to be published. Whereupon on motion it was ordered that the Clerk of the Council select as the paper, that one having the largest circulation within the corporate limits of the Town, and to

ascertain that fact he address a note to each publisher asking the number of town subscribers to their respective papers, and that he be governed in his selection by the report of said publishers.

Ordered that the fixing the salaries of the Police Officers and the election of Police Officers be further postponed.

Ordered that the Committee on public property provide a table for the use of a reporter for the Editor of the *Democratic Recorder*.

An order of the Hustings Court, passed 11 April 1850, directed to the Committee on Public Property, requesting an examination of the Jail and to have the same repaired was laid before the Council by the Mayor, and it being state by Mr Hugh Scott, that the damage done by the recent fire in the Jail was occasioned by a servant of Doct J H Wallace being confined there for the convenience of said Wallace and therefore the expense of repairing should be paid by him; it was on motion Ordered that the Committee on Public Property call upon Doctor Wallace for the purpose of ascertaining what he will do in the business.

An order of the Hustings Court dated 11th April 1850, respectfully requesting the Council to appoint a day, and have a poll opened for the purpose of taking the sense of the voters of the Corporation in relation to the building of a new Court house was also submitted to the Board by the Mayor and on motion of Hugh Scott it was laid on the Table

Mr Charles Herndon of the firm of Conway & Herndon attorneys at law, read to the Board an elaborate opinion in relation to the power of the Council to lay and assess taxes on the persons and property of the inhabitants of that part of the Town, commonly called Allen Town. Whereupon the following Resolution was submitted and passed, viz;

Resolved that the Commissioner of the Revenue be required forthwith to make out a list of all taxable persons and property in that part of the town above mentioned in [Page 405] such manner as is required by the ordinances of the Corporation, and that he return the same to the Collector of Taxes who is hereby required and ordered to collect the taxes so assessed and to distrain for the same should payment be neglected or refused.

The Clerk of the Council at the request of Mr Charles Herndon was directed to hand over to Mr Herndon the opinion he had read, with the view to his making out a fair and legible copy of the same to be placed on file.

On motion it was ordered that such portion of a fine recently imposed by the Mayor on Murray Forbes Esq for a violation of the ordinance licensing drays &c as the Corporation is entitled to, be and the same is hereby remitted for reasons satisfactory to the Board.

On motion, the Recorder, Wm Allen and H Scott, Esquire were appointed a Committee to examine and report jupon the condition of the road in the neighborhood of Mrs Johnston, the same being represented as a nuisance to the persons residing in that part of Town.

On motion of Mr John Pritchard, who stated to the Board that the individual subscription for boring for water, referred to in an order of the Council of the 5th February last, had been exhausted, so far as collection of the same had been made, of which however only about one-half had been paid, it was Ordered that the Treasurer of said Company or association be and he is hereby authorized to draw on the Chamberlain for the amount of the appropriation named in said order of the 5th February 1850, that is to say for a sum not exceeding \$216.

Mr Peyton Hough of the Committee on Public Property reported to the Board that under the order of the last meeting of the Council, he had called on Doct John H Wallace, and that he declines paying any portion of the expense to be incurred in the repairing of the Jail, the servant confined therein at the time the fire broke out having been arrested by a Constable as a runaway and committed to custody as such.

The Committee to whom was referred the subject of the Corporation subscription to Hazle River respectfully recommend to the Council that the Mayor execute scrip (the form to be determined in Council) for \$10,000, in obedience to instructions of the people expressed at the polls on the 18th Ult, the scrip to be paid over in installments in the same manner and pro rata with individual subscription. Whereupon petitions signed by numerous voters for and against said subscription, respectfully, retracting or reaffirming their votes on the 18th Ult having been presented and read, a motion was made by L J Huffman to adopt said report, to which George W Eve offered as an amendment or substitute a motion to refer back to the people the whole question of subscription no the part of the Corporation to said improvement and the vote thereon being taken by ayes and noes resulted as follows, viz;

The report of the Committee on subjects of taxation was then on Motion taken up and the [vote] being taken on each item in said report, viz; Real Estate, annual value, white males above 16 years, Slaves above 12 years; free Negroes and Mulattoes, male & female above 16 years, Horses, Carriages, Carioles, Gigs, Phaetons, Pleasure carriages of every description, Goods, Ware and merchandize, household and Kitchen furniture; hogs, pigs & shoats; cows; dogs; bowling or ten pin alleys; billiard tables; bagatelle or other tables for amusement at place of public resort; Cake boys and peddlers, Libraries of \$100 value and over. The same was adopted

The recommendations and suggestions in said report were also passed upon and adopted and ordered to be entered on the minutes as follows, viz; And whereas the Council will have additional powers by the new Code of the State which is to go into effect on the 1st July next, we would recommend for your consideration the propriety of an assessment and levying of taxes on or after the 1st of July of the various subjects of taxation which the Council will then have the authority & power to tax, and that the Commissioner of the Revenue be directed in taking the lists of taxable property as enumerated in this report be directed also to take a list of all such as will be subject to a town tax after the 1 July next, so far as the same are comprehended in the list he takes in his returns for the State. And it also appears from a partial examination that there is evident inequality in the assessment of taxes, we would therefore recommend that the Books of the Commissioner of the Revenue be submitted to the Council for revision and correction annually, before the Council lay the taxes and that the Commissioner be requested in listing the various subjects of taxation to give his particular attention to the duties required of him by the ordinances of the Corporation on this subject in order to attain a more equal and just assessment. And we would also suggest that the Chamberlain be directed to open an acct with the Collector of Taxes for the deferred taxes and Rents and insolvent lists of each year, in which he shall regularly bring forward the balances in order that the Committee appointed annually for the settlement of the accounts of the Corporation may have before them all of said items and that the insolvent lists returned in each and every year [Page 410] be sworn to by the Collector of Taxes and that copies thereof be posted up by him on the 1st July in each and every year in the Clerk's & Mayor's offices as well as on the Court House door as at present ordered

On motion a tax of one dollar for each dog and five dollars for sluts was passed and all dogs running at large without a collar with the Corporation stamp on it as evidence of payment of the tax, to be killed by the Police Officers, who shall receive [Page 411] one dollar for each and every dog or slut so killed, said dogs or sluts to be buried without the limits of the town and the person killing and burying to be paid by the Corporation, in case the same cannot be obtained from the owner of said dogs or sluts; and the Clerk of the Council was directed to prepare an ordinance in accordance with the above view, to go into effect 1st June next; which said ordinance is in the words and figures following and entitled;

An Ordinance concerning Dogs

1. Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that a tax for the current fiscal year of one dollar on each dog and five dollars on each bitch, owned by persons residing within the limits of this town be and the same is hereby imposed; said tax to be paid to the Mayor of the Town who upon the receipt thereof, shall furnish without cost or charge therefore to the persons paying the same a collar with the Corporation stamp thereon to be worn around the neck or his or her dog.

2. Be it further ordained that all dogs owned by residents of this town which shall be found running at large in the streets without a collar with the Corporation stamp thereon shall be liable to be killed and it is

hereby made the duty of the Police Officers to kill all such, by shooting or otherwise and to have such as may be killed, buried without the limits of the Town; and for each dog so killed and buried without the limits of the Town, the said officer shall be entitled to and receive a fee of one dollar, to be recovered by warrant with costs, of the owner of the dog so killed if any owner can be found; otherwise, or in the event of the owner being insolvent, then the same to be paid by the Corporation upon affidavit being made by said officer of the service rendered.

3. Be it further ordained that the Mayor be and he is hereby authorized to procure at the expense of the Corporation such a number of collars with the Corporation stamp thereon as may in his discretion be deemed necessary and that he render to the Council at the end of each quarter of the fiscal year, an account of the expense incurred in the purchase of collars and the amount of tax received under and by virtue of this ordinance.

This ordinance shall be in force from and after the 1st day of June 1850 [Page 412]

On motion the Commissioner of the Revenue was released from the duty of taking a list of dogs, cake sellers in the streets & pedlars among the subjects to be embraced in his returns on the Commissioner's books.

The following ordinance was passed entitled "An Ordinance concerning Hogs"

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that it shall not be lawful for any hog to run at large within the limits of this town and it shall be the duty of the Police Officers to take up all hogs found running at large in the Town and sell the same at any public corner to the highest bidder for ready money; one moiety whereof shall go to the Police Officer and the other to the Chamberlain for the use of the Corporation.

This ordinance shall commence and be in force from and after the 10th of May 1850.

On motion the salaries of the Police officers was fixed at the rate of \$200, per annum, each, to commence at said rate from this day.

Bernard Cole and John S Timberlake were then elected Police Officers and took the oath of office before the Mayor

On motion ordered that the Street Committee be and they are hereby directed to enquire into and report to the Council, all cases where any street or streets may be closed up by fencing or otherwise whether the same shall have been done so by the permission of the Council or not.

That the Citizens of this Corporation be respectfully requested to abstain from all secular business during the same hours and to close their stores and offices.

That sixty six guns be fired during the tolling of the bells that being the age of the lamented chief Magistrate.

That this body will and the officers of the Corporation are requested to wear the usual badge of mourning for sixty days.

That the Clerk of the Council be requested to forward to Mrs Taylor a copy of these proceedings as a testimonial of our high respect for the memory of her late exalted husband, and of our sympathy with herself and family.

That the edition of the Newspapers of this Corporation be requested to publish these proceedings.

Mr L J Huffman then offered the following resolutions which were adopted,

Resolved that a majority of the people should govern in all questions of public interest; that we are the servants of the people and should carry out their views upon all questions of a public nature. Resolved that the proxy of the Corporation be and they are hereby directed to cast the vote of the Corporation at the meeting of the Stockholders of the Fredericksburg & Valley Plank Road now in session in conformity to the wishes of [Page 435] a majority of our Town Stockholders as expressed by them in voting for or against any measure at said meeting.

Doct B R Wellford, one of the proxies of the Corporation asked of the Board an explanation of the instructions contained in the last of the foregoing resolutions, at the same time giving his construction of them and suggesting that the Clerk of the Council should be directed to cast said vote; this explanation being given, he then resigned as one of the proxies and his resignation was accepted; as also was that of Mr Geo W Eve, which was tendered by Mr Eve.

Daniel Bradford, resigned his officer of the Clerk of the Market and the Board proceeded to fill the vacancy when Mr James N Campbell was unanimously elected.
