Fredericksburg City Council Minutes 1851

The Council met pursuant to a call by the Recorder at the Council Chamber Monday evening Jan'y 6, 1851

In the absence of the Mayor the Recorder took the Chair and called the Council to order.

Present, Wm Allen, C C Wellford, H Scott, J Minor, John Pritchard, L J Huffman, J B Alexander, James McGuire—Common Councilmen

The Clerk of the Council being absent from sickness, John McGuire was appointed Clerk pro tem

The Recorder stated that the Council had been called together to take into consideration the propriety of memorializing Congress upon the subject of the erection, in the Town of Fredericksburg, of a National Monument in honor of General Hugh Mercer of Revolutionary memory.

Whereupon, Mr John Minor presented and read the following memorial which was unanimously adopted, viz;

Whereas Congress by a resolution dated the 8th April 1777, directed that a monument should be erected in the Town of Fredericksburg, Virginia to the memory of General Hugh Mercer, who feet at the Battle of Princeton [Page 441]

And whereas we are informed that a movement has been made to obtain an appropriation from the present Congress to fulfill the pledge given by the Continental Congress and that steps have been taken to procure a charter from our State Legislature for a Mercer Monument Association for the purpose of appearing before our National Legislature in a more authoritative manner and we approve of the said movement both in our own individual and Corporate capacities, and believing it is particularly desirable at this time that all means should be adopted to recall to recollection the struggles and trials of the Revolution and revive the hallowed association connected with the Patriots & Heroes of our past history and thereby teach the value of our present institutions, therefor be it

Resolved that we the Common Council of the Corporation of Fredericksburg do most heartily approve the objects of the said Mercer Monument Association, and do earnestly recommend it to the special attention of Congress, with the hope that their request may be granted.

Be it further Resolved that we request the Senators and Representatives from Virginia to use their influence to obtain such appropriation as may be deemed necessary in furtherance of the said design. Be it further resolved that a copy of those resolutions be properly authenticated by the Clerk and forwarded with the Memorial of the said Association to our Representative in Congress.

And then on motion the Council adjourned.

The Council was convened for the purpose of appointing a proxy to represent the Stock of the Corporation at an adjourned meeting of the Stockholders of the Fred'sburg [Page 442] and Valley Plank

Road, to be held at the Town Hall this evening at 7½ o'clock; Whereupon on motion of Mr Geo W Eve it was ordered that three persons be elected proxies to represent the Stock of the Corporation at said Meeting or any other that may be held between this the third Monday in March next, and John S Caldwell, J Sanford, and W S Chesley were duly elected by ballot.

An account of Wm Slaughter amounting to ten dollars for a Map of the Town shewing the limits as proposed to be enlarged was passed and ordered to be paid by the Chamberlain.

The Mayor informed the Council that the Governor had consented to let the Corporation have the use of a Cannon, with the understanding that a suitable and proper cover or shed be provided to protect it from the weather; Whereupon on motion of Mr Allen, the matter of providing a suitable shed or cover for the same was referred to the Committee on Public Property.

The Recorder state the Council had been called for the purpose of considering a matter touching the interests of the Town, to wit; An application from the Citizens of Falmouth and others, to the Legislature for a charter and an appropriation to construct a canal from Falmouth tapping the Rappahannock Canal at Minor's dam; Whereupon on motion it was ordered that the Recorder and Mr John Minor be and they are hereby appointed a committee to prepare a counter Memorial to said application to be presented to the Legislature.

Mr Geo W Eve, at the instance of Mr John Coakley brought to the notice of the Council the fact that part of the house near the old Market House pump extends [Page 443] upon the said Coakley's premises and that he requests the Council to cause the same to be remove; whereupon on motion the subject was referred to the Committee on Public Property for action thereon.

The Council we organized by called Wm Allen to the Chair, and in the absence of the Clerk from indisposition, J S Caldwell was appointed Clerk, pro tem.

Mr Sanford information the Council that they had been convened for the purpose of getting the Council to express an opinion whether the Corporation proxies had expressed the sentiment of the people of the Town when they voted against approving the report of the President and Directors of the Plank Road Company at a meeting of the Stockholders of said Company held on the 24th Ult it having been represented to the Board of Public Works by the proxy of the State that they had truly reflected the opinion of the people in that vote; Whereupon Mr Huffman moved that the report of the President and Directors of the Fredericksburg and Valley Plank Road Company made to the Stockholders at the meeting of said Company on the 24th Ult be adopted, which motion was carried in the affirmative.

On motion it was ordered that that the Clerk transmit a copy of the proceedings of the Council to the President of the Fredericksburg & Valley Plank Road, now in the City of Richmond.

The Mayor stated he had convened the Council for the purpose of considering more at length what measures it might be necessary to take in regard to the application now before the Legislature for authority to construct a branch of the Rappahannock Canal to Falmouth.

A Memorial and remonstrance was presented and read by the Mayor, setting forth our objections to the scheme, and protesting against the grant of authority asked for.

The Memorial was unanimously adopted and a committee of three appointed to perfect and forward the same to our delegate in said Committee to consist of W Allen, John Minor, and Geo W Eve; and on Motion the Mayor was added to the Committee.

The following preamble and resolution was offered by John Minor and adopted, viz; Whereas it has been represented to this Board that Doctor B R Wellford is going to Richmond, therefore, Resolved that it be communicated to him by the Mayor that this Council will hold it good service if he would use such influence as he may possess in opposition to the memorial lately presented by Falmouth for a Charter and appropriation to divert the water of our River from the Canal of the Rappahannock Company to the great injury of this Town as well as of the said Company.

Ordered that hereafter a tax of three dollars for each day shall be levied on all exhibitions within the limits of this Town where pay is required (other than scientific & literary lectures) to be collected by the Collector of the Taxes as other taxes are collected.

The following accounts were presented and ordered to be paid by the Chamberlain, viz; Jesse White, amounting to \$1.50

J B Alexander's for taxes improperly assessed \$7.00 [Page 445]

An account of Ficklen & Brower for Coal for the Jail amounting to 3.75 was ordered to lie on the table.

It was, on motion, ordered that the ordinance regulating the measurement of wood be amended in this, that a cord of wood shall be 4 feet 4 inches high well packed, instead as a present, and to require that all wood brought to this market by water shall be measured.

The Mayor stated the Council had been convened at the instance of the Collector of Taxes for the purpose of obtaining instructions in relation to the execution of the order of the Council of the 11th Inst imposing a tax on all exhibitions where pay is required, other than scientific and literary lectures, and the Collection being present informed the Council that in attempting to execute said order in the case of Monsieur Adison for recent exhibitions in the Citizens Hall, the proprietors of said Hall objected to the power of the Council to impose such tax and that by agreement with said proprietors the matter had been referred to the Council for their consideration.

Whereupon after due consideration, said order of the 11th Inst was rescinded so far as exhibitions in any licensed Hall and Musical concert are concerned.

The following ordinance taxing the proprietors or occupiers of public rooms used for exhibitions was passed;

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that a tax of \$40 per year be and the same is hereby imposed upon the proprietors or occupiers of any public room fitted for public exhibitions, who permit the same to be used for such purposes; and any proprietor or occupier of such public [Page 446] room or rooms who shall permit any exhibition in said room or rooms without paying the tax and obtaining a license shall pay a fine of \$20, and be liable also for the tax, which tax shall be recoverable forthwith.

Be it further ordained that said tax shall be paid to the Chamberlain of the Corporation who shall give his receipt therefor and the license be issued by the Mayor to the party paying the same. This ordinance shall be in force from its passage.

A memorial of the Fredericksburg Guards praying pecuniary aid for the purpose of keeping up said company, and also the use of the Town Hall for the purpose of drilling, therein, was presented by Captain Wm S Barton and being read by him was on motion of Mr Allen laid on the table until after the 3rd Monday of March next.

The Mayor, H Scott and J Sanford were appointed a Committee to go to Richmond for the purpose of asking the aid of the State towards the opening of the south branch of the Rappahannock River.

Applications from W L Shepherd and Mrs Richard Maury to be refunded certain taxes paid by them for the present year were submitted to the Council and on motion were laid on the table.

Ordered that the Chamberlain of the Corporation be directed in all application to take out licenses to sell cake & [?] in the Streets from this date, to charge at the rate of \$10 per year until the 1st April next, at which time said [Page 447] license shall expire.

The Mayor reported to the Board the result of the visit of the Committee to Richmond to obtain the aid of the State towards the opening of the Rapidan River, stating the obstacle in the way of obtaining the aid of the State in the shape of a subscription of \$100,000 of the stock of the Rappahannock Canal Company towards said improvement to be the holding by Colo Pickett Withers of certain bonds given by individuals conditioned for the completion of said improvement by a certain time; and suggested that said obstacle may be removed by the payment of a consideration to said Withers to surrender said bonds to the obligors.

Whereupon H Scott and Jas McGuire were appointed a committee to confer with Colo Withers and ascertain what he would be willing to take for the surrender of said bonds to the obligors, in the event that the State should subscribe the aforesaid \$100,000 of the stock of the Rappahannock Canal Company towards the improvement of the Rapidan River; and to report to the Council together with any other information they may obtain pertinent to the matter referred to them.

The Committee appointed at the last meeting of the Council reported that they had conferred with Colo Withers on the subject matter referred to them and Colo Withers being present would himself submit to the Board a proposition on the subject.

Colo Withers, then arose and stated that he would surrender the bonds held by him for the consideration of the sum of two thousand dollars to be paid by the Corporation and the Rappahannock Canal Company; whereupon the [Page 448] following resolution to wit;

Resolved that the Corporation will pay to Colo Pickett Withers the sum of \$1000 for the surrender to the obligors of certain bonds held by him (amounting to about \$40,000 and given for the improvement of the Rapidan River) provided a subscription of \$100,000 in cash or its equivalent on the part of the State, towards the opening of said river can be, or shall be obtained at the present session of the Legislature; was offered and the vote being taken by ayes and noes resulted in the following, viz;

Mr James McGuire was then appointed a delegate to go to Richmond and attend to the prosecution of said subscription on the part of the State.

The Mayor stated the Council had been convened to hear the report of Mr James McGuire, the delegate to Richmond to invoke the aid of the State towards the opening of the Rapidan river.

Mr McGuire then made a verbal report of the results of his efforts towards effecting the object of his mission and stated that Mr John Baker, one of the proprietors of and representing the Rappahannock Canal Company was present and wished to submit a proposition to the Council on said subject. Whereupon the following resolution and Memorial was offered by Mr Hugh Scott at the instance and request of Mr Baker, who pledged himself that the said Memorandum should be signed by the other proprietors of said canal, and should be binding on said Company in the [?] of the adoption of said Resolution of the Council.

"Resolved that Major Oscar M Crutchfield, the delegate from [Page 449] this County be requested to advocate the bill now depending before the Virginia Legislature for the relief of the Rappahannock Company provided he can procure an amendment thereto to the following effect, to wit; That the stock to be held by the State in the Rappahannock Company by authority of the pending law, shall be transferred to the Corporation of Fredericksburg, for the purpose of being applied to the improvement of the Rapidan River or failing in this then the following amendments, viz; That the stock to be held by the State in the Rappahannock Company by authority of the pending law shall be transferred to a Company to be incorporated and to be styled "the Rapidan Company" to improve the Rapidan River"

Memorandum

We bind ourselves to use all legal means to transfer and secure to the Rapid Ann Company for the purpose of improving the Rapid Ann, the gross tolls derived by the Rappahannock Company from

tonnage ascending from Fredericksburg or descending to Fredericksburg and passing over the works of the Rappahannock Company which shall come from the Rapid Ann River or which shall be destined to pass up said River; this arrangement is to commence when boats begin to convey tonnage from the Rapid Anne River to Fredericksburg and is to continue for ten years thereafter.

It is the purpose of this agreement to secure the gross tolls of the trade of the Rapid Ann, for the above period to the Rapid Ann Company, but said gross tolls are to be deducted from the proceeds of the tolls on the Rappahannock River before dividends are declared else the Rapid Ann Company would receive the said gross tolls under this arrangement and also divide on the same subject as Stockholders of the Rappahannock Company.

We make this agreement in consideration that the Corporate authorities aid us in the application now depending before the Legislature

On the Chamberlain's account, "The undersigned committee appointed to examine and settle the account of the Chamberlain of the Corporation respectfully report that they have performed that duty and find the credits in said account to be correct, the debits supported by proper vouchers, and that there is a balance of \$1369.83 in the hands of the Chamberlain.

They beg leave also to report that said account exhibits [Page 452] as a credit to the Corporation the proceeds of a note for \$800 at 120 days being, the amount authorized by an order of the Council of the 9th July 1850 to be raised by the Chamberlain, to meet the first installment to the Fredericksburg and Valley Plank Road and that said note at its maturity appears as a debit in said accts that during the year as appears by said account, \$4000, has been paid to J S Armstrong, the holder of the Bond of the Corporation to the Rappahannock Company and \$2000 to the Fredericksburg and Valley Plank Road on account of the subscription of the Corporation to said improvements. They further report that the scrip book of the Corporation has been exhibited to them by the Chamberlain and shows the issue to this date of \$7,100 of the bonds of the Corporation of which amount \$5,000 has been issued to the Hazle River Navigation Company on account of the subscription of the Corporation to said improvement and \$2,100 sold, which last sum appears to the audit of the Corporation in the Chamberlain's account of the \$5,000 issued to the Hazel River Navigation Company, \$3,000 dated the 2nd Dec last; They are informed by the Chamberlain is still in his hands, no person authorized to receive the same having called for it; they are further informed by the Chamberlain that he is not aware of the existence of any outstanding claim against the Corporation for the fiscal year terminating this day, except the interest due on the 1st February last on the \$5000 stock issued to the Hazel River Navigation Company which would have been promptly paid, but no call has been made upon him for it. All of which is respectfully submitted Signed, Hugh Scott, Peyton Hough, John B Alexander Fredericksburg, March 17, 1851

On motion it was Resolved that all non-residents who are free holders of the town shall be allowed to vote for Councilmen and all persons resident in Town above 21 years of age who have been assessed with and have paid their taxes for the preceding year, even if they shall not be house keepers, shall be allowed to vote.

This being the day fixed by law for the election of twelve men to serve as Common Councilmen for the Town of Fredericksburg until the 3rd Monday in March 1852 and until other are elected in their stead, the voters met at the Council Chamber and deposited their ballots and upon counting the same it was found that the largest number of votes were given for the following persons, to wit;
