An ordinance entitled "an ordinance to prevent obstructions on the footways and other portions of the Streets" was presented to the board, read, passed and ordered to be printed & is as follows, viz;

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that it shall be the duty of the Superintendent of Streets and he is hereby empowered on all cases where the occupants of lots in the town shall cause and obstruction or inconvenience to a free passage upon the footways, or other portions of the streets by the passage of water from their lots, or by any other means, to notify the lot holders to removed such obstructions and upon default of the said lot holders to do so within a reasonable time, the said officer is required to have said obstruction removed at the costs and charges of said lot holders to be recovered by warrant with costs, before any Justice of the Peace of the Corporation.

This ordinance shall be in force from and after its passage

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that it shall not be lawful for any person hereafter to camp at night or feed their horses, mules or oxen by day in any of the streets of the Town after having been duly warned by an officer, or any citizen of this Corporation and that any person so offending, if a white person shall for every such offense be fined not less than \$1 nor more than \$5 to be recovered by warrant with costs before any justice of the peace for the Corporation of Fredericksburg; and any slave or free negro offending herein shall upon conviction thereof before a justice be fined not less than \$1 nor more than \$5 and if the fine so imposed shall not be paid by the party convicted nor by the owner or employer of such slave or some other person for him, then such slave or free negro shall be punished by stripes at the discretion of the Mayor or justice before whom such conviction shall take place; provided always that such stripes shall not be less than five, nor more than twenty in number. This ordinance shall be in force [Page 153] from the passage thereof.

- 1. That there shall be appointed annually a fit and proper person to act as clerk of the Market, whose duty it shall be to have the Market house and market space kept clean, to keep the scales in proper order to be in the Market during the Market hours, to weight all articles bought or sold in the market if desired by buyer or seller, without fee or reward.
- 2. Be it further Ordained that the person who shall be appointed Clerk of the Market in pursuance of this ordinance shall before entering upon the duties of his office take an oath faithfully and impartially to discharge the same.
- 3. Be it further ordained that for the convenience of the country people there be three stalls in the Market House set apart for their use.
- 4. Be it further ordained that no person shall during [Page 158] the Market hours buy or offer to buy any kind of meat, poultry, butter or eggs within the Market House or market space for the purpose of selling again and every person so offending shall forfeit and pay for every such offence the sum of five dollars to be recovered by warrant before the Mayor or some other Justice of the Peace of this Corporation which warrant it shall be the

duty of the Clerk of the Market or of any Constable of the Town to procure and prosecute in the name of the Chamberlain of the Corporation.

- 5. And be it further ordained that no person shall offer or expose to sale any blown, stuffed, meazley, tainted or unsound meat, at the Market House, or at any other place within the limits of the Corporation; any person so offending shall for each offence forfeit and pay a fine not exceeding five dollars; and all such meat so offered or exposed for sale shall be seized by the Clerk of the Market and buried or otherwise disposed of
- 6. Be it further ordained that all butter, lard, and tallow offered for sale in the Market house or market space shall be sold by weight only under the supervision of the Clerk of the Market; any person refusing to have the same weighed shall forfeit and pay to the Clerk of the Market, one dollar for the use of the Corporation to be recovered by warrant as heretofore prescribed.
- 7. And be it further ordained that any person who may be aggrieved by the acts of the Clerk of the Market may appeal to the Mayor or some Justice of the Peace of this Corporation whose duty it shall be to hear and determine the matter in dispute.
- 8. And be it further ordained that it shall be the duty of the Clerk of the Market to keep all dogs out of the Market House during Market house, and that the owner of any dog found in the Market house during those hours who shall not have obtained a license for that year shall forfeit and pay one dollar to be recovered by warrant before the Mayor or some other Justice of the Peace as heretofore prescribed, and any person who shall hinder or obstruct the Clerk of the Market in the discharge of his duties under this section shall forfeit and pay five dollars to be recovered by warrant as aforesaid. [Page 159] And that the Clerk of the Market be and he is hereby empowered to call in the assistance of the Police of the Corporation if necessary to carry this section into effect.
- 9. And be it further ordained that any Butcher or other person leaving in the market space or throwing or causing to be thrown into the streets or market space of the Corporation any feet, heads, or haslets, or any part of any animal slaughtered by him, or offal of fish, shall forfeit and pay for every such offence a sum not exceeding three dollars.

Be it further ordained that no Butcher shall rent more than two stalls in any one year and that no butcher or other person besides those who have rented a stall or stalls for the year shall sell or expose to sale in the Market House or Market space any meats or fish of the kind hereinafter names, except upon the payment of the following rates, to wit:

For each slaughtered bullock, cow or steer, twenty five cents

For each veal, mutton, lamb, hog, shoat, or sturgeon, twelve and a half cents

And if any butcher or other person occupying a stall or stalls rented by them shall thereat dispose of meats for the benefit of others he or they shall be liable to pay for all meats sold at said stalls for the benefit of others the same rates the owners thereof would have been liable to pay, if the same had been sold by them.

- 11. And be it further ordained that it shall be the duty of the Clerk of the Market daily to demand and receive from the persons liable for the payment of the same the rates fixed in the preceding section and in the event of their failure or refusal to pay, the party so failing or refusing shall be liable to a fine of one dollar to be recovered by warrant with costs before the Mayor or any other Justice of the Peace of the Town aforesaid. Which warrant shall be brought in the name of the Chamberlain of the Corporation.
- 12. Be it further ordained that all monies collected for rates and fines accruing under this ordinance shall enure to the use of the Corporation and it shall be the further duty of the clerk of the Market to keep a regular account of all such and pay over the same quarterly to the chamberlain of the Corporation and as compensation for his services herein he shall be allowed [Page 160] a commission of fifty per cent on the amount collected.
- 13. All Ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.
- 14. This ordinance shall be in force from and after the 15th of October 1854.
