Whereas at a General meeting of the stockholders of the Fred'g Water Power Company held on the 30<sup>th</sup> day of January 1859 the following plan to raise the funds necessary to complete the Works of the said Company and to render the Power afforded thereby available for use within the limits of the Corporation of Fredericksburg was adopted, viz;

A contract to be entered into between the Mayor & Commonalty of the Town of Fredericksburg and the Fredericksburg Water Power Company to the following effect; the Mayor & Commonalty to convey its stock to a Trustee to be conveyed & transferred to the Company by him, when the works of the said Company shall be completed and the Water Power thereby afforded be ready to be applied to some industrial use within the limits of the said Town.

In consideration of which the said Company shall covenant and engage never to grant any right or permit any power to be used outside of the limits of the said Corporation.

A preferred stock to be created to the amount of three hundred and fifty shares to be preferred to the extent of six pr cent dividends.

To each share of such preferred stock the Company shall grant four shares of Stock to be transferred by the Corporation of Fredericksburg.

In taking subscriptions to such preferred stock the tax payers of the said Town to have to right to subscribe in preference to all other persons.

An equitable scaling of stock to take place in case the subscription by tax payers should exceed the amount named

And Whereas no other available plan presents itself to secure the indirect benefits to this Corporation which have always been looked to as the chief object sought to be obtained through the said Company, Therefore Be it resolved by the Mayor and Common Council of the Town of Fredericksburg that the said plan be and is hereby adopted by them for and on behalf of the said Town. And the Mayor [Page 284] is hereby instructed to execute on behalf of this Corporation the proposition with the said Company to carry the said plan into full effect. And he is further instructed to execute instruments conveying the stock now held by this Corporation in the said Company to John M Herndon, hereby appointed Trustee for the purpose upon the Trust that when the works of the said Company shall be completed so that the power afforded by them shall be available for use within the limits of the said Town, he shall convey and transfer the said Stock to the said Company.

Montgomery Slaughter was elected Recorder of the Corporation and took the oaths of office before Benj Clark a Justice of the Peace for the Corporation of Fredericksburg.

The Salary of the Clerk of the Market was fixed at \$100 pr annum

The mayor stated that the Council had been convened for the purpose of receiving the report of the Finance Committee on the subject of the Taxation for the present year; and thereupon Mr J H Herndon [Page 292] Chairman of the Finance Committee reported a bill imposing taxes for the year 1859 which bill having been read was passed and is as follows, viz;

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that there shall be levied and collected on persons, property, and other subject in the said Town to defray the expenses of the Corporation for the year ending the third Monday in March 1860, the taxes following to-wit;

On real estate, one dollar & fifty cents on every hundred dollars value thereof by the Commissioner's books On all Personal property other than slaves, one dollar & fifty cents on every hundred dollars value thereof agreeably to the Commissioner's books

On each white male above twenty one years of age, three dollars

On each slave above twelve years of age, five dollars

On each free colored male above 21 years of age, three dollars

On monies, bonds, securities and liquidated claims except the bonds of the Corporation of Fredericksburg and Virginia State Bonds, eighty cents on every hundred dollars

On all Capital invested or used in any manufacturing business or invested, used or employed in any trade or business, fifty cents in every \$100.

On the Capital monies and personal property of Joint Stock Companies, eighty cents on every hundred dollars. On the interest or profits which may have been received by any person or converted into principal so as to become an interest bearing subject or otherwise appropriated within the year next proceeding the first day of May 1859 arising from bonds, bank stock and certificates of debt of this state or of any public corporation created by this state, thirteen and one third per centum.

On all money and Bonds or other evidences of debt under the control of any person acting as receiver or Commissioner under an order of any Court, eighty cents on every hundred dollars

On the salary, income, or fees of every person as ascertained by the Commissioner's Books under the laws of the State, \$1.25 on the \$100.

On Estates of Decedents as prescribed by the 39<sup>th</sup> Chapter of the Code of Virginia, one per cent on such Estate. On every license granted to an insurance agent, eight per centum on the amount received by him as Commission or compensation and in no case, less than fifteen dollars.

On every merchants, Auctioneers, ordinary keepers and livery stable keepers license granted by the State, thirty three & a third per centum of the State Tax.

On every license to a broker, thirty three & a third per centum on the State Tax

On the Dividend declared by Insurance Companies within the year preceding the 1<sup>st</sup> day of February 1859 to be paid by such Companies respectively, thirteen & a third per centum

On every slave sold by auction, one dollar on every hundred dollars of the amount of such sale to be paid by the auctioneer

On Bagatelle tables, fifteen dollars

On Ten Pin Alley, fifteen dollars, provided that where there are more than one such alley in any room, ten dollars each shall be charged for the excess over one.

On Billiard tables, fifteen dollars provided that where there is more than one such table kept in any room, ten dollars shall be charged for the excess over one.

On every license to a person selling goods by sample or card otherwise than at some store house or place of trade, unless the party shall obtain a merchants license, thirty dollars

On Hawkers & Pedlars and others vending articles in the street or elsewhere in the Town, whether of foreign or domestic growth and manufacture, ten dollars for each carrier and no license to issue for less than one year from the 1<sup>st</sup> of April last.

On every license granted by the State permitting the proprietor or occupier of any public room fitted for public exhibition to use the same for such purposes, twenty dollars, And if the Proprietor or Proprietors of any such room shall use or permit the same to be used for such purpose without first paying the said tax, he or they shall forfeit and pay to the Mayor and Commonalty of the Town of Fredericksburg fifty dollars, and shall be liable also to the said Tax. In such case the tax shall be recoverable immediately by warrant or distress.

On every license to the Owner or occupier of a Daguerrean or Ambrotype room or gallery, ten dollars for each room.

On every public show, exhibition or performance, ten dollars for every twenty four hours and for every exhibition of a circus or menagerie, thirty dollars for every twenty four hours.

On every Toll Bridge, twenty dollars.

Be it further ordained that the Commissioner of the Revenue do extend in the books provided for the purpose the amount due from each person under the provisions of this ordinance.

Be it further ordained that the said Commissioner shall assess all persons required to obtain license under the laws of the State and make a fair alphabetical list thereof so far as he may have progressed with the same at intervals not exceeding fifteen days, and deliver such lists to the Collector for his guide in collecting the Taxes imposed by this ordinance on such licenses.

Be it further ordained that the Commissioner of the Revenue shall return to the Chamberlain a list of all persons required to obtain licenses as aforesaid, that is to say, a list of such as are granted on or after [Page 294] the 1<sup>st</sup> day of April and before the 1<sup>st</sup> day of July, shall be returned on or before the 10<sup>th</sup> day of the said month of July and a list of such as are granted on or after the 1<sup>st</sup> day of July and before the 1<sup>st</sup> day of March following shall be returned during the said Month of March, such lists shall specify the date of each license for what purpose it was granted, the name of the person to whom granted and the amount of the tax.

Be it further ordained that any licensed auctioneer who may sell at auction in this Corporation any slave or slaves shall within ten days after such sale render an account to the Chamberlain of the Corporation of the number sold and the prices obtained for them and also pay over to the said Chamberlain the tax imposed by this ordinance on such sales. And any auctioneer who shall neglect or refuse to render such account to said officer within the time prescribed shall forfeit and pay to the Mayor and Commonalty of the Town of Fredericksburg ten dollars for every slave so sold by him to be received by warrant with costs.

Be it further ordained that all persons who shall call on the Collector at the Court House and pay him the tax due by them under this ordinance by the 15<sup>th</sup> day of June next shall be entitled to a deduction of five per centum and those paying by the 15<sup>th</sup> of July to a deduction of three per centum on the amount of their respective accounts and all taxes not paid by the first day of August shall bear interest at 6 per centum per annum from that date.

Be it further ordained that the taxes shall be collected & accounted for and paid to the Chamberlain of the Corporation by the Collector from time to time as collected and that the said Collector shall finally settle his accounts on or before the first day of December next.

Be it further ordained that the said Collector shall not be allowed to return any list of insolvents, absentees, or deferred taxes or have any credits therefor but upon oath or affirmation that such list is true nor shall such return be admitted by the Chamberlain in his statement with the Collector until the same be passed upon and allowed by the Mayor and Common Council.
