On motion of J S Caldwell & upon the statement of Mr J M Herndon, agent of the Mutual Assurance Society of Virginia, Resolved that the additional premium required by the said society upon the buildings belonging to the Corporation now occupied by the 30<sup>th</sup> Reg't of Va Volunteers be paid by the Chamb'n when required by sd society; to wit ¼ of 1 pr cent pr month.

A Petition signed by a number of the citizens of the Town of Fred'g requesting the Mayor & Common Council to make an appropriation to supply the home volunteers of the 30<sup>th</sup> Reg't of Va Volunteers with overcoats &c was presented & read and thereupon on motion of Mr J S Caldwell; Resolved that the sum of one thousand dollars be & the same is hereby appropriated to provide the materials for overcoats for the volunteers from town

who belong to the 30<sup>th</sup> Reg't of Volunteers, the same to be paid by the Chamberlain on the order of the Finance Committee to the Captains of the Companies.

The Mayor read a communication regarding the invasion of our Town and recommending defensive measures; and thereupon on motion, Mr J B Sener, addressed the board in favor of such defense, his information upon the subject having been derived by Capt Lynch the former commander of the battery at Aquia Creek, and thereupon on motion of Mr John S Caldwell.

Resolved that a Committee be appointed to wait immediately on the secretaries of War & Navy of the Confederate States and call their attention to the unprotected state of the Town of Fred'g and the importance of the free navigation of the Rappahannock River for supplies for a large portion of the Army of the Potomac, that the Army aforesaid is absolutely dependent on the farms bordering on the River for Corn &c for subsisting the Army and that said Committee be instructed to report to the Council as speedily as possible.

The Mayor appointed John S Caldwell and John E Tackett the Committee under the foregoing resolutions.

On motion of Mr John S Caldwell, ordered that the Mayor be added to the foregoing Committee and that said Committee do act in conjunction with our delegates in Congress & the Legislature.

An account of Dr F B Richeson, amt'g to \$50 was presented and on motion laid on the table for the present.

Ordered that the Chamberlain refund to E L McKenner[?] the sum of \$5 the amt of an erroneous assessment upon him for the year 1860.

The Mayor stated that the Council had been called to consider an application which would be made by Mr J Horace Lacy concerning the two field pieces belonging to this Corporation; and Mr Lacy being present stated to the Council that he desired to raise an artillery Company but that neither the Confederate, nor State Governments could furnish Cannon but that if the Council would let him have the two field pieces belonging to the Corporation he could possibly raise a Company; Whereupon on motion of John E Tackett, it was resolved that the Public Property Committee be authorized to lend the two field piece aforesaid to Mr Lacy for the public defense during the War.

On motion of John A English, ordered that upon the application of the proper offices, the powder and balls on hand be also delivered to Mr Lacy whenever he may call for the same; and inventory and estimate of such ammunition being first made by the Public Property Committee

The Committee appointed at the last meeting of the Council to wait upon the Secretaries of the Navy & War in relation to the defense of the Rapp'k River, reported verbally that the waited on the Secretary of the Navy only, on the suggestion of the Hon D Dejarnette, who with our Delegate Mr D H Gordon accompanied them, and that the Secretary stated that he would send an officer immediately to survey the River for the purposes of suggesting the proper places for defense.

An a/c of English & Spindle amounting to \$62.25 was presented & ordered to be paid.

On motion ordered that the Chamberlain pay to John S Caldwell \$15.50 for himself and \$6. For Mr J E Tackett the amt of expenses incurred by them as a Committee to wait on the Sec'y of the Navy under an order of the Council.

In view of the present exigency in public affairs and the large number of troops quartered in our vicinity upon whose sobriety, efficiency and valor, momentous issues depend, and the perilous consequence attendant upon the immediate use of intoxicating liquors.

Be it therefore resolved that all persons within the limits of this Corporation be and they are earnestly invoked to suspend the sale of ardent spirits for the present; and be it further resoled that Maj'r Gen'l T H Hoomes,

commanding the Department be and he is hereby requested to use all his authority forthwith to prevent the sale thereof by the people of this Town to the troops under his command and to all others.

And be it further resolved that the police officers be and they are hereby required to visit all parts of the town daily and report to the Mayor the names of all persons who they have cause to believe disregard the above request and that the Mayor cause the keepers of all tippling shops who may be so reported to him to be arrested and dealt with according to law.

The Chamberlain exhibited to us this bank book shewing a balance to his credit in the Bank of Commerce of Twenty five thousand, nine

hundred and forty four dollars and 79/100 and having in his hands in cash paid today by the Collector a sum sufficient to cover the balance, the coupons and scrip notes embraced in the account were burned by us J M Herndon, Jas H Bradley—Finance Committee"

The Council having been called in order to confer as the what action is proper to be taken by them in the present position of the Town;

It was unanimously ordered that a Committee consisting of the Mayor & Mess'rs William A Little, J Gordon Wallace, Thomas B Barton, Wm F Broaddus & John L Marye Jr, be appointed whose duty it shall be to confer with the Military commander of the forces of the United States now threatening the occupation of the Town and that this conference be held whenever said Commandant shall ask a communication from these authorities; that said Committee shall inform the Commander that inasmuch as the forces of the Confederate States have evacuated the town, no resistance can or will be made to its occupation by the United States forces, but that these Municipal authorities expect and claim that adequate steps will be taken by the Commander to insure protection of persons and property during such occupation, according to the recognized rules of civilized warfare; and that said Commander be further informed that the population of this Town have been in the past and are now in conviction and sentiment loyal to the existing government of the State of Virginia and the Confederate States of America.

Whereas it is manifest that to preserve the peace and good order of the Community during the occupation of the Town or its vicinity by the troops of either Army during the Present war it is manifestly necessary to prohibit the sale or distribution of intoxicating liquors so as to prevent their use by the soldiers; Therefore Be it ordained by the Mayor and Common Council

1<sup>st</sup> That the sale, gift or distribution in any manner of intoxicating liquors within the corporate limits of the town is hereby expressly prohibited except upon the Certificate of the Mayor, or of a physician & for medical purposes.

2<sup>nd</sup> That any person violating this ordinance shall be arrested, tried before a Justice of the Peace and upon conviction there be punished by fine, not exceeding twenty dollars (one half of which shall go to the informer) and imprisonment in the Corporation Jail, not to exceed thirty day, at the discretion of said Justice if said party be white or if a Negro or Mulatto by stripes not exceeding thirty nine, at any one time and the liquor found upon his or her premises shall be destroyed by the police officers.

3<sup>rd</sup> This ordinance shall be in force from its passage and shall continue during the present war.

Ordered that the Clerk of the Council cause the foregoing ordinance to be published in hand bill form and that the Police officers distribute the same in the Town.

Resolved, that Mess'rs John G Hurkamp and Andrew B Adams be and they are hereby authorized to proceed to any point on the line of the road between here and Richmond that they may can communicate with Richmond and to Richmond if necessary to inform the authorities of the Confederate Government of the evacuation of Fred'burg by the United States Troops, and also to request to best offices of the Confederate Government in behalf of the citizens of our Town, who are now incarcerated in the City of Washington as Political Prisoners.

John M Herndon, by note in writing addressed to the Council resigned his office as Recorder which on motion was received.

Mr Jno S Caldwell, was elected Recorder of this Corp'n was qualified before B Clark, Justice of the Peace for the Corp'n
