An account of Dr J G Wallace against the Corporation amounting to \$8 is allowed and ordered to be paid.

An account of John Timberlake, late Jailer of this Corporation amounting to \$75.75 is allowed and ordered to be paid.

On the petition of John L Andrews, setting forth that he had lost during the occupation of a part of the county of Spotsylvania by the Yankee Army during the Spring & summer of 1862, 24 bonds of \$100 each issued by the Corporation of Fredericksburg to Andrew & Quisenberry and of which he was the assignee, and asking that duplicates thereof be issued to him, on consideration whereof [Page 371] the Council doth direct and order that the Chamberlain issue duplicates of said bonds, upon the said John L Andrews entering into bond with security to be approved by the Chamberlain in the penalty of \$4,800.00 conditioned to indemnify & save harmless the Corporation from all loss damage or injury which she may sustain or be liable to sustain by reason of issuing such duplicates & that he pay the expenses thereby incurred.

On motion ordered that the Chamberlain issue to Wm J Jeffries a new bond for \$100 in place of a mutilated one for that amount which has been delivered prior to the Chamberlain.

Mr D H Gordon by note in writing resigned his office as a member of this board, which resignation was on motion received.

The Council proceeded to elect a member of the Board to supply the vacancy occasioned by the resignation of Mr D S Gordon, when Mr Geo W Eve was duly elected.

On motion ordered that the Chamberlain cause the Commissioners books for the year 1862 to be brought from their present place of deposit to his office in the Town of Fredericksburg, to be turned over by him to the Finance Committee.

An account of G F Chew amt'g to \$20 is allowed and ordered to be paid.

An account of Kelly, Tackett, Ford & Co amounting to \$320.25 is allowed and ordered to be paid.

Three accounts of Wm King, amounting in the aggregate to the sum of \$1,006 are allowed and ordered to be paid.

The Committee heretofore appointed to invest the sum of \$50,000 paid in to them by M Slaughter, Treasurer of the Relief fund in 7 pr ct coupon bond of the Confederate States, made a report in writing in the words and figures following to wit: To the Mayor & Common Council of Fredericksburg, Gentlemen: The undersigned respectfully report that in pursuance of the directions of the Common Council at their former meeting. They proceeded to invest the sum of \$50,000 in 7 per cent coupon bonds of the Confederate States which they purchased at \$100.50 the premium of ½ percent on \$250 being paid by a drafter through John M Herndon on Geo F Chew, Chamberlain [Page 372] of the Corporation. Said bonds are deposited by Mr Herndon in the Bank of Virginia at Richmond for safe keeping & Mr Herndon

was requested to ascertain whether said coupon bonds can be transferred into registered bonds of the Confederate States & to make the change if it can be done. The amount directed to be paid on to the Chamberlain at said meeting of Council of \$18,000 for the [use] of the Overseers of the Poor, and of \$25,000 to same for the purchase of bonds of the Corpo of Fred'g by the Finance Committee have been duly paid over by Mr Slaughter, Treas of relief fund to said Chamberlain.

On motion ordered that James H Bradley, J J Young, John G Hurkamp be and they are hereby authorized to purchase from Mer five hundred bushel of corn & other for distribution among the needy citizens of the Town, a cost & charged.

The following resolution was unanimously adopted viz'

Resolved that the Commissioner General be respectfully requested to abstain from impressing articles of food meat &c in the Town of Fredericksburg, where in fact there is but very little food of any sort, and the population are actually in danger of starvation, and where we believe that the supply of meal at present instead of being sufficient to permit us to have ½ a supply for the people for six months would not in fact furnish a ½ supply for the people for 1 month. And we respectfully suggest that the meat recently impressed by Capt Roy, in the store of Messrs Heinichen & Berrey & Co which was perhaps the only meat in any quantity for sale in the Town be released from said impressment.

The Mayor stated that the Council had been called for the purpose of taking steps for the relief of our citizens who have been arrested as hostages by the enemy, and who are now confined at Fort Delaware and therefrom the following statement of fact &c in the shape of a communication to the Hon Sec'y of War of the Confederate States was presented by Mr Wm A Little and unanimously adopted, viz Fredericksburg Va May 31, 1864

To the Hon James A Seddon

Sec'y of War of the Conf'd States

Richmond Va

At a meeting of the Mayor & Common Council of Fredericksburg Va held this 31 of May 1864 a Committee of the citizens, to wit, Montgomery Slaughter and John F Scott were appointed to repair to Richmond and present to you the following statement and application.

Statement

On Sunday the 8th Inst a number of slightly wounded and straggling Federal soldiers who entered the town, many of them with arms in their hands and with the capacity and intention we feared of doing

mischief in the way of pillage and injuring our people who were unprotected by any military force, were arrested by order of our municipal authorities and forwarded to the nearest military post as prisoners of war under a guard of citizens. These prisoners amounted to about 60 men of whom but few are said to have been slightly wounded. In retaliation for this act the Provost Marshall under orders from the Secretary of War in Washington arrested on the 20th inst some sixty of our citizens and forwarded them to Washington to be held as hostages for said prisoners. Ten of the Citizens were afterwards released in Washington and have returned to their homes, leaving some 51 citizens still in confinement who have been sent to the military prison at Fort Delaware.

In behalf of these unfortunate people who are thus made to suffer so seriously and for their suffering families who are thus left without their natural protectors and many of them without [Page 378] their means of support, we appeal to you to take such steps as may be proper & in accordance with military regulations to return the said prisoners to the Federal authorities, and thus secure the release of our citizens. Surely the matter of a few prisoners cannot be allowed to interfere with the human or generous work of restoring to these desolated homes and those mourning women and children the only source of comfort which the fate of war has left them in this war ravaged and desolated town, the presence of those loved ones who are separated from them and imprisoned at Fort Delaware.

Resolved that the Council tender their thanks to Messrs Slaughter and Scott for the faithful discharge of their duty in the premises from the time of their entering thereon to the present period was passed by the following vote; Ayes, W H Cunningham, H B Hall, J J Young, Jas McGuire, B T Gill, Jas H Bradley -6 No, W A Little, who stated that he approved fully of the action of the Committee up to the time of their return to Fredericksburg be that he disapproved of their subsequent action as unauthorized and as establishing a bad precedent.

The Mayor stated that the Council had been called in order to receive and consider the report of Mr G H C Rowe of his mission to Washington to effect the release of your Citizens, now in confinement as hostages at Fort Delaware, and thereupon Mr Rowe made a report in writing as follows: viz Fredericksburg, June 20th 1864

Hon M Slaughter, Mayor &c

Sir: In discharge of the Commission confided [Page 381] to me by the Municipal authorities to represent to the Federal authorities, the terms upon which the exchange of certain citizens of Fredericksburg was proposed to be procured by consent of the Confederate Government. I have to report that I proceeded to the officer of Col H H Wells, Provost Marshall General of the defenses south of the Potomac at Alexandria as the nearest military post of the United States with which I had opportunity of communicating. It was received and treated by that officer with all the consideration and delicacy consistent with the circumstances of my approach and finally furnish with a passport to return and signify to the Confederate Government the assurance that the authorities at Washington would unconditionally release the citizens captured at Fredericksburg when the soldiers taken prisoners by the Municipal officers were surrendered. They gave me authority to bring the prisoners referred to with their lines with the assurance of certainty that I should simultaneously receive the captured citizens. I therefor propose that the soldiers in question be delivered to you on parole to be nullified & fulfilled only when the citizens shall be forthcoming. This proposition it seems to me, obviates all difficulty of misconstruction and I will thence take the delivery and receipt of the prisoners at Alexandria. It is proper to state that in 1862 I undertook and executed a similar commission of exchange of citizens captured with success and thorough satisfaction to our Government, and I am sure with its assent and cooperation as proposed, I will now reap a similar result.

Resolved that M Slaughter, Mayor and G H C Rowe, Esq be and they are hereby appointed Commissioners on the part of the Corporation of Fredericksburg to proceed to Richmond and to urge upon the Confederate States authorities to agree to the return of the prisoners arrested in Fredericksburg, either by parolling them subject to exchange for our citizens, prisoners now in the custody of the United States authorities, or in any other way which may be agreed upon to effect the object and the whole subject is hereby referred to said Commissioners, with full authority to do every thing in the premises which in their judgment they may deem necessary and proper to secure the release and return of our citizens to their homes.

Sir: I have the honor to report that I reached the Military Lines of the United States in safely with the fifty-six Federal prisoners of War and four Civil officers of the so-called State of West Virginia, committed to my change by the Corporation authorities to be exchanged for the captive citizens of Fredericksburg after some difficulty in obtaining personal access to the authorities at Washington and several days discussion there, I succeeded in closing a negotiation that the Federal prisoners delivered by

me should be released from their paroles simultaneously with the delivery of fifty then captive Citizens of Fredericksburg and seven Confederate prisoners of war on board a flag of truce steamer with transportation to Split rock on the Potomac River. In the execution of this obligation the Federal [Page 384] authorities delivered to me, on board the Steamer Weycanoke whence they were landed at Split Rock on yesterday forty nine citizens & two prisoners of war according to the roll which accompanies this report. Marked A. The four citizens and five prisoners of war still due, I have solid assurance will be forwarded by the same route at an early day. In discharge of expenses I have paid the sum of \$366.83 in Federal money & \$70 in Confederate Money,

And thereupon on motion of L B Rose, it is resolved that a committee to consist of three be appointed by the Mayor to draw up a memorial as aforesaid and report the same to the Council at its next meeting for its consideration.

The Mayor appointed Messrs L B Rose, J H Bradley, W A Little the Committee under the foregoing resolution.

Dr J G Wallace, Physician apptd to attend small pox cases made a report which was read and ordered to be filed. Information therein expressed received.

Ordered that the account of Dr J G Wallace amt'g to \$564.00 which is allowed by the Council is paid by the Chamberlain.

Whereas as the Council in their former resolution may have done injustice to Mr Smith, the salt agent & upon further understanding & a full verbal report from the said agent, in regard to his action & the instructions under the law giving him considerable discretion in distributing the salt in certain contingencies, therefore Resolved that the Council are now satisfied that the said salt agent had not disposition to violate the law or the instructions [Page 388] of the Council which may have been

misunderstood by him and they are willing and do hereby withdrawn any censure of said agent which may be implied in said former resolution.
