2<sup>nd</sup> That the said Trustees be requested to comply with the wishes of the Council as expressed in the foregoing resolution.

3<sup>rd</sup> That the Finance Comm'e of the Corporation be instructed to carry out the foregoing resolutions

On motion Mr Wm H Cunningham was appointed a member of the Finance Committee during the absence of Mr Jas A Bradley.

On motion, Ordered the Property Comm'e & they are hereby authorized to permit Mrs Martha Stephens to occupy [Page 394] and cultivate the Fair Grounds during the pleasure of the Council.

On motion of Mr Wm A Little, Resolved that our Townsman W S Gillman Esq be and he is hereby requested by the Council to give us the benefit of his influence & cooperation with T B Barton Esq who was appointed heretofore to press before the members of Congress the application of this Corporation now pending there for relief Confederate States taxation.

The Mayor stated the Council had been called for the purpose of giving some expression of the high estimate in which our fellow Citizen Gen'l Daniel Ruggles is held in this Community.

Upon motion it was unanimously Resolved,

That this Council has recently with great pleasure greeted the return upon a short Furlough of Brig Gen'l L Ruggles to his home in our midst. That they have observed with pride & pleasure his steady devotion to the Confederate cause and his distinguished and arduous services in our army for the past four years and have seen with regret that Promotion in his case has not followed and unawarded his devotion to the

cause. Born in the Enemy's country but marrying a daughter of Virginia, and making his home among us, at the first call of the Southern War Trumpet he resigned his commission as Command in the Enemy's Army and all the fair prospects of rank and promotion sacrificing property & family ties and tendered his sword to his adopted State, and among the first if not the very first officer of the old who did so, with unswerving devotion has directed his best efforts to the success of the Southern Cause, after four years of arduous & valuable service he returns to us with the Rank of Brigadier General, the Council and the whole community feel mortified to think that an adopted son of old Fredericksburg should thus labor unrewarded and that his distinguished services should be thus overlooked & unappreciated and they respectfully present his case to the consideration [Page 395] of the Confederate Authorities in the confident trust that they will repair this injustice & permit this war torn & loyal Town to repair in the reflection that the devoted loyalty & prompt and valuable service of Daniel Ruggles are appreciated and honored by his adopted Country.

Resolved, that a copy of these Resolutions be respectfully forward to the President, Sec'y of War & to Gen'l R E Lee, Commander of our Armies & to Gen'l Ruggles

On motion of Mr Wm A Little, It was resolved that George F Chew be and he is hereby recommended by the Common Council of Fred'g to the Commissioners appointed under the Act of February 1864, to distribute the fund coming to this Corpo for the relief of the indigent families of soldiers & sailors in the Confederate Service from Fred'g. It is believed that Fred'g has furnished some 500 soldiers & sailors to the Country and there are now 82 families many of them large & helpless dependent upon this fund for bread &c

The following Resolution was unanimously adopted.

Resolved that Mess'rs G H C Rowe & John F Scott be and they are hereby appointed by the Council to wait on the Military Authorities of Fred'g and to respectfully request that the impressment of corn or other provisions in a community so destitute of supplies as ours, be suspended, and that they earnestly protest against the reported impressment this morning and against any further action in that direction looking toward such impressment the Council being satisfied that the supplies in the Town are entirely insufficient for the supply of our people and the poor depending upon them for bread.

The following proceedings were heard viz

Whereas it has come to the knowledge of this Council that a large lot of tobacco said to be 4000 boxes part of which has already arrived is about to be transported to and Stored within the limits of this Corporation under the control and by direction of certain officials of the Confederate government, the manifest effect of which is to attract a raid of the Enemy upon us, inviting more injury and destruction to us impoverished Citizens, and their unfortunate town for it will be impossible to conceal the fact from the enemy of this arrangement is completed. This Council therefore being of opinion that a proper regard for their own interests & those of the Confederacy require that they should communicate this information to the Secretary of War that the Government may be fully advised of this proceeding respectfully do so hereby.

And they further respectfully suggest that if this be a bona-fide government transaction its results may be disastrous to this Community in its present unprotected and exposed condition and while we are prepared to do all thing & to suffer all things which a proper regard for the public interest may demand of us as loyal and law abiding community we are unwilling to subject ourselves to unnecessary and useless exposure without adequate results in benefit to this Order; and we further respectfully suggest that a large brick fire proof house owned by William Pratt, Esq with a mile of Hamilton's Crossing on the river would be a better point to store and ship said Tobacco if it must take this direction, and its storage there would save costly transportation to this Government and perhaps avoid the dangers to us which its deposit here so manifestly threatens.

On motion Resolved, that the Mayor be requested to communicate the foregoing proceeding as soon as possible in such manner as he may think best.

Fredericksburg, Va Aug 1<sup>st</sup> 1865. Mayor Slaughter.

The sanitary conditions of the town will of course claim the first and earnest attention of your council. I am desirous of co-operating so far as I am able in this matter, and desire the co-operation of the City authorities in return. It will be indispensable to have labor which cannot be procured without money. I would therefore suggest that your take into consideration the propriety of levying a small per capita tax and also property tax for this purpose.

Be it further ordained that the said Commissioner of the Revenue shall assess all persons required to obtain licenses and make a fair alphabetical list thereof as far as he may have progressed with the same at intervals not exceeding fifteen days and deliver such list to the Collector for his guide in collecting the taxes imposed by this ordinance on such licenses.

- 31. Be it further ordained that all persons who shall call on the collector and pay him the taxes due by them under this ordinance (except for license tax) by the 15 day of December next, shall be entitled to a deduction of five per centum and those paying the by 15 day of January next to a deduction of two per centum on the amount of their respective accounts.

II. Resolved, that the forbearing and conciliatory course of President Johnston and his wise and magnanimous statesmanship claim our admiration, confidence & grateful appreciation and that we recognize in his co-labor in the work of the restoration of the South, Hon F D Pierpont, Governor of Virginia an officer equal to the arduous task before him and whose administration calls for this recognition of its ability and success.

III. Resolved that we take this occasion to testify our appreciation of the able impartial and courteous character of the Military administration of Mayor Gen'l S S Carroll, Commanding this District, that we recognize his successful efforts to administer justice & promote harmony among all classes, and in our opinion the interests of the Government will be served by his continuing in command at this place.

Charles Herndon from the Committee appointed on yesterday to consider & report upon the communication of the Street Committee presented on yesterday made a report which was read and adopted and is as follows, viz.

Whereas the Corporation of Fredericksburg in the original grant to the Richmond, Fredericksburg & Potomac Rail Road Company expressly stipulated that in laying the rails across the streets the said company shall not allowed to form any inconvenient obstruction to the passage of carriages along the street across the said railroad, nor to obstruct the passage of the water through the gutters of the said streets. And whereas said company lately rebuilt its bridge over the Rappahannock river at this place and in such rebuilding at line without the consent of the Corporation authorities elevated said bridge and by consequence it tracks through [Page 419] the Town, thereby in the opinion of the Street Committee and other citizens forming inconvenient obstructions to the passage of carriages across said streets and whereas the culverts and the means of drainage on or near Princess Ann street are in the opinion of the same committee in such condition as not effectually to drain the water from the street and lots adjacent thereto.

And whereas Col Carter M Braxton, the Engineer agent of the said Company states in person before the Council that he is instructed by said Company so to grade the streets as well in his opinion do away with any and all obstruction so complained of or likely to be complained of and that he is instructed also so to open and clear out the culverts and other means of drainage at the points complained of as effectually to drain the streets & lots adjacent thereto. Now this Council not desiring to act in any capricious spirit but only to preserve intact the rights of the town are willing at the instance of the said Engineer officer to await the result of said grading and cleansing which in the opinion of said Engineer will remedy the said grievances or cause their delay or actual prejudice to the streets of the Town in the premises and said Company will have to remunerate any and all individuals who may be injured or damaged by the work already done or that which is to be done. Should said grading when completed satisfy the Street Committee that said track as it then stands forms no inconvenient obstruction to the passage of carriages across said street, and should said cleaning effectually drain the streets and lots now complained of, then this Council will be will be satisfied that no damage will result to the town from the present elevation of said track.

But should the said grading and cleaning not effectually remedy the grievances complained of, then this Council will proceed at once against said Company to enforce the legal rights of the Town in the premises.
