Geo W Shepherd elected a member of the Council appeared and qualified and took his seat.

An a/c of A Walker for pulling down the walls of the Freemont Hotel building amounting to \$19.50 is allowed & ordered to be paid.

The Mayor submitted a report in writing of his interview with Mr A K Phillips in relation to the interests of the Corporation [Page 429] under the will of the late, Mrs Margaret Phillips which was read and ordered to be filed.

Present: J G Hurkamp

The Mayor submitted a communication in writing to the Council touch various subject of interest to the Corporation.

On motion made & seconded, ordered that the Mayor be instructed to employ four competent men as night police men upon the best terms he can & report to the Council.

On motion & seconded, ordered that the Pump Committee proceed without delay to have all the Public pumps of value in the Corporation put in complete order

On the recommendation of the Mayor, It was resolved that a Board of Health to consist of three physicians be appointed for this Corporation whereupon on motion the Council proceeded to ballot for the members of the board, when Dr Geo T Carmichael, Dr J G Wallace & Dr W S Scott were duly elected a Board of Health for this Corporation, who were respectfully requested to make suggestions & recommendation from time to time to the Council as they may deem it expedient and proper in relation to the sanitary condition of the Town.

On motion, made & seconded & in pursuance of the Mayors recommendation, ordered that the overseers of the poor be directed to contract with some person for the delivery of thirty cords of wood to be distributed by them in their discretion among the poor of the town.

On motion, ordered that the discount of five per cent to tax payers be allowed to all who pay their taxes within twenty days after notice that the Commissioner books are in the hands of the Collector and that the discount of two percent be allowed to all who pay their taxes within forty days after said notice, and that the collector be directed to publish said notice as soon as the Commissioners Books are placed in his hands by the Commissioner of the Revenue.

On motion made, Ordered that the Mayor be instructed to confer with the Surveyor of the Corporation and ascertain what it would cost to make a new map or plot of the Town on Parchment and report to the Council.

On motion made & seconded, Ordered that the Public Property Committee be instructed to have the jail of this Corporation repaired & put in safe & comfortable condition for the reception of prisoners. Present: Thomas F Knox, John G Hurkamp

Mr Knox moved that the compensation of the night police now be fixed at the sum of \$50 per month for one to act as chief of police, and \$40 per month for the remaining three, which motion Mr Scott moved to lay on the table which was carried.

Mr Scott moved to reconsider the action of the last meeting directing the Mayor to employ five night policemen which motion was carried, six members voting in the affirmative.

On motion made & seconded, Ordered that the Public Property Committee be instructed to wait again upon the Commandant of this post and request the removal of troops now quartered in the [Page 431] the Town Hall Building.

A Communication from Mrs Juliant Perry to the Mayor was read & on motion, ordered to be laid on the table.

On motion made & seconded ordered that the compensation of the Commissioner of Streets be fixed at one dollar per day whilst he is actually employed in the discharge of his duties

The Council proceeded to elect by ballot a Commissioner of Streets for the Corporation, when Geo Aler was duly elected

Doctors Carmichael & Wallace declined to act as members of the Board of Health, whereupon the Council proceeded to fill the vacancies, Doctor Jones & Rose were duly elected members of the Board of Health of this Town to supply the vacancies aforesaid.

On motion, ordered that the Young Men Literary Society be allowed to use the Court House hall on the evening of their meetings.

On motion made & seconded, Resolved that the products of the present tax bill does not admit of the practicability of receiving the past due coupons of the bonds of this Corporation in payment of taxes for the current year.

On motion, Resolved that the Board of Health be requested to consider promptly all matters relating to the sanitary conditions of the Town, especially the condition of the marsh and [Page 432] canal on the wets of the Town, and report to the Council.

Resolved, That the Fred'g Agricultural Society be authorized to resume possession of the Mercer Square upon the terms and condition of the former occupation before the war, the design of said society be review its annual meeting and to endeavor to revive the society and thus promote the interests & prosperity of this section of the State.

Resolved, that the Telegraph Company be directed to place their post not at Mr Carter's door but at Wellford's corner.

On motion, Ordered that James B Sener, John J Young & B T Gill have permission to plant trees in front of their residences provided they are not alanthus trees, the Street Committee to superintend & point out the location of the trees

On motion the Council adjourned M Slaughter, Mayor

Mr Young moved that the order made at the last meeting requiring the American Telegraph Co to place their post at Wellford's Corner instead of in front of Mr Carter's house be reconsidered, Mr Scott moved to amend the resolution by appointing a special committee to consider the whole subject and act definitely therein, the amendment was lost & thereupon the question occurring on the original resolution the same was carried.

Mess'rs Sener, Hurkamp & Gravatt, members of the Street Committee was excused from voting on the resolution & amendment.

On motion, Resolved that Street Committee, be requested to cause the post of the American Telegraph Company to be placed at Wellford's Corner, if practicable, to do so, if not the post remain where it is at present in front of Mr E Carter's house. Mess'rs Sener, Hurkamp and Gravatt were excused from voting on this resolution.

Mr James B Sener, by note in writing, resigned his position as Commissioner of the Freedman's Court, which resignation was accepted.

On a/c of R W Hart, amounting to \$11.64, W Sener has permission of leading [Page 434] a branch pipe from the main on the corner of Caroline & George Street & leading into the well on the East corner of said street for the purpose of cleaning out the water pipes when it may be deemed advisable to do so.

Resolved, that the Clerk of the Council be instructed to prepare an ordinance repealing all the Corporation laws on the Statue Book of the Corporation, relating to slaves.

Resolved, that it is not in the power of the Council to pay the interest on our Corporation debt this year, that the Clerk be instructed under the supervision of the Finance Committee to prepare an ordinance providing for the funding of all the interest now due and accruing during the present year upon the bonds of this Corporation.

It appearing by the survey made by Carter M Braxton, Civil Engineer, that in order to drain the Marsh through Kenmore & Sandy Bottom, a sufficient fall cannot be obtained with lowering the culverts constructed by the Rail Road Company near the Depot. It is ordered that the Mayor inform the Richmond, Fred'g & Potomac Rail Road Company that the Council desires that the said Company shall make the needful alteration of said culvert as speedily as practicable in order that the same may be completed while [Page 435] the work of draining said Marsh is progressing and the Council declining the removal of such an obstruction as called for by the terms of the original agreement made by said Company in obtaining the right of way through the Town, ask for a prompt cooperation by said Company in this matter, which is deemed important to the health of the Town.

On motion, ordered that John B Alexander, H B Hoomes, L J Huffman & Chs S Scott be severally summoned to appear forthwith before this Council to give evidence.

On motion made & seconded, ordered that a committee to consist of four members be appointed to take into consideration all matters connected with the draining of the Marsh on the West of the Town, and to confer with John L Marye Esq'r and all person interested therein, and to report their action to the adjourned meeting of the Council on Tuesday evening next.

On motion, Resolved that the sum of \$500.00 be appropriated to the purchase of Fire Apparatus for this Corporation, and that the agents of the Insurance Companies & private citizens of the town be requested to aid as far as possible by their contributions in effecting this very desirable work said [Page 436] appropriation not to be used until enough money has been raised to purchase on Engine, of eight inch cylinder & seven hundred feet of hose for said purpose & that the Commander of the Fire Company be requested to solicit subscriptions to carry out the above object

2nd That said committee be instructed to contract as soon as possible under the supervision of a competent Engineer with some responsible party to said work speedily and thoroughly.

3rd That John E Tackett on the part of the Water Power Company, John L Marye on the part of the Kenmore Company & M Slaughter, Mayor & C W Scott President of the board of Health, constituted said Committee.

Which on motion made & seconded was ordered to be laid on the Table.

The Special Committee in relation to draining the Kenmore Marsh made a report, Whereupon on motion made & seconded the further sum of \$150 is appropriated for the purpose of effecting the object of the Committee.

It is hereby certified by the Council, that the Council has not furnished a Mayor's office during the past year & the Mayor therefore has been compelled to use his private counting room for that purpose for which he has charged no rent, also that no clerk of the Market been appointed, the ordinances relating to the Market if not enforced has not been owing to any want diligence of the Mayor in that regard.

On motion of Mr Cunningham permission is granted him to plant trees in front of his house on Caroline Street under the supervision of the Street Committee.

Resolved that Mr Jno G Hurkamp be permitted to enclose the unopen street through Alsop's lots near the basin, said inclosure to be removed whenever ordered by the Council.

On motion, ordered that the trees planted by Mr Bradley in front of the Baptist Church remain where they are now planted.

On Motion, ordered that the report of the Street Committee laid upon the table at an former meeting, be taken up and that the same be returned to the Committee.

It is my sad duty to announce to you the death of Geo F Chew Esq'r the accomplished and efficient clerk of the Council and Chamberlain of the Corporation. In communicating this melancholy event I cannot refrain from saying a few words in token of my appreciation of his character as a faithful officer and valued citizen. For many years our official duties brought into daily intercourse, it was therefore my fortune to know him intimately, Possessed of rare abilities, remarkable accuracy, and familiarity with all matters pertaining to the history and interests of the Corporation, he was ever at his part prompt to discharge the obligations of his office and to meet the constant demands upon him fro gratuitous labour & information. His intelligence, skill and fidelity as an officer commanded the confidence and admiration of his associates. This kind of disposition, Courteous bearing and accommodating spirit secured the esteem and regard of all who knew him. Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that any person to whom interest upon the bonds of the Corporation may be due at the present time and up to the first day of January 1867, when the amount of interest so due to any such person, shall not be less than fifty dollars, shall be entitled to receive in discharge of such interest in whole or in part, a bond or bonds of the said Corporation of the date of said first of January 1867, bearing six percent interest per annum payable semi-annually in sums of fifty dollars, or any multiple thereof, the said bonds to be made payable not less than ten years nor more than thirty years after date, as the person receiving them may elect.

On motion, ordered that the profits and fees provided for in Chapter XXXIX of the Bye laws of this Corporation be and they are hereby tendered to any citizen who will erect and keep up a public magazine for the keeping of gun powder—such building to be located and created under the supervision of the Public Property Committee

And then the Council adjourned [Page 461]

At a called meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber on Thursday the 20th day of December 1866.

Dorsey Cole appointed at the last meeting of the Council as substitute for James L Cole absent by leave of the Council having resigned the position. On motion the Council proceeded to elect a substitute for E Dorsey Cole until the return of James L Cole.

George H Timberlake, Edwd S Haynie and C W Edrington were put in nomination and a ballot being taken, George H Timberlake was elected as a night policeman to serve during the temporary absence of Jas L Cole.

The Mayor having reported in writing that the Police officers have discharged their duties during the quarter ending to day, it is ordered that the Chamberlain pay them their salaries for that time.

On motion, Resolved that the minimum amount of the bonds in which the interest of the Corporation debt to 1st January 1867 is to be funded be fixed at the sum of thirty dollars instead of fifty dollars and that the Chamberlain be authorized to issue certificates of debt for the surplus of interest above thirty dollars or some multiple of thirty dollars in each case bearing interest at 6 per cent payable annually and said certificates to be paid ten years after date, and that the ordinance passed on the 27th day of November 1866 be amended in conformity with this resolution.

On motion made and seconded, ordered that a Committee of three be appointed by the Mayor to ascertain what would be the cost of furnishing lamp posts for lighting the streets, setting them up and what would be the cost of Gas annually.

The Mayor appointed as the committee Mess'rs Sener, Bradley and Ford.

And then the Council adjourned.
