Fredericksburg City Council Minutes 1868

At a regular meeting of the Common Council of the Town of Fred'bg held at the Council Chamber on Tuesday 28th Jan'y 1868 at 7 PM

Present M Slaughter, Mayor

J J Hurkamp, Jos W Sener, Wm A Little, E M Braxton, G W Wroten, Jas H Bradley, A P Rowe Wm H Cunningham, Jno McGuire, Jno J Young

On motion made & seconded, St Geo R Fitzhugh Esq presented to the Council a proposition from Mr J B Ficklen offering the sum of five thousand dollars in the Bonds of the Corporation for the fee simple title to the house & lot on Main Street now held by him on a lease for lives.

On motion of Mr E M Braxton, as attorney for the parties ordered that the Collector of Taxes be instructed to settle their ground rents now due and to become due by D Green's estate, by receiving the past due Coupons of the Corporation in payment thereof.

Mr Wm A Little moved the following resolution,

Resolved that the Pub Prop Committee be instructed to advertise for 20 days for proposals to purchase in the Corporation Bonds the lots on Market Square in which the Corporation now holds the reversion & the 10 acres known as the Mercer Square & failing to make said sale privately, they be, and they are hereby instructed at the expiration of said time to sell the same at Public Auction; subject to the confirmation of the Council;

Which Mr Bradley moved to amend by inserting the words "for Cash or" after the word purchase; and the amendment being seconded the question was taken & the amendment was lost, the question then recurred on the original resolution of Mr Little and it was adopted.

The Mayor then presented a communication from Robt Walker [Page 490] and J T Smith preferring a complaint against Martin Cahill & Chas W Edrington two of the night police and on motion Mr Walker & Mr Smith were heard by the Council, Mr Mazeen was also heard & likewise Mr Cahil & Mr Edrington; Mr J B Sener appeared as counsel for Mess'rs Walker & Smith & was heard by the Council.

Mr J H Bradley moved that the action of the night policemen, Cahil & Edrington, in the matter complained of by Mess'rs Walker & Smith be sustained by the Council which upon being seconded, the motion was adopted.

A bill of Johnston & Co against the Corporation amounting to \$2.43 was passed and ordered to be paid.

Mr J W Sener called up the report submitted to the Council in Jan'y 1867 by a committee appointed to ascertain the cost of lighting the Streets of the town with gas & asked that the report might be read again, which was accordingly done.

A bill of the *Fredericksburg Ledger* for printing the delinquent list amounting to \$72.50 was read and Mr Braxton moved that it be paid. Mr Huffman, Mr Little & Mr Sener were heard on the matter when the Council after a division, the Mayor giving the casting vote, refused the bill.

Mr McGuire moved that the bill be referred to the Finance Committee for report which motion was lost.

On motion of Mr A P Rowe ordered that the sum of \$64.80 be paid the Editor of the *Fredericksburg Ledger* in full for printing the delinquent list.

On motion of Mr A M Braxton, ordered that the Street Commission be directed to fill up the well at the corner of A K Phillips lot on Main Street.

On motion of Wm H Cunningham,

Resolved that a Committee of three be appointed to confer with the Gas Company & with the Citizens of the town & ascertain if an arrangement can be made by which the town can be properly lighted & the Corporation relieved of the expense of lamp posts & other fixtures & report to a meeting of the Council to be held by next Tuesday evening.

Committee, Wm H Cunningham, Jas H Bradley & Jos W Sener. And the Council adjourned till Tuesday next, the 4th day of Feb'y at 7 PM [Page 491]

At a adjourned meeting of the Common Council of the town of Fredericksburg held at the Council Chamber on Tuesday evening the 4th day of February 1868

The Mayor stated that this was an adjourned meeting of the Council to receive the report of the Committee appointed to confer with the citizens & with the Gas Company as to lighting the streets of the Town.

Mr Wm H Cunningham, (Chairman of the Gas Co) presented a report in writing accompanied by a plan for the position of the lamps, in words and figures following, to wit viz,

The Committee appointed to confer with the Gas Company, and with the Citizens of the Town, upon the subject of lighting the streets with gas, beg leave to report, that having conferred with the President of the Gas Co, they were led to believe that immediately on the use of the Gas by the Corporation to the extent of the consumption twenty five or more lamps, the price of gas would be reduced to all consumers from its price of six to four dollars pr thousand feet, and the President stated that he would immediately call a meeting of the Gas Co to authorize this arrangement which has been accomplished, as will appear by difference to accompanying report of proceedings of the Gas Company at their meeting on the 30th ultimo. This arrangement having been stated to the Citizens, generally property holders & business men of the Town, we found universally disposed to contribute to the purchase of lamps & other fixtures necessary to the town, being properly lighted, and in some cases it was stated that if the amount contributed was not sufficient, and additional amount would be given it being considered that the success of the movement was highly important to the interests of the Town, leaving entirely out of view personal comfort & convenience. The amount already subscribed is eleven hundred & fifteen dollars (\$1,115) & subscriptions for the Steamboat Companys & other parties are confidently expected, accompanying is a plan prepared by the Committee for the arranging the lamp posts proposed to be used, which has been prepared with care & which they recommend for your adoption, this plan involves the use of 32 lamps and post, three of which are already furnished, one by the Episcopal, one by the Methodist church & one by the Exchange Hotel.

The Gas Co, by which a large reduction in the price of Gas is made to all consumers was urged not only on the ground of a large consumption by the Corporation which will scarcely equal the amount of reduction but also on the ground of a increase of consumption at the reduced price on the part of the Citizens of the Town, & it is hoped by your Committee, who are not in any manner identified with the Gas Co, that the Citizens generally will now use the gas and thus insure the continuance of an arrangement which we think will prove beneficial to all parties Respectfully submitted,

Which on motion of Mr Jno J Young were adopted.

Mr Wm H Cunningham moved that the vote adopting the report of the Gas Committee be reconsidered which being seconded, the vote was taken & resulted in the affirmative, so the vote was reconsidered.

On motion Mr Wm H Cunningham again read the report of the Gas Committee, when Mr A P Rowe offered the following as a substitute therefore, viz.

Whereas it appears to the Common Council of the Town of Freds'burg that a portion of the Citizens are very desirous that the streets of said town shall be lighted with gas, and whereas in the present condition of the Corporation Treasury, the inability of the said Corporation to meet its interest obligations and the poverty of a portion of the people (being such as to require a large portion of real estate to be offered for sale for the taxes due thereon) entirely preclude the Council from inflicting any further tax on the people at this time for lighting said Streets with gas; Therefore be it ordained by the Mayor & Common Council, that it shall be lawful for any person or persons to erect lamp posts, for either gas or oil, on the streets of this Corporation, under the Supervision of the Street Committee, providing that said posts shall not obstruct the streets & footways & provided also that the parties erecting the said posts, shall pay all the expense of said posts and for all gas or oil consumed by said lamps [Page 493] which being seconded, before the vote was taken Mr Sener presented a report sharing the expense of lighting the streets with gas per lamp, whether the question being taken on the substitute offered by Mr Rowe, the Ayes & Noes were called for and resulted as follows

So the substitute was lost

Mr McGuire then moved that the matter of lighting the streets with gas be referred to the people for a vote to be taken thereon, which being seconded the Ayes & Noes were called for and resulted as follows:

Ayes Mess'rs Rowe & McGuire 2

So the motion was lost

On motion of Mr Wm A Little the report of the Committee on gas with the plan accompanying was received and adopted.

The following resolutions offered by Mr Wm A Little were adopted,

1st Resolved; that Wm H Cunningham, Jas H Bradley, & Jos W Sener, be and they are hereby appointed a permanent Commit'ee upon Gas and that they be & they are hereby instructed to collect the subscriptions & contract for the work of purchasing and putting up the lamp posts and other fixtures and carrying out the plan submitted in the report.

2nd Resolved; that said Committee be instructed to have said work done as far as possible by our own mechanics in Fredericksburg.

At a Regular Meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber on Tuesday the 25th day of Feb'y 1868

The Mayor presented a communication from Mr W J Jefferies in regard to the booth at the corner of Commerce & Main Streets when Mr Bradley moved that Mr Jefferies be allowed to occupy the said booth at the pleasure of the Council which motion was lost.

Mr A P Rowe moved to reconsider the vote, by which the application of Mr Jefferies was rejected which was carried [Page 494]

On motion of Mr J G Hurkamp, ordered that Mr Jefferies be allowed to occupy the booth at the corner of Commerce & Main Streets, during the pleasure of the Council, provided that he obtains the consent in writing of a majority of the property holders and tenants in that square and files the same with the Clerk of the Council.

And then the Council adjourned

At a called meeting of the Common Council of the Town of Fred'sburg held at the Council Chamber on Friday evening March 6^{th} 1868.

The Mayor stated that this was a called meeting of the Council to receive a report from the Public Property Committee, but as the Chairman of that Committee was not present, the Council proceed to other business.

Mr J B Sener, by consent of the Council called the attention of the Council to the fact that Dr Sears, the Chairman of the Peabody Educational Committee was now distributing the funds appropriated by Mr Peabody for the cause of Education in the South, Whereupon on motion of Mr Bradley, Resolved that the Mayor & Chamberlain be appointed a committee on the part of the Council to correspond with Dr Sears and obtain from him the facts in regard to the distribution of the Peabody fund,

Present Jno McGuire & Ab P Rowe

Mr Jos W Sener, by note in writing, tendered his resignation as a member of the Gas Committee, which on motion was laid on the table.

Mr Jos W Sener was excused from further attendance at this Council

Absent: J W Sener

Mr McGuire, Chairman Pub Prop Commt'ee submitted a report in writing in the words and figures following to wit,

The P P Committee, who were charged by resolution of your honorable body of the [blank] day of January with the sale of certain property therein [Page 495] mentioned, beg leave to respectfully to report, that as the sale was to be made subject to the confirmation of the Council, they determined to let it go to highest bidder without any other reservation & the following is the result, viz

The house occupied by Jas L Green was knocked down to Ab P Rowe payable in Corporation Bonds at \$4,000

That occupied by S Hirsh to J B Ficklen \$7,000 Mercer Square to Dr Wm S Scott \$6,100

The latter property had been divided into ¼ acre lots (see accompanying map) and was put up as an entirety, reserving the right to annul and sell in lots, but the limited number of bidders present determined your Committee to report as above.

Which report on motion was received.

On motion of Mr Bradley resolved that the sales reported by the Pub Prop Committee be not confirmed.

Mr Bradley moved that the Pub Prop Committee be authorized to sell the house on Main Street occupied by J Hirsh for \$8,500, the house occupied by J L Green for \$6,500 and the Mercer Square for \$9,000 payable in Corporation Bonds the refusal to be given to the highest bidder at the sale reported to day, the said Committee to report to the next meeting of the Council, which was adopted. And then the Council adjourned

At a meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber on Tuesday the 24th day of March 1868

The Mayor stated that this was a regular meeting of the Council & there being not reports from Committees, the Council proceeded to other business.

The Mayor presented a communication from Mr Jas Mazeen asking permission to erect a privy in the Market House Yard, which on motion was laid on the table.

The Mayor presented an application from Mess'rs Wait & Sener asking the privilege of digging a well in rear of their store on Commerce Street for the purpose of making a sink, which on motion of Mr Wm H Cunningham was referred to the Pub Property Committee.

The Mayor presented from G A Rawlett asking the Council to refund to him the amount paid by him for redemption for a hog caught running at large and sold under the ordinances of the Corporation, amounting to six 50/100 dollars, which on motion of Mr Braxton was granted and the Chamberlain was ordered to pay the said amount of \$6.50 to Mr Rawlett.

On motion of Mr Wroten, ordered that the Chamberlain refund to Mr P B Dunn one 75/100 dolls, the amt for which a hog belonging to him & caught running at large, was sold under an ordinance of the Corporation.

Mr E M Braxton presented a communication from Duff Green Adm'r of D Green dec'd in regard to the ground rent paid by him since the war in greenback amount'g to \$135.00 & on motion Mr L J Huffman was heard, when on motion of Mr J W Sener the communication was referred to the Finance Committee

A bill of Geo Aler's for defending a suit against Wallace amt'g to \$25.00 & also certain fee bills of the Clerk am'tg to \$6.49 were referred to Finance Committee.

Mr Geo W Wroten presented a communication from Mr Jas L Green asking to be relieved from a fine imposed upon him this day amounting to twenty dollars for hauling lumber in the Town of Fredericksburg without a license & on motion Mr J L Huffman was permitted to make a statement, which on motion of Mr McGuire the communication was laid on the table.

On motion of Mr Bradley the tax on Drays, Carts & Wagons from the 1st April 1868 to 1st Apl 1869 was fixed as follows, viz, on Drays & Carts five dollars and on Wagons ten dollars.

On motion of Mr Jos W Sener, Ordered that the Police Officers notify all owners of property in the Corporation where pavements are out of order to repair the same within ten days from date of notice & in the event that they fail to repair the same, that the Corporation will have it done & the expense to be recovered by warrant.

On motion of Mr McGuire, ordered that the claim of the Corporation against Dr B R Wellford for repairs to the pavement in front of his house on Princess Ann Street and all similar claims against other persons be referred to the Finance Committee with instructions to make the same.

The Mayor stated that the Council had been convened at the instance of several members to take into consideration the finances of the Corporation incidentally and more directly the question of retaining the Night Watch in office.

On motion of Mr Little, Ordered that on and after the 1st day of April next the number of Night Watch shall be reduced to two

The Council then proceeded to ballot for the two Night Watchmen to be retained and resulted as follows viz

So Chas W Edrington & Martin Cahill are declared to be elected as Night Watch after the 1st day of April 1868 to serve during the pleasure of the Council.

Mr Little presented and read to the Council a statement in regard to the action of the Council in appointing the Night Watch, which was adopted by the Council and ordered to be spread on the minutes, and the Clerk of the Council is ordered to prepare a copy of the said statement and enclose the same to Mr Jno L Marye Jr at Richmond, with the request that he present the same to Gen'l Schofield.

The statement is as follows:

To Gen'l Schofield

Commanding Military District No1

The Common Council of Fredericksburg, Va, being informed that Lieut H Sears who is an agent of the Freedman's Bureau in this place, has reported or is about the report to your Head Quarters the action of this body in appointing a Night Watch as a violation of your Gen'l Orders No. [blank] which requires all officers hereafter qualifying to take the oath required by the Act of 1862 before entering on the duties of their officers, respectfully state that they have in no way violated said order as alleged, The robberies at night having increased to an alarming extent in the Town, the Council appointed five citizens to act as a Night Watch to patrol the Town at night and guard the property of the Citizens from their depredations, The Night Watch is [Page 498] is paid per night and is removable at the pleasure, they are in no sense police officers given no bond & security & have no right to arrest except the right which any other citizen has to arrest a party engaged in violating the law & carry him before some magistrate for examination & committal or discharge. Not regarding said Night Watch as officers required by said Gen'l Order to take the oath referred to, they were not required to do so & this action was understood to have been approved by Col Johnson who was then in charge of the Freedman's Bureau officers here.

Recently and on the night of the 24th inst one of the Night Watch being present on the occasion, was directed by the Mayor to arrest a Negro who was then very drunk and engaged in the actual violation of the laws in the presence of the Mayor.

This order could as well and as lawfully have been given to any private citizen who happened to be present, as to a member of the Night Watch, and as it can hardly be maintained that the two constructions of said Gen'l Order would require a magistrate, before deciding a citizen to aid in the arrest of a flagrant violation of the law in his very presence, to stop and wait until he administered the said oath to him, in order to qualify him to perform said duty, the action of the Mayor in ordering said arrest by a member of

the Night Watch cannot be considered as making the said Night Watch a Police Officer, nor as violating said Gen'l Order.

The Mayor & Council of Fredericksburg have endeavoured to the best of their ability to comply strictly with the laws of the land, and with all orders from therein authority which in the present state of the Country, it was manifestly their duty to obey, and the[y] respectfully challenge any investigation into their conduct in the past, which may be desired by any having authority over such matters.

Ordered that the tax on vehicles other than drays, carts, & wagons, be fixed at the same rate as last year.

The use of the picks, shovels &c, belonging to the Corporation in the hands of the Superintendent of the Streets was on motion given to the Committee on Gas to assist in putting up the lamp posts.

And then the Council adjourned.

The Mayor stated that the meeting had been called at the instance of two or three members to complete some unfinished business.

The following resolution offered by Mr Jos W Sener was unanimously adopted, viz Resolved, that the Council hereby conveys all its right & title to the schooner now sunk in the harbor to Capt John Williams, who is raising the Steam Boat wrecks, on the condition that said schooner be removed so as not to obstruct or impair navigation.

The following resolution offered by Mr J H Bradley was adopted,

Resolved that the lamp posts, the lamps & fixtures purchased by private subscription and put up in the Streets of the Town, by permission of the Council, for the use of the Corporation in lighting the Streets are now and shall remain the private property of the said private contributors, subject to the said use only of lighting said streets, and that the Chairman of the Gas Committee is requested to deposit with the Clerk of the Council a list of all the said private contributors.

The Finance Committee reported adversely to the application of Duff Green, Ex'r of Duff Green dec'd which was referred to the Finance Committee at the last meeting of the Council.

The Finance Committee having also reported adversely to the payment of a bill of Geo Aler referred to the Committee at the last meeting of the Council.

The Finance Committee having reported favorably ordered that the fee bills of J J Chew, Clerk, amounting to \$6.47 be paid by the Chamberlain.

A bill of Jas McGuire amounting to \$5.25 was ordered to be paid.

On motion of Mr Jas McGuire, Resolved that Mr Jas L Green, be allowed to pay a fine adjudged against him of twenty dollars for hauling in the Corporation with a license, in the past due coupons of the Corporation, in consideration of the circumstances of the case.

A bill of A P Rowe against the Corporation amounting to Twenty dollars was allowed by the Council and ordered to be paid.

And then the Council adjourned.

At a meeting of the Common Council of the Town of Fredericksburg convened in obedience to instructions from Maj Gen'l Schofield, commanding this District, communicated through Lieut G G Greenough, Military Commissioner, there were present the following old members of the Council, who hold over under orders from Gen'l Schofield, viz

Mess'rs M Slaughter, Mayor, Wm A Little, Wm H Cunningham, J G Hurkamp & Ab P Rowe

And the following new members appointed by Gen'l Schofield viz.

Chas E Hunter, Wm C Morrison, L C Frost, W J Jefferies, Peter Couse, D C Ellis, Geo W Eve Appeared were qualified by the Mayor, by taking the oath required by the act of Congress passed July 2nd 1862 & took their seat at the Board.

On motion of Mr J G Hurkamp, ordered that the salaries of all the officers of the Corporation who are appointed by the Council be fixed at the same rate as at present.

The Council then proceeded to recommend to Gen'l Schofield a suitable person to be appointed Mayor of this Corporation to serve until his successor shall be duly elected and qualified when Chas E Mallam & Geo W Eve being put in nomination, the vote was taken by ballot and resulted as follows, viz

For Chas E Mallam Seven For Geo W Eve Three

So Chas E Mallam was declared duly recommended: not voting Geo W Eve.

The Council then proceeded to recommend a suitable person for Recorder of this Corporation, when L C Frost, Esq'r was unanimously elected.

On motion of Mr Wm A Little, Resolved that a committee of three be appointed by the Mayor to take into consideration the recommendation of suitable persons, to fill the offices of the Corporation and to report to the next meeting of the Council.

The Mayor appointed Mess'rs Wm A Little, Geo W Eve, & Peter Couse as the Committee under the foregoing resolution.

Ordered that when the Council adjourn, it adjourn to meet on Thursday next at eight O'clock PM [Page 501]

And the Council adjourned till Thursday next at 8 O'clock PM

At an adjourned meeting of the Common Council of the Town of Freds'burg held at the Council Chamber on Thursday evening April 23rd 1868

Mr Chas E Mallam appointed Mayor of the City of Fredericksburg under orders of Maj Gen'l Schofield, appeared was qualified before M Slaughter, Esq'r by taking the Oath prescribed by the Code of Virginia & also the oath prescribed by the Act of Congress passed July 2nd 1868, and took his seat at the Board as presiding officer

The following resolution offered by Mr Wm A Little was unanimously adopted and ordered to be spread on the minutes of the Council and published in the papers of the Town.

Resolved, that in parting with their late Presiding Officer & Mayor M Slaughter, who for the last eight years has occupied the position & performed so faithfully the duties of the said office, it is proper and become in as the members of the Common Council of Fredericksburg to give expression to one united & unanimous opinion as to his satisfactory performance of said duties & to tender to him as we do hereby the assurances of our high appreciation of his said services, and of our cordial respect and esteem.

On motion of Mr G W Eve, the report of the Committee on Officers of the Corporation was taken up, and the report was read by the Clerk of the Council.

On motion of Mr Eve, Resolved that the compensation for lighting and extinguishing the lamps in the Streets of the Town, be fixed at the rates of Two hundred dollars per annum & shall not at any time exceed that rate.

The vote being taken by ballot, Mr Wm G H Hancock was unanimously appointed to light and extinguish the Gas lamps.

The Mayor read a communication from S Richardson which on motion of Mr Little was laid on the table.

Be it ordained by the Mayor & Common Council of the Corporation of Freds'burg that there shall be levied and collected upon the persons & subjects liable to taxation in said Corporation, for the year ending the 3rd Monday in March 1869 the following taxes, to wit:

On Real Estate, \$1.25 on the \$100 value

On Personal Property \$1.25 on the \$100 value

On every male person over the age of twenty one years, three dollars,

On licenses on all persons required to be licensed by the State laws of Virginia within the said Corporation except Brokers & Real Estate Agents, a license of three fourths of the State license imposed for the current year.

On Incomes, interest & salaries and all other subjects of State taxation, within the Corporation, three fourths of the State tax for the current year.

On licenses to Real Estate Agents & Brokers 50 per cent of the State tax for the current year.

Of which tax the Collector shall be authorized to receive one third [Page 507] in money and two thirds in the Corporation interest or past due obligations of the Corporation.

A deduction of five per cent shall be allowed on all taxes paid to the Collector on or before the 15th day of August 1868 and of three percent of all taxes paid to the Collector on or before the 15th day of September 1868 and said taxes shall be liable to be distrained for on and after the 1st day of October 1868.

Be it ordained by the Mayor & Common Council of the Town of Fredericksburg that a tax be levied and collected on all male dogs of \$1.25 and on all female dogs of \$2.25 for the year ending third Monday in March 1869. This ordinance to take effect on and after the 10th of June 1868.

Ordered that the Police Officer be directed to give notice immediately of the foregoing ordinance by posting hand bill throughout the town.

On motion, ordered that the Mayor be authorized to contract for the purchase of as many collars & medals as may be necessary to supply the owners of dogs, provided the price shall not exceed twenty five cents each.

And then the Council adjourned

A bill of C W Edrington against the Corporation for going to Stafford by order of Jno Coakley acting Coroner, amounting to \$4.00 was ordered to be paid.

Mr Wm H Cunningham for the Gas Committee returned to the Council a list of all the persons who subscribed to the erection of the lamp posts, lamps &c & a report showing the receipts & expenditures of the Gas Committee leaving a balance in the hands of the Council of \$105.64 and asked that a new Committee on Gas be appointed, which report was received and ordered to be filed.

The Mayor [appointed] as the Gas Committee, Mess'rs Hurkamp, Cunningham & Hunter
