The Mayor presented appropriation from Mr J B Ficklen, tendering the sum of \$1500 in currency for the interest of the Corporation in the house on Main Street in which he now holds an interest dependent on one life. And on motion of Mr Little,

Resolved that the fee simple title to the said property be offered to Mr Ficklen for the sum of \$6500 in the bonds of the Corporation, provided the said offer accepted within thirty days.

The Mayor also presented a communication from Mess'rs M Eldridge & Co through Mr J E Tackett, Agent of the Alex'a & New York & Alex'r & Philad'a Steam line, asking the co-operation of the Common Council in establishing a permanent Steam communication via Aquia Creek, from Fredericksburg to New York & Philadelphia and on motion Mr Jno E Tackettt & Mr P Newton Harper were heard on the subject. When on motion of Mr Little,

Resolved that a committee of four members of the Council be appointed by the Mayor to confer with the Committee of the Board of Trade & also with the Committee of the said Steam Boat Company on in the subject presented in the above communication.

The Mayor appointed as the Committee under the foregoing resolution Mess'rs L C Frost, J G Hurkamp, D C Ellis, & Wm A Little.

On motion of Mr Hurkamp, Resolved that Mr Jno E Tackett be added to the above committee.

Mr Jno E Tackett by permission of the Council called the attention of the Council to the condition of the Marsh in the western suburbs of the Town and on motion, Mr Geo Aler was also heard on the same subject, when on motion of Mr Little,

Resolved that the whole subject be referred to the Street Committee who are requested with the assistance of the City Surveyor, to ascertain what is necessary to be done in the premises and what will be the probable costs thereof, and they are requested to make the necessary examination thereof as early as possible in order to report to a meeting of the Council which will be called to receive the report.

A communication from Jno M Herndon was read and on motion the same was referred to the Finance Committee for investigation and report.

A bill of Scott & Bowering amounting to the sum of Eleven dollars & fifty cents for adjusting the Bell of the Town Clock was allowed and ordered to be paid.

An account of Dr B S Herndon was read and on motion referred to the Finance Committee for investigation and report to the next meeting of the Council.

Mr Hurkamp who was appointed at the last meeting of the Council to ascertain the cost of hose &c made a verbal report and on motion Mr Bowering was heard on the subject and after some discussion, on motion of Mr Frost,

Resolved that a committee of four be appointed by the Mayor to ascertain and report to the next meeting of the Council any feasible plan for furnished a suitable fire apparatus for the town, and also [Page 515] any information they can obtain in regard to the cost of a Steam Fire Engine or other apparatus or plan which will furnish the best protection to the town from fire.

A bill of Wm A Little, amounting to the sum of seventy five dollars was allowed and ordered to be paid.

The Mayor appointed as the Committee on a Fire apparatus Mess'rs Frost, Hunter, Morrison & Hurkamp.

The Mayor presented a plot and survey of a lot formerly Betty Minor's which was sold for taxes to Mr Thomas Manuel. And it appearing to the Council that the said plot and survey is made out by the Corporation Surveyor in accordance with Section 7 Chapter 40 of the Ordinances of the Corporation, on motion of Mr Little the same is ordered to be recorded.



It being announced that a committee from the Young Men's Christian Association were in attendance, on motion of Mr Eve & by consent of the Council, Mr St Geo R Fitzhugh made a statement on behalf of the Association asking that a room be appropriated by the Council for the use of the Association. When on motion of Mr Frost, Resolved that the Young Men's Christian Association be allowed the choice of two rooms, the one on the left and the other on the right of the present Council Chamber to be occupied during the pleasure of the Council for the uses and purposes of the Association.

Mr L C Ellis, Chairman of the Street Committee made a verbal report in regard to the condition of the Kenmore Marsh and the Mayor also presented a written report in regard to the matter from C M Braxton, Corporation Surveyor & also the written offers of several persons, owners of the lands lying adjacent to contribute to the proper drainage of the Marsh, when by consent of the Council, Mr Braxton made some remarks on the subject, When Mr Frost moved that the sum of \$250 be appropriated to draining the said Marsh, to be expended under the superintendence of the Corporation Surveyor & in conjunction with the offers of individuals referred to above & also the tender of Mess'rs Hurkamp, Rowe & Hoomes, to which motion Mr Eve offered as an amendment that the whole matter be recommitted to the Street Committee for further report, which amendment was lost, and the question recurring on the motion of Mr Frost it was adopted.

The official bond of Wm E Straight, Chamberlain of the Corporation in the penalty of Ten Thousand Dollars, with A J Underhill, D W Bailey & C L Straight as his securities was presented to the Council, approved and ordered to be delivered to the Mayor to be by him deposited in the National Bank of Fredericksburg for safe keeping.

S E Chaffee appointed collector of taxes for the Corporation appeared and was qualified before the Mayor by taking the Oaths of Office & the Oath prescribed by the Act of Congress passed July 2nd 1862

The official bond of S E Chaffee collector of taxes for this Corporation in the penalty of ten thousand dollars with Wm Lang, G W Eve, Chas E Hunter & L C Frost as his securities was presented to the Council, approved and ordered to be delivered to the Mayor to be by him deposited in the National Bank of Fredericksburg for safe keeping.

Mess'rs F Bauman & Henry Miller, appointed members of the Council appeared and was qualified by the Mayor by taking the oath of office & the oath prescribed by the Act of Congress passed July 2nd 1862 & took their seats at the Board.

Mess'r Montgomery appointed measurer of wood & lumber appeared & was qualified before the Mayor by taking the oath of office & the oath prescribed by the Act of Congress passed July 2nd 1862

On motion ordered that the late Clerk of the Council be directed to turn over all books & papers in his hands belonging to the Council to Wm E Straight the present Clerk of the Council.

On motion ordered that the late Chamberlain of the Corporation be directed to turn over all books, papers & monies in his hands belonging to the Corporation, to Wm E Straight the present Chamberlain.

On motion ordered that the Finance committee be directed to examine the accounts of the late Chamberlain & collector of taxes & to make report to the next meeting of the Council [Page 18]

Ordered that the number of Police Officers be fixed at two, and thereupon the Council proceeded to ballot for them, Chas W Edrington, Wm Way & Washington Jennings being on nomination which resulted in the election of Chas W Edrington & Wm Way as temporary Police Officers

On motion the salary of the Mayor for the years ending the 3nd Monday in March 1870 was fixed at four hundred dollars.

Mr Hunter moved that the salary of the Police Officers be fixed at the sum of three hundred & fifty dollars which motion after a division was lost.

Mr Frost moved that the salary of the Police Officers be fixed at the sum of three hundred dollars, which motion after a division was lost.

On motion of Mr Eve, the salaries of all the officers of the Council was fixed at the same sum as heretofore.

The Mayor appointed the following Committees

Petition was presented by Chas E Hunter to allow Mess'rs A S & C G Hilper to close Frederick Street the depth of their property to be opened at any time by the order of the council. Petition granted.

On motion of Mr Jeffries it was ordered that the license of drays and wagons be levied the same as the past year.

On motion of Mr Frost it was resolved that the Police Officers be given one half of the fines imposed for violations of the laws of the Corporation.

On motion of Mr Frost it was resolved that Mr Hurkamp be continued upon the Fire Comt'ee as in the final report [Page 519]

The Council then adjourned to meet at 7 O'clock on the 9th of April 1869

L C Frost asked and obtained leave, and did make a personal explanation. Mr Frost then handed to the Mayor the resignation of himself, Mr Chas E Hunter and W C Morrison to take effect when persons can be found and qualified to succeed them. On motion of Mr Eve their resignations were ordered to be laid on the table.

The Finance Committee through their chairman Mr Frost, reported that they had examined the account of the late Chamberlain and find the same to be correct. And a balance due him by the Corporation of \$57.40 which amount they recommend to be refunded to him out of the first funds that may come into the hands of the Chamberlain.

The Finance Committee through their Chairman Mr Frost reported that they had examined the accounts of L J Huffman late collector of taxes and find the same to be correct & a balance of uncollected taxes in his hands amounting to the sum of \$9,495.32.

The Mayor vacated the Chair to offer the following resolution which was accepted. Resolved that the Council express its feelings of deep regret that circumstances have rendered it necessary that the accomplished Chamberlain & Clerk of the Council Col Rob't Chew should vacate his office, it is felt by the Body that the removal of Col Chew will be a public loss. The manner in which he has conducted his responsible duties deserve the highest praise, therefore the thanks of the Council for his valuable services are hereby tendered to him, together with best wishes for his future prosperity.

The Finance Committee offered their report for the Current year which was accepted and ordered to be recorded

The Committee upon Fire apparatus then offered their report which was accepted.

The Mayor then presented the petition of Joseph Hall to close for the present Willis Street. Referred to the Street Committee.

The Mayor brought to the notice of the Council the unsafe condition of the Jail, Whereupon, [Page 520] on motion of Mr Frost the matter was referred to the Committee on Public Property.

On motion of Mr Hunter of the Finance Committee Mr Heinichen of the Overseers of the Poor made an explanation in regard to the expenditures of the past year.

On motion of Mr Frost it was ordered that \$1,200 be appropriated to the maintenance of the Poor for the present year under superintendence of the same Overseers.

On motion of Mr Hunter it was ordered that the ration of Sugar & Coffee for the Poor be dispensed with except to the sick.

D C Ellis offered his resignation as a member of the Council and on motion of Mr Eve it was accepted.

On motion of Mr Hunter it was ordered that the Collector be directed to collect at once the license for all drays and Wagons now due.

On motion of Mr Frost it was ordered the Pub Property Committee hereby authorized to contract with some responsible party to wind up and keep in order the Public Clock for the current year at a sum not exceeding \$50.00.

On motion of Mr Frost it was ordered that the tax list be published in the *Fredericksburg News*.

Mr Hunter gave notice that he would at the next meeting of the Council submit a motion that some grade be established for the streets of the Corporation.

On motion of Mr Frost it was ordered that the report of the Finance Committee for the fiscal year ending March 15th 1869 be published in all three City papers.

The Council then adjourned

The Tax Bill reported by the Finance Committee for the Year ending March 1870

To the Mayor and Common Council of the City of Fredericksburg

The undersigned members of the Finance Committee respectfully report that they have prepared and herewith submit an ordinance imposing taxes for the years ending the third Monday in March, 1870. They find that with the most economical administration of the affairs of the Corporation it has required the sum of about nine thousand (9000) dollars in money to meet necessary Municipal expenses exclusive of the claims for interest on the Bonded debt of the City, which amounts now [Page 521] to about thirteen thousand (13,000) dollars annually, this amount interest and some accumulation of interest past due were provided for in part by the Finance bill of the past year, by the City receiving two thirds of the taxes due her in interest Coupons.

But as large amounts of Bonds are held out of this City in various parts of the State and even outside of the State those coupons are not annually sent in and bought by our tax payers, thereby leaving a considerable amount of interest coupons of the past year still unpaid and one or more bonds for raising wrecks which will fall due in the current year. Your Committee are therefore compelled to provide in the present tax bill for the payment of the interest for the current year and the above mentioned bonds in money. At the same time your Committee realized the necessity of making the tax as light as possible and of receiving some portion of the tax of the current year also in coupons.

The Committee's Books shows the taxable subjects to be as follows.

Real Estate \$1,282,838.00 Personal Property \$120,000.00

Poll tax on 750 polls of which only about six hundred are remittable

Licenses in 1868 realized 6,539.72

Your Committee propose to levy the tax for the current year as follows

On Real Estate \$1.25 in the \$100 value being the same as last year \$16,147.02 On Personal Property also same as last year \$1.25 on the \$100 value \$4,678.12

On Persons \$3.00 per head

On Licenses except Real Estate & Brokers three fourths of the State tax

For the current year \$6,539.72 \$27,364.86

Last year \$25,335.00

On incomes interests and salaries and all other subjects of taxation in the Corporation three fourths of the State Tax for the current year. On which your Committee recommend that one third be received in coupons interest and past due obligations, viz \$9,021.62

And two thirds in money viz \$18.243.24

\$27,364.86

There remains due \$9,495.32 of the last years taxes unpaid and in the hands of the Collector, from which your Committee believe a sufficient sum will be collected to make up any deficiency in the cash part of the current year.

Your Committee further recommend that a tax of one dollar per head upon all male dogs and two dollars upon all female dogs be imposed and that the Ordinance in regard to the tax collars for dogs as modified during the past summer, by the present Council be strictly enforces.

We also recommend that the same deduction on taxes paid before the 15th of August & the 15th day of September be made as last year.

The Chairman of the Public Property Committee reported that he had made contract with Mr Murray to wind up and keep in order the Town Clock for the sum of \$40 per annum and on motion the report was accepted.

Moved by C E Hunter that there shall be established by actual survey a standard grade for the streets and side walks of the city & that C M Braxton be and it hereby authorized to make said survey.

The Mayor presented a bid from Chas A Grave offering to keep the City pump in order for twelve months and on motion referred to the Pump Committee.

On motion of Mr Frost, the Pump Committee were requested to investigate and report at the next meeting on the condition of the Pump opposite the house of J J Chew and to ascertain the best and cheapest method of obtaining water at that pump.

On motion of L C Frost resolved that the board authorize and direct the Public Property Committee to furnish sufficient lumber to enclose two sides of the burying grounds known as Potters field, provided the colored people do the labor of building said fence.

On motion of L C Frost be resolved that so much of the Ordinance relating to Dogs, which on the fourth line calls for a collar with a piece of metal attached thereto be amended so as to read or leather strap to serve as a muzzle, the form of which shall be arranged by the Mayor to be paid for the same as the collar and metal and that said collar and muzzle be obtained from the Chamberlain.

The Mayor presented a communication for Judge Alfred Motion asking if some steps could not be taken to secure some portion of the Peabody Fund and on motion of Mr Eve, resolved, that the Mayor, Judge Morton, Maj Kelley be and are appointed a committee to present the claim of the Corporation to a share in the funds recently contributed to the South by Mr Peabody for Educational purposes.

On motion of Mr Dolbar ordered that the Street Committee be authorized to advertise by posting hand bills for bids for person who will contract to keep the Streets of this Corporation clean for the balance of the present year.

On motion of Mr Barstow ordered that the matter of repairing the Gunnery Spring be referred to the Pump Committee

The Chamberlain presented the [blank] of Maj Kelley for advertising amount to \$27.00 and on motion it was ordered to be paid.

The Council then adjourned.

At a regular meeting of the Common Council held at the Council room this Friday evening August 24th 1869

The Finance Committee to whom was referred the matter of paying the interest upon bonds, held by Mr Richardson for the removal of wrecks from the River, made their report and upon motion of Mr Eve, their report was ordered to be laid upon the table until the report of a committee can be heard as to the liability of the Corporation for the payment of the Bonds.

On motion of Mr Couse it was ordered that the Finance Committee be directed to examine and enquire into the liability of the Corporation for the payment of the above mentioned bonds.

The Street Committee who were directed at the last meeting to advertise for bids from persons who would contract to keep the Streets of the Corporation clean for the balance of the year, reported that George Aler was the lowest bidder, and that they had partially contracted with him to keep the Streets in order & that Mr Aler had been at work upon the Streets for several days.

On motion of Mr Barstow, ordered that the Street Committee be instructed not to make any further payment of money to Mr Aler for cleaning of the Streets until a contract and bond for the faithful discharge of said work is properly executed and signed.

On motion of Mr Chas Miller, the Pump Committee are directed to repair the Gunnery Spring as to them may seem most advisable. On amendment of Mr Eve, it was ordered that the work done upon said Spring and all work done for the Corporation be let to the lowest bidder.

On motion of Mr Jefferies it was ordered that the judgment against the Corporation in favor of E H Taliaferro for the sum of \$16.80 be paid.

A communication from Capt Quinn & Mr Reed was presented asking that the Friends of Temperance Society be allowed to use of the South end room of the Court House in which to hold their meetings, and on motion of Mr Couse the request was granted, they agreeing to deliver up the same at the pleasure of the Council.

W E Straight, Chamberlain, presented a new bond in the penalty of Ten Thousand dollars with C L Straight & W E Nye as his securities and on motion the same was ordered to be accepted and delivered to the Mayor and by him to be placed in the Bank for safe keeping.

On motion of Mr Couse, the Street Committee were directed to make enquiries as to the expediency of numbering the houses of the City.

The Chamberlain presented the bill of J W Adams for stationary furnished the Corporation since April 1868 amounting to \$10.10 and on motion it was ordered to be paid.

Bill for 75 cents was presented by Mr Heinichen for carting dirt from the Street and on motion it was ordered to be paid.

The Finance Committee who were directed at the last meeting to enquire into the liability of the Corporation as to the payment of Bonds given for raising the wrecks in the river, Reported that they had made a thorough investigation of the matter & in their opinion the Corporation are liable for the payment of the bonds.

On motion of Mr Eve, ordered that the Chamberlain be directed to pay six months interest Mr Richardson upon bonds issued for wrecks.

The Street Committee to whom was referred the matter of numbering the Streets of the City were granted further time to report and were instructed to ascertain the cost of numbering the houses and report at the next meeting.

The Finance Committee made a written report in regard to the interest now due & unpaid by the Corporation & on motion of Mr Eve their report was ordered to be re-committed to them for further report.

A petition from C C Wellford and others asking that foot bridges on Main at the intersection of all the Streets above Commerce, and on motion referred to the Street Committee Present: Henry Miller

On amendment of Mr Eve to Mr Jefferies motion, the night Police salary was fixed at \$250.00 per annum.

On motion of Mr Eve it was ordered that the special Police be paid one dollar per night for their services

A bill of Mr Herndon, Counsel for the Corporation in the case of Taliaferro vs the Corp of \$5.00 was ordered to be paid.

On motion of Mr Jefferies fixing the salary of the Night Police was reconsidered.

On motion of Mr Jefferies resolved that the night police be dispensed with.

On motion of Mr Eve ordered that the Chamberlain advertise and receive bids for lighting the lamps of the City for one year, said bids to be submitted to the Council [Page 530] at their next meeting for their approval.

The Council then adjourned.

On motion of Mr Dolbar, the council proceeded to an informal ballot for Lamp Lighters with the following result:

After which a formal ballot was taken by which Washington Wright received 5 and John Brown 3, whereupon Wash Wright was declared elected at the salary of \$125.00 per annum.

On motion of Mr Dolbar, it was ordered that the Lamp Lighter light the Street lamps on all dark nights, where instructed so to do by the Mayor.

A bill presented by Mr Bowering of \$10.00 against the Corporation for making bunks for the jail was ordered to be paid.

A bill of Capt Green for \$18.50 for blankets furnished for the use of the Jail was ordered to be paid.

A bill presented by Mr McClain for making a ladder for Lamp Lighter amounting to \$2.50 was ordered to be paid.

P B Dunn was appointed a member of the Street Committee in place of Mr Beardsley [Page 531] resigned

Mr Wallace asked that the Chamberlain be directed to redeem three one dollar bills issued by the Corporation prior to the War and on motion the matter was referred to the Finance Committee

A Petition of the Police to have an increase of Salary and motion of Mr Eve it was laid upon the table until the next meeting of the Council.

The Council then adjourned

On motion of Mr Eve it was resolved that Mr Huffman be sent for and asked to attend this meeting & to report what progress he has made in collecting the taxes of 1868.

On motion of Mr Barstow, Resolved that the tax Collector be requested to collect as rapidly as possible the taxes now due and unpaid and that he distrain against any and all delinquents who shall not have paid their taxes by the 15th day of December 1869.

The Mayor presented a bill of C E Hunter for furnishing stovepipe for the use of the Jail amounting to \$8.05 was ordered to be paid.

On motion of Mr Eve, Resolved that there be one extra policeman appointed to serve as night watch and that one of the day policemen be designated a Night Watch & that they be paid at the rate of \$365.00 per year.

On motion of Mr Jefferies, the resolution fixing the Night Police salary at \$365.00 per year was reconsidered.

And a motion of Mr Miller was put to the vote fixing the salary at \$500.00 per year was taken and lost.

Whereupon the original motion of Mr Eve was put, making the pay of Night Police \$365.00 per annum and was carried.

Duncan Thompson Jr presented an appointment from Maj Gen'l Canby as Chamberlain & Clerk of the Council and it having been certified to this Council that Mr Thompson has qualified before Mr Eustace Chaffee by taking the several oaths of office prescribed by the laws of the State of Virginia together with the oath prescribed by the Act of Congress July 2nd 1862, he is therefore allowed to take his seat as Clerk of this Board.

Duncan Thompson appointed Chamberlain by Gen'l Canby in place of W E Straight who has resigned, presented a bond in the penalty of ten thousand dollars, with Wm E Straight, W E Nye, H H Lamb, Peter Couse, & Wm M Morrison and in motion the same [Page 533] was accepted and ordered to be delivered to the Mayor by him to be place in the bank for safe keeping.

Simon Hirsh and Wm E Straight appointed Councilmen by Gen'l Canby produced certificates of their due qualification and they were directed to take their seats.

Present: Wm E Straight & Simon Hirsh

Mr Eve presented a bill from B S Herndon MD as salary as physician to the Poor House from March 1st 1861 to Dec 5th 1861, amount of bill \$38. On motion of Mr Eve the bill was ordered to be paid.

A bill from D Herndon MD was presented for surgical services rendered in the case of Samuel Folk for two weeks attendance visits and dressing wound twice per day, am't of bill \$50.00

On motion of Mr Eve it was ordered that the bill be referred to the Overseers of the Poor.

On motion of Mr Eve the Finance Committee were directed to examine the accounts of the late Chamberlain and turn them over to the present Chamberlain.

A communication from Braxton & Wallace was read to the Council requesting the payment of three years interest amounting to eighteen hundred dollars on the Bonds of the Corporation, owned by Thomas Hill, administrator of George Ficklen, on motion W E Straight the matter was laid over until next meeting.

On Motion of Mr Eve the resolution passed at the last meeting of the Council directing the Collector of taxes to distrain for all taxes not paid by the 15th of December was amended so as to read the 15th of January.

The Council then adjourned.

On motion of Mr Eve, the report was accepted.

A communication from Braxton & Wallace requesting the payment of interest on bonds held by Thomas Hill, administrator of Geo Ficklen, dec'd which was laid over at the last meeting, was taken up and after some discussion it was ordered on motion of Mr Straight that the communication be referred to the Finance Committee and on motion of Mr Eve the Mayor was requested to act with the Committee.

Mr St Geo Fitzhugh appeared before the Council and requested the sale of property belonging to the Corporation situated on Main Street.

On Motion of Mr W E Straight, the matter of the sale of said property was referred to the Property Committee to report at the next meeting.

The following appointments were made by the Mayor:

Simon Hirsh on the Street Committee; W E Straight on Finance Committee; Chas Miller on Pub Property Committee.

On motion of W E Straight, it was ordered that the Street Committee be directed to have the Street on Winchester & Amelia repaired at once.

On motion of Mr Eve it was ordered that the Street Committee be ordered to examine the damage done of Charles Street by waste water form Mr Marye's Mill race and request Mr Marye to repair the damage immediately.

On motion of Mr Jefferies it was resolved by the Common Council that the name of William Street be changed to Commerce and the name of Caroline Street be changed to Main Street.

On motion of Charles Miller, the Street Committee was the directed to enquire into and ascertain the probable cost of putting up the names of the Streets at the corners and number of the houses and report at the next meeting, showing samples of the lettering numbering &c.

On motion of Mr Eve the Mayor was requested to procure a Street lamp to replace one that is broken.

Johnston & Co presented a bill to the Council for Coal Oil &c amounting to \$13.72.

On motion of Mr Jefferies it was ordered to be paid.

James McGuire presented a bill for sundry articles purchased by the Corporation amounting to four dollars & twenty cents, on motion of Mr Eve it was ordered to be paid.

Markey presented a bill for blankets amounting to thirty two [Page 535] dollars. On motion of Mr Eve it was laid over until the next meeting.

The Council then adjourned.
