Duncan Thomas [Thompson] Jr Chamberlain & Clerk of Council tendered his resignation to the Council and on Motion of Mr Jeffries the same is accepted & the Finance Committee is directed to examine his accounts & turn the same over to his successor

A Bill of W R Mason, amt'g to \$11.10 was ordered pd

On Motion of [Mr Dolbear], Mr R W Adams who has made application & there being no dissenting voice, be appointed Chamberlain & Clerk of the Council in place of Duncan Thompson who has resigned

On Motion of Mr Jeffries, Mr Geo W Eve is appointed Recorder of the Corporation in place of W H Barstow, resigned

An account of C E Hunter amt'g to \$8.87 was read and ordered to be paid

The Clerk of the Council was directed to refer to the records in reference to the a/c of Hoyer & Ludwig and report the results of his investigation at the next meeting

On Motion, Mr Eve, the order directing the payment of \$69.76 to W C Morrison was reconsidered and the account of Mr James Tongue, in which is included the a/c of Morrison amounting to \$210.55 was read and ordered to be paid

On Motion, W J Jeffries, Resolved that the sum of one hundred dollars asked for by the Committee be and is hereby appropriated to aid in defraying expenses of said Committee bearing the Memorial of the Citizens to Washington

The vote being taken upon Mr Jeffries resolution, It was carried, Ayes five, Noes four

A petition from the Young Men's Literary Society asking the use of Armory Hall, was presented and on motion the use of the Hall was granted, subject to the control of the Council

The subject of the appropriation for the cleaning of Kenmore Marsh was brought before the Council by the Mayor, and the Motion was laid on the table

Mr Eve made some remarks in reference to the late Mayor and On his Motion it was, Resolved unanimously that the thanks of this body be tendered to Colo W E Nye late Mayor for the important, faithful and courteous manner in which he [Page 539] discharged the duties of the office

The Mayor on Motion was directed to appoint the Committee

The Mayor appointed Mr Young, Mr Eve and the Clerk of the Council as that Committee On Motion the Mayor was added to the Committee

The Mayor called the attention of the Council to a demand by J Tome for payment of one Bond \$500 past due and for the interest on \$3000 held by him

On Motion, The Chamberlain was directed to pay Mr Tome the A & interest due on the Bonds held by him

Two accounts of Waite & Sener for \$17.50 and \$6.10 were read and ordered to be paid

A Bill of Martin Cahill for services rendered at the late fire amt'g to \$2.00 was read and on motion was ordered to be paid

Permission was asked by Mr Wm Burke to put a stone footing across Main St erecting opposite the building he is now at his expense which was unanimously granted

A Petition signed by numerous Citizens at the lower end of Town asking the erection of a pump at the corner of Princess Ann & Dixon St was read by the Mayor and before any action was taken, Mr Eve stated that Mr Van Doren was present and desired to be heard upon the subject of a proposition to supply the Town with water.

On Motion Mr Van Doren was head and his remarks favorably considered

Mr F Bauman was appointed a member of the pump committee

The Mayor suggested that the Council appoint a Street Commissioner

On motion, Mr Eve, Resolved that a Street Com'r be appointed by the Council and that the salary be fixed and one hundred dollars pr annum.

Mr Geo Aler was nominated and unanimously elected Street Commissioner [Page 541]

Mr Chaffee was heard in reference to difficulties in the way of his prosecuting the duties of his office growing out of the Enabling Act passed by the Legislature of Va

On Motion Mr Eve, ordered that Capt Chaffee, Collector of Taxes proceed at once to rent out the Hay Scales and Market Stalls and complete the collection of taxes as speedily as possible

The Mayor stated that upon conferring with privately a majority of the members of the Council he offered Mess'rs Green & Edrington a reward of \$50 for the detection of the parties breaking into the Store of Scott & Kearsley and he now considered that they had performed their duty in the arrest of certain parties supposed to be guilty of the offence.

On motion made and seconded, it was ordered that the rewards offered by the Mayor be paid to Mess'rs Green & Edrington

The Mayor suggested that some action be taken with a view to laying off the Town in wards for the purpose for the convenience of voters at the approaching collection and in conformity with the recent act of the General Assembly of Virginia, and On Motion, It is hereby ordered that in conformity with an Act of the General Assembly of Virginia passed [blank] entitled an Act [blank]

That the whole City of Fredericksburg shall be embraced in one ward and that there shall be two precincts or voting places in said ward Viz, the Court House and the Town Hall and that George Street to Liberty and thence with Liberty to the Turnpike and thence with the Turnpike to the Western Limits of the Corporation shall be the dividing lines between said precincts and it is further ordered that all voters residing north of said line shall vote at the Town Hall and all voters residing South of said line shall vote at the Court House of the City

Resolved by the Mayor & Common Council of the Town of Fredericksburg that permission be and is hereby given to Bazil Gordon, William T Lowery, Edwin Carter, William H Fitzhugh, Mrs Janet R Pollock, John Coakley and the heirs of Peter Goolrick, dec'd, the present owners of most of the Lotts & buildings between George & Hanover Streets on the West sides of Caroline St in the said Town of Fredericksburg and to their heirs and assigns the future owners of the said buildings & the lots on which the said buildings now stand, to make such excavation on said Caroline Street from the beginning of the present culvert near George Street, along the line of that portion of said culvert extending from the beginning to a point opposite the building now owned by the said Mrs Janet R Pollock, thence on the same line to such point below the buildings now owned by the said heirs or devisees of Peter Goolrick, dec'd on the said square as the said parties Bazil Gordon &c as may elect and thence across said Caroline Street and on the north side of said Hanover Street outside of the curb stones of said street to a point at or near the Bank of the River as may be necessary, at their own expense for the repairs and improvement of the old and for the construction of a new culvert or drain of brick & such other material and at such depth and of such dimensions as the said Grantees or a majority thereof may elect from the said point of beginning along the route indicated to the proposed terminus at or near the River Bank, and to uncover the same or any part thereof after its completion whenever it may be necessary for changing out or repairing the said culvert or drain and to tap the same with lateral culverts or cover drains from their respective lots.

A letter from Mr A W Moody, alias R Jas Buckly asking that the Council remit the whole or a part of the license tax recently paid by him was read and on motion laid on the table

Mr J B Sener was by permission, heard upon the subject of the condition of the Court House and urged that some action be taken by the Council looking to placing the property in a condition of undoubted safety

On Motion, Mr Young, Ordered that the Public Property Committee with the assistance of the Mayor be directed to examine the condition of the Court House and report at once if the same needs any repairs in

order to make it safe for the public use, and also make an examination of the Town Hall and to report whether it can be safely and suitably arranged for holding of the Court

On Motion Mr Eve (Couse ordered) that the License on Drays & Carts be fixed at \$5.50 and on Wagons at \$11 for the years ending April 1st 1871

Mr Roy Jones was nominated and balloted for and unanimously elected Clerk of the Market The Salary of Clerk of the Market was fixed at one hundred dollars pr annum

On Motion Mr Eve It was ordered that the Clerk of the Council prepare an ordinance fixing a fine of [blank] upon all parties bringing meats, fowls, Butter, Eggs or vegetables into Town and offering them for sale during Market hours on the streets and submit the same to the next meeting for its action

Mr H Miller asked and obtained leave to retire

The Mayor called the attention of the Council to the necessity of the appointment of a Committee for the revision of the Charter of the Town to conform to the recent Constitution of the State of Va and also revise the ordinances of the Town.

On Motion Mr Eve, It was resolved that the Mayor, J J Young & the Clerk of the Council be appointed a Committee to revise the Charter of the Town and also the Ordinances now in force and submit the same to the [Page 544] next meeting of the Council.

A Motion, made & seconded, It was ordered that the Public Property Comm be requested to receive proposals for the repairing of the present and the building of a new Court house with plans and specifications for same with a view of submitting the question of repairing the present or building a new Court House to the voters of the Town at the coming election

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg that if the owner or agent of any meats, fish, Butter, Eggs, or other Marketing brought into Town shall offer the same for sale or sell any of the said articles upon any of the Streets or elsewhere within the limits of the Corporation during the Market hours of the Town, the said owners or Agent shall forfeit and pay not exceeding [blank] for every sale of Meats, Fish, Butter & other Marketing so made, Provided that nothing herein shall be so construed as to prevent the sale of any Marketing brought into Town at the Market house of the Town, subject to existing ordinances regulating the sale of same.

This ordinance shall be in force on and after 1st Day of July 1870 [Page 545]

On Motion, Mr Eve, The ordinance was unanimously adopted

On Motion ordered that the blank in the ordinance be filled with the sum of "Two Dollars" and made to read "Not exceeding Two dollars" for every sale of Meats, Fish, Butter, & other Marketing so made.

The Mayor informed the Council that they were called together more particularly with a view to the appointment of a Commissioner of the Revenue and suggested that the matter be taken into consideration.

The subject was discussed by Mess'rs Eve, Dolbear & Couse, and it being determined to go into an election for Comm'r Revenue to serve until the 30th June next,

Mr Dolbear nominated Mr L Morgan Mills who was balloted for and the ballots being counted resulted in the election of Mr Mills unanimously

The Resignation of Mr W E Straight as a member of the Council was read and on Motion was accepted

Mr Eve Moved that the Council go into the election of a councilman to serve in place of Mr Straight, resigned, which being seconded and carried, the Council proceeded to the election; J G Hurkamp, Geo Gravatt & P McCracken were nominated and balloted for; the votes being counted resulted as follows McCracken 3, Gravatt 3, Hurkamp 1; no election; a second ballot was had with the following result, Gravatt 4 votes, McCracken 3 votes; so Mr Geo Gravatt was declared elected to fill the vacancy occasioned by the resignation of Mr Straight

R W Adams and R S Chew were nominated and balloted for, Adams received 7 votes, R S Chew 3 votes and was declared elected

Mr Young, Recorder-elect was qualified before the Mayor, also R W Adams Clerk of the Council

The Mayor presented a paper for the deliberation of the Council and called the Recorder to the Chair Absent: M R Mason, Mayor

Mr Young, Recorder in the Chair

The resignation of Mayor Mason was presented by the recorder

Mr Doggett moved to lay the resignation on the Table, Mr Wallace moved as a substitute be placed in the hands of the Clerk to be forwarded to Judge Herndon, Mr Doggett withdrew his motion and Mr Conway offered the following as a substitute to the motion of Mr Wallace

W R Mason, Mayor having tendered his resignation to the Council, It is ordered that such action as the Council shall judge it proper to take in the premises be postponed for the present which being seconded by McCracken and the vote being taken the resolve Motion of Mr Conway was carried [Page 548]

On motion Mr Sener, the Council proceeded to the election of Collector of Taxes

Mr L J Huffman was nominated and balloted for and unanimously elected Present W R Mason, Mayor, who resumed the Chair, Mr Young retiring

The Council then proceeded to the election of Police Officers

Mr Doggett moved that the Council go into the election of police officers fixing the number and their salaries, which being seconded and the vote being put the Motion was carried. Mr Mason, Mayor giving the casting vote

It was decided by vote to fix the number of police at four and their salaries be fixed at \$300 for annum

The following parties were put in nomination, J S G Timberlake, C A Gore, W Jennings, Geo S Green, J A Taylor; and balloted for and the ballot being taken resulted in the election of J S G Timberlake, J A Taylor, G S Green and C A Gore as police officers for the ensuing twelve months. Mr J W Sener

The Common Council elect of the Town of Fredericksburg at the election held May 26th 1870 in Conformity to an Act of the General Assembly of Virginia, passed May 11, 1870 entitled an "Act to provide for a general election" met pursuant to call of W R Mason, Mayor at the Council Chamber, Fredericksburg, Friday evening July 1st 1870

- 6th Incomes, Interest, Salaries, and all other subjects of state taxation within the Corporation, Seventy five per cent of the State tax aforesaid thereon for the year 1870
- 7th On Licenses to Brokers and Real Estate agents, fifty per cent of the State Tax assessed thereon for the year 1870
- 8th And be it further ordained that two thirds of the taxes so assessed by this bill be received in the Past due Coupons and Interest on the Bonds of the Corporation of Fredericksburg at par
- 9th And it is further ordained that a deduction of five per cent shall be allowed to such persons as shall pay their taxes on or before the 15th day of October 1870; and of three per cent to such persons as shall pay on or before the 15th day of November 1870

Dr Wallace at the request of Mr J G Hurkamp stated to the Council that owing to erroneous assessment he had declined to pay his taxes, and asked that the Council take such action as proper in this premise

On motion Mr McCracken, the subject of Mr Hurkamp's request was referred to the Finance Committee for investigation and settlement

Mr McCracken offered the following which was seconded by Mr Doggett,

Resolved: That all privileges heretofore granted to Mess'rs Scott & Herndon, Jno F Scott or Mess'rs Scott & Bowering to the use of the Street in front of their foundry be and the same are hereby rescinded and that they be required to remove all obstructions placed by them in any of the Streets of the Town, in violation of the ordinances of the Corporation

Mr Conway moved a reconsideration of the vote by which the substitute was lost, [Page 579] which was carried and then, on motion Mr Conway the substitute of Dr Wallace's was unanimously adopted

The Chair appointed Dr Wallace, Mr Sener, Mr Morrison, Mr Doggett, and Mr McCracken as the Committee
