On motion of Dr Wallace, the report of the Committee was received

Mr Little submitted the following resolution which was unanimously adopted

Resolved, that the sum of \$300, be placed at the disposal of the Committee heretofore appointed to consider the matter of procuring the materials &c for a Hook & Ladder Co, and that said committee be authorized to collect the amounts subscribed by the Insurance Companies (reported to be \$275.00) and with the said fund to purchase and provide the necessary subjects and building for the purpose as per their report of this date

Provided that they can be satisfied that an efficient Hook & Ladder Co will be organized at once to use the said materials when thus provided by the Corporation, and that the said Committee be further instructed to prepare and submit an ordinance to organize a Fire Department for this town, and nominate the proper officers therefore to a subsequent meeting of this Council.

Mr Magrath submitted the following resolution which was unanimously adopted,

Resolved that the City Treasurer be and he is hereby requested to furnish to the council at its next meeting a statement shewing the amount of the public debt of the Corporation at this time, specifying as near as possible, how much is owing of principal and how much of interest, and also how much of Principal and interest has been paid off and discharged by the Corporation of Fredericksburg since the first day of April 1865

Mr Mason tendered his resignation as a member of this Council

On Motion of Dr Wallace, Mr Mason was requested to withdraw his resignation which being seconded and vote taken, the motion was unanimously adopted.

Mr Mason withdrew his resignation as a member of this Council

On motion, Mr Russell.

Ordered that the sum of two hundred and fifty dollars be appropriated for the [Page 88] use of the public schools of the town, subject to the order of the Board of Trustees of the Public Schools

On motion, Mr Little,

Resolved that the subject of the powers of the Board of Trustees of Public Schools to draw on this Council for funds for expenses of School be referred to the Finance Committee for investigation and report.

Mr Sener, Submitted the following resolution which was unanimously adopted

That inasmuch as we are informed that the Legislature of Virginia are about to establish additional lunatic asylums in the State, and as in the opinion of this Council, no more eligible situation for such an institution can be found in the State than the Town of Fredericksburg,

Resolved that the Mayor is requested to present the claims of Fredericksburg to the location of said asylum to the Legislature in proper form and out Senator Charles Herndon Esq'r and our Delegate J H Kelly Esq'r be and they are hereby requested to urge said claim with all proper zeal when said subject shall come up for final action in the bodies of which they are representatives

An account of R B Merchant, amt'g to \$8.75 was read and ordered to be paid.

Lt Gov Marye desired to be heard by the Council in reference to Matters connected with the F & G R R on motion, Gov Marye was permitted to be heard.

Stated that Mr Fairbanks, the Engineer [Page 90] sent to examine into the affairs of the Rail Road and was present suggested that the Council hear him on the subject, On motion, Mr Fairbanks was permitted to be heard

Mr Russell submitted the following, which, on motion, was unanimously adopted,

Whereas this Council has been informed by Mr A Fairbanks who has appeared before the Council that by the request and authority of the parties who claim to have purchased the Fredericksburg and Gordonsville Rail Road at the sales (made by the Trustee under the mortgage), held on the 28th December 1871 at New York, the said Fairbanks is engaged in making an examination of said Rail Road with a view to make an approximate estimate of the cost of completing said Rail Road, which estimate is to be returned to said parties and the Council is further informed that the said Fairbanks desires to inspect the papers prepared by Mess'rs Taylor and Braxton, late Chief Engineers of the Company and that said papers are now in the Custody of M Slaughter Esq'r & Wm L Slaughter Esq'r at Fredericksburg, and whereas this Council is earnestly desirous in furtherance of the interests of Fredericksburg, to and in facilitating the affording of all information which may reasonable tend to promote the completion of said Rail Road, and the Council is informed that the gentlemen so having custody of said papers have declined to allow Mr Fairbanks to inspect the same

Therefore, Resolved that the Council hereby requests Mess'rs Montgomery Slaughter & Wm L Slaughter [Page 91] as also the Board of Directors of said Company (if their consent be necessary thereto) to allow said papers to be delivered to L B Rose, the Mayor, in order that the latter may allow said Fairbanks to make such inspection and examination of the same as he may need in order to make the estimate aforesaid, upon the understanding that said Mayor Rose shall keep the possession of said papers and have

supervision, of same and shall return the same to the Mess'rs Slaughter when said inspection is complete, and that said papers shall be thus returned within two days after same are so delivered to the Mayor.

Resolved that M Slaughter, President and the Directors of the Fredericksburg & Gordonsville Rail Road Co be respectfully requested to place in the hands of the proxies representing the stock of the Corporation of Fredericksburg in the said Road, any maps, profiles or other papers in their possession which may be necessary to enable [Blank] Fairbanks, Engineer, to make an estimate of the cost of completing the said road to Orange C H

Provided that the said papers be returned to the said Slaughter, President, as soon [Page 93] as the said estimate is completed not exceeding two days

The Mayor stated that the Council had been convened at the instance of Mess'r Terry, Walker, Atkins & others parties claiming to be interested in the purchase of the of the Fred'g & Gordonsville Rail Road at the recent sale (under a mortgage) in the City of New York, that they might be heard in reference to their plans for completion of the said road.

Lieut Gov Marye was present and presented a Communication, signed by L P Royer, Wm M Smith, C M Atkins, Thomas George Walker, E L Ferry & T A Hughes, and addressed to the Council which was read and is in the following words

To the members of the Town Council of the City of Fredericksburg Gentlemen,

We reached your city the PM at nearly 7 o'clock instead of at Noon as we had anticipated, because of the ice blockage in the Potomac and which nearly defeated our purpose of getting here on this day. Important engagements compel some of us [Page 97] to return by the next train tomorrow morning and as a consequence we cannot in a body have the pleasure and advantage of an informal personal interview with you, we have had barely time to take the necessary formal action required to give form and vitality to the new Rail Road Corporation created by force of a general law of your State as a result of the recent sale of the property and franchise of the Fredericksburg and Gordonsville Rail Road Company, [blank] some formal legislation will be probably desirable to give aid and greater efficiency to our purpose to complete the road as soon as practicable to Orange Court House and then to Charlottesville, a purpose which we are confident will promote the interests of your City and the counties along the line of our Road and for which we are sure we do not miscalculate when we say we expect your sympathy and cooperation We have conferred with Gov'r Marye, who with his known devotion to your local interest approves our plan for the future work to be done, [blank] We propose to hold a more formal and important Corporate meeting here on the 22^d February next, when we trust we shall have the pleasure of meeting you and stating somewhat in detail what we hope and expect soon to accomplish toward the final construction of the road. We have the fullest confidence and expectation that this result will occur in a few months "Fredericksburg, Jan'y 30th 1872"

After reading the communication, the mayor state that Mess'rs Walker and Terry were present and [Page 98] would like to address the Council in regard to their connection with and their plans for the completion of the Road (These gentlemen were introduced by Geo Marye)

Mr Walker was on Motion heard in reference to the plans of himself and associates respecting the Fred'g & G R Rd

Mr Conway submitted the following

Resolved that a committee of three members of this Council be appointed by the Mayor whose duty it shall be to meet with the parties claiming to have purchased under the foreclosure of the mortgage of the F & G R Rd Co in New York on the 28th of December 1871 and proposing to complete said road and to protect the interest of this Corporation in any Matter regarding said Rail Road, and report to the Council from time to time the action necessary for the Council to take in said matters.

Which being seconded and the vote being taken by Ayes & Noes it was adopted by the following vote Ayes Messrs Conway, Little, Hurkamp, Bowering, Sener, Russell, Shepherd, Magrath 8
Noes Messrs Doggett, McCracken 2

The Mayor appointed Mess'rs Conway, Little and Russell as the Committee Mr M Slaughter, President of the Fred'g & Gordonsville Rail Road Co being present was on Motion, requested to be heard and Mr S stated [Page 99] for the information of the Council that the person

claiming to have purchased the Fred'g & G R Rd did not recognize the President & Directors present of said Co, or the existence of such a Company

Whereupon Mr A Little submitted the following which was unanimously adopted

Whereas we have received with unfeigned sorrow, the information of the death of Mrs Elizabeth Hurkamp, the estimable wife of our fellow Councilman, Mr John Hurkamp, and sincerely sympathize with our afflicted brother in his sad bereavement.

Resolved that as an expression of our sympathy with our friend and fellow Councilman in his affliction we will attend as a body the funeral of Mrs Hurkamp to take place this morning at 11 o'clock from the Presbyterian Church.

Resolved that a copy of these proceedings be furnished Mr Hurkamp, and that the same be published in the papers of the town.

Mr Conway, Chrmn of the Committee appointed at a meeting held on 31st January to confer with the parties claiming to have purchased the Fred'g & Gordonsville Rail Road at the sale on 28th December last, stated that the Committee desired to make a report; He reported (orally) that upon conferring together the Committee were unanimously of the opinion that the original Stockholders of the Fred'g & Gordonsville Rail Road Co held the right to the road, but notwithstanding this, he was satisfied that the Council desired to throw no obstacle in the way of the new company, toward carrying out their plans of completing the Road to Orange Court house and then to Charlottesville as they propose. The committee, however, deemed it important in view of past experience and action that such security should be required as a forfeit in the event of failure to complete the road within the time to be fixed upon, the Committee had a conference with Lieut Gov Marye, representing the parties interested and informed him what would be insisted upon, before the co-operation of the Council could be had in their efforts to procure the legislative action desired, [Page 102]

Gov Marye stated that he feared the parties would object to giving the security asked, but that he would communicate the views of the Committee and inform them of the result.

Mr C stated that Gov Marye had heard from the parties interested and their response in the view of the Committee was much more favorable than anticipated; Instead of personal security the parties propose to turn over the Road and franchises to the original Stockholders in the event of their failure to complete the work by a given time and they further propose that this condition shall be inserted as an amendment to an act the New Co is now seeking to have passed in the Legislature.

The Committee congratulated the Council upon this result; Mr Conway then read the paper containing the proposition of the parties submitted through Lieut Gov Marye, which is in the following words; If said Fredericksburg, Orange, and Charlottesville Rail Road Company shall fail to complete the said Rail Road from the Town of Fredericksburg as far as Orange C H with a single track equal in point of work, materials and adaption for travel and transportation of merchandise to either of the Rail Roads connecting with said track, and erect Depots along said track suitable for accommodation of travels and freight consisting of one Depot at each terminus of the Road and not less than four intermediate Depots on or before the first day of May in the Year 1873, the said Company [Page 103] shall forfeit to the State of Virginia, their Corporate rights, and franchise, together with the said Rail Road Track, Road Bed, and all work and materials thereon and all other property of said Company; and the State of Virginia shall thereupon have right to enter upon and take possession of said Rail Road tracts, Bed and Materials thereon (and hold the same as Trustee for the benefit of the said State of Virginia, the Corporation of Fredericksburg and the private Stockholders in the proportion of their original subscriptions to said stock of Fredericksburg & G R Road)

This act shall not be in force until said Company shall file in the office of the Board of Public Works of Virginia the acceptance of the same with its conditions to be signed by the President and Secretary of said Company with the Common Seal of said Company affixed thereto.

Lieut Gov Marye being present was on Motion heard in reference to the matter under consideration. Messrs J B Sener, St Geo R Fitzhugh and M Slaughter were also present and Motion were heard.

On Motion, of Mr McCracken, the consideration of the subject of the report of the Committee was postponed until Tuesday, Feb'y 13th 1872

And then the Council adjourned until Tuesday next 13th Inst. L B Rose, Mayor [Page 104]

The minutes of the last meeting were read, Mr Conway objected to that portion of same referring to the report made by him as inaccurate in part and stated that he would tonight submit a written report

Mr Conway, Chairman of the Committee appointed at the Meeting held on 31t January 1872 submitted a written report which he read and is in the following words

The undersigned, a committee appointed by the Common Council by its resolution adopted the 31st January 1872 (appended hereto) respectfully report that your Committee held a meeting the morning after their said appointment and took into consideration the important matters submitted to them. Your

Committee were fully aware that it was indispensable to the success of the said purchasers in their enterprise of completing said Rail Road, that their title to the same should be free from doubt or embarrassment; and further that it was necessary to said enterprise that said purchasers should obtain an Act of the General Assembly extending [Page 105] the Charter of the Company organized by said Assembly and authorizing said Company to create a Mortgage upon said Road in order to raise the moneys necessary for such completion, Your committee were further aware that the assent and cooperation of this Council was necessary in order to clear up the title and to procure the said legislation; your Committee had reason to believe that the said purchasers at the Mortgage sale (so far as those arising therefrom were concerned who held a contributing interest and power over the action of the said purchasers were men of substance and good standing in their respective communities, and your Committee had reason to believe that it was the purpose of said purchasers to proceed with energy on the work with a view to its ultimate extension to Charlottesville.

Yet while there appeared to be a favorable prospect for the prosecution of this improvement so vital to the welfare of Fredericksburg and a large section of the Country, it was nevertheless subject of gravest concern to your Committee to how to extend and at the same time obtain satisfactory security in behalf of Fredericksburg to protect her interests against a possible failure on the part of said purchasers to complete said Rail Road within a reasonable time, Your Committee considered and conferred upon several modes of providing such a security and condition to recommend one which they thought said purchasers might reasonably accept, Facts have occurred [Page 106] which make it needless for your committee to state formally in this report, what that plan for security was, they deem it sufficient to state that at their request the character of the security proposed was made known to said purchasers and that on the evening of the 10th Inst the Counsel for the said purchasers placed in the hands of your Committee a proposition in writing from said purchasers to provide a guaranty and security for the completion of the Road with the authority to the Committee to tender it to the Council. Your Committee having no time to make their report to the Council in writing before the meeting of the Council on the same night, submitted the said proposition with such oral statements as they deemed necessary.

The written proposition is before your body and your Committee desires it to be considered a part of the report, It will be perceived that this proposition agrees that a provision shall be inserted in the body of the Act of Assembly asking for extending the Charter and authorizing the mortgage creating the fundamental condition, that in case said Rail Road be not completed to Orange Court House on or before the 1st day of May 1873, the entire Rail Road work and materials and all the property rights & franchises of said company shall on that day be forfeited to the State of Virginia as a Trustee for herself and the Co Stockholders with the State, in the Stock of the original Fredericksburg & Gordonsville Rail Road Company with power to the State to enter upon and take possession of the said Rail Road and other property. Your Committee after full & mature [Page 107] consideration express it as their decided judgment that the said proposition provides a firm and sure guarantee upon the basis of which this Council and the entire Community may rest with safety and should act cordially in furnishing the said purchasers all practicable aid and co-operation in obtaining the legislation which they ask concerning the extension of the Charter and the creation of a Mortgage; and your Committee would esteem it as very impolitic to seek to affix, or prescribe any further conditions beyond the ample guaranty contained in said proposition, Your Committee do not regard it necessary to present in this report their reasons at length for depreciating the policy of seeking to prescribe additional conditions; they content themselves with stating that such a course of action would in the decided opinion of your Committee tend seriously to delay and might end in the defeat of an early prosecution of the work to its completion, if not defeat it altogether. Your committee therefore recommend the adoption of the following resolutions

First, That Charles Herndon, Esq'r State Senator and J Harrison Kelly Esq'r, Delegate in the Gen'l Assembly be respectfully requested to use all proper efforts to procure at the present session of the Legislature the passage of the Act (as asked for by said purchasers) extending the Charter of the Fred'g, Orange & Charlottesville Railroad Co and authorizing the creation of a Mortgage of said Rail Raod by said Company

Provided that the said written proposition of [Page 108] security for the completion of the said Rail Road to Orange Court House (so tendered by said purchasers and now accepted by this Council) be incorporated as part of said act.

Second. That a copy of the proceedings be furnished by the Clerk of the Council to Charles Herndon Esq'r and to J H Kelly Esq'r without delay

Mr Conway moved the adoption of the report of the Committee, which was seconded by Mr Little Dr Wallace moved the following as a substitute which was seconded.

The Common Council of the Town of Fredericksburg, Va are anxious for the Completion of the Fredericksburg, Orange and Charlottesville Rail Road to Orange Court House and desire that no obstacle shall be thrown in the way of the new management in all proper efforts for that purpose; yet they deem it a duty they owe to the people of Fredericksburg and along the line of the Road to provide by legislation such just and not possibly objectionable restrictions and limitations as will secure for the bonds, which the Company propose to raise by a Mortgage on its works and franchises a proper price in the finances, markets, by giving to the bond purchasers legislative assurances that the funds derived from the sales thereof will be duly applied to the building of the said road, as raised, thus insuring not only the Completion of said Road, but satisfying any such and all contractors that they may reasonably calculate upon their estimates as their work progresses, by a judicious sale of the bonds so authorized [Page 109] to be issued: Therefore

Be it resolved by the Council of Fredericksburg, that the Legislature be requested to grant the Fredericksburg, Orange and Charlottesville Rail Road a Charter to build their Road and authorizing there under effect a loan upon a Mortgage at a rate of interest not exceeding say ten per cent, but with the following proviso to wit: that the said company shall issue upon the Road bed as now built, Bonds not exceeding say seventy five thousand dollars, and upon each and every additional mile, beginning at a point say seventeen miles from Fredericksburg Va, when completed by them or the Company organized by, through or under them, a sum not exceeding twenty five thousand dollars until the road shall reach Orange Court House, and shall be properly equipped; Thus the Company may make such further issues of its bonds as to it shall seem best, and provided further that the said additional sum of twenty five thousand dollars for each mile of railway shall not be issued until the Chief Engineer of said Road and the Finance Committee of the Town of Fredericksburg shall jointly certify that so many miles of miles of said Road have been built as it may be proposed to issue bonds for, and Provided further that work on said Road under the provisions of this Charter shall be commenced by the first day of July 1874 and be completed to Orange Court House by the first day of September 1873.

This act shall not be in force until said Company shall have filed in the office of Public Works of Virginia their necessary [Page 110] of the same with its conditions, to be signed by the President and Secretary of said Company with the Common Seal of said Company affixed thereto.

The following is the address of Mayor Berrey to the Council in assuming the duties of his office and which by resolution was ordered to be spread upon the Minutes of the Council Gentlemen of the Common Council,

In entering upon the duties of the office to which I have been called by my fellow citizens, I feel some distrust or distrust as to my ability to discharge these duties in such a manner as well best promote the interests of our town, and make my administration a success. I cannot do this by any effort of my own solely, but I am sure that with the co-operation of these Gentlemen of enlarged experience who have so faithfully heretofore represented and protected the various interests of the Corporation I need have no serious misgivings as to the result. On yesterday under favorable auspices I entered upon my duties as Mayor of this Corporation with the full determination to give freely of my time and to bring to bear what talent I may possess to a faithful, impartial and conscientious discharge of the same, as the chief executive officer of this Town I will see that the Law and Ordinances are strictly enforced and that the officers who are charged with the enforcement of them are diligent in the discharge of their duties, and if there are ordinances which have become inoperative through the changes of the times or other causes I will recommend their repeal and if I find the Ordinances defective in any particular I will bring the fact to your notice that you may devise such remedy as the case requires.

I will endeavor to intelligently perform [Page 139] perform all the duties prescribed, but will give special attention to a thorough review of the Streets for the purposes named in the prescribed duties of the mayor. As the presiding officer of your honorable body I feel it my duty to familiarize myself with the rule adopted for the government thereof, I will endeavor to be punctual in my attendance at your meetings, prompt in my rulings, impartial in my decisions, and courteous in my intercourse with the members of the Council

With my limited experience in deliberative bodies, I feel it due to myself to ask the aid of those who by age and experience are capable of giving advice so that I may better qualify myself for the responsibilities I have assumed and that the business of the Council may not be retarded by want of experience on my part.

Disclaiming any intention of indulging in fulsome compliments, I take great pleasure however in congratulating the members of the present Council who were re-elected upon receiving this merited

tribute to the zeal and fidelity with which they discharged their responsible duties last year, and feel sure that for the present year their zeal will not abate and that the interests of the Corporation will not suffer at their hands, It is a cause of congratulations too that in the election of new members we have been so fortunate as to secure the services of two gentlemen so eminently qualified for the high trust committed to them.

In the arrangement of the Standing Committees I have been influenced by no other consideration than that of the general interests of the town

In recognition of the valuable services rendered the Corporation by the Standing Committees of [Page 140] the old council I have kept them intact except when necessary to fill vacancies, But two changes have been made at all, and these were imperative—the necessity for which I think will be recognized by the Council.

I have as briefly as possible indicated my purposes and expectations, and it only remains for me in conclusion to again earnestly invoke your hearty support and co-operation in originating and carrying out such measures as will conduce to the welfare of our Town and the health and comfort of our citizens. - 6th On all male Dogs one dollar and on all female dogs two dollars
- 7th One third of the said taxes shall be paid in National Currency of the United States, and two thirds in past due Coupons, or past due interest on the Registered Bonds of the Town of Fredericksburg or the Tax payer may at his option pay the said two thirds of his taxes in National Currency of the United States at the rate of sixty cents (60) in the dollar.

The Committee on the subject of the provision for the poor of the Town, respectfully report that they have given much thought to the subject, Grave evils existed for some years in maintaining the poor.

The superintendancy has been inefficient and the system unnecessarily costly; calling for reform in both,

The superintendancy has been inefficient and the system unnecessarily costly; calling for reform in both, under our present ordinance and be accord between the overseers of the poor and the Finance Committee & monthly statements of expenditures your committee have strong hopes that the poor will be maintained better than formerly and at less costs.

Your Committee are decidedly of opinion that the present poor house ought to be discontinued as unnecessary and costly, there being at this time but three inmates involving large outlays for rent, fuel, & wages.

Secondly, we think the overseers ought personally to furnish nothing to the Poor, but obtain what is needful from others at the lowest practicable cost.

Your Committee will not make any other specific recommendations, a great deal will depend on the intelligence and the fidelity of the overseers to be appointed by your body.

Your Committee hopes much from that new departure from the old system. The expenditures for the month of July which were audited by the Finance Committee and ordered to be paid were greatly less than for the corresponding month of last year and about one half of the average for the year. It is too much to suppose that the expenditures will continued to be at this rate, but we confidently expect a decided change for the better.

Mr Russell, Chairman of the Street Committee to whom was referred the memorial of sundry citizens of the Lower Ward and also the Communication of J G Read, Corporation Surveyor, submitted the following report which on Motion, was received and unanimously adopted to wit:

To the Mayor and Common Council of Fredericksburg, Gentlemen

Your Committee on Streets to whom was referred the report of the Corporation Surveyor Mr Read beg leave to offer the following report of their action.

In compliance with the request of Mr Read we went with him and examined the lines of Ferdinand and Dunmore Streets which we found as reported by him to be undefined. After running several lines and making numerous measurements, Mr Read satisfied your Committee that the width of Dunmore St was intended to be and should be forty feet and the width of Ferdinand Street 57 2/10th feet. This Street we supposed had been laid out originally 60 [Page 162] feet wide, but owing to the fact of their being a good brick house on either side of it, your committee thought it best to leave it at 57 2/10ths feet as it now measures, Running the lines of the two streets at these ascertained widths, a corner was found at their intersections which your surveyor and Committee agreed upon as the proper place for it. Your committee beg leave to report also upon the petition of sundry citizens and property holders of the lower ware as to the condition of Charles St. Having viewed that portion of the Street complained of your committee decided to put a trunk in the street there so as to make a good crossing at all times and give as much improvement to the Street as the condition of our treasury would admit of Signed Wm H Russell, L O Magrath, Benj'n Bowering, Street Committee

The Mayor read a communication from Chas E Bragdon, Harbor Master, calling the attention of the Council to the unsafe condition of Grinnan's wharf, the property of the late Dr B R Wellford and intimating that unless the property is soon repaired the wharf would in his judgment give way and serious damage would be done thereby to the navigation of the River.

On Motion, Mr Sener,

Resolved that the Mayor be requested to communicate with the representatives of the late Dr B R Wellford upon the subject of the condition of the wharf property referred to in the Communication of the Harbor Master, and request that immediate steps be taken to place the wharf in a safe condition. [Page 163]

A communication from J G Read, Surveyor of the Corporation was read by the Mayor, in which he makes certain suggestions in order that the corners and lines of the streets may be better defined—referred to the Committee on Streets

Mr Conway stated that the attorney for the owners of the lost Bonds, known as the "Hazel River Navigation Bonds" and to which the attention of the Council had been called previously desired now to have duplicate bonds issued in place of those lost, he having taking the necessary legal steps in the premises by advertising &c

By consent of the Council, Mr C W Wallace, owner of the Bonds was heard upon the subject Mr Conway submitted the following, which was seconded

It appearing that the Bonds known as the Hazel River bonds amounting to the sum of \$10,000 as numbered and described in the advertisement hereinafter mentioned have been lost and that the loss of the same has been duly advertised for three months in the *Virginia Herald*, the liability of the Corporation for their payment having been ascertained in a suit and judgment for interest, it is hereby ordered that there be issued duplicates of said bonds, payable to Hazel River Company; and to be signed by the Mayor and Treasurer, but before the same are issued, the said Hazel River Company, or some one for them shall give a bond with security to be approved by the Finance Committee in the penalty of \$15,000, conditioned to protect and save harm by the Corporation of Fredericksburg, and all other parties interested from any legal loss or damages resulting from the re-issue of said bonds, But the Treasurer shall endorse as a credit all interest which has been paid or recovered by judgment or otherwise.

The vote being taken upon the passage [Page 164] of the order it was adopted by the following vote Ayes Mess'rs Conway, Bowering, Wallace, Sener, Russell, Doggett, Magrath, & McCracken

Noes none

The Mayor having reported favorably, it was ordered that the salaries of the police officers for the present quarter ending October 1st be paid

On Motion, Dr Wallace

Ordered that Chapter 46 of the Gen'l Ordinance be amended in this, that the words "and fifty cents" in the 6th line of said Chapter be stricken out, so that the last clause of the same shall read,

"and for every such attestation a tax of one dollar shall be paid to the Mayor for the use and benefit of this Corporation."

Mr Doggett presented an application of the "Greeley and Brown Club" of this place for the use of the Court House for two nights in each week rented 5ht November, for the consideration of twenty five dollars.

Mr St Geo R Fitzhugh, being present he was by consent of the Council heard in advocacy of the application.

On motion, Mr Conway, the subject was postponed until Monday evening next 30th Inst.

On motion Mr Sener the Council the adjourned until Monday 30th Inst

Mr McCracken moved as a substitute that three dollars be inserted in place of five which was also seconded & whereupon Dr Wallace moved as a substitute for the whole

That the ordinance concerning the use of the amendment passed Aug 22d 1871 and the amendment passed Septm'r 21 1871 be repealed and the whole matter indefinitely postponed which being seconded and the Yeas & Nays called for the substitute of Dr Wallace was lost by the following vote

That hereafter the Court House shall not be opened for public meetings by the keeper thereof until permission to use the same shall be obtained in writing from the Mayor by the person or persons desiring to use the same and also a certificate from the Town Treasurer showing that the said person or persons have paid into the Town Treasury the sum of Four dollars to pay for gas and cleaning for each night the Court House may be so used, and any [Page 167] person or persons obtaining such permission shall be responsible for all damages by such usage

The vote being taken by Ayes & Notes, the resolution of Mr Conway was adopted by the following vote:

The memorial of John M Robinson, President of the Richmond, Fredericksburg, and Potomac Rail road Company asking to be released from the payment of City taxes on any property of the company used in connection with the purposes for which it was Chartered was presented to the Council at its last session and an order entered suspending the collection of all taxes assessed against the said Company until the subject could be investigated and it now appearing that the sum of seventy five dollars is assessed upon the depot and other buildings which are necessary to the company for their purposes under their charter, is exempt from taxation by law, it is ordered that the said sum be released [Page 171] and deducted for the tax account against the said company and that the collector of taxes do proceed to collect the taxes assessed upon the other property owned by the said company in this Corporation not used in connection with the purpose of the said Charter.

On Motion, Dr Wallace

Resolved that the report of the Committee be received and the committee discharged and that the clerk be directed to enter the report of the Committee upon the minutes of the Council

Mr Doggett by unanimous consent of the Council withdrew the resolution offered by him at the last meeting

The Mayor presented the following communication from Daniel E Davenport, Supt Fredericksburg, Orange & Charlottesville Rail Road Co, which was read and is in the following words, to wit: To the Common Council of the Town of Fredericksburg

The undersigned Daniel E Davenport (acting for himself and for his associates who have contracted with the Fredericksburg, Orange, and Charlottesville Rail Road Company to build said Road to Orange Court House, and who will be the owners of all the Capital Stocks of said Company, when they have performed said contract) respectfully represent to your honorable body that in order to render said Rail Road when constructed a productive improvement in the way of inducing freight and travel upon it, it is desirable to

obtain such connections for the same both terminal points as well enable said [Page 172] to put both travels and freight in cheap, certain, and advantageous access to the Northern and Eastern cities. In pursuance of this obvious policy the undersigned have in view making a connection with a Rail road to be built from Fredericksburg to Mathias Point on the Potomac River; from a point opposite the Maryland side a rail road is already built and is now running to Baltimore.

In order to make this connection it is necessary for the Fredericksburg, Orange and Charlottesville R Rd Co to have the privilege of extending its Rail Road from its present depot at Fredericksburg to the Rappahannock River with a view to a Railroad bridge across said River at a point above the site of the present Rail Road bridge. The undersigned now respectfully request your honorable body to grant this right of way through one of the streets of Fredericksburg to the said Company under such provisions and policies regulations as are just and right.

The undersigned are willing to accept said privilege under reasonable limitations of time as to the actual building of the proposed extension. They will build and maintain their machine car, and other shops at Fredericksburg, which fact should be an inducement to grant the facilities asked,

Mr Little offered the following resolution which was unanimously adopted

Resolved that the Council will cheerfully grant to right of way asked for by the contractors of the Fredericksburg Orange and Charlottesville Company, through Prussia or [Page 172] one of the Streets of the town to the Rappahannock River upon proper terms and conditions guarding the interests of the Corporation and citizens and the petition of said contractors is hereby referred to a committee of the Council who are instructed to agree upon the term s and conditions of said grant, and to report said agreement to a future meeting of this Council for confirmation and final action

The Mayor appointed Mess'rs W A Little, H S Doggett & W H Russell as the Committee

The Mayor presented a plot and survey of a lot formerly owned by Robert Evan's Est, which was sold for taxes in the year 1868 to Mr John Tayloe and by him assigned on 16th September 1871 to Page Rollins, and it appearing to the Council that the said plot and survey is made out by the Corporation Surveyor in accordance with Section 7 Chapter 37 of the Ordinance of the Corporation, On motion of Mr Conway the same is ordered to be recorded.

An account of Mess'r Sener, Couse, & Hunt for services in the election in May last and for printing "usury tickets, amt'g to \$14.00 was presented by the Mayor and On Motion, Mr McCracken referred to the Finance Committee.

A Motion of Dr Wallace.

Resolved that the Pump Committee if in their judgment they deed it necessary be authorized to erect a new pump on Liberty Street at such locality as in their discretion they may consider it best for the accommodation of the citizens
