## Fredericksburg City Council Minutes 1874

At a regular Meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber on Tuesday January 27<sup>th</sup> 1874

The Minutes of the last Meeting were read and approved

Mr Conway, Chrmn of the Finance Committee to whom was referred the account of the Fred'g Cemetery Co., stated that the Committee had examined into the matter and were of opinion that the account was correct and recommended its payment

On Motion, the account of the Fred'g Cemetery Co. for tax of Lot Belonging to the Corporation in the Fredericksburg Cemetery for twenty years amounting to Twenty dollars was ordered to be paid Present J G Mason

Mr Conway, Chrmn of the Finance Committee presented the following accounts which were passed and ordered to be paid, Viz:

W J Moon for carrying returns of Election to Spotsylvania CH in 1871	\$4.00
R B Merchant for advertising amt'g	\$18.50
J W Adams for Stationary amt'g to	\$35.23

Mr Mason one of the proxies appointed by the Council to represent the Stock of the Corporation in the Stockholders Meeting of the Fred'g & Gordonsville Rail Road Co stated that [Page 259] the Meeting was held on 5<sup>th</sup> January and the organization completed and as was known to the Council one Member of this body was elected President and three others Directors of the Company; no other business was transacted and the meeting adjourned to Jan'ry this day; the adjourned Meeting was held and again adjourned to meet on 13<sup>th</sup> Feb'y proxima. It was stated in the Meeting today that a communication had been received from Judge Hughes, representing the stakeholders of the late organization that it was impossible for him to be present, and the Meeting was adjourned in order that these parties might confer with the present Co in reference to the Completion of the Road.

Mr Bowering, Chrmn of the Street Committee to whom was referred the complaint of Mr Thomas Manuel of the enclosing of "Mint Spring" by Mr A K Phillips, submitted the following reports:

To the Hon Mayor & Council of Fredericksburg, your committee to whom was referred the complaint of Thos Manuel Esq'r of the enclosing of "Mint Spring" by A K Phillips Esq'r respectfully reports that they find that in June 1854 a number of the Citizens of the Town to wit: John S Caldwell, Peter Goolrick, Jas W Ford, C M Brown, Thos Manuel, E McDowell, Jno E Foster & Geo F Chew, purchased of John Howison a tract of land containing over one hundred acres embraced with the limits of the plat afterwards made by Wm Sneeden, Civil Engineer a copy of which is herewith returned, on which is situated said Mint Spring, afterwards to wit: in 1856 said parties Caldwell &c had a part of their said purchase laid off in lots and streets by said Sneeden and sold said lots to various parties, [Page 260] Lot 43 which adjoins "Spring Street" out of about the center of the centre of the south eastern part of which said Spring issues, being sold to A P Rowe and conveyed by deed dated July 1856, and lot 44, which lies on the other side of said Spring Street being sold and conveyed to A K Phillips by deed dated July 1856, In July 1857, the same parties conveyed to said A P Rowe & A K Phillips two other lots laid out on the same plat made by Sneeden, and in the same deed is the conveyance of "also all the right, title, and interest of the parties of

the first part (said Caldwell & others) to surplus & waste water of the Mint Spring that issues from the land that was purchased by the said parties of the first part from John Howison"

All the deeds describing the boundaries of the lots conveyed by these parties describe them by referring to the Map made by said Sneeden

Said map is of record in the Corporation Court of Fredericksburg

Buildings have been erected upon several of the lots so sold by said Caldwell & others, but none so far as your committee know have ever been erected upon either lot 43 or 44;

Your Committee are informed that when these lots were sold it was with the understanding that the said Streets as laid off by said Sneeden were to be for common benefit as was also the said Spring,

By Act of Assembly passed 28<sup>th</sup> March 1851 the Corporate Limits of the Town were extended so as to embrace the land of nearly all the lots and all of the Streets so laid off by Sneeden and there is contained in said Act this clause or proviso: "Provided however that nothing herein contained shall be [Page 261] construed to prevent the owners of land within the Corporate limits of said Town from opening such streets as they may deem proper upon their own lands."

Your Committee further find that under the direction of the this Council on the Town Colo C M Braxton, then Corporation Surveyor in April 1867 made a Map of the Town laying off the lots and Streets of that part of it, laid off by said Sneeden, as per Sneeden's Map, and returned his said Map to said Council, which accepted the same and that names of the Streets so set off in said plat of Sneeden have been used as streets and some of them worked by the Corporation. But as yet there has been no distinct use of said Spring Street, as the whole ground round above it was all unenclosed

Your Committee further state that they find upon inspection of said Spring and the ground about that it is now enclosed by a fence running entirely across said Spring St, where it comes into Frederick Street and on the side next the F & G R Rd, and is as it were thrown into the lots on either side of it which once enclosed by a fence some five feet high on all sides

Your Committee have concluded from their investigation that said Spring Street as well as the other Streets laid out in Said Sneeden Map and transferred to Colo Braxton's Map are Streets belonging to the Corporation and that the said laid Mint Spring was also intended for the public use and devised to the Town and they respectfully recommend that for the purpose of preventing further misunderstanding and difficulty said street be expressly declared to be the streets of the Town, and that proper proceedings [Page 262] be taken for procuring the removal of the fence which has been placed across said Spring Street

All of which is respectfully submitted Signed Benj'n Bowering L O Magrath J G Mason

On Motion Mr McCracken, the report of the Committee was adopted

Mr Mason submitted the following which was adopted

Resolved that for the purpose of removing all doubts and misunderstanding as to the Streets laid off in the plot or Map made by Wm Sneeden, Civil Engineer in June 1856, of record in the Corporation Court of Fredericksburg, the Council doth declare that the Streets laid off as per said plat on Map have been and are regarded and held as Streets of the Town.

Resolved 2<sup>nd</sup> That the Mayor be instructed to notify A K Phillips Esq'r that he must forthwith remove the fence placed by him across both ends of "Spring Street"

The Mayor presented in writing the resignation of Jas W Sener, Esq'r, Recorder and member of the Council

On Motion, Mr Little, the resignation of Mr Sener was accepted

On Motion, Mr Magrath; Resolved that the Council now proceed to the election of a Recorder to fill the vacancy occasioned by the resignation of Mr Sener.

Mr Hugh S Doggett was nominated, balloted and unanimously elected Recorder in place of Mr Sener resigned. [Page 263]

The Mayor administered the oath of office to Mr Doggett and he took his seat as Recorder at the Board On Motion Mr Conway; Resolved that the Council do now adjourn subject to the call of the Mayor Rob't B Berrey, Mayor

The Mayor requested Mess'rs McCracken & Magrath to wait on Mr Hurkamp and inform him of his election and to request his presence at the Council Chambers

The Committee returned with Mr Hurkamp, the Mayor administered the oath of office to Mr John G Hurkamp, Councilman elect and he took his seat at the table

Present: John G Hurkamp

On Motion: The rule passed restricting the action of the Council to the business for which it was called was suspended for the present meeting

The Mayor presented in writing the resignation of Mr S J Quinn, as a member of the Board of Trustees of Public Schools

Mr Quinn being present, on Motion was heard stating his reasons for his resignation

#### On Motion Mr Hurkamp,

Resolved that the matter of the resignation of S J Quinn as a member of the Board of Trustees of Public Schools be referred to a Committee of three of the Council to examine into the same and report at the next regular meeting and that Mr Quinn be requested to continue in office for the present.

The Mayor appointed Mess'rs Hurkamp, Little & Doggett as the Committee The Council then adjourned Rob't B Berrey, Mayor [Page 266]

Mr Hurkamp from the Committee to whom was referred the matter of the resignation of S J Quinn as a member of the Board of Trustees of Public Schools reported verbally that in the opinion of the Committee Mr Quinn could not act as a Trustee while holding an Office under the United States Government.

The Mayor read a Communication signed by the teachers of the Public Schools expressing regret at the resignation of Mr Quinn and requesting that no action be taken upon the same for the present

On Motion of Mr Conway, the report of the Committee was accepted and the Committee discharged Present: C E Hunter

The Council then proceeded to the election of a Trustee of Public Schools to fill the vacancy occasioned by the resignation of Mr Quinn, When Rev'd J P Smith and Mr A B Bowering were nominated and the vote taken by Ballot and the ballots counted resulted as follows:

For Rev'd J P Smith 3 For Mr A B Bowering 7

So, Mr Bowering having received [Page 267] the majority of the votes cast was declared elected a member of the Board of Trustees of Public Schools for the unexpired term of S J Quinn resigned

Mr Conway presented for the examination of the Council, a plot and certificate of Survey of a parcel of land, sold for taxes by the late L J Huffman, Collector of Taxes, belonging to the late George Aler and purchased by John T Knight who now desired that the usual order be entered upon the minutes of the Council in accordance with the Ordinance of the Corporation

Mr W H Fitzhugh, being present, was on Motion heard in behalf of Mr Knight in reference to the matter presented by Mr Conway

On Motion of Mr Doggett

Resolved: that action upon the application of Mr Knight be postponed until the next regular meeting of the Council.

On account of J A Taylor, amt'g to \$6.00 was presented and on Motion referred to the Finance Committee Mr McCracken submitted the following preamble and Resolution which were unanimously adopted Whereas a committee from Congress will visit our City about the 7<sup>th</sup> of March next to report upon the unfinished monument to Mary the Mother of Washington

Be it resolved that the Mayor appoint a Committee of three on the part of the Council with the Mayor added and three of our citizens to make all the necessary arrangements to entertaining the Congressional Committee with any friends or reporters of the press that may accompany said Committee [Page 268]

Resolved that the Treasurer of the Corporation be directed to pay on the order of the said Committee so appointed by the Mayor the amount expended in entertaining the said Committee and friends while the guests of this City

Mr Hurkamp presented the following which was adopted

Whereas we are informed that the Fred'g Gas Company, which it is very important to the well being of the Community and the proper lighting of our Churches and Public Buildings should be sustained, will probably be compelled to suspend its operations because of the insufficient support afforded it by the citizens and Whereas the use of Gas in lighting the Streets of the Town even to a limited extent, if contracted for by the Council may enable the said Gas Co to maintain itself and continue its operations; Therefore Resolved, that a Committee of three be appointed to confer with the Gas Co and ascertain on what terms and to what extent it will contract with the Council for lighting the Streets of the Town with gas

The Mayor appointed Mess'rs W A Little, C E Hunter, J H Myer as the Committee

An account of L B Rose & B S Herndon amt'g to \$10.00 was read and ordered to be paid

The Council then adjourned

Resolved that the Pump Committee be authorized to erect a pump at the upper end of Princess Anne St in such location as they may deem advisable.

Mr Little from this Committee appointed by the Council to confer with the Gas Co upon the subject of Lighting the Streets was gas, stated that the Committee were not yet prepared to report as the Committee were informed that the Gas Co would probably soon have a new organization and they deemed it best to confer with the parties who would then have charge.

A Communication from S J Quinn late Comm'r of Revenue was read stating that Mr McDonnell was charged with the tax on a Dog, which he thought should be refunded as the Dog died on January last. [Page 270]

On Motion Mr Conway, Ordered that Mr McDonnell be relieved of the tax on his dog and if the tax has been paid, the Collector of taxes is directed to refund to Mr McDonnell the amount paid

On Motion Mr Conway

Ordered that the license tax on Drays, Carts and Wagons for the Year ending 1<sup>st</sup> day of April 1875 be fixed as follows:

On Drays and Carts Five 50/100 dollars
On Wagons Eleven dollars

Mr Little presented and read a paper placed in his hands by the Board of Directors of the Fred'g & Gordonsville Rail Road Company which is embodied in the following resolution offered by him and duly seconded

Resolved that we hereby agree to transfer the Stock of the Corporation of Fredericksburg in the Fredericksburg and Gordonsville Rail Road Co to such parties as may contract with the Directors of said Company for its completion, and actually complete the same according to the terms and conditions of the proposition now submitted to the Council by the Board of Directors and which is in the following words to wit:

The undersigned Stockholders of the Fredericksburg and Gordonsville Rail Road Company do hereby agree and bind themselves to assign transfer and surrender at the price of one cent per share the respective shares of the Capital Stock of said Company owned and held by us severally unto such person or persons as shall under and by virtue of a contract [Page 273] made with the Board of Directors of said Company actually construct and complete said Rail Road to Orange Court House and Gordonsville

This Agreement is to be held and kept by said Board of Directors, and not rights or privileges under it shall accrue or become effectual until said completion is actually performed, and we authorize constitute and appoint the said Board of Directors our attorneys in fact to transfer and assign our said shares of Stock unto the parties who shall so contract for and complete the construction of said Road when the completion of said Road actually occurs"

And we hereby authorize and instruct the Mayor to execute said paper on the part of the Corporation and deliver the same to said Board of Directors

Dr Wallace moved to amend the resolution of Mr Little by inserting after the word same (in the 6<sup>th</sup> line) the words "by the 1st day of October 1876" Which motion was seconded and the vote taken by Ayes and Noes and it was lost by the following vote:

This agreement is to be held and kept by said Board of Directors, and no rights or privileges under it shall accrue or become effectual until said completion is actually performed, and we authorize, constitute and appoint the said Board of Directors our attorneys in fact to transfer and assign our said shares of stock unto the parties who shall so contract for and complete the construction of said road, when the completion of said Road actually occurs."

Mr Mason moved as an amendment "Provided that the said Directors shall make no contract for the completion of said Road to Orange C H for a longer period than one year from this date, which was seconded and the vote taken by Ayes and Noes and it was lost by the following vote:

The following parties make application to the Council for relief from the Dog Tax assessed against them Mr Richard Bozel assessed with two males & female. The Dogs belonged to Mr Bozel and were taken to Washington about the time of assessment and left. This last fact I know to be true.

Walker Howard and John Turner, colored assessed with one each, did not own a dog at the time they were assessed, This is concurred in by their families who I have seen.

W S Perrey was assessed with a female dog which he killed two days after the assessment, but failed to report the fact [Page 279] and paid the taxes, witness having seen her killed informing Me of the fact and he being embarrassed by death in his family I refunded him the money believing the council would relieve him of the tax.

I believe that this statement made by each party are correct and would have reported some of the cases to the Council before this, but have been waiting to make this last and final application.

On application of Mrs E A Fitzgerald for the remission of the Tax of \$5200 U S Bonds erroneously assessed was on Motion referred to the Finance Committee

The Mayor reported in writing that the Police officers had discharged their duties faithfully for the present quarter, On Motion the Treasurer was directed to pay the Police Officers their salaries for the quarter ending 30<sup>th</sup> Inst

Mr Hurkamp, Chairman of the Pump Committee reported verbally that a contract had been made with Mr Pollard for keeping the pumps of the Corporation in good order for the sum of one hundred and fifty pr annum, all new work done by the contractor to be an additional charge

Present: J S Knox, Recorder, L O Magrath

Mr Conway, Chrmn of the Finance Committee to whom was referred the application of Mrs Connelly and Mrs Fitzgerald, stated that upon the application of Mrs Fitzgerald the Committee were not prepared to report at the present meeting; upon the application of Mrs C he reported that upon examination he found that Mrs C had been erroneously assessed with the tax on a Dog and that he directed the same to be erased from her tax bill

Present: W A Little

The Mayor stated that Colo Abert, U S Engineer who had charge of the work improving the Navigation of the Rappahannock at Fredericksburg contemplated the building [Page 310] of a Dkye [Dyke] on the South Side of the River between the Rail Road bridge and Wellford Wharf and having obtained in writing the Consent of the owners of the property along the line of the proposed work he desired the consideration or approval of the Council in the premises

Whereupon Mr Conway submitted the following resolution which was unanimously adopted Resolved that the Common Council of the Town of Fredericksburg approve and consent to the Building of a Dyke by the United States Government along the River front on the South side of the Rappahannock River between the points proposed by the Engineer, the owners of the property along said front having consented in writing to this building of the same

Mr J S Knox, Chrmn of the Street Committee to whom was referred the petition of Citizens for the opening of Prince Edward Street to Frederick Street, reported verbally that the Committee had given the subject proper consideration and as the work in their judgment would cost over one thousand dollars exclusive of land damages, they could not favour the prayer of the Petitioners

On Motion, Mr Conway, the verbal report of the Committee (through the Chairman) was received and the Committee discharged from further consideration of the subject

Resolved that the Mayor be authorized to offer a reward of one hundred dollars for the apprehension and delivery to the proper authorities the Negro who shot and wounded Sergeant C W Edrington while in the discharge of his duty

An Account of Jos Hazard amt'g to \$52.50 was presented and ordered to be paid

Mr Conway presented and read the receipts of the Treasurer of the delivery to him by A B Bowering, Commissioner of the Revenue the Land and Property Books of the Corpo and also lists of License and dog tax for 1874 which was directed to be filed

Mr Magrath moved that the Treasurer be directed to pay Mr Bowering his salary as Commissioner of the Revenue amt'g to two hundred and fifty dollars, which was seconded and the Yeas and Noes called for Mr Conway asked to be excused from voting and on Motion Mr Conway was excused

The vote then being taken upon Mr Magrath's motion it was adopted by the following vote Ayes Mess'rs Scott, Hurkamp, Bowering, Little, Knox, Hazard, Magrath, Thorburn 8 Noes Mess'r McCracken 1

Mr Conway gave notice that at the next regular meeting he would an amendment to Chapter 19 of the General Ordinance of the Corporation
