Resolved that the report of the Committee be received and that the same be published in one or more of the newspapers of the City and in pamphlet form as the Committee may determine

Mr Hazard, Chrmn of Gas Committee submitted a written report which was read also a proposal from Mr Fleming Supt of the Citizens Gas Co to light the Street lamps with Gas which was also read

On Motion the report of the Committee was received and filed [Page 172]

Mr Sener from the Finance Committee presented bills of *Fred'g News* for advertising amt'g to \$3.00 which were ordered to be paid.

Also the accounts of the overseer of the Poor for the Month of January amt'g to \$119.46 which were also ordered to be paid

Mr McCracken in the absence of the Chrmn of the Street Com, presented the report of the Committee upon the application of T McCracken to establish a Magazine for storing powder on his lot near the two Rail Roads, the Committee stating that the application of Mr Mc was granted

The Mayor stated that Mr Willis had been assigned to the Committee on Streets

A Memorial signed by a number of Citizens near the Rail Road protesting against the establishment of a powder magazine in this lot of Mr McCracken and praying the Council to rescind their action was presented and read

On Motion, Mr McCracken

Resolved that the memorial be referred to a special Committee to report at next meeting The Mayor appointed as the Committee the members of the Public Property Committee

Mr McCracken presented a communication from Mr M Slaughter asking the Council that he be allowed \$50 for his services in preparing the Statistics of Commerce & Manufacturers of the City for 1879 Mr Minor moved that the appropriation for preparing statistics of Commerce & Manufacturers of the City for 1879 be increased in the sum of \$20.75 which was seconded and the vote taken [Page 173] by Ayes & Noes. It was carried by the following vote.

Mr Minor from the Special Committee appointed by the Council to whom was referred the memorial of Citizens protesting against the establishment of a powder magazine on Mr T McCracken's lot near the Rail Roads submitted a written report which was read, the committee reported in substance that they had examined into the matter and found that the citizens in the locality of the proposed magazine were bitterly opposed to its establishment as injurious to their property's and the Committee recommend that the Council rescind its action granting Mr McCracken the privilege to establish the Magazine On Motion, Mr Ficklen

Resolved that the report be referred back to the Committee to be reported upon at the next meeting of the Council with the understanding that in the meantime Mr McCracken will not store any powder in the Magazine until the matter is determined by this Council

Mr Ficklen, Chrmn of the Finance Committee presented the accounts of the overseer of the poor for the month of January amt'g to \$159.24 [Page 175] also bills of Fred'g News for advertising amt'g to \$3.00 which were ordered to be paid.

Mr Ficklen, Chrmn of the Finance Committee presented the following Report and Resolutions To the Mayor and Common Council of Fred'burg

The Finance Committee of your Honorable body beg leave to submit the following report in reference to the delinquent taxes due this Corporation for the years 1865 to 1875 inclusive as stated in the tax book prepared by this Committee and its report at the regular meeting held on 3^d Friday in December to which we refer for details

This matter being again referred to us for our recommendation as to the best & quickest way of collecting the said taxes with or without suit state that they have examined the matter carefully and find that many parties owing to the way the books of the former collector were kept are ignorant of the tax bills being against their property being heirs or innocent purchasers of it, therefore in view of the existing state of facts and the Corporation not wishing to be oppressive or burdensome to its tax payers and being desirous to collect the amounts due as soon as possible so as to reduce as much as possible our tax bill for the next year, though every dollar & Interest is justly due the Corporation and can be made legally out of the property with costs &c, we unanimously recommend the following

Resolved that the tax Collector is hereby directed & authorized to receive from all parties who are delinquent for taxes for the years 1865 to 1875 [Page 176] inclusive their taxes without interest as now charged against them with the regular charge of 5% commission who will come forward and settle the same on and before the 1^{st} day of April 1880, with the further abatement for the years 1867 to 1875 inclusive as allowed at that time of $2/3^{rds}$ of the amount to be commuted at 60ϕ at 1.00 cents in the dollar remaining 1/3 @ 1.00 cents in the dollar.

Resolved that the Tax Collector give the Finance Committee security for the faithful performance of his duty and be allowed the same Commission as allowed for the Collection of the yearly taxes All of which is respectfully submitted

On Motion, Mr Minor, the report and resolutions were unanimously adopted

The resignation of Mr J W Mills as Scavenger of the upper ward was presented in writing and read and on Motion Mr Hurkamp the resignation of Mr Mills was accepted to take effect when his successor was elected and qualified.

Mr J Samuel Payne was nominated, balloted for and unanimously elected Scavenger of the upper ward for the unexpired term of Mr J W Mills, resigned

A Communication from MR W G Webb, Gen'l manager of the Washington Automatic Gas Light Co of Balto was presented and read, proposing to light the city with Gas under their process at \$20 pr lamp [Page 177] per annum

Mr Webb being present was on Motion heard on the subject On Motion Mr McCracken, the communication was referred to the Gas Committee for report

Mr Minor presented and read a Memorial from sundry citizen barbers praying the Council to pass on ordinance requiring all the Barber Shops of the City to be closed on the Sabbath day.

Mr Minor moved that rule 23 be suspended for the present meeting, which was seconded put to the vote by Ayes & Noes and lost by the following vote.

Mr Ficklen presented the following which was unanimously adopted

Resolved, that the American Union Telegraph Company be allowed to erect poles for its line from the Rail Road Track up Water Street to Hanover and up Hanover Street to the Exchange Hotel and back again to the Rail Road Tracks; or from Scotts Bridge down Water Street to Hanover St and up Hanover St to the Exchange Hotel and along Hanover Street to the Corporate limits under the direction of the Street Committee of this Corporation, The poles to be straight, painted and forty five feet above the ground and so located as not to damage the property of citizens along the line, Provided that the said American Union Telegraph Co in accepting the privilege granted them by this Council agree to accept [Page 179] and conform to all laws & ordinances now in force relating to Telegraph Companies or that may be hereafter be passed by this Council

Mr McCracken, Chrmn of the Comm & Navigation stated that the object of the present called meeting was to consider the propriety of sending a suitable person to Washington to look after the application now before Congress for an appropriation for cleaning out the Navigation of the Rappahannock River, and in the judgment of the Committee it was thought that Hon E M Braxton was the most suitable person to represent our interests and he therefore offered the following resolutions which were [Page 180] adopted unanimously

1st Resolved that Hon E M Braxton be requested to proceed to Washington DC and there together with Hon R S T Beale our Representative in Congress lay before the proper Committee of Congress the Statistics of the Trade and Manufacturers of the City of Fredericksburg and the Rappahannock Valley for the year ending December 31st 1879, and urge upon the said Committee the importance of recommending an appropriation of not less than fifty thousand dollars for the improvement of the Rappahannock River so as to make easy navigation as far as Fredericksburg

2^d That the Committee on Commerce & Navigation with the Mayor and Hon J L Marye be appointed a Committee to visit Washington should it be deemed necessary, to act in conjunction with Mess'rs Beale & Braxton, in their efforts to procure the appropriation

3^d That the Committee on Com'e & Nav'n be and they are hereby authorized to pay the expenses of Mr Braxton and the Committee in the prosecution of this work.

Mr Magrath asked a suspension of the Rules for the Present Meeting in order to a personal explanation On Motion Rule XXIII was suspended

Mr Magrath stated that it was known to the Council that the act passed by the last Gen'l Assembly of Virginia for the establishment of Water Works in Fredericksburg would expire on the 28th March next and that he requested our Delegate in the Legislature to have the act re-enacted [Page 181] with some unimportant change which was done. Mr M further stated that he designed to bring the matter before the Council before the passage of the Act by the Legislature, but owing to affliction in his family he was prevented; He laid before the Council a copy of the act

On Motion Mr Ficklen, the time for payment delinquent taxes 1865 to 1875 inclusive was extended to 1st May 1880

Mr McCracken, Chrmn of Comm Commerce & Navigation reported that Maj E M Braxton who was appointed by the Council to visit Washington in the interest of the improvement of the Navigation of the Rappahannock, had returned and he submitted a communication from Major Braxton, which was read

On Motion the Report was received

Mr Minor from the Committee appointed by the Council in reference to the privilege granted Mr McCracken to locate a powder magazine on his lot near the Rail Roads submitted a written report recommending that the privilege granted Mr McCracken be rescinded

Mr Bowering from the same committee did not concur in the report and was opposed to rescinding the privilege granted Mr McCracken, while other parties were allowed to have Magazines within the limits of the Corporation.

Mr Minor moved that the privilege granted Mr T McCracken to establish a powder magazine on his lot near the Rail Road be rescinded which was seconded put to the vote by Ayes & Noes and carried as follows [Page 183]

Mess'rs Magrath & McCracken were excused from voting.

Be it ordained by the Mayor and Common Council of the City of Fredericksburg that hereafter it shall not be lawful for any Barber in this City to open his shop for the purpose of plying his trade on the Sabbath day and that hereafter no Barber shall in any public place ply his trade on Sunday, that any person that shall be found acting in the capacity of a Barber in any public place on the Sabbath day shall be subject to a fine of not less than five, nor more than ten dollars at the discretion of the Magistrate trying the case. And it is further ordained that it shall be the duty of the police officers to see that this ordinance is enforced and that one half of the fine collected or received under this ordinance shall enure to the benefit of the officer making the arrest

This ordinance shall be in force from its passage

Resolved that the Gas Committee of this Council be and is hereby authorized to contract for one year from 1st April with the Citizens Gas Co for lighting the 50 lamps now up at \$26 each, the Gas Light Co to keep the same in order and repair and to burn on an average of nine hours per night except moon light nights and with the further agreement if the Council determine to light 10 more lamps, that they will reduce the price on all to \$25 each and keep the same on good order and repair; the Gas Co to furnish four feet burners for all the lamps now in use or to be put up hereafter and to light and extinguish the same Mr Magrath moved to strike out \$26 and insert \$24 pr lamp which was seconded and put to the vote and lost by the following vote

The license tax on Wagons was fixed at \$8.00 and on Drays & Carts at \$4.00 for the year commencing on 1st April 1880

This is all the Debt of the City that we can hear of, except \$2500 of the old Bonds belonging to Miss Alexander as heretofore mentioned which we cannot get funded. The Bonds & Certificates bought for the Sinking Fund together with all the coupons paid have been burned by your Committee, The Finance Committee regret to have to report and ordinance increasing the taxes for the year 1880-1881 but as we have shown our expenses exceeded our receipts last year with all the economy that we could use and have done so for several years past, we deemed it best to meeting the emergency at once by a small increase in all the taxes & licenses which will not bear hard on any one class but on all alike. The present tax bill will prevent our running behind hand in our expenditures over receipt next year and by a judicious and economical administration carry on our City Government, provide for our Public Schools, Poor, the Interest & Sinking Fund of our debt and reduce our floating debt or balance due Treasurer as above stated

Our people have had the benefit of very low taxes and still have in Comparison with other Cities in the State and although we have \$6168.26 due for taxes during the past 4 years leaves a small amount due us from 1866 & 1875 Yet a larger portion of it cannot be made or collected except by degrees or by a sale of the property. Therefore your Committee has considered it best to raise the taxes for the coming fiscal year rather than allow the debt to increase any further.
