Mr Willis, Chrmn of Pub Prop Comm, reported the house for the Hook & Ladder &c finished and ready for the Fire Department. The Reel is here and paid for.

Mr Gouldman, Chrmn Ordinance Comm reported the Ordinance concerning Water Works printed and ready for distribution at a cost of twelve dollars

Mr Knox for the Comm on Water Works, reported that the Works are progressing, not yet received by the Committee, the Committee had ordered 4500 feet of lead pipe and he suggested that the room next the Mayor's office to be turned over to the Committee for storage of the pipe and for the use of the Superintendent of the Water Works.

On motion, Mr Willis, The room next to the Mayor's office now used as a lock up was turned over to the Water Committee to be used by the Supt of Water Works.

The Mayor laid before the Council the Proceedings of the Corporation Court, appointing Mr J W Colbert a member of the Common Council of Fredericksburg to fill the vacancy occasioned by the resignation of Mr S J Quinn.

The Mayor presented a communication from Fred'g Hall Assn asking a reduction of the license tax upon exhibitions.

On Motion, Mr Cole the communication was referred to the Finance Comm for report.

The Mayor reported fines for the past quarter \$38.25, also Total amount received from Dog tax to date \$385.50.

Be it ordained by the Common Council of the City of Fredericksburg, in the manner following that is to say there shall be an annual license tax assessed and paid by all persons and firms in this City engaged in the different descriptions of business, professions, and occupations named in this ordinance, and enumerated below for the year beginning on the 1st of May 1885 and ending on the 1st May 1886.

Mr Knox from the Water Comm, presented an ordinance fixing the rents for the use of the City Water which was read.

Mr Cole, moved that the ordinance be adopted which was seconded,

Whereupon, Mr Rowe, moved the action upon the ordinance be postponed for a week and that the ordinance be printed for the use of the Council, which was also seconded put to the vote by Ayes & Noes and carried by the following vote.

Mr Hirsh, from Pump Committee, reported that the pump in the vicinity of the old Fair Grounds was completed and furnishing a good supply of water to the people living in that part of the City.

Applications for Gas Lamps; 1 near Mr H F Crismond, 1 in the vicinity of the "Bottom" and 1 near the Narrow Gauge Depot where the Bridge crosses the Canal were presented, and on Motion the applications were referred to the Gas Comm for report.

Mr Knox, from the Water Comm, reported that the works had been received and paid for according to contract, and all in order—a written report would be presented hereafter.

A communication from S J Quinn, Clerk of the School Board stating that the terms of office of HMD Martin, Trustee for the Upper Ward and C L Cole Trustee for the Lower Ward would expire on 4th April proximo and asking the Council to elect their successors.

On Motion, The Council proceeded to the elective [Page 555] of School Trustees in place of Mess'rs Martin & Cole and the ballots being counted

Dr H M D Martin was elected Trustee for the Upper Ward

Mr C L Cole was elected Trustee for the Lower Ward

A communication from the Fire Department asking an appropriation of \$300 for the purpose of purchasing Coats & Caps &c for the members was read.

On Motion, Mr Rowe, the sum of \$300 or as much as may be necessary was appropriated for the use of the Fire Department in equipping the members with coats &c.

On Motion, Mr Rowe, a committee of three was appointed to wait on the Insurance Co's doing business in the [city?] and ascertain what amount they would contribute towards equipping the fire Co. Mess'rs Rowe, Gouldman & Hirsh were appointed as the Committee

On Motion, Mr Myer, the Pub Prop Comm was authorized to purchase two nozzles for the use of the Fire Department

The Mayor called the attention of the Council to the lock up at the Jail and suggested certain changes. The Matter was referred to the Pub Prop Comm for report.

The Mayor stated that on examination of the City Ordinances he found that the Police Officers were only entitled to half the fines in certain cases, the he had following the custom of those who preceded him, been allowing half fines to the officers in all cases—he deemed it best to bring the matter to the attention [Page 556] of the Council so that such steps as thought best could be taken.

On Motion the subject was referred to the Ordinance Comm for report.

On Motion, Mr Hirsh, Rule 24 was suspended for the present meeting.

On Motion, Mr Knox, Section 30 of the Ordinance Concerning City Water was amended by inserting the words

"The informant shall be allowed one half of all the fines imposed by this ordinance."

The Council then adjourned

The Mayor stated that the Council was called to consider the question of rates of City Water, as laid before the last Council by the Finance Comm.

A bill of the *Free Lance* for printing amt'g to \$2.50 was presented and ordered to be paid. Mr Knox, from the Finance Committee presented for the consideration of the Council the Tariff of rates in the use of the City Water, being the same before the Council at its last meeting.

Mr Cole, moved the adoption of the Tariff of rates, presented by the Finance Comm; Whereupon Mr Rowe offered the following as a substitute for the Committees bill which was also seconded.

Resolved that a water tax of \$4.00 per annum be levied and assessed upon each and every dwelling (which shall included such out houses as may be connected to the same) and that a like sum of \$4.00 per annum be levied and assessed upon every house devoted to business purposes, where the same is disconnected from dwellings, which may be situated along the line of the Water Main as laid in the Corporation of Fredericksburg, and that each dwelling house and building so assessed shall be entitled to the use of water for any and all purposes except for such purposes, as may be hereinafter specified and excluded from this provision.

Resolved that a special tax of 5 cents on every hundred dollars of value be levied and [Page 558] and assessed upon such dwellings and business houses for protection against fire as are situated within such distance as may be reached by Water from the Fire Plugs—This latter provision not to apply to the dwelling houses specified in the first section of the first resolution.

The vote upon the substitute of Mr Rowe was taken by Ayes & Noes and was adopted by the following vote.

The Mayor appointed Mess'rs Rowe, Hirsh, Willis, Cole and Gouldman

Mr Myer moved that the Council adjourn until Friday next, which was seconded, put to the vote and lost

On motion Mr Rowe, the resolution passed at the last Council fixing water rates was reconsidered. Mr Rowe presented the following ordinance fixing water rates, which was read and seconded and is in the following words

An Ordinance regulating Water Rates in the City of Fredericksburg

Be it ordained by the Mayor and Common Council, that to meet the interest on the Water Bonds, to pay the running expenses of the City Water Works, and to create a sinking fund to liquidate the debt incurred in erecting said City Water Works there shall be levied and assessed an annual Water Rent as follows, to be paid semi-annually on the first of January and July of each year, whether the water is used by persons occupying or owning such buildings or not.

1st On all dwellings, storehouses, warehouses [Page 560] business houses, and other houses on the Street where the water pipes are laid, four dollars, but this provision shall not apply to the kitchen or outhouses on any premises, and each and every store or place of business shall be considered a separate house or building for the purposes of this section, and dwelling houses and other buildings in the cross streets, and between the Streets where the main pipes are laid, or which shall be connected with the Mains or any one of them by service pipe of lead or galvanized iron or other material shall be considered as being on the mains for the purpose of this ordinance and shall be liable to the Water rents under this provision. And the occupants of all such buildings for the consideration of the four dollars water rent shall have the free and unrestricted use of the City Water for all purposes except as hereinafter provided.

2nd In addition to the water rent on each house or building as above there shall be levied and assessed on

3rd That in all buildings of whatever kind not on any of the Main pipes, but which are near enough to a fire plug to be reached by the hose for extinguishing fires, shall be levied and collected for fire protection five cents on the hundred dollars assessed value of such buildings and the lots upon which they stand, but this clause shall not apply to any house or building that comes under the four dollar clause.

4th All Water rents under this ordinance including the levy of five center on the one hundred dollars value of property for fire protection shall be a lien upon the Real Estate upon which the water rent or fire protection is laid and if not paid in a reasonable time shall be collected in the mode and manner prescribed for collecting delinquent taxes, and the Superintendent of Water Works, or other person whom the Council may authorized to collect the Water rents &c is hereby clothed with the power and authority for collecting any delinquent water rents &c as the collector of City taxes has for collecting delinquent City taxes.

5th During the progress of a fire within the town no water shall be drawn from a hydrant or Street hose until the fire is extinguished or gotten under control, but this provision shall not apply to persons living in the vicinity of the fire who may use their street hose to prevent their property from taking fire. Any one offending against this provision shall be fined five dollars in each case [Page 562] and the informer shall have one half of the fine.

6th No one shall be allowed to use a nozzle or hose for sprinkling Streets or lots with a larger opening than 3/16th of an inch

Any person offending against this provision shall be fined five dollars in each case, the informer to receive one half of each fine,

7th All ordinances and parts of ordinances which conflict with this ordinance or with any of its provisions, and so much of the ordinance concerning the City Water Works adopted December 19th 1884 as is rendered unnecessary by reason of the adoption of this ordinance are hereby repealed 8th This ordinance shall be in force from its passage.

Mr McCracken offered the following as a substitute for the ordinance offered by Mr Rowe. Be it ordained by the Mayor and Common Council that to meet the interest or the Water Bonds, to pay the running expenses of the City Water Works and to create a Sinking Fund to liquidate the debt incurred in erecting said city Water Works the following shall be the rates for the use of the City Water, payable 1st January and 1st July of each year Viz;

Mr Knox, Chrmn Finance Comm presented bills of *Fred'g News* amt'g to \$7.50 and *Free Lance* for \$2.50 For advertising &c which were ordered to be paid.

The Committee reported that the bill of Williams & Wheeler presented at the last meeting was not authorized by the Committee on Poor, but recommended that \$5.00 of the amount be paid, which is the usual amount allowed for such service &c

On Motion, The Treasurer is authorized to pay Mess'rs Williams & Wheeler the sum of Five [Page 566] Dollars in full of the account for funeral expenses of the late Mrs Willie.

Mr Cole, Chrmn Poor Comm, Reported that matters were moving on well at the Alms House.

He presented an account of Mr J F Alsop for house rent for Wm Brown; Mr Cole stated the Committee had nothing to do with the bills, did not rent any house of Mr Alsop and of course owed him nothing. The Committee furnished Mr Brown with rations &c during his sickness because it was impossible in his low state of health to be carried to the Alms House.

On Motion, Mr Gouldman, the Committee was requested to return the account to Mr Alsop as he had no claim against the Corporation.

Mr Hunter, Chrmn Health Comm, reported that the Comm had 500 hand bills printed and circulated urging the Citizens to have their cellars and lots kept clean, so as to prevent sickness during the summer.

Mr Rowe, from the Committee appointed at the last meeting, reported that the Companies represented by Capt Barney donated \$30 and the Companies represented by Mr Crutchfield \$5 towards equipping the fire company; It was known to the Council that Mr Bott's Co subscribed \$50, before the Committee was appointed.

Mr Hirsh, presented and read a communication from Mr R R Farr, Supt Public Instruction, addressed to Gen'l Ruggles in relation to the Institute to be held in Fredericksburg during the Summer.

Mr Hirsh presented the following which was seconded.

Whereas, Hon R R Farr, Superintendent of Public Instruction for the State of Virginia [Page 567] has officially directed that one of the three annual Normal Institutes of the State will be held at Fredericksburg during the coming summer and

Whereas as one of the conditions precedent to the ordering of the Normal Institute to this place was the promise that suitable accommodations would be furnished for the meetings of say 400 or more teachers, and their entertainment and

Whereas certain citizens have pledged themselves to carry out these pledges, therefore Resolved that the Common Council of Fredericksburg do hereby appropriate and set aside the sum of one hundred and fifty dollars or so much thereof as may be necessary to carry out the pledges made, one hundred dollars of said sum to be applied to payment of rent for the use of the Opera House, and fifty dollars for such other expenses as a Committee of this body shall decide to be proper and to whose order the said amount on one hundred and fifty dollars shall be paid; said Committee to Co-operate with a similar Committee of Citizens in the expenditures of the latter sum of fifty dollars.

On Motion Mr Willis, the resolutions of Mr Hirsh was referred to the Schools Committee for report at a called meeting of the Council.

On Motion Mr McCracken,

Resolved that the water Committee be authorized to furnish the City Water free of Charge, to the White & Colored cemeteries of the City, said Cemeteries on their managers paying the cost of conducting the water to the premises.

The Mayor presented the resignation of S H Beale, Scavenger for the upper ward to take effect 1st June proximo, which was read and on motion Mr Rowe, the resignation of Mr Beale was accepted. Mr Knox also presented a communication from J L Marye Exr Mrs Charlotte Thornton dec'd asking the Council to remit the penalty of 5 per cent and interest on the taxes due to the City by Mrs T upon the Real Estate owned by her and devised to her nieces.

On Motion the communication was laid on the table.

Mr Knox, reported that the tax bills for the years 1876 to 1884 inclusive had been received from [Page 590] Mr Young, the late Collector and turned over to the present collector Mr A P Rowe Jr

Mr McCracken, Chrmn Com & Nav Comm, reported two of the wharves formerly reported still in bad condition.

Mr Knox, Chrmn Water Comm, reported that the Reservoir had been repaired at a cost of about \$300, and read a letter from Mr Taylor, the contractor, asking the Committee to receive the materials left here by him in part payment of the claim.

The Mayor presented a communication from B Goldsmith & others calling attention of the Council to the Market House lot and asking that the drainage &c from the lot be investigated.

The Communication was referred to the Street Committee with instructions to abate the nuisance.

On Motion, Mr Cole, the Pub Prop Committee was requested to have the privies in the Market House lot removed at once.

The Mayor presented a communication from L F Morse of Boston, stating that the Warren Monument Assn of Boston designed petition Congress to aid in erecting a Monument of Gen'l Warren and asking the Co-operation of the Council for the erection of a Monument to Gen'l Mercer at Fredericksburg. On Motion, Mr Knox, the Mayor was requested to correspond with Mr Morse and also to confer with any of the surviving members of the Mercer Monument Association of Fredericksburg, in reference to the Monument authorized by Congress many years since, to be erected in Fredericksburg to the Memory of Gen'l Mercer and report.

The Mayor reported fines since last report \$17.55, Dog tags \$370.00

On Motion, Mr Knox, the Mayor was allowed a fee of fifteen cents each for issuing Licenses for dogs.

The Mayor stated that the Harbor Improvement Convention would assemble in Savannah on 24th Inst [Page 591] and he had appointed Mess'rs Geo W Shepherd and R B Merchant as delegates to represent Fredericksburg in said Convention.

The Council then adjourned

The minutes of the last meeting were read and approved.

Mr Knox, Chrmn of Finance Committee, submitted the following amendment to Section 54 of the Ordinance concerning theatrical performances; by "Striking out in the fifth line of said Section the word 'five' and inserting the word 'three'" so as to make the tax three dollars, instead of five as a present On Motion, Mr McCracken, the rule was suspended for the present meeting On Motion, the amendment submitted by Mr Knox was adopted.

Mr Knox, Chrmn Finance Comm, submitted the following amendment concerning the City Water Works, Viz.

"Strike out all of Section 13 as found on the 4^{th} page of said ordinance as printed in pamphlet form and insert therefor the following:

"15th day of the month in which the rent falls due, If a bill for water rent shall [Page 592] remain unpaid after that date the Superintendent shall add 5 per centum as a penalty and interest at the rate of 6 percent per annum."

On Motion, Mr McCracken, the amendment offered by Mr Knox was adopted.

Mr Knox, Chrmn Water Comm, stated that the Committee had taken all the materials left by Mr Taylor that could be used for the water works amt'g to about \$200; which left a balance due by Mr T of about \$103 and a statement had been forwarded to him for payment.

The Mayor read a communication from G F Downing & others of the Fire Department commendatory of Capt McCracken, Ch'f of the Department and asking the re-election of Capt McC.

Mr McCracken submitted a written report of the Fire Department setting forth a length the action of the Department and showing the importance of this institution to the City in the preservation of property and recommending the Council to foster and encourage the same in every laudable manner.

The Report also showed that the whole expense to the City in maintaining the Department was \$32.00.

On Motion, Mr Cole, the report was received and ordered to be filed and the amount due the Fire Department say \$32 was ordered to be paid.

On Motion, Mr Rowe, Mr T McCracken was unanimously elected Chief of the Fire Department for the ensuing year.

On Motion, Mr McCracken, the salary of Superintendent of City Water Works was fixed at \$600 per annum.

The Mayor read a communication from S J Quinn, asking at the hands of the Council a re-election to the office of Superintendent of City Water Works.

The Council proceeded to the election of Superintendent of City Water Works, and the ballots being counted Mr Quinn received the whole number of votes cast and he was declared unanimously elected Superintendent of City Water Works for the year commencing 1st January 1886. [Page 593]

The Mayor presented and read a communication from the Stafford Co Bridge Commissioners desiring to know of the Council what part the City would take in the building or purchasing a free bridge across the Rappahannock for travel between Stafford and Fredericksburg.

Mr Rowe offered the following which was accepted.

Resolved that a Committee of six, three of the Council and three on the part of the Citizens of Fredericksburg, be appointed by the Mayor to confer with the Board of Free Bridge Commissioners of

Stafford County in regard to securing a free passage across the Rappahannock River, to the Citizens of Stafford and Fredericksburg and make report of their action to this body, and if they should deem it expedient to also hold a conference with the present bridge owners in regard to the above matter.

The Mayor appointed Mess'rs Rowe, McCracken, & Knox on the part of the Council, Mess'rs Chs Wallace, F W Johnston, & L O Magrath on the part of the Citizens as the Committee.

Mr McCracken presented a petition from a number of Citizens asking the Council to take some action in repard to simplifying the nomenclature of the Public Streets and grounds in such manner as they may find most expedient and practicable.

On Motion the petition was referred to the Street Committee.

Mr Cole, Chrmn Poor Comm, asked permission of the Council to tap the Main pipe of the Water Works to conduct the water to the Alms House.

On Motion, Mr Hunter, the permission was granted.

Mr McCracken, stated that at the last meeting of the Fire Department a Committee was appointed to wait on the Council to ask that a Fire Alarm be provided for the Dept, and as Mr Downing was present, he would be glad to have the Council hear him in regards to the matter.

On Motion, Mr Downing was heard on the subject and gave his views at length as to the benefit of a Fire Alarm or distinct bell, to the Fire Department.

On Motion the subject of the Fire Alarm was referred to the Pub Prop Comm.

Mr J G Mason, Commonwealth Atty was before the Council and stated that additional legislation was needed in respect to the Alms House Property, regarding taxation and the acquisition of additional land, should the Council at any time conclude to purchase and he had prepared and forwarded to our Delegate Mr Crismond, the necessary requirements, and suggested that it might be well to ask our Delegate to put the bill forward as fast as possible.

On Motion, Mr Knox, Resolved that our Delegate, Hon H F Crismond be and is hereby respectfully requested to use his best efforts to procure the passage of the bill forwarded by Mr Mason, through the Legislature in regard to this Poor House Property.

Mr Cole offered the following, which was adopted.

Resolved, that Mr Mason, Commonwealth Atty be requested to prepare an Act to be submitted to the Legislature of Va in regard to Registration in the City dividing the City into two wards and requiring vote in the ward which they reside and also the have the City Charter so amended as to make the election of Councilmen biennial instead of annual as a present.

The Mayor having reported favorably, on Motion, the Treasurer was directed to pay the police officers their salaries for the quarter ending 31st Inst

The Council then adjourned.
