Fredericksburg Council Minutes 1886

At a Meeting of the Common Council of the City of Fredericksburg held at the Council Chamber on Friday January 15th 1886

Present J Hazard, Mayor

M B Rowe, Recorder

J H Myer, E D Cole, C E Hunter, J S Berryman, I Hirsh, J S Knox, H R Gouldman, T McCracken.

The Minutes of the last meeting were read and approved.

Mr Knox, Chrmn Finance Comm, presented the official Bond of S J Quinn, for \$2000 (as Supt Water Works) with E D Cole and Geo Gravatt as securities was presented and approved.

Mr Rowe, from Pub Prop Comm, reported that the pavement in front of the Town Hall had been completed at a cost of about \$150.

Mr McCracken, Comm Com & Nav Committee, stated that the Committee had requested the Legislature through our Delegate, Mr Crismond, not to remit the fine against Mrs Pittman until the wharf had been repaired. On Motion, The report was received.

Mr Cole, Chrmn Street Comm, reported that the matter of drainage of the Market House lot had be investigated and that the nuisance complained of did not arrive from the lot itself, but from the several lots adjacent.

Mr Cole, Chrmn Comm on Poor, reported the Alms House in good condition and the inmates doing well; two colored men were found recently in the City during the recent cold spell in an almost frozen condition, these were taken charge of by the Committee and were being treated by Dr Herndon. The Committee had been called on for aid from parties outside the Alms House, but as the ordinance restricted them to the Alms House in supplying the Poor at this particular season, and all other times they desired the sense of the Council on the Matter.

Dr Herndon being present stated to the Council [Page 596] the condition of the two men referred to by the Committee

On Motion, Mr Knox, the report of the Committee was received and the Committee authorized to act as they deemed best in the premises.

Mr Cole, Chrmn Poor Comm called the attention of the Council to the fact of three blind children being a charge on the Corporation, and that one of the children be sent to Dr White of Richmond with the hope that the treatment would prove successful, and the other two could be sent, in such event.

On Motion, Mr McCracken, the Committee was authorized to send one of the children to Richmond to be operated upon, and to make the best terms it could with the authorities.

Dr. Herndon being present called the attention of the Council to the painful & deplorable condition of a female in the lower end of Town and stated that such treatment of her case as was desired could not be had here, and suggested that she be sent to the Providence Hospital in Washington City, as he had assurance from the authorities there that she would be taken in and cared for. He would go with the woman himself, if the City would defray expenses.

On Motion, Mr Hirsh, the sum of \$10, or so much thereof as necessary, was appropriated to pay the expense of the woman referred to & Dr Herndon to Washington.

A communication from the Garfield Guards (colored) asking an appropriation of \$50 to aid in paying the rent of their Armory was presented and read.

On Motion, Mr Knox, the sum of fifty dollars was appropriated to aid the Garfield Guards in paying the rent of the Armory.

Mr Rowe, Chrmn of the Committee appointed by the Council to confer with the Stafford Bridge Commissioners after reading the correspondence &c which had taken place between the Committee & Commissioners, submitted the following report, which was read.

To the Mayor and Common Council

Gentlemen,

The Committee appointed by your honorable body to confer with the Bridge Commissioners of Stafford (at their request) in relation to the part of town would take in buying or building a free Bridge desire to report that after repeated meetings and conferences with the Commissioners they made a proposition to your Committee that the Stafford Commissioners would secure a free passage for the Citizens of Fredericksburg across Ficklen's Bridge, provided that Fredericksburg would secure for Stafford the same right across Scott's Bridge, Your Committee examined carefully their proposition and they unanimously agreed to recommend to your honorable body to purchase Scott Bridge and make it a present to the County of Stafford, provided they would build an iron bridge at that site. They received our communication and now submit the same proposition that the Committee discussed and could not approve as we considered it impracticable, we now put the whole matter before you that you may express your wish, and continue or discharge your Committee.

Mr Cole, Moved that the report be received and the Committee discharged, which was seconded, Whereupon Mr Hunter, moved that the report of the Committee be received, its action approved and the Committee continued, which was also seconded, put to the vote by Ayes & Notes and adopted by the following vote;

Mr Rowe, from the Street Comm, offered the following,

Resolved that the Street Committee be instructed to paint the names of the Several Streets on boards or such other material as they may think best, and have them conspicuously posted at the several Street Corners in the Town.

On Motion, Mr McCracken, the subject of the resolution was referred to the Street Comm, to enquire into and report the cost of the work to be done.

The Council then adjourned.

The Mayor stated that the Council was called at the instance of three members of the Council, Mess'rs McCracken, Rowe & Cole; either of whom would state the object of the Meeting.

Mr McCracken, stated that the Council was called for the purpose of applying to the Legislature for authority for supplying the City with Gas or Electric Light, on certain conditions and to issue Bonds of the City to the extent of \$25,000, not over 6% interest per annum. Mr McCracken presented and read a bill which had been prepared for the consideration of the Council and if adopted, he desired should be at once forwarded to our Delegate & Senator in Richmond, that it might be acted upon at once in the Legislature. Mr Cole offered the following resolutions which were seconded;

Resolved that the paper read by Mr McCracken be adopted by this Council and that the Clerk of this body be instructed to forward the same at once to our Representative in the Legislature that he may introduce it without delay.

Resolved that our Representative Hon H F Crismond and our Senator Hon W E Bibb be requested to use their best endeavors to procure the passage of said paper at this session of the Legislature. Resolved that a copy of these resolutions, officially signed, be forwarded to our [Page 600] Representative and Senator in the General Assembly by the Clerk of the Council.

The vote upon the resolutions being taken by Yeas & Noes they were adopted unanimously Ayes Mess'rs Hurkamp, Colbert, Hirsh, McCracken, Berryman, Rowe, Cole, Hunter, Gouldman, Myer 10

Noes 0

On Motion, Mr Cole, the rule was suspended for the present meeting.

Mr Rowe read a letter addressed to Mr C S Scott from Mr James Semple, desiring information as to the lot in which his father, the late R B Semple was entered and if permission could be had to bury his mother on the same lot and erect a monument over their remains.

On Motion, Mr Rowe, Resolved that the request of Mr James Semple to have the remains of his mother interred by the side of her husband, the late Robert B Semple, former mayor of this City, in the lot belonging to the City, in the Fredericksburg Cemetery, and that he have the privilege of erecting a monument over their remains.

The Council then adjourned [Page 601]

Mr Knox, Chrmn Finance Comm, presented a bill of *Free Lance* Co amt'g to \$3.00 which was on motion ordered to be paid.

Mr Rowe, Chrmn P Property Comm, called the attention of the Council to several small bills left unpaid by the Committees of last year, to G E Chancellor and others; which bills were ordered to be paid, when properly certified by the Committees.

Mr Rowe, Chrmn P Prop Comm, reported verbally that the Committee enquired into the cost of erecting a tower to the building used by the Fire Department, and exhibited a plan prepared by Mr Wroten of the proposed tower, also specifications for the work; the cost of which would be about \$400. And the Committee recommended that the work be done.

On Motion, Mr Hirsh the report of the Committee was received and adopted.

On Motion Mr Hirsh, the sum of \$400 or as much as thereof as was necessary was appropriated for the building of the Tower and other improvements of the House of the Fire Department.

Mr Berryman presented the following,

Whereas there has been many complaints about the bad and dilapidated condition of our Streets and it does appear that better streets would meet the demands of our Citizens generally, and by making the Streets hard with small round rock would especially facilitate the business of our merchants in the transfer of their goods to and from places of shipment and release [Page 602] the draymen of a great burden of hauling through mud with half loads to the disadvantage of all concerned and believing that such improvement would increase the value of property.

Therefore be it resolved by the Mayor and Common Council of Fredericksburg, that the sumo of one thousand dollars be and is hereby appropriated for the purpose for the exclusive purpose of putting round rock or gravel upon the streets, and this appropriation, shall not be used for any other purpose. On Motion, Mr Rowe, the resolution of Mr Berryman was referred to the Street Committee.

Mr Berryman presented a bill of E K Wheeler amt'g to \$4.00 for use of teams &c shoveling snow, which on Motion of Mr Hunter was referred to the Street Committee.

The Council then adjourned.

Mr Knox, Chrmn Finance Committee presented the Ordinance imposing a License tax for the Year 1886-87, fixing the rates at the same as for the year 1885-86 with the exception of the tax on theatricals, which is fixed at three dollars for each performance, instead of five dollars.

On Motion, the Ordinance was unanimously adopted. (see the ordinance, page 3)

Mr Rowe, Chrmn Pub Prop Comm, reported that the Committee had advertized for proposals to build the Tower and other work on the House of the Fire Department, and the bids for the same received and opened and the contract for the work was awarded to Mr A J Bowling for \$320, being the lowest bidder & subject to any changed the Council might think proper to adopt.

Mr Rowe also submitted a written report in regard to the improvement of the Jail, with drawings of the proposed improvement, and asked that the Committee be allowed to advertise for bids for the work Present: W T Tomlinson

Mr Colbert asked and obtained leave to retire: Absent Mr J W Colbert On Motion, Mr Knox, The Pub Property Committee was authorized to ascertain the costs of the improvements of the Jail by advertizing for bids for same and report.

Mr Tomlinson, Chrmn Street Comm, stated that the Committee had expended \$70.84 in grading the side walks on Princess Ann St and bills for same had been place in the hands of the Collector of Taxes to be collected from the owners of the property and he asked that the amount expended be place to the credit of the Committee

On Motion, Mr McCracken, the sum of \$70.84 was ordered to be placed to the credit of the Street Committee

Mr Cole, from the Street Comm, called the attention of the Council to the condition of Princess Elizabeth St from Caroline to Sophia, and stated that certain work was necessary to be done in order to make the street safe for pedestrians &c and prevent the Corporation being liable for damages &c and asked the concurrence of the Council in the premises.

On Motion, Mr McCracken, the Street Committee was authorized to make such improvements on Princess Elizabeth Street as they deemed necessary

Mr Cole, Chrmn Comm on Poor asked that the sum of \$231.38 expended by the Committee in fencing the Alms House lot and painting &c Alms House be placed to the credit of the Committee.

On Motion, Mr Knox, the sum of \$231.38 was ordered to be placed to the Credit of the Committee on Poor

On Motion, Mr Cole, the Pub Prop was requested to procure plans & specifications with the probable cost of a suitable Brick building for the use of the [Page 3] Fire Department and submit the same to the Council, also that the contract for the building of the Tower with Mr Bowling be cancelled for the present.

Mr Tomlinson, Chrmn St Comm to whom was referred the resolution of Mr Berryman reported adversely upon the improvement recommended.

The Mayor reported that the Police Officers had discharged their duties faithfully and on motion, the Treasurer was direct to pay the Police Officers their Salaries for the quarter ending 31st Inst. The Council then adjourned.

Ordinance imposing License Tax of 1886-87

1st Be it ordained by the Common Council of the City of Fredericksburg, in the manner following that is to say there shall be an annual license tax assessed and paid by all persons and firms in this City engaged in the different descriptions of business, professions, and occupations named in this ordinance, and enumerated below for the year beginning on the 1st of May 1886 and ending on the 1st May 1887. The license tax shall be assessed and collected at the following rates and paid on or before the 1st of June 1886

Mr McCracken offered the following which was seconded:

Resolved that the Public Property Committee be authorized to contract at once with Mr Geo W Wroten for the enlargement and improvement of the Jail, and that the sum of \$2250, be appropriated out of any money in the Treasury not otherwise appropriated for the purpose of paying for said work.

Mr Rowe, Chrmn Pub Prop Comm Stated that the Committee was not yet prepared to report upon the cost of a House for the Fire Department, no plans having been submitted.

Mr Rowe, from the Comm, on Public Schools, submitted and read a communication from Mr J M Holliday, Supt Schools, in reference to holding a State Normal School at Fredericksburg during the Summer, and he offered the following which was adopted.

Whereas the Board of Education will soon designated the places where Normal Schools are to be held in Virginia this summer, and

Whereas Fredericksburg is the most Central place and convenient point for such a school in this part of Virginia and will draw large numbers as was evidenced by the attendance here last summer, who expressed themselves delighted with our pleasant town and hospitable people, and

Whereas our citizens expressed a desire at the close of the last Normal to have another held here this year: Resolved that a Committee of three from the Council be appointed who shall be authorized to associate with them such number of our Citizens as they may desire to take the Matter in had and use their influence with the Board of Education to have Fredericksburg designated as one of the places for hold Normal Schools this summer.

Resolved that this Committee be authorized to inform the Board of Education that a suitable building for the school and rooms for lecturers and recitations will be furnished by the City and that the City agrees to bear all necessary individual expenses of running the Schools.

The Mayor appointed Mess'rs Rowe, Hunter and Hirsh as the Committee. [Page 12]

Mr McCracken submitted the following which was adopted

To the voters of the City of Fredericksburg:

Whereas by act of Assembly, approved February 1885 it is provided:

That there shall be a new registration of the voters of the City of Fredericksburg to be made at such time during the year 1886 as may be determined by the Council of said City by which said voters shall be registered only on the book of the ward or election precinct in which they respectively reside: notice of the time and place or places for such new registration shall be given by said Council by the publication in the Newspapers of said City and by printed hand bills posted in at least ten public places in each of said wards or precincts for at least ten days prior to the beginning of such registration.

2nd The registrants of said wards or precincts shall sit for five days at the place or places designated for such new registration.

3rd The registration made under this act shall have the same force and virtue as thought made under the said general registration laws: shall be revised, altered, added to and amended I the mode prescribed by said general laws and shall take the place of all registration of voters heretofore made in and for said City: Now therefore be it resolved by the Council of Fredericksburg, that the said new registration shall begin on Tuesday the 4th day of May 1886 and continue for five consecutive days: that the place for the registration of the voters of the upper ward, or those residing to the north west of George Street be the room adjacent to the Mayors office in the Town Hall; and the place for the registration of the Lower Ward or those [Page 13] residing to the Southeast of said George Street be the Court house building. Resolved 2nd That this notice be published for three times in each of the News papers of the City, and that hand bills containing the same be posted in at least ten public places in each of said wards, at least ten days prior to said 4th day of May 1886.

Mr Rowe offered the following which was adopted

Whereas the interests of Fredericksburg demand the erection of a suitable public building in which the business of the United States Government may be more conveniently transacted and

Whereas Congress has evinced a willingness to make liberal appropriations for the improvement of the old or erection of new government buildings in other portions of the State:

Resolved that our Representatives in Congress and Senators Mahone and Ridleberger be requested to write in asking an appropriation for the erection of a public building in Fredericksburg:

The Melancholy occasion which convenes the Council is one of no ordinary sorrow and loss to this body and to the Community it represents. The death of any good and useful citizen is a sad event; but when a Citizen and Member of this Council dies such as John G Hurkamp, who for 43 years lived among our people, filling well and worthily large and important relations to the community, it is especially fitting that this body shall put on record a faithful tribute to his life and Character.

Few of our Citizens remain to testify to the beginning of the Career of the deceased brother as he entered our town in 1843 a young man without money or influential friends, but with an honest heart, a resolute will and indomitable energy, by his sturdy arm, well trained in a useful industry, he steadily built up a reputation for skill and capacity, which soon enabled him to begin manufacturing on his own account. His business operations were conducted with such intelligence, integrity and energy as to expand with healthy progress, until for 30 years past he prosecuted one of the largest manufacturing interests [Page 16] of Fredericksburg, He was not merely an energetic and successful business man; he was full of public spirit, and co-operated heartily in every hopeful enterprise to advance the propriety of the town, and promote the welfare of the citizens. He loved his adopted home, and his time and means were ever ready to be spent in enlarging its material interest, and contributing to the social welfare of its people.

As a Citizen, Neighbor and friend, he was uniformly kind charitable and true. The people of Fredericksburg appreciated his worth as a Citizen, and his capacity for usefulness in public trusts; and among other marks of their esteem and confidence elected him continuously for many years past a member of this body. In discharging his duties here he was zealous in the advocacy of every measure designed for the public good which met his approval, prompt and efficient in his labours as a representative and uniformly courteous and agreeable to his associates.

It is therefore with a sad sense of the loss sustained by the Community and by the Council in the death of our esteemed associate that this Council resolves,

1st That the Common Council of Fredericksburg deeply deplores the death of John G Hurkamp as a serious loss to the town and us depriving this body of a valuable and esteemed member.

Resolved that a Committee of three be appointed to confer with the owner and ascertain from him in writing what he will convey by a good and sufficient deed and at any time within the next eighteen months to be approved by the Attorney General of the United States, such lot of ground together with the right of ingress, egress and regress thereto, for all the people [Page 49] of the United States, and ground enough on which to erect a keepers house, it being the intention of the Corporation to purchase and convey said lot to the United States, if it can be obtained at a reasonable price in the event of a sufficient appropriation being made by Congress to complete said Monument.

And said Committee are directed to report back to the Council Forthwith
