At a Regular Meeting of the Common Council of the City of Fredericksburg held at the Council Chamber on Friday January 20<sup>th</sup> 1888

Mr Wroten, Chrmn Street Comm, to whom was referred the account of J M Smith presented an itemized account shewing the amount of same \$28 and recommended that the sum of \$17.50 be allowed Mr Smith in full of his Services for Surveying &c to this date.

On Motion, Mr Wroten, the Treasurer was directed to pay the account of Mr Smith amt'g to \$17.50.

Mr Knox, Chrmn of Finance Comm presented an account of G W Wroten for drawing plan &c for Fire Department amt'g to \$18 which on motion was ordered to be paid.

Mr Rowe, Chrmn of Gas Committee, reported verbally upon the application of Citizens for light at the Corner of Sophia and Hanover Streets that it was the sense of the Committee that no change could be made in the present System of lamps to accommodate the wishes of the petitioners.

Mr Hunter presented a Petition from the Mechanics Building Fund Assn asking the Committee to grant the Association the use of the Mayor's Office in which to hold their meetings. On Motion, Mr Knox, the application was referred to the Mayor.

Mr Hunter moved that the use of Mayor's office be granted the other Building Associations of the town in which to hold the meetings, seconded, and on motion [Page 113] Mr Knox the same was referred to the Mayor.

Mr Knox offered the following which was adopted,

Resolved that the Mayor be requested to enquire of the Church authorities of the Baptist Church what steps if any they are taking to secure a building and when they will be ready to vacate the Court House.

The Mayor presented in writing the resignation of Mr Terrace McCracken as a member of the Council for the Lower Ward.

On Motion, Mr Myer the resignation of Mr McCracken was accepted.

Mr Knox, Chrmn of Finance, stated that he had the official Bond of S J Quinn, Supt Work Works in the penalty of \$2000 with George Gravatt, E D Cole, as securities; the Bond was approved and directed to be deposited in Natn'l Bank of Fred'g for safe keeping.

The Mayor presented a communication from the members of the Fire Department asking at the hands of the Council the re-election of T McCracken as Chief of the Fire Department.

Mr Myer, asked and obtained leave to retire: Absent Mr J H Myer

On Motion, Mr Knox, the Council proceeded to the election of Chief of Fire Department.

Capt T McCracken was nominated, balloted for, and unanimously elected Chief of Fire Department for the ensuing year.

The Mayor presented and read a memorial from the Fire Department asking the Council to provide the Department with a new light reel, 350 feet additional hose, 2 nozzles, also Gum Boots for the use of the members in time of fire or service in the Department.

Mr Knox offered the following which was adopted,

Resolved that the Public Property Committee be instructed to purchase 350 feet hose and [Page 114] light two wheeled Reel, capable of carrying 350 feet hose, and two check nozzles and gum boots of the Fire Company, at the lowest possible rates, and also the Committee be instructed to advertise for bids according to plan and specifications heretofore furnished and paid for, for building a Fire Tower and house, and also that they be instructed find out and report back to this Council what is the best alarm bell to be had and whether it can be conducted by the Electric Light Co.

The Council then adjourned

The minutes of the last meeting were read and approved

Mr Rowe, Chrmn of Pub Prop Comm, stated that the Committee was in correspondence with parties in reference to the purchase of Hose & Hose Carriage, but had nothing definite to report at the present meeting. Mr R also stated that the Committee as directed advertised for bids for the building of a House for the Fire Department and received bids from the following parties, Viz

A J Bowling for the sum of \$1600 A M Garner for the sum of \$1570 John Hancock for the sum of \$1497 J J Heflin for the sum of \$1473.50

Mr Heflin being the lowest bidder the Committee recommended that the contract for building be awarded to him.

On Motion, Mr Gouldman.

Resolved that the bid of Mr J J Heflin for building the house & tower for the Fire Department be accepted and that the contract for building same be awarded to him.

Mr Wroten, Chrmn Street Comm, presented a communication from Mrs J S Berryman asking the privilege of erecting a porch in front of his residence, corner Caroline and Princess Elizabeth Streets.

On Motion, the Communication was referred to the [Page 116] Street Committee with power to act.

Mr Cole, Chrmn Commerce & Navigation reported that statistics of the Commerce of Fredericksburg had been prepared and forwarded to Colo Abert of the Engineer Bureau at Washington and our Representative in Congress Hon T N Browner.

Mr Rowe presented the following which was unanimously adopted.

Whereas his Excellency Grover Cleveland, President of the United States will pass through Fredericksburg on Tuesday the 21<sup>st</sup> Inst and

Whereas this body desires to shew a proper and becoming respect to the head of the Nation;

Resolved that a Committee of three be appointed by the Mayor to wait on the President and ascertain at what time the train bearing the President will reach Fredericksburg, and that said Committee be directed to invite him and the distinguished parities accompanying him to stop and view the battlefields, visit the Tomb of Mary, the Mother of Washington, accept the freedom of the City and afford our Citizens an opportunity to greet him and pay their respects, and report the result to a called meeting of this Council body.

The Mayor appointed Mess'rs Rowe, Cole & Hunter as the Committee.

Mr Griffin presented the following which was adopted

Whereas for many years the appropriations made for Streets have been expended without any permanent improvement being made thereon,

Therefore be it resolved that the Street Committee be and they are hereby authorized to enquire into the cost of and feasibility of paving the Streets of the town with granite or other materials and report the same at some future meeting of this Council.

On Motion, Mr Rowe, the Street Committee was instructed to ascertain at what the Boxley House and lot on Wolf Street could be purchased for and report to Council.

The Mayor presented the Certificate of the Rappahannock Valley Agricultural & Mechanical Society for 100 shares of Stock of said Society, subscribed and paid for by the Corporation.

On Motion, Mr Rowe, The Mayor was appointed to represent the Corporation in all meetings of the Stockholders of the Rappahannock Valley Agricultural and Mechanical Society.

The Mayor presented and read a communication from Mr W A Little Jr, counsel for Shiloh Baptist Church, stating that the suit now pending in the Circuit Court would not be decided until the May terms and asking the Council to let the Church occupy the Court House until a suitable house could be procured.

On Motion, Mr Cole,

Resolved that the Mayor be requested to notify Shiloh Baptist Church that they can occupy the Court House until 1<sup>st</sup> June next, they paying all expenses for fuel & light and to vacate after that time without further notice.

The Mayor presented and read a circular from J L Bass, Sec'y [blank] Assn at Atlanta asking a contribution of \$15 to defray expenses of the Assn.

Referred to the Finance Committee.

Mr Myer moved to go into election of the Councilman in place of T McCracken, resigned, which was seconded & whereupon

Mr Foster, moved that the election of Councilman in place of Mr T McCracken be postponed until next meeting which was also seconded put to the vote and adopted.

The Council then adjourned.

At a Called Meeting of the Common Council of the City of Fredericksburg held at the Council Chamber on Thursday March 1<sup>st</sup> 1888

The Mayor stated that the Council was called at the request of the Ordinance Committee, the Committee desiring to submit the ordinance prepared concerning the proposed Street Railway.

Mr Gouldman, Chrmn Ordinance Committee presented the following ordinance which was read: Whereas by Act of the General Assembly of Va approved April 11<sup>th</sup> 1887 the Fredericksburg Street Railway Company was incorporated and given power and authority to construct, equip, maintain, and operate a Street Railway along the Streets of the City of Fredericksburg, with the consent of the Common Council of said City, and into any adjoining County on the County roads of said County with the Consent of the County Court of said County; and said company hath applied to the said Common Council of Fredericksburg for permission under said act, to construct and operate a Street Railway along certain Streets of the said City; now therefore be it ordained by the Mayor and Commonalty of said City, that said Company be and they are hereby granted permission to construct and operate a Street Railway, along the following Streets, Viz; Sophia or Water, Caroline or Main, Princess Ann, Charles, William or Commerce, and such other of the present Streets of said City parallel to said William or Commerce Street as said Company may select as necessary to make connections for a continuous [Page 119] circuit subject to the following restrictions and conditions, to wit:

1<sup>st</sup> The construction of said Railway shall be made under the supervision and direction of the Street Committee of the Council, of such other authority or Agency as may be substituted by said Council, and said Railway and the moving of the cars over the same shall be at all times subject to the Police regulations and control of said City of Fredericksburg.

2<sup>nd</sup> The tracks to be laid shall be of uniform width and of Standard gauge, so that vehicles of the usual and customary width may travel along the same.

3<sup>rd</sup> Said Railway shall be constructed so as not to impede or obstruct the flow of water on any Street or in the gutters of any Street, and it shall conform to the existing or future grades of the Streets through which it passes; and after being built, should any change be made in the grade of any Street along which said Railway passes, such Railway shall be altered and made to conform to the grade to which such street is made by said City at the expense of said Company.

4<sup>th</sup> Upon all the Streets of the City which said Railway may be laid, it shall be the duty of said Company to keep in repair that portion of the Street which lies between the rails of the track and one foot beyond each of the rails, and should the said City at any time pave or macadamize any of said Streets, or any portion of the same, on which said track is laid, it shall be the duty of said Company to pave or macadamize at its own cost all that portion of such Street lying between the rails of its track and one foot beyond each of said rails under the supervision [Page 120] and direction of said Street Committee or such other agency as the Council may appoint.

5<sup>th</sup> Said tracks shall be laid as nearly level with the surface of the Streets as possible, and as near the centre of the Street as practicable, so as not to interfere with any sewer, gas or water pipes already laid or which may hereafter be laid by order or permission of the City.

6<sup>th</sup> Said Company shall have authority to use horse, electric, or cable power to propel its cars.

7<sup>th</sup> The permission hereby given shall vest in said Company the exclusive right to erect, build and operate a Street Railway upon and along the Streets of said City as heretofore named; provided that if said Company shall fail to begin substantially and in good faith the work of constructing said Railway within four years from the passage of this ordinance, of it shall fail to complete at least one mile of said Railway within the period of eight years from the passage of this ordinance then all the rights and privileges hereby granted shall be and are hereby declared forfeited.

8<sup>th</sup> The City reserves the right to fix the maximum rate of speed for the running of the cars of said Company in the City, and the Maximum fare to be charged upon the same shall be five cents.

9<sup>th</sup> Nothing in this ordinance shall prevent the City from at any time imposing such charges in the way of license taxes or otherwise, upon said Company for the privilege of transporting freight or may in the judgment of the Council be just and proper to equalized the charges for like privileges imposed on Carts, Wagons, Drays and other vehicles.

On Motion Mr Knox, the rule was suspended for the purpose of acting upon the ordinance.

Mr Wroten moved that the word "four" in the 7<sup>th</sup> section be stricken out and the word "three" inserted instead, which was seconded, Whereupon

Mr Hunter moved that the ordinance be amended by striking out in the 7<sup>th</sup> Section the word "Four" and inserting the word "three" also by striking out the word "eight" in the same section and inserting the word "six" which was also seconded and put to the vote by Ayes & Noes and adopted by the following vote:

Noes Mess'rs Foster, Rowe, Phillips, Gouldman

On Motion Mr Knox, the ordinance as amended was adopted.

The Mayor presented a communication from Major E F D Myers, Supt R F & P Rail Road asking that a fine recently imposed upon the Company be remitted.

Mr C C Cox, Ag't of the Company was present and permitted to be heard; Mr Robinson, Police Officer was also heard, both making their statements as to the speed of the cars, at the time the fine was imposed.

Mr Hunter moved that the fine imposed upon the Richmond, Fred'g & Potomac Rail Road Co be remitted which was seconded put to the vote by Ayes & Noes and lost.

The minutes of the last meeting were read and approved.

Mr Wroten, Chrmn Street Comm in response to the resolution passed at the last council reported that in a conference with the owner of the Boxley property, he was willing to relinquish the land through which the extension of Wolfe Street passes provided the Corporation would remove the house from its present location in a line with the Street and place the same in good tenantable condition, the Committee further reported that the house could be removed and put in good condition for \$200.

On Motion, Mr Rowe,

Resolved that the report of the Committee be received and that they be authorized to have the building removed at a cost of not exceeding two hundred dollars.

Mr Knox, Chrmn Finance Committee, reported adversely upon the Application of the Atlanta Association up for a donation of \$15.00

Mr Wroten, Chrmn Street Comm, presented a bill of O D Foster & others Commissioners appointed by the Corpo Court amt'g to \$12.00 which on motion was ordered to be paid.

Mr Rowe, Chrmn of Pub Prop Comm reported that the Reel and Hose and Gum boots had been purchased and had arrived and been paid for [Page 123]

Mr Wroten presented a communication from Shiloh Baptist Church asking the Council to grant the Church the privilege of erecting a building at the foot of Hanover St on East side of Sophia St; in which to hold their services of worship until further arrangements can be made by them for building permanently.

On Motion, Mr Gouldman, the application of Shiloh Church was refused.

Mr Rowe, Chrmn Gas Comm, reported that two of the Electric Lights had been removed, the one from the old Fair Grounds to near the P F & P R Rd Depot, the other from the Pickle Factory to the two bridges at the lower end of the New Street.

Mr Knox, Chrmn of City Water Works, submitted a written report from S J Quinn, Supt City Water Works, which was read.

Mr Knox offered the following which was adopted.

Resolved that the committee on Water be instructed to enquire as to the most eligible site for a reserve reservoir, its necessary dimensions and the probable cost of constructing it and report at a meeting of the Council to be called for the purpose of considering said report.

Resolved that in prosecuting this work the committee is authorized and empowered to employ an expert to make the necessary surveys and estimates of cost.

The Mayor presented a communication from S J Quinn, Sec'y of Trustees Public Schools informing the Council of the expiration of the term of Service on 4<sup>th</sup> April proximo of HM D Martin from the Upper and C L Cole from the Lower Ward, as trustees of Public Schools and requesting that their successors be elected at the present meeting for the term of three years.

The Council proceeded to the election of two trustees to succeed Mess'rs H M D Martin and C L Cole and the ballots being counted resulted in the [Page 124] re-election of H M D Martin for the Upper and C L Cole for the Lower Wards, as Trustees of Public Schools for the term of three years, from the 4<sup>th</sup> of April 1888.

The Mayor presented and read a communication from Mr A H H Bernard, asking the Council to do certain work to improve the drainage of his pavement &c.

On Motion, Mr Rowe, the Communication was referred to the Street Committee.

Mr Rowe, Chrmn Special Committee appointed by the Council to wait on the President of the United States and invite him to stop at Fredericksburg on his trip South, reported that the Committee had performed that duty and expressed themselves as highly pleased with the President in their interview with him, the President regretted that he could not visit our City at the time, but stated that he wished to do so in the near future and the Committee thinks the prospect of a visit from the President is very good during Summer or Fall.

The Mayor reported the Police Officers had performed their duties faithfully during the past quarter, and recommended that their salaries be paid.

On Motion, the Treasurer was directed to pay the Police Officers their salaries for the quarter ending 31<sup>st</sup> Inst.

Mr Rowe, Chrmn, Washington Monument Comm, reported that matters were progressing favorably in regard to the appropriation asked for from Congress.

A Communication from C E Hunter and others owning the Opera House was presented and read asking the council to fix the license tax upon the Opera House at \$100 for all performances during the Year. On Motion, Mr Gouldman, the communication was referred to the Finance Committee.
