At a Regular Meeting of the Common Council of the City of Fredericksburg held at the Council Chambers on Friday January 18th 1889

The minutes of the last meeting were read and approved.

Present: W E Bradley—councilman

Mr Knox, Chrmn Finance Comm, presented an account of J W Adams amt'g to \$4.90, which on motion was ordered to be paid.

Mr Foster, Chrmn Pub Prop Committee, reported that the Committee had examined the apparatus &c of the Fire Department and found same in very bad condition.

The Committee at once took steps to have the property put in as good condition as possible and employed hands for the purpose.

Mr Cole of the Pub Prop Committee, also spoke of the condition in which the Committee found the apparatus of the Fire Department and recommended that a Janitor be appointed to take charge of the property of the Department and that an ordinance be framed regulating and governing the Fire Department.

On motion Mr Willis, the subject was referred to the Ordinance Committee to report a suitable ordinance for the government of the Fire Department.

Mr Wroten, Chrmn Street Comm, reported the New Street in rather bad condition owing to the large number of teams passing over it, and its being new made earth. Main & Commerce Streets he reported in fine condition about 1500 loads of dirt had been removed from same and a number of loads of gravel put upon Commerce and Main Streets.

The Mayor presented and read a letter from Maj E P D Myers, Supt R F & P R Rd with a report from Engineer W F Gordon [Page 166] in regard to drainage about the Depot of the Rail Road Company Property.

On Motion, Mr Willis, the letter of Maj Myers, with the report of Engineer Gordon was referred to the Street Comm for report.

Mr Willis, Chrmn Water Comm, presented the official bond of S J Quinn, Supt Water Works in the penalty of \$2000 with Geo Gravatt and E D Cole as securities, which was approved by the Council and turned over to the Mayor to be deposited in the National Bank of Fredericksburg for sale keeping.

Mr Willis, reported in writing the cost of the new reservoir \$3487.33.

On Motion the report was received and ordered to be filed.

Mr Willis stated the Committee on Water recommended that Mr Quinn be allowed \$100 for extra duty in building the new Reservoir.

On motion, the sum of one hundred dollars was allowed Mr S J Quinn for extra services in building the new Reservoir.

Mr Colbert presented the following which was adopted.

Whereas with the view of promoting, and to the end of securing an appropriation by Congress a fund to be expended in the cleaning out and perfecting the navigation of the Rappahannock River, the same being in a distressing state for that purpose, and to that end, that proper representations of the matter may be communicated to our Representative in Congress, Hon Bayley Brown.

Therefore, be it Resolved that this Council appoint a Committee of five composed of two members of the Council and three Citizens of this City who shall confer with Mr Henry Williams, Agent of the Weems Line of Steamers running between this point to Norfolk, Baltimore, and other cities and the captains of the respective Steamers as to the extents and character of the improvements in said River necessary and such information as they may gather from other sources of value concerning the same and that [Page 167] upon the accumulation of information they will represent the grievances touching the same, to the Hon Bayley Broan and urge him to use his best endeavors in Congress to secure the required amount necessary to perfect the bed of the said river and thereby further its facilities for navigation and that the said Committee will report to the Council the result of their work at the next meeting of the Council.

Mess'rs G W Wroten, and J M Griffin of the Council and W K King, Charles Wallace and W D Scott of the Citizens were appointed as the Committee.

Mr Gouldman, Chrmn Light Comm, reported that the Committee had ordered a light to be placed at the foot of Rocky Hill, on Sophia Street.

Mr Griffin, Chrmn, School Committee, presented and read a communication from the Trustees of Public Schools in response to the resolution passed by the Council October 19th 1888.

On Motion, Mr Wroten, the communication was received.

Mr Knight offered the following which was seconded.

Resolved that it is the opinion of the Council that the course of study in the Coloured Schools ought to be extended so as to include branches taught in the grammar grades as well as the primary, thereby conforming to the law which requires that Colored Schools shall be under the same rules as to general management, usefulness and efficiency as the white schools, and that the school board be requested to submit to the Council with the least possible delay a practicable plan and estimate of the cost of introducing the grammar grade studies into the Coloured Public Schools, Whereupon,

Mr Myer, moved that the resolution be laid on the table, which was seconded, put to the vote by Ayes & Noes, and lost by the following vote,

The question recurring upon the adoption of the resolution [Page 168] offered by Mr Knight and the vote taken by Ayes & Noes, it was lost, as follows

Mr Foster not voting.

Mr Willis asked and obtained leave to retire: Absent Mr M G Willis

Mr Cole, Chrmn Alms House Committee, reported 24 inmates at the Alms House, also that the claim against the County of Caroline had been turned over to the Commonwealth Atty for collection

Mr Bradley, Chrmn Health Committee, submitted and read letters from Drs Martin, Doggett, & Herndon in regards to the Mill race of Ray & Pettit and its bearing upon the health of the City.

Mr Knight offered the following which was seconded

Resolved that the Committee on Water be requested to place a hydrant on the corner of Hanover & Sophia Streets.

The Resolution was referred to the Committee on Water.

A Communication from the Washington Memorial Temple Association asking the Council if it would consent to the location of the Temple on the North East Corner of the Court House Square and upon what terms.

On Motion, Mr Wroten, the communication was referred to the Pub Prop Committee for report.

A communication from Dr L Ashton, asking the Council to grant him the privilege to erect poles for a Telephone along Sophia St to Lewis Drug Store, Corner Main & George Sts.

Mr Cole moved that the application be granted, the poles to be placed under the supervision of the Street Committee, which was seconded, Whereupon,

Mr Bradley moved that the application be laid on the table for 30 days which was also seconded put to the vote and lost.

The vote was taken upon the motion of Mr Cole [Page 169] and it was adopted.

On motion Mr Knight, the Public Property Committee was requested to sell the old Engine belonging to the Corporation to best advantage.

The Mayor reported fines since last report \$9.50 paid over to the Treasurer.

The Council then adjourned.

The Mayor stated that the Council was called at the instance of the Pub Prop Committee who would state the object of the call.

Mr Foster, Chrmn Pub Prop Comm stated that the Committee had been called on by the School Authorities in regard to depredations committed by parties the night before by breaking open the school room in the Court House and perpetrating outrages in the room and the Committee wished to know if the Armory was under the Control of the Pub Prop Committee.

Capt T McCracken was present and on motion was heard. Capt McC stated that the Military Co was in the habit of giving balls and other entertainments at the Armory for the benefit of the Company and he was satisfied that the Company was in no way responsible for the depredations committed upon the school house or had an knowledge of it. He further stated that the Company had made an arrangement with Prof Lauber of Richmond for the use of the Armory for a dancing class for 3 months and he would

be glad if the Council would allow the arrangement to be carried out as no other room in the City could be had for the purpose.

After considerable discussion in which nearly every member of the [Council] engaged.

Mr Knight offered the following which was seconded.

Resolved that the Fredericksburg Grays be [Page 171] allowed the use of the Armory as an Armory and for the purpose they have been using it, with the understanding that they allow no damage to the property, Provided that Permission is obtained by the Public Property Committee from the insurance agent for using the same for any other privilege than that of an armory, Whereupon

Mr Bradley moved that the whole matter be referred to the Pub Prop Committee with the request that the Commonwealth Attorney be consulted as to the right of granting the privilege under the contract of the Corporation with the Fredericksburg Hall Association, and report, which was also seconded put to the vote by Ayes & Noes and lost by the following vote:

Noes Mess'rs Wroten, Griffin, Phillips, Gouldman, Knight, Myer 6

The Question recurring upon the resolution of Mr Knight another discussion arose as to the power of the Pub Prop Committee over the Armory, when Mr Knight made the following addition to the resolution offered, and seconded

Provided further that the Public Property Committee shall at all times have supervision of the Hall and that there is no conflict in said privilege with the contract now existing between the Fred'g Hall Association and the Corporation.

The vote was then taken upon the resolution of Mr Knight as amended and it was adopted unanimously. The Council then adjourned.

Your Committee appointed to draft suitable resolutions expressive of the feeling of the Council at the death of Hon Jos W Sener, beg leave to submit the following:

While submitting with humility to the decrees of the Almighty we deeply mourn the sudden taken off our friend Joseph W Sener, who for a long period of years was a useful member of this Body.

As Mayor of the City, Recorder, Councilman and in every station of life, public and private he discharged his duties with fidelity, honesty of purpose and to satisfaction of the Public.

In the private station he was devoted husband, kind father, faithful friend, honest and upright in all his dealings.

Our City has sustained a great loss in the death of Mr Sener; his acquaintances & neighbors a faithful friend and true man, his Church a consistent, devoted and useful member and the various orders to which he belonged a worthy and highly respected member and official.

We recommend that the Council had in session [Page 174] together with all surviving ex-Mayors, ex-Councilmen, City and State Officials attend the funeral in a body, and we furthermore recommend that the Mayor request all business houses to close and suspend business during the funeral as a mark of respect to the deceased, and afford all employees the opportunity to attend the funeral and thus show their respect and sympathy.

Mr Foster also stated that he was requested by the Washington Memorial Temple Association to withdraw the application presented to the Council on 18th Jan'y last.

Mr Wroten, Chrmn Street Committee present the following report:

Your Committee to whom was referred the letter of Major Myers with the report of Engineer Gordon respectfully state that they have given the matter due consideration and report that the suggestion of Engineer Gordon as to conducting the water through Ray & Pettit's trunk should be entertained by the Council.

That the paving in the vicinity of Dignums should be at the expense of the Rail Road Company. If the Company should construct a brick culvert from Dignums to the River the Corporation is not to bear any of the cost.

A communication from Mr Jos McCracken, Agt of the Cable Postal Telegraph Company was presented asking the Council to grant the Company the privilege of erecting poles on Main Street to Charles St down Charles Street to Sophia Street down Sophia to Commerce, up Commerce St to the Company office, thence out Commerce to the Southwestern Corporate Limits.

On Motion Mr Willis, the application was granted, the Poles to be erected under the supervision of the Street Committee.

Mr Phillips, Chrmn Ordinance Committee submitted the following report, which was adopted. In regard to the resolution offered at the last meeting of the Council and referred to the Committee on Ordinances with the request that they bring in an ordinance defining the duty of a Janitor to be appointed for the Fire Department respectfully report;

That after having thoroughly considered the present ordinance passed October 19th 1884 regulating the Fire Department and the Power and duty of the Chief, beg to state that they are unanimously of the opinion that the existing ordinance covered the ground and protects the property of the Town in charge of the Fire Department and the Committee are further of the opinion that instead of a Janitor, a standing Committee having Special Charge of the Fire Department and matters pertaining thereto would accomplish more than the election of a Janitor.

On Motion, Mr Cole, the ordinance was requested to prepare an ordinance creating a committee on Fire Department and Police as one of the Standing Committees.

Mr Wroten for Comm on Commerce & Navigation, reported that the Committee appointed under the resolutions offered by Mr Colbert had met and selects Mr Chs Wallace as Chairman and Mr W D Scott Secretary, so far the Committee [Page 177] had done nothing, but would procure all the information possible and forward to Washington and do all in their power to get all the aid possible from the Government for the improvement of the Navigation of our river.

Mr Myer, Chrmn of Park Committee, stated that he had nothing to report save that the Park was infested with Hens, chickens &c damaging the grass and scratching the walks of the park and suggested that some steps be taken at once by ordinance or otherwise to rid the Park of these pests.

Mr Knight offered the following which was adopted.

Whereas Mr Myer having reported damage done in the Park by fowls;

Resolved that the matter be referred to the Ordinance Committee for action.

Mr Bradley asked and obtained leave to retire. Absent: Mr Bradley

The Mayor presented and read a communication from Hon A W Wallace, Judge of Corpo Court calling attention of the Council to the indictments of the Grand Jury of the Mayor & Council for nuisances permitted in the Corpo and suggesting that steps be taken for abatement of same.

On Motion, Mr Willis, the Mayor and Street Committee were requested to examine into the matter of the indictments and report at a called Meeting of the Council.

A Communication from Citizens in the upper Ward in the vicinity of Fauquier & Main Streets asking the Council to have an electric Light placed in that part of the City

Present: Mr Bradley

On Motion, the communication was referred to the Light Committee.

Mr Phillips stated that he was requested by the Rappahannock Boat Club of this place to ask the Council for the use of the Council Chamber by the Va Amateur Oarsmen in which to hold their meeting on 1st March proximo

The application was referred to Pub Prop Comm.

Mr Griffin offered the following which was adopted;

Resolved that the City Treasurer be and is hereby directed to furnish the Council at the end of the fiscal year [Page 178] a Statement of all the Corporation funds paid out to whom paid and for what purpose.

Resolved, that the Committee on Schools be requested to obtain from the Board of School Trustees a classified estimate as required of the amount of money needed for the public free schools for the Current Schools years which should have been submitted to the Council when the appropriation for Schools was asked for; and that the Committee report at the next regular meeting of the Council.

Mr Wroten stated that he with the Mayor had investigated the indictments and found that the first indictment was the one on Prince Edward Street, where the land had been condemned by the Corporation and the land raised, which caused the lands on each side of the Street to overflow.

The Second indictment the Corpo had nothing to do with, as it was for a nuisance upon the lot belonging to the Estate of Forbes & Wellford which property had been sold for taxes and bought by the Commonwealth.

On Motion, Mr Gouldman, the Street Committee was requested to have the nuisance for which the Council indicted on Prince Edward Street abated at once.

On Motion, Mr Phillips, the Mayor and Chrmn of Street Committee were requested to appear before the Court and State that the Council had taken steps to abate the nuisance on Prince Edward St.

On Motion, Mr Cole, the rule was suspended for the present meeting.

Mr Knight offered the following which was adopted.

It having been widely published through the public journals and otherwise that the grave of Mary the Mother of Washington and the unfinished Monument to her memory would be sold today at the Capitol of the United States, the Council and Mayor of Fredericksburg regarding the proposal as a scandalous reflection upon [Page 180] a civilized Community desire hereby to place upon their records the stamp of reprobation upon what would appear to be an attempt to make merchandise of those sacred and venerated relics, and it having been declared by a Mass Meeting of Citizens with the approval of the Judges of the Circuit and Corporation Courts there present, that the public authorities of Fredericksburg have an indisputable right and power to protect this sacred soil;

Resolved that the Council for the purpose of preventing any further desecration of this Spot, deem it peculiarly proper at this time to assert that right and to exercise that power and therefore instruct the Committee on Streets to cause a suitable enclosure to be erected around the said grave and monument, and to ascertain the necessary cost of opening the avenue and Street leading thereto

Mr Knox, Chrmn of Finance Committee presented the ordinance levying the License tax for the year 1889-1890 being in word and figures as the ordinance of 1888-89, which on his motion was adopted On Motion Mr Willis, the subject of publishing the license ordinance in pamphlet form to extent of 200 copies was referred to the Finance Committee with power to act.

Mr Willis, Chrmn Water Committee stated that the banks of the new Reservoir was being seriously injured for the want of rip rapping with tone to prevent further washing, the work ought be commenced at as early a day as possible and finished by or before 15th May; a fence ought also be placed around the reservoir but not until the rip rapping was finished, the Committee thought that the cost of the work would be about \$750.

Mr Knight offered the following which was seconded.

Resolved that the Committee on Water advertize for proposals for rip rapping the new reservoir and report to the Council the cost, at its next regular meeting or a special called meeting.

The vote upon the substitute offered by Mr Knight was taken and it was adopted.

Mr Phillips, Chrmn Ordinance Committee submitted the following which was adopted Resolved, that Chapter page 119 and the amendment and re-enactment of the same passed at the meeting of the Council in June 1888 be and it is hereby amended in the Section relating to Standing Committees so as to add "a Committee on Fire Department and Police"

Resolved that Chapter 52 page [blank] be amended by addition Section 18. That on and after 20h day of March 1889 it shall not be lawful for fowls caught within the Park enclosure.

Mr Griffin, Chrmn School Committee presented a communication from A B Bowering, President of the Board of Trustees Public Schools dated Feb'y 28th in response to the resolution of the Council passed Feb'y 22nd stating that the resolution would be placed before the board at the next regular meeting.

Mr Cole, Chrmn Alms House Comm, submitted the report of the Superintendent of the Alms House, shewing number of inmates at this time, 25, viz 9 Whites and 16 Colored

A Communication from S J Quinn Sec'y School Trustees was read informing the Council that the term of O D Foster from the Lower and Isaac Hirsh from the Upper Wars would expire on 4th April next and requested that their successors be elected at the present meeting.

On Motion, Mr Cole, the Council then proceeded to the election of School Trustees in place of Mess'rs Foster & Hirsh, whose terms of office expire on 4th April next.

Mr O D Foster & Mr J T Knight were nominated and balloted for and the ballots being counted resulted in the [Page 183] election of Mr O D Foster, who was declared elected Trustee of Public Schools for the lower ware for 3 years from 4th April next, Mr Knight receiving one vote

Mess'r Isaac Hirsh and B S Herndon were nominated & balloted for as Trustee of Public Schools for the upper ward and the ballots being counted resulted as follows

For Isaac Hirsh 6 For B S Herndon 4

Mr Hirsh having received a majority of the votes cast, he was declared elected School Trustee for the Upper Ward for 3 years from 4th April next.

The Mayor called the attention of the Council to the Condition of the Canal or raceway leading to Ray & Pettit's Mill and stated that from personal inspection he was of the opinion that the health of the City would be imperiled unless something was done at once to remove the mud out of the Canal as well as other obstructions.

Mr Cole presented a communication signed by M B Rowe, B Bowering & W H Hurkamp Extr which was read, asking the Council to have the water in the Mill Race turned off at an early day, so that the condition of the Canal could be examined along its whole length and suggesting that if the race was thoroughly cleaned and kept cleaned annually the land adjacent would soon be drained and become as Market gardens.

Mr Knox offered the following which was seconded,

Resolved that the Mayor be requested to notify Mess'rs Ray & Pettit that the condition of the Mill race is such as to imperil the health of the town and that they must take steps at once to remove the mud in the race and other obstructions, and thus afford a clear channel for the flow of the water.

The vote was taken upon Mr Knox resolution by Ayes & Noes and it was adopted by the following vote,

We have rec'd your communication of the 18th Inst together with Copy of your resolution passed at the regular meeting of your body, requiring us to clean out the "mill race" and in reply state that we are informed that the Grand Jury of the Corporation Court of this City under the instruction of Judge Wallace recently made a most thorough examination of all the lands appurtenant to this Mill race and of the cause of the alleged nuisance and found indictments against both the Hon A P Rowe, Mayor & the Common Council for creating a nuisance by filling up said Mill Race, and with the whole matter before them and a most earnest attempt to place the entire responsibility upon us the Grand Jury declined to find an indictment against us and yet you the Mayor & Common Council both under indictments for the nuisance undertake in derogation of the Court action [Page 186] and usurping the prerogatives of the Court to shift your own responsibility and attempt to indict us by the action of your body by an equally divided vote and the casting vote of the Hon A P Rowe, Mayor.

We are advised by our attorney that this action is a contempt of the said Court and unless your ordinance is promptly repealed we shall apply to said Court to protect us and assert its jurisdiction and prerogative, We beg to be,

Mr Griffin called attention of the Council to and read an article in the *Free Lance* alleging that a proposition had been made to the Water Committee by which water could be pumped into the reservoir on the hill at a cost of \$600.

Mr G stated to the Council that no such proposition had been made to the Water Committee and he pronounced the statement false.

Mr Willis, corroborated the statement of Mr Griffin, and stated that if such a proposition had been made he would have opposed it as the limited quantity of water in the lower reservoir would not justify any such expense as \$600 to place it on the hill, with no immediate prospect of any additional supply.

Mr Gouldman, Chrmn Light Comm, reported the cost of lighting the City with electricity for the year \$1878.19.

On Motion the report was received.

Mr Cole, Chrmn Alms House Comm, presented and read the report of the Committee showing amount expended for support of the Poor for the year \$1218.09, excess of appropriation, \$18.09. On Motion, the report was received and \$18.09 appropriated to cover deficiency.

Mr Knight, Chrmn Fire & Police Comm, presented the report of the Committee, shew'g amount expended for the Fire Department \$58.50.

On Motion the report was received and ordered to be filed.

Mr Myer, Chrmn Park Comm, submitted the Annual Report of the Committee, showing amount expended on the Park for the year \$150.

That this shall be the compensation in full to us for the City's use of the race for conveying the water from the Turbine wheels of the City Water Works to the river and for sewerage purpose to the to the Waste gate at Prince Edward Street Bridge, the Committee or its agents to [Page 210] regulate the flow of water down said race, provided that we shall not be deprived of our full head of water where there is sufficiency of water in the Canal. This provision to apply to the use of the race heretofore and for the future by the City.

That in the event there shall be a need for so doing, the City through its proper officers or Committees may widen or deepen said race from the Paper Mill Site to the Waste gate at Prince Edward Street bridge free of any charge or compensation to any person or persons, the same as we could do under purchase rights.

That this agreement shall be binding on ourselves, our heirs, administrators, and assigns so long as the City shall use said race as aforesaid.

Mr Geo F Wheeler, on behalf of Mess'r Wider & Co next addressed the Council, stating that it was the object of Mess'r Wilder & Co to erect a silk Factory here which in the course of six months would give employment to about 200 hands, mostly girls from 15 years of age and upwards, and they asked of the Council a donation of a suitable lot on which to erect the Factory &c and to exempt the plant from Corporation taxes for a term of years. 4th Your Committee therefore suggests that a Committee be appointed and instructed, as soon as practicable to get such legislation was will confer upon the Corporation and the Districts of lower Stafford and Upper King George all legal power needed in the premises, embracing in such legislation a provision to submit this matter to a vote of the people in the manner provided by the previous act.

Mr Knox, Chrmn Finance Comm, stated that the Committee was not prepared to report upon the application of Shiloh Baptist Church. He presented the application of Rev'd J K Mason to have refunded to him the tax on \$300 Fred'g Bonds, assessed against him and asked the Council to consider the same at the present meeting.

On Motion, the treasurer was directed to pay to Rev'd J K Mason the amount of taxes on \$300 Fred'g Bonds erroneously assessed and paid by him.

Mr Willis, Chrmn Water Committee stated that the water works were now in running order and there was [Page 225] a good supply of water for all. He also stated that inasmuch as the people were without a supply of water for about three months owing to the breakage of the Water Power Co dam, the Committee thought it advisable to collect only nine months water rent on 1st Jan'y and on this he hoped the Council would take some action. The Committee was not prepared to report upon the subject of Mr Griffin's resolution not yet having had a conference in regard to it.

Mr Knight offered the following which was adopted.

Whereas as a result of the flood of June 1st last the Water Works of the Town were rendered useless and subscribers to the Water could not be supplied for three months, therefor be it Resolved that a rebate of three months rate of water tax be allowed to all subscribers and that nine months tax be collected instead of twelve on January 1st 1890.

Mr Willis called attention of the Council to the washout or land slide on Hurkamp land, and on his motion the Street Committee was requested to examine into the matter and ascertain if it cannot be remedied.

Mr Cole, Chrmn Alms House Comm, stated that the amount voted by the Council about 12 months since for the support of Mrs Malone and daughter was still being paid. He also stated that some reports were in circulation as to MRs M's daughter which were not very favorable.

The Mayor reported fines for the past quarter \$54; one half of which was paid to the officers, balance to the Treasurer.

On Motion, Mr Cole

Resolved that the Street Committee be requested to examine into and report upon the feasibility of grading the side walk in front of Mr Moon's Store on Commerce St and report at the next meeting.

The Mayor stated that he was informed [Page 226] by Mr S W Howard that he intended to bring suit in Judge Barton's Court against the Corporation for damages upon Miss Clark's property.

Mr Cole offered the following which was seconded,

Resolved that the Water Committee be requested to report to the Council the probable cost of a new pump house.

The vote upon the resolution was taken by Ayes & Noes and it was lost by the following vote:

Mr Colbert stated that Mr J G Mason was present and desired to be heard on behalf of Mess'r Wilder & Co.

Mr Mason, on Motion, was permitted to be heard and he presented an application from Mess'r G W Wilder & Co asking the Council to grant them the privilege of digging a canal or raceway across Princess Ann Street in order to conduct the water from the present water power canal to their proposed Silk Mill lot, and thence across Main Street by tunneling or otherwise to Christy Spring lot

Mr Colbert presented the following which was adopted.

Resolved that permission be and is hereby granted Mess'r G W Wilder & Co, or to Benj Bowering who has contracted with them, to dig a canal or raceway across the upper end of Princess Ann St to the Brick Yard lot, to conduct the water for use in the proposed Silk Mill to be built by said G W Wilder & Co on said Brick Yard Lot, and to Bridge said Canal or [Page 227] raceway, and that like permission be granted said parties to tunnel Main Street for the purpose of Conducting the water after use at said Mill to the Christy Spring lot according to the petition of said G W Wilder & Co,

But all of said work is to be done with the co-operation and approval of the Street Committee, provided however that said G W Wilder & Co, their assigns and successors using said Canal and raceway across said Princess Ann Street and said Culvert or Tunnel under Main Street shall keep at all times said Canal and raceway and Bridge across Princess Ann Street and said tunnel under Main Street in good order, repair and condition.

2nd That a committee to consist of the Mayor and three members of this Council to be selected by the Mayor be appointed whose duty it shall be to take such steps in furtherance of this movement made at Boston which is hereby most cordially approved as in their judgment shall seem proper and if by them deemed best to do this by organized effort independent of the Council, then the said Committee are requested to formulate some suitable plan to accomplish this result.

And Whereas there exists in this City an Association known as the Mary Washington Monument Association of Fredericksburg,

Resolved that the citizens of Boston be [Page 230] requested to co-operate with the aforesaid Mary Washington Monument Association in this movement.

Resolved that this action be furnished the press of the Country for publication.

Mr Cole from the Committee appointed by the Council in July last, submitted a majority report in the shape of a Charter prepared by Judge A W Wallace which is in the following words.

An Act entitled An Act to authorize the City of Fredericksburg to build and operate a bridge across the Rappahannock River at Fredericksburg, and to purchase if desirable the rights and privileges owned by Charles S Scott.

Sec 1 Be it enacted by the General Assembly of Virginia that it shall be the duty of the Mayor and Common Council of Fredericksburg when petitioned by fifty voters of the City one-half of whom shall be free-holders, to cause a vote of the said City to be taken at the next election for any of the City officers, or upon notice not to exceed thirty days, advertised by hand bills and by publication once a week in the *Fredericksburg Star*, and the *Free Lance*, upon the question of authorizing the Common Council of said [Page 232]

City to build a bridge across the Rappahannock River at some point between Fauquier Street and Prussia Street of said City, and, if desirable to purchase the rights and privileges owned by Charles S Scott incident to an appertaining to what is known as Scott's bridge. The entire cost of building said bridge, including the purchase of all rights and privileges above mentioned not to exceed the sum of twenty thousand dollars. Such vote to be taken at the usual voting places in the Upper and Lower Wards in Fredericksburg, pursuant to Section 1224 of the Code of Virginia 1887, except that on the ballots used shall be printed or written "for the bridge" or "against the bridge" instead of "for the subscription" or "against the subscription" as provided by such section. If it shall appear that a majority of the qualified voters voting at said election, which shall include a majority of the free holders so voting are in favor of the building of said bridge and the purchase if desirable of the right and privileges above mentioned, provided the purchase price of said rights and privileges is not to exceed four thousand dollars. Sect 2nd The Mayor and Common Council of Fredericksburg are authorized to issue bonds, and to create a loan in the name of and binding the City of Fredericksburg for the purposes mentioned in the first section of this Act to an amount not exceeding twenty thousand dollars, bearing interest at the rate of six percent per annum, redeemable in ten years and payable in thirty years, and to negotiate said bonds at a rate not lower than their par and face value. Said bonds to be secured by a mortgage on said bridge and on the rights and privileges mentioned in the first section if purchased. And said Common Council is hereby directed to levy a tax on the real and personal property of the said City of Fredericksburg not to exceed fifteen cents on said the one hundred dollars to pay the interest on said bonds, to [Page 233] provide for the expense incident to operating said bridge and to create a special sinking fund of five hundred dollars per annum to pay said bonds at maturity.

Sec 3rd Said Mayor and Common Council are authorized to operate said bridge, to make said bridge as free bridge or to charge toll at a rate not to exceed five cents each way for one foot passenger, ten cents each way for every man on horseback, and five cents a wheel each way for every carriage, wagon, or cart, or it may be made free to the Citizens of Fredericksburg City or to any portion of Stafford and King George Counties upon the payment of a specific sum of money annually to the Treasurer of the City of Fredericksburg, said sum to be agreed upon by said Common Council and by authorized parties of said portions of said counties.

Sec 4th The title to said bridge and all rights and privileges in this act mentioned if purchased shall be in the City of Fredericksburg.

Sec 5th This act shall be in force from its passage and all acts inconsistent with this Act are hereby repealed.

Mr McCracken moved the adoption of the report which was seconded, Whereupon

Mr Knight offered as a minority report the following amendment to the Act or report offered by Mr Cole, touching the location of the bridge.

In the upper or lower ward of said City as shall be determined by the qualified voters of said at the said election, which was also seconded and the vote on same taken by Ayes & Noes it was lost by the following vote:

And the Council hereby directs the Mayor to appoint a Special Committee of three citizens and three member of the Council to be known as the Bridge Construction Committee, to take charge of all matters concerning the building of said bridge and to report from time to time to the Council.

Mr Knox offered the following which was adopted,

Resolved that the Chairman of the Bridge Committee read the bills prepared by them for Stafford & King George counties.

Mr Colbert asked and obtained leave to retire, Absent: Mr Colbert

On motion, Mr Cole, the rule was suspended for the present meeting.

Mr Bradley offered the following which was adopted.

Whereas a recent disastrous fire has destroyed many of the manufacturing establishments of Lynn Massachusetts, and swept out of existence many of their industries,

And Whereas the people of this City have heard with profound regret of the loss and damage to Lynn, be it Resolved

1st That the Council of the City of Fredericksburg extends to the Citizens of Lynn the sincerest sympathies of this community in their calamity.

2nd That the Council invites the Manufacturers and others of the City of Lynn before re-building their factories to visit this City where a genial climate, fine water power, cheap labor and land at low prices and low rates of taxation offer many advantages not found elsewhere.

3rd That every facility will be extended parties [Page 235] desiring to examine the advantages of our section by the Council.

4th That public aid in the shape of exemption from taxation, the gift of a site or some other satisfactory aid will be given by the Council to reliable parties wishing to establish a plant here.

5th That this action of the Council be communicated to the people of Lynn

Resolved that a committee of two be appointed by the Mayor who shall prepare a suitable circular to be sent to each manufacturer in Lynn, containing the above resolutions and setting forth the advantages of Fredericksburg as a manufacturing centre, also that the resolutions be published in a Lynn paper, and a copy be sent to the Mayor of Lynn.
