# Fredericksburg Council Minutes 1902

At a regular meeting of the Common Council of the City of Fredericksburg, Virginia held pursuant to notice in the Council Chamber of said City on Thursday the 16<sup>th</sup> day of January 1902 at 7:30 o'clock PM There were present Capt T McCracken, Recorder, Acting Mayor

Councilmen E D Cole, W E Bradley, J P Rowe, C W Jones, M S Chancellor, S S Bradford and Lawrence Perry

The meeting was called to order and the minutes of all meetings held since October 21st last were read and approved (but not signed by the Recorder)

Col Cole, Chairman Finance Committee presented bills of the *Free Lance* for \$3.00, a bill of R A Kishpaugh for \$1.00, a bill of Dr K N Goolrick for medicine furnished prisoners in Jail \$5.20 and a bill of Dr J N Barney for medical services to prisoners in jail amounting to \$9.25 (said services having been rendered in the absence or indisposition of the regular Jail physician and not included said physician's account against the State) in all amounting to \$18.45 were on motion ordered to be paid.

And Col Cole presented a tabulated statement of the insurance now carried on the buildings belonging to the City

On Fire Department Building, expiring in 1904	\$1,000.00
On Alms House, expiring in 1903	\$2,800.00
On Court House, perpetual	\$10,000.00
On Town Hall perpetual	\$8,800.00
On White Schools perpetual	\$5,000.00
On Colored Schools perpetual	\$2,500.00
Total insurance now carried.	\$30,100.00

Mr Jones, Chairman of Schools stated that he had received a personal letter from the President of Fredericksburg College saying that all students entered in said College by this Council on behalf of the City were doing well.

On motion of Mr Rowe the Hon Alvin T Embrey, Commonwealth Atty of the City addressed the Council, Mr Embrey stated that he appeared voluntarily on behalf of the Police Officers of the city to ask that their salaries be increased, he stated that they were paid less than such officers of any other City or Town in the State. After Mr Embrey's remarks Mr Rowe moved the salary of the four police officers of the City be increased in the sum of ten (10) dollars per month each, to take effect on and after the first day of February, 1902. A recorded vote being called for was had as follows

For said increase in salary Messrs Cole, Rowe, McCracken, Jones, Chancellor, Bradford and Perry = 7 Against Mr Bradley = 1 and the motion was adopted

Capt McCracken called Col Cole to the Chair and as Chairman of the Light Committee stated the Electric Light plant was about completed and asked that the sum of \$5,500.00 be placed to the credit of said Light Committee to be entered on account of said Plant

And on motion of Mr Chancellor the said amount was ordered to be placed to credit of said Committee for said purpose and

Capt McCracken presented a communication from John C Melville, manager of the Melville Woolen Co claiming \$500.00 damages caused by the City's Electric Light Plant in the recent washout, said communication was on motion of Mr Bradley referred to the Light Committee with request to investigate

the claim, confer with the City Attorney about it, also with Engineer Willis and report to the Council thereon.

Capt McCracken also presented a letter from J G Clark, agent for Martha E Clark for water rent from Sept 1<sup>st</sup> 1901 to Dec 1<sup>st</sup> 1901 amounting to \$202.50, which on motion of Mr Bradley was referred to the Light Committee for investigation conference with the City Attorney and report thereon to the Council.

Mr Rowe moved that a Committee of the Business Men's Association who were present should be heard, which was carried and Mr W D Carter on behalf of said Committee addressed the Council on behalf of the importance of investigating the condition of the gas mains, particularly in the Streets proposed to be paved or macadamized and also the water mains in said streets before the same are so improved.

Mr Bradley moved that the matter be referred to the Light Committee for investigation and report and Mr Rowe amended the motion empowering the Light Committee to employ an expert engineer, a recorded vote was called for on the amendment and had as follows;

For Messrs Rowe, McCracken, Perry = 3

Against Messrs Cole, Bradley, Jones, Chancellor, Bradford = 5 and said amendment was lost Whereupon a recorded vote on the original motion to refer was demanded and had as follows For Messrs Cole, Bradley, McCracken, [Page 433] Chancellor & Bradford = 5 Against Messrs Rowe, Jones & Perry = 3 and the motion declared adopted

A letter from Mr St G R Fitzhugh & Capt M B Rowe, a committee of the Executive Committee of the Fredericksburg and adjacent National Battlefield Park Memorial Association of Virginia asking that the sum of \$250 be paid out of the City Treasury to further the purpose of said Association was read and on motion of Mr Bradley the Treasurer of this City was directed to pay to Hon H F Crismond, Treasurer of said Association the sum of \$250.00

Col Cole presented an ordinance relating to carrying concealed weapons, and

An ordinance relative to the sale of torpedoes, pop-cracker &c both of which were on motion referred to the Ordinance Committee for report thereon

And Mr Jones offered an ordinance concerning signs & sign boards which on motion was referred to the Ordinance Committee for report on same

Mr Jones moved to pass by the election of Superintendent of City Water Works, a recorded vote was called for an had as follows

For motion to pass by Messrs Bradley, Jones & Bradford = 3

Not to pass by Messrs Cole, Rowe, McCracken, Chancellor, Perry = 5 and the said motion was defeated

Mr Rowe moved to go into the election of Superintendent of City Water Works which was carried

Mr Chancellor moved that the salary of said Superintendent be fixed at same as last year \$900 Mr Jones moved to amend said motion and fix said salary at \$750; a recorded vote was demanded & had on the amendment with result as follows

For Messrs Jones & Bradford = 2

Against Messrs Cole Bradley, Rowe, McCracken, Chancellor, Perry = 6 and the amendment was lost and Mr Chancellor's motion fixing said salary at \$900 was adopted and the application of Capt S J Quinn for re-election was read and a ballot being had he was unanimously elected Superintendent of the City Water Works for the year 1902

Col Cole moved to go into election of Superintendent of City Gas Works, which was adopted

And Col Cole moved to fix salary at same as last year \$800.00

Mr Bradford moved to amend & fix salary at \$900.00; Mr Bradley moved to further amend by fixing salary at \$700.00, the question being on Mr Bradley further amendment a recorded vote was called and had as follows

For said further amendment Messrs Bradley & Jones = 2

Against Messrs Cole, Rowe, McCracken, Chancellor, Bradford & Perry = 6

And said amendment was lost, and a recorded vote being demanded on Mr Bradford's amendment to the original motion was had as follows;

For [Page 434] said amendment Messrs Bradford & Perry = 2

Against Messrs Cole, Bradley, Rowe, McCracken, Jones & Chancellor = 6 and said amendment was defeated

And the question was on the original motion of Col Cole to fix salary at \$800 and another recorded vote being demanded was had with the result, viz;

For Messrs Cole, Rowe, McCracken, Chancellor, Bradford & Perry = 6

Against Messrs Bradley & Jones = 2 and the salary was fixed at \$800 per year

An application of Wm Fitzpatrick for re-election was read & a ballot being had he was unanimously elected Superintendent of the City Gas Works for the year 1902.

On motion Mr Chancellor was excused and retired

Mr Bradley offered the following which was adopted

"Resolved that the Light Committee of this Council be requested to ascertain at once the probable cost of an incandescent system of electric lighting to be generated in conjunction with the Arc system now owned by the City of Fredericksburg"

Col Cole had read a petition from sundry citizens asking that an electric light be placed on the corner of 11<sup>th</sup> & G Streets (presumably Amelia & Douglas Streets) which on motion was referred to the Light Committee.

Col Cole had read a letter from Capt S J Quinn together with one from Judge Beverly R Wellford Jr of Richmond, Va calling attention to the importance of pushing the matter of a monument in Fredericksburg to General Mercer of this City who was killed at the battle of Princeton and for which the Congress appropriated \$5000 some 125 years ago, and moved that the said letters be referred to a committee of six members to be appointed by the Mayor, 3 of whom shall be members of this Council & 3 from the Citizens, 2 of whom shall be members of the Business Men's Association, the motion was adopted and Col Cole moved that in connection with the foregoing the Committee on Public Interests of the Council take up the matter before the Congress of Harbor Improvement of our City and that the Committee of the Businessmen's Association for said purpose be requested to co-operate with said Council Committee

The Recorder as acting Mayor reported fines collected \$24.00 Dog licenses 2.50

And asked what dispositions he should make of the same. On motion of Col Cole moved that the Recorder be requested to pay the same over to the Treasurer & take his receipt therefor which was carried. And the Recorder reported the police had done their duty.

Mr Rowe, Chairman of Ordinance Committee offered the following amendment to the ordinance passed on December 11, 1901, relating to the postings of notices, signs, posters &c, so that the same shall read as follows

"Be it ordained by the Council of the City of Fredericksburg, Virginia

1<sup>st</sup> That it shall be unlawful for any Corporation, Firm, City official, or other person to nail, tack, paste or in any other manner attach or cause to be attached any sign, notice, advertisements, or any other posters, to any telegraph, telephone, or electric light pole or curbing, or any public property whatever, within the limits of the Corporation, or on any trees on the streets or sidewalks or to any house, wall, or fence within said limits without the written permission of the owner or owners thereof

2<sup>nd</sup> Any violation of this ordinance shall subject to offender to a fine of not less than \$1.00 nor more than \$2.00 for each offence.

3<sup>rd</sup> This ordinance shall be in force from its passage.

Which was adopted the rules being suspended therefor

And then on motion the Council adjourned

At a regular meeting of the Common Council of the City of Fredericksburg, Virginia held in the Council Chamber of said City on Thursday the 20<sup>th</sup> day of February, 1902 at 7:30 o'clock PM

There were present Hon M G Willis, Mayor

Capt Terence McCracken, Recorder

Councilmen E D Cole, G W Wroten, W E Bradley, J P Rowe, W S Embrey, C W Jones, M J Gately, M S Chancellor, S S Bradford and Lawrence Perry

The meeting was called to order and the minutes of the last meeting were read and approved and signed by the Recorder acting Mayor and the minutes of the meeting held on December 11<sup>th</sup> 1901 which had been approved by not signed were duly signed by the Mayor.

Col Cole, Chairman Finance Committee presented the following bills, viz; S S Bradford for one half of expenses of Committee on Public Improvement to Washington \$9.50; *Free Lance* \$3.00, J W Adams, 3 bills one approved by Mayor for \$7.10; one approved by City Collector for \$6.00 & one for sundries furnished for Elections \$2.64; which were ordered paid [Page 436]

And Col Cole presented a statement from the Treasurer's books setting out the cost of the Sewers to be \$18,045.57, leaving a balance on hand to credit of Sewer account of \$8.43 which balance was on motion of Mr Bradley ordered to be turned into the general fund of the City.

Major Embrey, Chairman of the Street Committee asked for an appropriation of \$400 which sum would fill out the annual sum appropriated and on motion of Mr Wroten \$400 was ordered to be placed to the credit of the Street Committee.

Mr Rowe, Chairman of the Ordinance Committee presented the following ordinance which had been referred to said Committee at the meeting in January

Be it ordained by the Mayor and Common Council of the City of Fredericksburg

That it shall be unlawful for any person in the said Corporation to carry about his person hid from common observation any pistol, dirk, bowie knife, razor, sling shot, or any weapon of the like kind and any person violating the provision of this ordinance shall be fined not less than ten dollars; provided that this section shall not apply to any police officer, sergeant, constable, sheriff, conservator of the peace or collecting officer while in the discharge of his official duty; and on his motion said ordinance was adopted.

And Mr Rowe asked further time in which to report of the other ordinances referred to said Committee at the January meeting which request was granted.

Capt McCracken, Chairman of Light Committee, presented and had read a report which containing a full history of the Electric Light Plant built and owned by the City from its inception to its acceptance by the Committee from the contractors, which report on motion of Col Cole was received.

And Capt McCracken also presented a comparative statement of the cost of lighting the City by its own plant and under the old contracts with the R E L & P Co

And Capt McCracken further reported for the Light Committee that the Claim of the Melville Woolen Co against the City for \$500 damages, which had been referred to said Committee had been carefully considered and after consultation with the City Attorney they recommend that the sum of \$300 be paid to said Melville Woolen Company and further reported that Mrs Martha E Clark had waived any claim for water rent prior to January first 1902

And Capt McCracken asked that the sum of \$200 be place to the credit of the Light Committee for the purpose of putting in the additional Electric Lights heretofore ordered by the Council and on motion of Mr Bradley \$200 or so much thereof as may be needed for the purpose was ordered to be place to the [Page 437] credit of the Light Committee for putting in said additional street lights.

Col Cole presented a statement from the Treasurer's books showing the cost of the City's Electric Light Plant to be \$17,905, leaving a balance to credit of said account of \$321.44 which he moved be turned into the general fund of the city and the motion was adopted.

Mr Wroten of the auditing Committee reported that said Committee had audited the accounts of Treasurer Robert T Knox in the matter of sewers and Electric Light Plant and had found the same correct.

Mr Bradford, Chairman Committee on Public Interests made a verbal report

The Mayor reported fines collected since October \$54.00 producing Treasurer's receipt therefor

Dog tax collection on 30 males at \$1.00 30.00

4 females at \$1.50 6.00

Mr Bradley moved that the usual fee for dog licenses be allowed the Mayor which motion was adopted When the Mayor further reported that the Police had done their duty

Col Cole presented a letter from Dr J N Barney the health officer of the City in relation to sinks or wells for reception of sewage and presented also an ordinance on the subject which was read and referred to the Ordinance Committee for report

Mr Chancellor, Chairman Water Committee presented the official bond of S J Quinn as Supt of City Water Works in the penalty of \$2000 with the U S Fidelity & Guaranty Co of Baltimore as his surety and it appearing that there was a clerical error therein it was withdraw for correction.

Capt McCracken, Chairman Light Committee stated that Mr Fitzpatrick Supt of City Gas Works would give a surety Company as his surety on bond and that until said bond was prepared he considered himself bound as surety for said Fitzpatrick

Col Cole moved that when the Council adjourns that it do so to meet on Thursday February 27, 1902 which motion was adopted and

Thereupon on motion the Council adjourned to said day at 7:30 o'clock PM

At a meeting of the Common Council of the City of Fredericksburg, Va held on Thursday the 27<sup>th</sup> day of February 1902 pursuant to the adjournment of said Council on February 20<sup>th</sup> 1902

There were present Hon M G Willis, Mayor

Councilmen E D Cole, George W Wroten, W E Bradley, J P Rowe, W S Embrey, C W Jones, M J Gately, S S Bradford and Lawrence Perry.

The meeting was called to order by the Mayor

Major Embrey, Chairman of the Joint Committee on Sewerage and Street Improvement stated that that Committee was not prepared to report fully, but that the Committee desired that Mr St G R Fitzhugh the City Attorney be heard.

And Mr Fitzhugh was heard and suggested securing additional legislation to collection of costs of sewerage.

Major Embrey then stated that the said Joint Committee would need the services of a civil engineer before it could determine important questions bearing on Street paving, such as grades, the condition of gas and water pipes &c

And Mr Wroten moved "that the Joint Committee on Sewer and Street Improvement be empowered to employ an engineer and report to the Council his findings as to grades, pipes and other matters pertinent to Street paving and said committee shall also report to the Council the terms of its contract with said Engineer which motion was carried and

Col Cole moved the following

Resolved that the joint Committee on Sewerage & Street improvement obtain such legislation from the present Legislature in relation to the collection of the cost of Sewerage as may be necessary in the event that the recommendations of said joint Committee shall be adopted by the Council which was carried. Col Cole, Chairman Finance Committee, stated that the bond of Mr Fitzpatrick Supt of City Gas Works had been presented & referred to the City Attorney, said Attorney not approving the force of said bond it had been returned to said Superintendent for revision

Col Cole gave notice that at the next regular meeting of the Council he would call up the matter of the election of a Police Justice for the City.

Mr Bradley moved to adjourn till next Thursday the  $6^{th}$  of March next at 7:30 o'clock PM or to such time as the Joint Committee on Sewerage & Street Improvements were prepared to report which was adopted and the Council adjourned

Councilmen E D Cole, G W Wroten, W E Bradley, J P Rowe, W S Embrey, W H Hurkamp, C W Jones, M J Gately, M S Chancellor, S S Bradford and Lawrence Perry

The Meeting was called to order by the Mayor. The minutes of the last regular and adjourned meetings were read and approved.

Col Cole of Finance Committee presented a bill of the Commercial Printing Co for \$.50 and a bill of R A Kishpaugh for \$1.15 both of which bills were approved by the Clerk and on motion were ordered to be paid.

Col Cole stated that the bonds given by the Supt of City Water Works and the Supt of City Gas Works were in his possession and Mr Bradley moved that said bonds be presented to the Council at its next meeting which motion prevailed

Col Cole also presented the License Tax Ordinance and stated that it would be called up at the next regular meeting.

Mr Rowe of Ordinance Committee submitted the following ordinance which had been referred to said Committee

Be it ordained by the Mayor and Council of the City of Fredericksburg, Virginia

That is shall be unlawful for any person to dig or otherwise construct any well or sink to be used for the reception of sewage of any kind or description within the limited of the City;

That this ordinance shall be in force from and after its passage.

And said ordinance was adopted and

Mr Rowe asked further time for the consideration of the ordinance proposed by Mr Jones at the January meeting, whereupon

Mr Jones moved that said ordinance be now considered and Mr Bradley moved as a substitute that the consideration of such ordinance be postponed till the meeting of the Council in May next, a recorded vote was called for on the substitute and it was adopted by the following vote;

For Messrs Wroten, Bradley, Rowe, Embrey, McCracken, Hurkamp, Gately & Chancellor = 8 Against Messrs Cole, Jones, Bradford and Perry = 4 and it was so declared

Capt McCracken of Light Committee stated that said [Page 440] Committee had settled satisfactorily and in full with the Melville Woolen Co for its claim of \$500 for damages sustained by the washout at the City Light plant last fall by paying to said company \$300 as ordered by this body on February 20<sup>th</sup> last And also stated that the delay in putting up the additional Street Lights was due to the failure to secure proper poles the roads being so bad they could not be hauled.

Mr Jones, Chairman School Committee stated that the terms of Messrs A B Bowering and D C Cole as School Trustees from the Lower and Upper Wards respectively would expire in April next, whereupon Mr Rowe moved to proceed to the election of School Trustees to succeed said Trustees, which was adopted and Mr A B Bowering from the Lower and Mr D C Cole from the Upper Ward were nominated as such School trustees and a ballot being had they were unanimously elected.

And Mr Jones stated that Dr Roseboro, President of Fredericksburg College had reported to him stating that all of the city's pupils were doing well save one.

Mr Embrey chairman of Joint Committee on Sewerage and Street improvement stated that said Committee was ready to report and requested Mr St G R Fitzhugh the City Attorney to read the report, which Mr Fitzhugh proceeded to do

After which Capt McCracken moved that the report be received and 1000 copies thereof be printed for distribution which motion was carried.

As the report recommends two ordinances in relation to sewer it, under the rules lies over

Col Cole moved that the ordinance passed tonight in relation to well or sinks be reconsidered, which motion prevailed, and Cole presented and had read another ordinance on the same subject which lies over under the rules.

Col Cole offered the following

Resolved by the Council that this City shall have a Police justice in pursuance of the Act of February 18, 1898 (pending which the Mayor called the Recorder to preside and vacated the chair)

And Mr Perry offered the following as a substitute for Col Cole's resolution.

Resolved that the matter of creating the office of Police Justice be postponed and that the Ordinance Committee of this Council be and is hereby instructed to report at the next meeting of the Council such an ordinance as will provide for submitting to the people in the Spring election the question whether Fredericksburg shall have a Police Justice?

And a recorded vote being called for was had as [Page 141] follows

for the substitute Cole, Wroten, Rowe, Embrey, McCracken, Hurkamp, Jones, Gately, Chancellor and Perry = 11

Against the substitute Mr Bradford = 1 and the substitute prevailed

And then on motion the Council adjourned

At a called meeting of the Common Council of the City of Fredericksburg, Virginia held pursuant to notice in the Council Chamber of said City on Wednesday the 9<sup>th</sup> day of April 1902 at 4 o'clock PM Present Hon M G Willis, Mayor

Councilmen E D Cole, Geo W Wroten, W E Bradley, J P Rowe, M S Chancellor, W H Hurkamp and Lawrence Perry

The meeting was called to order

Col Cole stated that the meeting had been called to hear a proposition from a Committee of the Businessmen's Association composed of Messrs C J Steigle, Dr J E Tompkins, and Henry Dannehl who were present

On motion of Col Cole it was ordered that the Committee be heard.

Mr Steigle addressed the council and stated that an extended correspondence had been conducted between the Businessmen's Association and the Union Veteran Legion in reference to the latter holding its annual meeting in this place this year. He stated that the organization asked in case they decided to come here that a hall should be furnished them in which to meet, a few committee rooms, that each member should provided with a badge and that the commander and his staff, ten persons in all should be entertained while here, which would be about three days. The total cost he thought would not exceed \$200, half of which the Businessmen's Association agreed to pay. He was instructed to ask that the Council would unite in the invitation and appropriate \$100, for the entertainment of the Legion.

Whereupon Col Cole submitted the following paper which was unanimously adopted It having come to the knowledge of the City Council through the Businessmen's Association that the Union Veteran Legion proposed to hold its annual session in this city in October, be it [page 442] Resolved: that the City Council does most heartily approve of the request of the businessmen's Association, having in view the extending of an invitation to the Union Veteran Legion to hold their annual session in city in October next, and

Resolved further that this Council does hereby request the Mayor to appoint a special committee of three to act in co-operation with a like committee from the Businessmen's Association in extending this invitation and in preparing for the guests should the invitation be accepted

Resolved that the Council does hereby appropriate the sum of \$100 to the entertainment of the Union Veteran Legion where a like amount shall have like been appropriated by the Businessmen's Association.

Resolved further that the Mayor instruct the clerk of the Council to extend this invitation to the Union Veteran Legion in behalf of the City

And

The mayor under the 2<sup>nd</sup> resolution appointed the following committee viz; Col E D Cole, Maj W S Embrey and Mr William E Bradley.

On motion of Mr Bradley the Council adjourned M G Willis, Mayor

At a regular meeting of the Common Council of the City of Fredericksburg, Virginia, held pursuant to notice in the Council Chamber of said City on Thursday the 17<sup>th</sup> day of April 1902 at 8 o'clock PM There were present Hon M G Willis, Mayor

Councilmen E D Cole, G W Wroten, W E Bradley, J P Rowe, E S Embrey, W H Hurkamp, C W Jones, M S Chancellor, S S Bradford and Lawrence Perry

The meeting was called to order and the minutes of the last called and regular meetings were read and approved.

Col Cole, Chairman Finance Committee presented and had read a list furnished by the Commissioner of the Revenue containing the names of all merchants doing business in the City, the account of their purchases annually and the amount of license tax levied thereon and

Presented also, pursuant to notice given at the regular meeting in March, the License Tax ordinance for the year beginning on the 1<sup>st</sup> day of May 1902. He stated that with the exception of a few changes, it was the same as last year, and proceeded to call attention to said changes namely in Section 8, 10, 11, 38, and 41, and in paragraph 4 of the General Provisions, and Mr Bradley moved to amend Section 38 making the tax therein act out \$7.50 instead of \$3.50, which amendment the Committee accepted and the said License Tax Ordinance as reported and amended was adopted by the Council. It is as follows, viz;

An Ordinance imposing Taxes in the City of Fredericksburg for the support of the City Government, the payment of the interest on the City debt and other expenses and providing for the collection thereof

1. Be it ordained by the Common Council of the City of Fredericksburg in the manner following that is to say, there shall be an annual license tax assessed and paid by all persons and firms in the City engaged in the different descriptions of business, professions and occupations named in this ordinance and enumerated below for the year beginning on the 1<sup>st</sup> of May of each year and ending on the 30<sup>th</sup> of April of each year.

The license tax shall be assessed and collected at the following rates and paid on or before the 1<sup>st</sup> of May of each year.

- 1. On every license to a Steam boat, steam ship, or other transportation agency (other than express companies) in this city the specified tax shall be \$35.00.
- 2. On every license to any person renting houses, farms or other real estate for compensation or profit, the tax shall be \$15.00
- 3. On every agent for the sale of books or maps, or canvasser for any book, newspaper, periodical, magazine, map, engraving, or picture, or solicitor for subscriptions thereto, ten dollars (\$10.00)
- 4. On every agent for copying pictures, fifteen dollars (\$15.00)
- 5. On the agent of each incorporated insurance company doing business in this city, thirty five dollars (\$35) But this shall not apply [Page 444] to the agent of accident insurance companies doing business in the City, upon whom the tax shall be ten dollars (\$10)
- 6. On every agent for hiring labor, ten dollars (\$10)

- 7. On every mercantile agent or reporter reporting the financial standing and credit of persons engaged in business, twenty-five (\$25)
- 8. On every agent for the sale of real estate, residing or keeping an office in the City, twenty dollars (\$20) Attorneys, Doctors &c
- 9. On every attorney-at-law, physicians, conveyancer, dentist, surveyor, civil engineer, the gross amount of whose professional receipt for the year ending April 30, 1902 was less than \$1000, ten dollars (\$10). Where the gross amount of their professional receipts for the same time was \$1000 and less than \$1500, fifteen dollars (\$15). Where such receipts were \$1500 and less than \$2000, twenty dollars (\$20), and for \$2000 and over, twenty five dollars (\$25). All persons other than duly licensed attorneys-at-law who for compensation shall prepare deeds, contracts, wills, or other writings shall be deemed conveyancers. Auctioneers
- 10. On every general auctioneer, \$20 whether he derives any compensation for his services or not.
- 11. Concession crier, fifteen dollars (\$15.)

Billiard Tables, Bowling alleys &c

- 12. On every license permitting a billiard or Pool Saloon to be kept in the City (whether a charge is made for playing or not) the tax shall be twenty-five dollars (\$25) and each additional table ten dollars (\$10).
- 13. On each bagatelle, Jenny Lind Or Dexter table ten dollars (\$10) and if said table is kept in the same house with or in any way attached to a bar room, hotel, boarding or eating house, this tax is imposed whether any charge is made by the proprietor thereof for the use of said table or not, and whether said table is used or not.
- 14. On every license permitting a bowling saloon or ten-pin alley (whether a charge is made for playing or not) to be kept in this City, the tax shall be ten dollars (\$10) on each alley.

Bill Posters

15. On every bill-poster ten dollars (\$10)

**Bakers and Confectioners** 

- 16. On every person keeping a bakery or manufacturing confectionary, other than merchants, ten dollars Boarding Houses, Hotels, Eating Houses &c
- 17. On every person keeping a boarding house ten dollars (\$10). Any person other than the keeper of a hotel, eating house or restaurant who shall furnish for consumption, board and lodging to any number of persons not less than five, for a period or time of one month or more shall be deemed a boarding house keeper. Any boarding house keeper who shall take boarders for a less period than one month, shall be deemed a hotel keeper.
- 18. On every person keeping a hotel, twenty dollars (\$20), but this license shall not cover the right to sell wines, spirituous or malt liquors.

- 19. On every person keeping an eating house or restaurant, sixteen dollars (\$16). Any person who shall cook or otherwise furnish for consumption diet or refreshment of any kind for casual visitors at his house and sold for consumption thereon and who is not the keeper of a hotel or boarding house, shall be deemed to keep an eating house or restaurant, but the refreshments herein named shall not consist of wines, spirituous or malt liquor, except where parties have license to sell the same.
- 20. On every person selling upon the street or other public place snacks and such like eatables five dollars (\$5), or \$1.50 per quarter.

Bankers, Brokers &c

- 21. On every private banker, two hundred and fifty dollars (\$250). The term "private banker" shall include all persons conducting the business of a stock, note, bond, money or bill broker.
- 22. On every pawn broker twenty-five dollars (\$25)

**Itinerant Doctors** 

23. On every chiropodist, cancer, eye or other itinerant doctor or optician ten dollars (\$10) Photographic Artists

24. On every daguerrean or photograph artist, twenty dollars (\$20).

## **Express Companies**

25. On every express company doing business in the city, done exclusively in the city not including business done to & from points without the State or business done for the Government of the United States its officers or agents \$100, and in default of the payment of the license tax for thirty day after the same becomes due a penalty of double the assessment of the tax hereby imposed half be incurred and shall be paid by each such defaulting company.

Junk Dealers

26. On any person trading in any kind of second hand articles, junk, old metals, rages, or other like commodities, thirty five dollars (\$35) and for each canvasser or agent canvassing the city for the purpose of buying junk or other matter for junk dealers or themselves, fifteen dollars (\$15)

Livery Stables

- 27. On every keeper of a livery stables thirty dollars (\$30)
- 28. On every two-horse hack, phaeton, omnibus, carriage, or wagon used for hire, eight dollars (\$8) on every buggy used for hire four dollars (\$4); on every one horse wagon, dray or cart used for hire four dollars (\$4).

# Liquor Dealers

- 29. On every person selling by wholesale wines, ardent spirits, malt liquors, or any mixture thereof, one hundred and sixty dollars (\$160), but where a person sells only malt liquors by wholesale the tax shall be twenty five dollars (\$25).
- 30. Retail liquors, including the privilege of drinking where sold, one hundred and twenty dollars (\$120). Retail malt fifteen dollars (\$15).
- 31. On every person distilling or manufacturing ardent spirits, twenty five dollars (\$25); and on manufacturing malt liquors, ten dollars (\$10)
- 32. A wholesale liquor dealer desiring to sell liquors by retail may do so by paying one-half of specific tax on a retail liquor license additional.

33. On every rectifier, twenty five dollars (\$25)

#### Merchants

34. On every license to a merchant or mercantile firm, the tax shall be graduated as follows; where the amount of purchases for the year ending April 1, 1902 did not exceed \$1000 the tax shall be ten dollars (\$10), where the purchases for the year did not exceed \$2000 the tax shall be fifteen dollars (\$15). On all purchases over \$2000, the tax shall be fifty cents on the one hundred dollars of said purchases, and upon all purchases over two thousand dollars and less than twenty five thousand dollars there shall be a tax of thirty cents on the one hundred dollars of said purchases.

Merchant tailors, lumber merchants, furniture merchants, butchers, green grocers, hucksters, dealers in coal, ice or wood shall be embraced in this section, but dealers in wood, coal or ice paying license tax under this section may peddle the same from vehicles without paying additional tax.

- 35. On every commission merchant forty-five dollars (\$45) Every person buying or selling on commission shall be deemed a commission merchant and that whether the articles bought or sold are bought or sold in this city or elsewhere.
- 36. Every agent for the sale of musical instruments, sewing machines, fertilizers, or other articles, twenty dollars (\$20)
- 37. On every person retailing tobacco, cigars, snuff five dollars (\$5)

## Medicines

38. On every person engaged in the sale on the streets or other public places of patent or quack medicines or any other articles by auction or otherwise or exhibiting the same seven dollars and fifty cents (\$7.50) for each day or night the same may be done. This license shall be a personal privilege, and only be granted by order of the Mayor.

Oysters and Fish

- 39. On every person selling oysters or fresh fish (other than duly licensed merchants) five dollars (\$5) Patent rights
- 40. On every person selling patent rights, ten dollars (\$10)

Peddlers &c

41. On every peddler, fifty dollars (\$50). Any person who shall carry from place to place any goods, wares or merchandise, and offer to sell or barter the same or actually sell or barter the same in transit or otherwise shall be deemed a peddler.

Railroad Tickets

42. On every person buying or selling railroad tickets other than the duly authorized agent of some rail road company with a depot in this city, ten dollars (\$10)

Swings

43. On every proprietor of a revolving swing, flying tournament or machine of like nature for each week ten dollars (\$10)

**Shooting Galleries** 

44. On the proprietor of every shooting gallery five dollars (\$5)

Theaters, Shows, Circuses &c

- 45. On every proprietor or lessee of a public or private building to be used for any theatrical or secular performance, panorama, or any other public exhibition show or entertainment, whether [Page 447] any charge for admission thereto is made or not, fifteen dollars (\$15), and no building shall be used for any such purpose until said tax is paid. But this section shall not apply to any exhibition held in any church or building owned or used as a place of worship by any religious congregation in the city.
- 46. The specific license tax on every show, every circus, and on the exhibition of a menagerie fifty dollars (\$50) per day, on the outside shows, whether attached thereto or not, five dollars (\$5) each. The specific license tax on every show, or exhibition of trained animals, Athletic or acrobatic performances in a tent twenty dollars (\$20) per day.
- 47. The specific license tax on any theatrical performance of any kind, professional juggler, necromancer, Negro minstrel shows concerts, lectures or other exhibitions or entertainments of like kind three dollars (\$3) for each exhibition; twelve dollars (\$12) for six consecutive days by the same exhibitor but when such exhibition performance or lecture is held or given for any charitable or literary purpose within the City, and the net proceeds actually applied or bestowed within the City to such charitable or literary purpose, the Mayor shall have power and authority to give a permit for such exhibition, performance or lecture free from all tax or charge; and every license included in the above clause shall be only granted upon the order of the Mayor. And each exhibitor shall pay the city collector the sum of seventy five cents for collecting, provided however that said collector has to leave his regular place of business to make such collection. Such license tax shall be paid to the city collector before any exhibition is held Telegraph Companies
- 48. Upon every telegraph company doing business in this City, for business done exclusively in the City, not including business done to and from points without the State, or business done for the Government of the United States, its officers or agents, thirty five dollars (\$35). And in default of the payment of the license tax herein imposed for thirty days after the same becomes due a penalty of double the amount of the tax hereby imposed shall be incurred, and shall be paid by such defaulting company.

Telephone Companies

- 49. On every telephone company having an office in the city, twenty five dollars (\$25) Dealers in Futures
- 50. Every person who shall conduct the business of dealing in what is known as futures in grain or other produce or merchandise, shall pay a specific license tax of twenty five dollars (\$25) and if a similar business be done in railroad or other stocks or bonds an additional license of twenty five dollars (\$25), but this shall not be deemed as interfering with the stock or bond dealing of regular bankers.

# **Guarantee Insurance Companies**

- 51. On every license to a person or firm to act as agent or solicitors for any company guaranteeing official or other bonds, not having its principal or home office the in the City, there shall [Page 448] be a specific license for doing business in this City of twenty dollars (\$20) for each company represented. Wagon Yards
- 52. Every person or persons keeping a wagon yard in this city shall pay upon each such yard so kept a specific license tax of ten dollars (\$10) for each year or fractional part thereof. Fortune Telling or Palmistry
- 53. Fortune telling or Palmistry when charge is made, either for admission or hand reading five dollars (\$5) per week.

### **General Provisions**

- I. Whenever a license shall be especially required by law on any business, profession or employment it shall be lawful to grant a license for said business, professional or employment. Where the ordinance aforesaid does not clearly define and provide for the same, the license may be granted according to the law, which governs in similar cases, and be subject to such restrictions as appertains thereto, and the Mayor of the City may authorize the granting of such license, which shall be deemed a personal privilege. II. All other license taxes imposed by this ordinance are subject to a pro rata deduction when the same are issued after the beginning of the year to which this ordinance applies; provided that the tax on the license issued shall always be assess as of the first day of the quarter in which issued and shall cover the period until the 30<sup>th</sup> April next succeeding.
- III. It shall be the duty of the Commissioner of the Revenue to keep a book in which he shall classify all the branches of business and occupations upon which a license tax is imposed by this ordinance and show the amount of assessment made of each license the name of the person against whom assessed and the person for which said license is issued. At the end of each quarter commencing with that ending on the 30<sup>th</sup> April 1902, he shall deliver to the Finance Committee extracts from said books showing the entries thereon made during the preceding quarter, properly classified. These extracts shall be certified under oath.
- IV. Any person who shall engage in, or exercise any business, employment or profession without license is required by law or shall in any manner violate the license or revenue laws of the city if as specified fine is imposed for such violations, shall pay a fine of not less than five dollars (\$5
- V. Every person or firm commencing business after the first day of May, and who shall fail to obtain a license within ten days thereafter shall be subject to the same penalties as in section IV.
- VI. Every license granted for the unexpired portion of the term heretofore mentioned shall be charged pro rata until otherwise provided. But no license shall be issued for a less sum than two dollars (\$2) nor granted for a longer period than to the first of May 1903.

  [Page 449]
- VII. The City Collector shall at the expiration of each week report to the Treasurer the amount of all money received by him for licenses, and pay the same over to the Treasurer, for which he shall be allowed two and one half percent.
- VIII. The Commissioner of the Revenue shall, before the first of March of each year ascertain the names of persons and firms who are engaged in any of the occupations, professions or businesses named or referred to in this license ordinance. He shall list and keep each list in his office and report copies of such list to the Common Council and Mayor on the first of April annually. He shall assess each person or firm named in the list with the license tax imposed by the ordinance and he is not authorized to release or discharge any of the persons or firms enumerated in this list who are engaged in the occupation, profession, or business upon which license tax is imposed without a judicial decision in the case. IX. Should there be an assessment made and not paid, it shall be the duty of the City Collector to make collection by levy and sale of the goods and chattels of the person assessed as is provided by the Act of the General Assembly of Virginia for the assessment lev and collection of taxes. A commission of 5

percent shall be allowed on collections so made from default or persons and such commissions shall be paid by the person or persons in default.

X. A discount of five per cent will be allowed on all licenses paid on or before May 15<sup>th</sup> of each year. XI. Be it further ordained that all laws ordinances and resolutions that are in conflict with this ordinance

XI. Be it further ordained that all laws ordinances and resolutions that are in conflict with this ordinance are hereby repealed.

Mr Rowe, Chairman of the Ordinance Committee presented the following ordinance which had been referred to said Committee and said ordinance was read and adopted it as follows to-wit; Be it ordained by the Council of the City of Fredericksburg

- 1. That is shall be unlawful for any person to dig or otherwise construct any well or sink to be used for the reception of sewerage of any kind or description with the limits of this City.
- 2. And it shall be unlawful for any person to use such well or sink already constructed for the reception of said sewerage or to permit such well or sink to remain open on his premises where the City provides sewer facilities contiguous to said property.
- 3. Anyone violating this ordinance shall be fined not less than \$5, nor more than \$25, and this fine shall be imposed for each day that this ordinance is violated after the same takes effect.
- 4. This ordinance shall take effect for May 15<sup>th</sup> 1902

And Mr Rowe also reported in response to a resolution passed on March 20<sup>th</sup> last, requesting said Committee to report on ordinance providing for submitting to the people in the Spring election [Page 450] the question, whether Fredericksburg shall have a Police Justice, that no ordinance is necessary for the purpose set forth in the resolution, that should an election for that purpose be had the ticket should read "For Police Justice", "Against Police Justice", and that separate ballot boxes, judged and clerks of election would be required as the judges and clerks conducting the May election could not act and On motion of Mr Jones the report was received and filed.

Mr Rowe of Light Committee asked permission to change the Electric Street Light from Washington Avenue & Amelia Street to Amelia and Douglas Street, read on motion the request was referred to Light Committee with power to act.

The Mayor reported fines collected \$27.50 and had read the Treasurer's receipt for same, and reported that the Police had done their duty.

Col Cole stated that an unruly child of [blank] needed restraint of some kind and Maj Embrey moved that said child be turned over to the Alms House Committee which was adopted

Petitions of sundry citizens resident of "Doswell Field" asking and Electric Street Light, and a request from E D Wheeler for an Electric Street light at the corner of Princess Anne and Charlotte Streets, were on motion referred to the Light Committee with power to act in each case.

Mr Bradley offered the following

"Resolved that the Water Committee be directed to purchase at once at a price not to exceed \$250 a street sprinkler, and put the same in operation as soon as needed to keep our streets properly sprinkled" and the resolution was adopted, and

Mr Chancellor presented a proposal from Julian School & Co to furnish a sprinkler (street) Studebaker, capacity 450 gallons for \$204.25 f.o.b. South Bend, Indiana.

Mr Bradley offered the following

Resolved: That from and after July 1, 1902, all bonded officers of this City be and are hereby required to furnish bond in some reliable Trust Company, said bond to be approved by the City Council. The resolution was adopted.

Major Embrey called up the report of the Joint Committee on Sewerage and Street Improvement which had been read at the March meeting and

Mr Bradley moved that when the Council adjourned that it adjourn to meet on Friday the 25<sup>th</sup> Instant for the purpose of considering said report, which motion prevailed. [Page 451]

Mr Jones gave notice that he would call up at the next regular meeting of the Council the report of the Committee on Fire Department made on September 20<sup>th</sup> 1900.

And on motion of Col Cole, the Council adjourned pursuant to motion this evening adopted. M G Willis, Mayor James P Corbin, Clerk

At a meeting of the Council on April 25, 1902 held pursuant to adjournment on the seventeenth instant, There were present Hon M G Willis, Mayor

Councilmen Col E D Cole, G W Wroten, W E Bradley, J P Rowe, W S Embrey, C W Jones, M J Gately, M S Chancellor, S S Bradford and Lawrence Perry.

The Mayor called the body to order and announced the order of business to be the consideration of the report of the Joint Committee on Sewerage and Street Improvement

Whereupon, Major Embrey, Chairman of said Joint Committee had said report (the same having been printed for distribution read, it was as follows

"The undersigned Joint-Committee on Sewerage and Street Improvement respectfully report that the cost of the partial sewerage of the City was as follows:

Paid to C T Hookway, the contractor	\$16,355.65
Paid to N Wilson Davis, the Engineer	800.00
Paid for right of way for sewers and incidental expenses	879.72
Making total cost of sewers	\$18,035.37
The bid of the contractor was	\$14,492.80

The differences between said bid and the above amount actually paid him was for extras allowed by the Engineer under the contract.

The Joint Committee in their original report to the Council based their estimate of the probably burden of one half of the cost of the sewers if laid on the property benefited on the original bid of the contractor for the construction of only the two main sewers east and west and the Commerce Street sewer.

It was after that estimate had been made and embodied in the report that the Committee by an addendum to their report recommended the additional sewerage from Bowering's Bridge over the Canal up Charlotte Street to Weedon Street; thence along Weedon to Mercer and Willis Streets. The Committee in said estimate did not take into consideration the cost of right of way which could not be then ascertained, nor did it estimate for the cost of [Page 452] connections of the main sewers brought to the pavements along streets to be paved.

Your Committee after the most mature reflection and after fully considering all the difficulties in the way of assessing one-half of the cost of the present sewerage against the real estate beneficial thereby, has reached the conclusion that as the present sewerage is only of limited extent, and yet the two main sewers that one the east traversing the entire length of the City – and that on the West traversing three-forths of the length of the City were the indispensable initial step in the complete system of sewerage for the City

which had been fully mapped out by Engineer Davis by direction of the Council, the entire cost of the work already accomplished should be borne by the whole city.

The Committee is also of the opinion that one half of the said cost should be returned to the City Treasury by a sewer tax extending through three years and that as said sewer tax is collected it should be applied to the further extension of the City Sewerage.

The assessed value of the real estate of the City is \$1,446,898, a sewer tax of 62½ cents of the \$100 of said assessed value would raise the sum of \$9,017.68, which sum is one-half of the entire cost of the sewers already completed.

If this amount should be raised in three annual installments the annual sewer tax for the three years would be (discarding fractions) 21 cents on the \$100 value of the real estate of the City.

The Joint Committee further recommend the adoption of the following ordinance:

"Be it ordained by the Council of the City of Fredericksburg, that:

- 1. The owner of every lot in the City with a dwelling house, Store or office building thereon which adjoins by the front, rear or side a street or alley in which there is a sewer owned or controlled by the City in which it is practicable to enter shall be assessed annually for the privilege of connection with said sewer the sum of \$3.
- 2. The owner of every lot with a house thereon as above described which adjoins by the front, rear, or side a street on alley in which there is a sewer owned or controlled by the City and into which it is practicable to enter shall form a connection from his lot with said sewer into which shall be carried all waste water except rain water, and any person failing herein for 90 days after this ordinance takes effect shall be fined not less than one dollar nor more than five dollars and each day thereafter until the connection is made shall constitute a separate offense. All such connections shall be made under the Supervision of the Superintendent of Sewers and with his approval and his written permit shall be first obtained.
- 3. Any owner of a lot who makes or causes to be made any such connection without the permit of the superintendent of sewers hereinbefore mentioned or any agent who makes or causes the same to be made without the aforesaid permit, or any plumber, bricklayer, or other person who makes such [453] connection or any part thereof without the permit aforesaid shall be fined not less than \$5.00 nor more than \$25.00.
- 4. No person shall either in a street or alley or upon any lot put any stone or brick or any other solid thing into a sewer, or shall in any way whatever injure, impair, or obstruct a sewer of fixture thereof. Any person violating any provision of this section shall be fined not less than five dollars nor more than twenty-five dollars, each day's violations of this section to constitute a separate offense.
- 5. Before any owner of a lot shall be required to comply with the provisions of section 2 of this ordinance, pipe connections with the sewers, owned or controlled by the City shall be made by the City at such points extending from the sewer to the inner side of the curb line of the street or to any alley as may be determined by the Water Committee at which points the connections from the premises provided for in said second shall be made.

(and) The Joint Committee further recommends in accordance with the written opinion of the City Attorney of June 25<sup>th</sup> 1901, the following ordinance:

Whereas a number of private sewers were laid in the Streets of the City prior to the establishment by the Council of a system of sewerage for the City;

And whereas said private sewers constitute a menace to the health of the City and one likely to become dangerous and offensive;

Be it ordained by the Council of the City of Fredericksburg

That all persons owning or interested in the private sewers laid in the streets and alleys of the City are hereby required within fifteen days after the adoption of this ordinance to remove said sewers from the streets and alleys of the City, and upon their failure to do so this Council at the expiration of said period will take the exclusive possession and control and regulation of said private sewers and they shall become the public sewers of the City and shall be subject to all ordinances, rules and regulations applicable to the

public sewers constructed by said City and connections therewith and shall be equipped with man holes; and proper connections shall be made with the public sewerage system of the City and the drainage of said private sewers into the river shall cease"

And, Mr Rowe moved that the ordinance in relation to private sewers set forth in the foregoing report be modified as follows "that the former owners of said sewers who have made connections with the same shall be relieved for a period of seven years from the charge in the Sewer ordinance [Page 454] prescribed for connection with the City sewerage", which was adopted by the following recorded vote, said vote having been demanded

for the motion Messrs Cole, Wroten, Rowe, Embrey, Jones, Gately, Chancellor, Bradford = 8 Against Messrs Bradley and Perry = 2

And, Mr Wroten moved that the provision in the ordinance in relation to the change for the privilege of connecting with the City Sewer be amended so as to substitute the sum of two dollars in the place of \$3.00 as recommended by the Committee, and a recorded vote being called for was had as follows For the amendment Messrs Cole, Wroten, Rowe, Gately, Chancellor and Bradford = 6 Against Messrs Bradley, Embrey, Jones and Perry = 4 and the said amendment was adopted

And, Mr Rowe moved to amend so much of the foregoing report in relation to the collection of one half of the entire cost of the sewer by an annual sewer tax of twenty-one cents on the \$100 of value of the real estate of the City for 3 years, and to substitute therefor the following "that instead of laying of a tax of 21 cents on the \$100 for 3 years, that a tax of  $10\frac{1}{2}\phi$  cents on the \$100 of value of real estate of the city be laid annually for six years, to be known as the "Sewer Tax" and a recorded vote being called for was had as follows

For the amendment Messrs Cole, Wroten, Rowe, Embrey, Jones, Gately, Chancellor and Bradford and Perry = 9

Against Messr Bradley, and the amendment was adopted

And Mr Embrey moved that in lieu of the recommendation of the Committee in the foregoing report in relation to the application of the sum raised by the Sewer Tax, the substitution of the following "that the whole collection from sewer tax and charges for connection be treated as one fund, out of which shall first be paid the interest on Sewer Bonds, and a Sinking fund of one per cent be set aside out of said fund and the remainder of said revenue from said sources be devoted to the extension of the Sewer system of the City, which was adopted.

Whereupon, Mr Rowe moved that the foregoing report of the Joint Committee one Sewerage and Street Improvement and the ordinances embraced therein as the same have been amended be adopted.

And Mr Perry offered a substitute for the whole another paper which was read and a recorded vote being called for one, said substitute as had as follows

For Mr Perry = 1

Against Messrs Cole, Wroten, Bradley, Rowe, Embrey, Jones, Gately, Chancellor, Bradford = 9 and the same was defeated

And Mr Bradley then offered a substitute for the whole [Page 455] which was read and a recorded vote being called for was had as follows

For the substitute Messrs Bradley, Gately and Chancellor = 3

Against Messrs Cole, Wroten, Rowe, Embrey, Jones, Bradford and Perry = 7 and said substitute was defeated.

Whereupon a recorded vote was called for on Mr Rowe's motion, with the following result For Messrs Cole, Wroten, Rowe, Embrey, Gately, Chancellor and Bradford = 7 Against Messrs Bradley, Jones and Perry = 3 and the motion prevailed

And Mr Rowe offered the following which was adopted

Resolved that the Finance Committee proceed to provide for the Sewer Tax set forth in the foregoing ordinance just adopted.

Mr Embrey moved that a sewer be put in from Hotel Dannehl down Princess Anne Street to Frederick and down Frederick to Charles Street to correct the imperfect drainage in that locality sum to be paid for out of the City Treasury.

Mr Perry amended said motion to the effect that the petition of Lower Main Street for a Sewer be likewise granted.

And Col Cole moved that the matter be referred to the Street Committee to bring in an estimate of the cost of each of these sewers, said estimate to be brought in not later than next Wednesday night

Mr Wroten moved as a substitute that the Street Committee be instructed to build the Princess Anne and Fredericks Street sewer at once and bring in an estimate of the cost of the Lower Main Street extension Mr Bradley offered the following as a substitute for the whole, "Resolved that the Street Committee be instructed to bring in an estimate of the cost of building a sewer from the Hotel Dannehl to the Main Sewer on Charles Street and report the same to a called meeting of this Council on Thursday night. To which Mr Perry offered an amendment: whereupon the Mayor ruled that "a substitute for the whole could not be amended, and Mr Perry appealed from said ruling and asked for a recorded vote, and the Mayor sustained as follows

For Messrs Cole, Wroten, Bradley, Rowe, Embrey, Jones, Gately, Chancellor and Bradford = 9 Against the ruling Mr Perry = 1

Thereupon a recorded vote was called for and had on Mr Bradley's substitute for the whole which was adopted, as follows

For Messrs Cole, Wroten, Bradley, Rowe, Embrey, Jones, Gately, Chancellor and Bradford = 9 Against Mr Perry = 1

And then, Col Cole moved that the Street Committee be instructed to bring in an estimate of cost of Lower Main Street sewer at the next meeting of the Council which was adopted [Page 456]

Mr Bradley presented a request of Charles L Kalenbach to be allowed the privilege "to erect a temporary building say 10 feet square at the corner of the alley and the church-yard wall in the Market Square for the purpose of exhibiting an acetylene Gas Plant this coming summer" and on motion of Mr Jones the said privilege was granted to the said Kalenbach for one year from the first day of May 1902.

Col Cole stated that the City was in immediate need of a "dumping ground" and Mr Jones moved that the Street Committee be empowered to secure by purchase or permit a suitable "Dumping Ground" which motion was adopted.

The ordinances and amendments thereto adopted in relation to sewers at this meeting of the Council codified are as follows:

Be it ordained by the Council of the City of Fredericksburg;

1. That a tax of ten and one half cents on the one hundred dollars of value of the real estate of the City be laid annually for six years, to be known as the sewer tax;

And that the whole collection sewer tax and changes for connection with the City sewer be treated as one fund out of which shall first be paid the interest on sewer bonds, and a sinking fund of one per cent upon said sewer debt be annually set aside out of said fund and the remainder thereof be devoted to the extending of the sewer system of the City; and it shall be the duty of the Finance Committee of the Council to provide for the collection of the sewer tax herein laid.

2. This ordinance shall be in force from and after its passage.

## Be it ordained by the Council of the City of Fredericksburg;

- 1. That the owner of every lot in the City with a dwelling house, store, or office building thereon which adjoins by the front, rear or side a street or alley in which there is a sewer owned or controlled by the City in which it is practicable to enter shall be assessed annually for the privilege of connecting with said sewer the sum of two dollars.
- 2. The owner of every lot with a house thereon as above described which adjoins by front, rear or side a street or all in which there is a sewer owned or controlled by the City and into which it is practicable to enter shall form a connection from his lot with said sewer into which shall be carried all waster water except rain water, and any person failing herein for ninety days after this ordinance takes effect shall be fined not less than one dollar nor more than five dollars, and each day thereafter until the connection is made shall constitute a separate offense. All such connections shall be made under the supervision of the Superintendent of Sewers and with his approval, and his written permit shall be [Page 457] first attained.
- 3. Any owner of a lot who makes or causes to be made any such connection without permit of the Superintendent of Sewer herein before mentioned or any agent who makes or causes the same to be made without the aforesaid permit or any plumber, bricklayer, or other person who makes said connection or any part thereof without the permit aforesaid shall be fined not less than five dollars nor more than twenty-five dollars.
- 4. No person shall either in a street or alley or upon any lot put any stone or brick or any other solid thing into a sewer or fixture thereof. Any person violating any provision of this section shall be fined not less than five dollars nor more than twenty-five dollars, each day's violation of this section to constitute a separate offense.
- 5. Before any owner of a lot shall be required to comply with the provisions of section 2 of this ordinance, pipe connection with sewers owned or controlled by the City shall be made by the City at such points extending from the sewer to the inner side of the curb line of the Street or to an alley as may be determined by the Water Committee at which points the connection from the premises provided for in said second section shall be made.
- 6. This ordinance shall be in force from and after its passage.

# Be it ordained by the Council of the City of Fredericksburg;

- 1. That all persons owning or interested in the private sewers laid in the streets and alleys of the city are hereby required within fifteen days after the adoption of this ordinance to remove said sewers from the streets and alleys of the City and upon their failure to do so this Council at the expiration of said period will take the exclusive possession and control and regulation of said private sewers and they shall become the public sewers of the City and shall be subject to all ordinances, rules and regulations applicable to the public sewers constructed by said City and connection there with and shall be equipped with man-holes, and proper connections shall be made with the public sewerage systems of the city, and the drainage of said private sewers into the river shall cease.
- 2. The foregoing section of this ordinance is modified as follows viz: that the former owners of said sewers who have made connections with the same shall be relieved for a period of seven years from the charge in the sewer ordinance prescribed for connection with the City sewerage.

3. This ordinance shall be in force from and after its passage.

2. That it shall not be lawful for the Treasurer to pay any amount in excess of appropriations aforesaid, and it shall be his duty to notify the Common Council at the next meeting thereafter if any of these appropriations are exhausted and not to pay any orders on bills until further appropriations are made to meet them.

And Col Cole offered the following tax bill which was adopted.

Be it ordained by the Mayor and Common Council of the City of Fredericksburg, Va

That the following taxes on personal property real and personal shall be assessed, levied and paid for the year 1902-1903 for the support of the municipal government, public schools, for the poor, for the lighting of the Streets, to pay interest on bonds, and to provide a sinking fund for the redemption of the City debt, viz:

1st On every male person over 21 years of age not legally exempt 50 cents

2<sup>nd</sup> On all real and personal property, income, toll bridges, monied capital, in any business, investments in bonds in or out of the State, and stock in incorporated companies, on every (\$100) one hundred dollars \$1.15

3<sup>rd</sup> On any property taxed by the State and not included in the foregoing, the tax shall be the same at that fixed by the State.

4<sup>th</sup> A deduction of five percent shall be made on all taxes paid on or before the 15<sup>th</sup> day of October next. 5<sup>th</sup> On all taxes remaining unpaid on and after the 15<sup>th</sup> day of October next, there shall be added 5 percent and interest from that date till paid, and the Collector shall proceed to collect the same in the manner prescribed by law and the ordinances of the City.

 $6^{th}$  The Taxes imposed by this ordinance shall be payable in National currency of the United States and in the coupons of the seven per cent bonds and in the coupons of all other bonds of the City, and on the first day of November next there after, and in coupons of other bonds of the city which have matured

And Col Cole offered the following special Tax Bill which was adopted Be it ordained by the Mayor and Council of the City of Fredericksburg;

1<sup>st</sup> That the following tax on the real estate of the City be assessed, levied, and paid for the year 1902-1903 to be known as the Sewer Tax, viz; a tax of 10½ cents on the \$100 of value be laid on all real estate of the City, which tax shall be due and payable on the 15<sup>th</sup> day of October next.

On all sewer taxes remaining unpaid after the 15<sup>th</sup> of October [Page 467] next there shall be added 5 per cent interest from said 15<sup>th</sup> of October until paid, and the Collector shall proceed to collect the same in the mode prescribed by law and the ordinances of this City.

2<sup>nd</sup> The said Sewer tax shall not be subject to the deduction of 5 percent on taxes paid on or before the 15<sup>th</sup> of October as provided in relation to the general taxes of the City, nor shall it be payable in other than National currency of the United States.

Mayor Embrey, Chairman of Street Committee to which committee was referred the application of the Upper Rappahannock Telephone and Telegraph Co, to enter the city, with request to report the franchise of the Rappahannock, Fredericksburg & Piedmont Co to this meeting of the Council, made said report, and moved that a similar franchise be granted to the first named company with the requirement that all new poled erected by said Company shall be not less that 30 feet high in said franchise was adopted and is in words and figures as follows, viz;

1<sup>st</sup> Be it resolved by the City Council of Fredericksburg, Va;

That the Upper Rappahannock Telephone & Telegraph Company be and is hereby permitted to construct and maintain a telephone line and to erect the necessary poles and supports from their telephone exchange through such streets and alleys of Fredericksburg as may be approved by the Street Committee, provided

however that the said Telephone line shall be completed and in operation within six months of the granting of this franchise and provided further that posts shall in no case be erected when the consent of property holders along the route of said lines can be obtained for the fastening of the wires to their buildings.

2<sup>nd</sup> The posts to be erected shall not be less than thirty (30) feet high and shall be smoothly dressed and neatly painted and be so placed as not to cause any obstruction to the free and convenient passage of the streets and that the said Company shall repair all damages to the streets and pavements caused by their erection remove all surplus material and shall in no case erect posts before any house without permission of the owner thereof.

Whereas, an Act has passed the Congress of the United States and been approved by the President authorizing the building of a monument in the City to General Hugh Mercer, who died on January 12<sup>th</sup> 1777, of wounds received at Princeton, New Jersey, on the 3<sup>rd</sup> day of January of the same year; and

whereas the building of the said monument in this City is conditional upon the City of Fredericksburg, or the citizens thereof, ceding and conveying to the United States such suitable site as in the judgment of the [Page 5] Secretary of War may be required for such monument

Therefore be it resolved that a committee of seven, of which the Mayor shall be chairman, together with three members of the Council and three from the body of citizens, be appointed by the Mayor and association with him for the purpose of recommending a suitable site for the said monument and for the purpose of conferring with the Secretary of War in relation to the selection of the site and the building of the said monument.

And that a Committee of 3 be selected from the Committee of 15, one from each of the classes named to receive the Committee of arrangement referred to in this circular letter and which Committee will arrive here between the 15<sup>th</sup> and 20<sup>th</sup> of the month.

The Mayor announced that the Council had been called to take such action in the death of Ex-Mayor J. L Marye as it might deem appropriate and to attend his funeral.

### Mr McCracken submitted the following paper

The announcement of the death of Hon John L Marye, which occurred yesterday morning, brings deep sorrow to all hearts. A man of distinguished ability and a willingness to serve his generation, his great talent was employed for the good of his country and the benefit of his fellowmen, and he goes to his grave after a long and useful life, full of honors, loved and mourned by the entire community. Coming from a

distinguished family that has resided in Fredericksburg for nearly a century and three quarters; he being the forth generation to make this town his home but Fredericksburg which he greatly loved and no neighbors but her people to whom he was strongly attached. Being a man of unusual vigor and mind, which was richly polished and adorned by a liberal education, including the law, he was fitted for any position in life to which he was called, and so whether as Lieutenant Governor, member of the Constitutional Convention of 1868-69, member of the General Assembly of Virginia, Mayor of this town, or member of this body, he discharged his duties with fidelity and with signal ability and had the confidence and approval of his constituents. As a high type of the Christian and member of the Church of God who was greatly honored by official station, he lived an upright consistent life, carrying a bright example for those who shall come after him, worthy of their imitation. And not only so, but his benevolent heart reached out and shared in the sorrows and distribution of the suffering and needy, which found expression not in kind and sympathetic words alone, but in material aid and relief. For this prominent characteristic of the deceased many shall rise up and call him blessed; but he was a special benefactor of every Virginian. When the Constitutional [Page 15] Convention of 1868-69 adopted disfranchising and disqualifying for office every citizen who aided, abetted, or sympathetic with the South in the late Civil War. Hon Jno L Marye, by his great abilities and magnetic influence, with other Virginians presented such a strong and convincing protest and appeal that President Grant permitted to objectionable clauses to be submitted to a separate vote, and they were defeated, thus averting the shackles which it was proposed to be fastened upon every true Virginian. For this Virginians owe him a debt of gratitude which she can never repay and which should sustain [?] him in her history for all time to come. But we shall see his benignant face and familiar form no more. He is gone from us forever. As a shock of corn ripe for the harvest he is gathered to his reward and recompense of heaven, leaving behind him as a rich legacy to his family and people the sweet incense of an unsullied name.

Therefore, Resolved that in the death of Ex Lieutenant Governor Mayre the State has lost a distinguished public servant, the City an upright public spirited citizen, the church a bright and shining light, and the people a true and loved friend.

Resolved that we deeply sympathize with the family of our deceased friend in their sad affliction and would point them to a kind Heavenly Father for consolation..

Resolved that as a mark of respect for the deceased we will now adjourn and attend his funeral in a body together with the other officials of the Town.

And, on motion of Mr Perry the resolutions were adopted and the clerk was instructed to furnish a copy thereof to the family of the deceased.

Yesterday the death of Hon Jno L Marye, Ex-Mayor and Ex-Councilman of Fredericksburg was announced and we were called upon as a body to follow his remains to their last resting place in the City Cemetery. Today we have the said intelligence of the death of Hon Josiah Hazard, the last of the ex-Mayors, and for a number of years a member of this body, and we are now called upon to perform a similar service for him and to follow his remains to the tomb.

Mr Hazard was born in Lancaster County, Va seventy eight years ago, and came to Fredericksburg while a young man where he engaged in business in various branches, until failing health and infirmities of age

compelling him to retire. He served 1 term as Mayor of this town and several years as a member of this body. In all of his official acts he was guided by justice tempered with mercy. He was kind and courteous in his demeanor, gentle and retiring in his manner, generous and benevolent in his disposition. He was a faithful public servant, discharging his official duties with credit to himself and acceptability to the Community; therefore,

Mr Cole from the Finance Committee presented the following bills, approved by his Committee, which were ordered to be paid, in favor of

Mr Chancellor from the Committee on Water submitted an approximate cost of the enlargement and improvement of the City Water Works, recommended in the Superintendent's report made to the Council in June last, amounting to \$8,950.00

On motion of Mr Jones the report was ordered to be filed.

Mr Dannehl from the Committee on Ordinance submitted an ordinance regulating the privileges of Hurkamp Park with reference to the white and colored races, which was referred to said Committee at the regular meeting in June last.

Mr Mills moved the adoption of the ordinance upon which Mr Cole called for a recorded vote which resulted as follows:

Ayes Messrs Revere, Embrey, Dannehl, Mills, Wallace = 5

Nays Messrs Cole, Rowe, McCracken, Jones, Chancellor = 5 There being a tied the Mayor voted nay, and the ordinance was declared defeated.

Mr Dannehl from the same Committee stated that the ordinance of City Surveyor was not ready and would be presented at some future meeting.

Mr Dannehl gave notice that he would present an [Page 18] ordinance regulating plumbing within the City and providing for an inspector of plumbing at the next regular meeting of the Council.

Mr Jones from the Committee on Schools made a verbal report upon the appropriation of \$450.00 for the ten (10) scholarships tendered the Council, and stated that the College management were willing to enter into a similar arrangement for the next scholastic year. He moved that the sum of \$450.00 be appropriated to the Fredericksburg College as heretofore for the ten scholarships furnished the town by said College, which motion was adopted and

Mr Jones moved that the ten scholars of the highest grade of the Public Schools making the highest average last session be selected for the ten scholarships.

Mr McCracken move an amendment that the Committee on Schools of the Council be authorized to select the ten scholars from the Public Schools, provided they are citizens of the town, which was adopted.

The Mayor reported fines collected this month amounting to \$72.15 and had read the receipt of the Treasurer for that amount turned into his hands. He also reported that the Police had discharged their duties.

The Mayor laid before the Council a letter from Mr Bushrod C. Washington, enclosing a commission issued to Augustine Washington by the Trustees of this town, dated on the 20<sup>th</sup> day of April 1742 appointing him one of the Trustees of the Town.

Mr H Lewis Wallace thereupon submitted the following which was adopted.

An ancient and original paper bearing date on the sixth day of April 1742 appointing Augustine Washington to the position as one of the Trustees of the "Town of Fredericksburgh in Spotsylvania County" having been this day laid before the Council of the City of Fredericksburg by his Honor, Maurice G Willis, Mayor, which paper is ni the words and figures following, to wit:

Whereas at a meeting of the Trustees of the Town of Fredericksburgh, April 6<sup>th</sup> 1742, according to the directions of the Act of Assembly instituted on Act for Erecting a Town [Page 19] in or of the Counties of Spottsylvania and King George

To supply the number of the Trustees in the Room of those gentlemen deceased we have unanimously made choice of and elected Augustine Washington, Gent, to be one of the Trustees or Feoffees for the town of Fredericksburgh in Spotsylvania County to fill up and compleat our full number and for confirming of the same we have according to the directions of the sd Act set our hands & seals this 20<sup>th</sup> day of April 1742

And a letter from Bushrod C Washington being at the same time laid before the Council, said letter being in the words and figures following, to-wit;

Charles Town, West Va, July 12<sup>th</sup> 1902

Mr Dear Sir;

The enclosed paper which I found among the papers of the late Mr Justice Bushrod Washington, of the U S Supreme County, and associate with Judges Marshall & Story – may be of interest to your from its connection with the early history of your city. If you care to place it among the city archives, it will give me pleasure for you to do so.

Therefore be it resolved that the City of Fredericksburg, through its Mayor and Common Council hereby express its cordial thanks to Mr Bushrod C Washington of Charles Town, West Virginia for presenting to said City the [Page 20] original and ancient paper above referred to, and as an evidence of its appreciation of the value of this gift it hereby directs James P Corbin the Clerk of the Council to have the same properly framed and covered with glass so as to protect it from injury and to have safely kept in the vault of the Corporation Court House to be shown to the public.

Be it further resolved that this preamble and resolution be spread upon the minutes of the Common Council and that a copy thereof be forwarded to Mr Bushrod C. Washington, Charles Town, West Virginia.

Mr Revere submitted the following resolution

Resolved by the Common Council of Fredericksburg;

That the Water Committee is hereby authorized and instructed to have a sewer laid on Main Street, beginning at a point between Prussia Street and the R F & P Railroad and continuing thence along Main Street to a point below the Gas-House and there connecting with the main Western sewer. The said new sewer being that section of the sewer system designated as the Main Street lateral in the map and survey of Engineer Davis.

Be it further resolved that this section of the City sewerage system shall be paid for out of the first money derived from the general sewer tax, after interest and sinking fund have been satisfied, and previous appropriations for sewer been paid.

Mr Dannehl moved that the resolution be referred to the Committee on Water with instructions to ascertain the cost of the work and report at the next meeting which was adopted.

Mr Chancellor from Water Committee had read a communication from Dr J N Barney, the health officer of the City to Mr W E Bradley in reference to the necessity of flush tanks and manholes in the private sewer on Fauquier Street and its laterals, recently taken possession of by the City, and stating that the health of that part of the City demanded them;

Mr Chancellor stated that it was the opinion of his Committee that if flush tanks and man holes were a necessity on that street they were [Page 21] also necessary on the sewer laid on Hanover Street, therefore he offered the following resolution.

Resolved that the Water Committee be and it is hereby instructed to place one flush tank each on the Hanover and Fauquier sewers and then man holes on each of the main sewers thereof and their laterals. Mr Cole moved to amend as follows and that the work be done at once and the cost thereof be paid out of the sewer fund, and the resolution thus amended was adopted.

Mr Chancellor presented a petition from Dr J W Rosebro and Mr A B Yates asking that a sewer be laid from the junction of Prince Edward and Lewis Streets along Lewis Street to the new house now in course of construction by Mr Yates on Said Street, they to pay the cost of construction and Mr Cole moved that the work by done by the Water Committee and the bill of cost be presented to the said petitioners for payment as soon as the work is completed which was adopted.

Mr Mills presented a petition from several citizens living west of Fauquier and Washington streets, praying that the Council construct a sewer beginning on Hawke Street near Washington Avenue, thence along Hawke to Winchester and then down Winchester to Fauquier Street connecting with the sewer at that point. It was claimed that this would abate a nuisance along those points created by outside water closets.

Mr Dannehl moved to refer the petition to the Water Committee with instructions to ascertain and report the cost of the work at next meeting of the Council.

Mr Dannehl presented a petition of the Virginia Excelsior Co to be allowed to "Cross Main Street" from the R F & P Railroad's reservation on the opposite site with a track suitable for running a hand car &c track to be 39 inches wide &c and in no wise interfere with traffic on Street or obstruct either pavement &c"

Mr Dannehl moved that petition be referred to Street Committee with power to act which motion was adopted.

Mr Dannehl presented a petition from Messrs Charles [Page 22] E. Wright and John B Cox asking the Wolfe Street be opened and moved that it be referred to the Street Committee with instruction to ascertain cost and report at next meeting of Council, which was adopted.

Mr Embrey, Chairman of Joint Committee on Sewerage and Street Improvement submitted the following report.

To the Honorable Mayor and Common Council of the City of Fredericksburg, Virginia Gentlemen:

The undersigned Joint Committee on Street Improvement, respectfully report that in view of the purpose of the Council to proceed now as expeditiously as possible to redress its oft repeated pledges to the people to introduce a system of street improvement and to enable the Council to take the initiative in so important an undertaking with intelligence the Committee deemed it advisable to seek the suggestions and advice of Col W E Cutshaw, who for twenty nine years has been the City Engineer of Richmond City, and has had to deal therewith conditions very similar to those which confront us here in that Richmond and Fredericksburg were largely built up without regard to any uniform system of grades.

Col Cutshaw kindly visited our City and carefully inspected and scrutinized the two streets embrace in the City's present scheme of improvement, viz; Main Street from the Railroad to Amelia and Commerce Street.

He made number of measurements of both pavements and road-beds and carefully noted the positions of the shade trees on Main Street. After viewing the location of these trees in every aspect with a view to saving them if possible he expressed the emphatic opinion that the proper paving of Main Street could not be subordinated to the matter of preserving the trees, nor could the one object be adjusted to the other, but that the paving of the streets according to the best method should be the paramount object and where it involved the loss of the present trees the City might set out new trees at proper distances (not closer than thirty feet a part).

He also advised that a comprehensive system of paving be adopted and that the grades and levels called for by that system be adhered to in districts not [Page 23] built up, but that in built up portions of the City there be established grades and levels may be for the present modified to meet existing conditions. Col Cutshaw was told by the Committee that the opinion prevailed on the part of some of the business community that any contraction of the present width of Main Street would interfere with the present as well as future traffic along said street.

He assured the Committee that this view was entirely erroneous, that a 42 feet road bed was ample for all business needs of the future as well as of the present and was abundantly wide to accommodate both street car lines and wheeled vehicle without occasioning any hindrance to either.

Col Cutshaw strongly advises that the Council adopt for the blocks now to be paved a road bed uniformly 42 feet between curbs, leaving the side walks to vary in width as the encroachments will permit.

He is also clearly of the opinion that no satisfactory or proper paving can be made if any trees are permitted outside of the curbing.

The Joint Committee concur in the above view of Col Cutshaw and recommend the same to the Council for adoption.

Until the Council can make a decision in relation to the foregoing questions it would be premature to employ an engineer to ascertain the matters called for by Mr Rowe's resolution of July 17<sup>th</sup>.

Col Cutshaw promised to recommend to the Committee a suitable man to inspect the pipes under the Street.

Maj Embrey, Chairman Street Committee to which the petition of the Virginia Excelsior Company to lay a hand car track way referred with power in said Committee to act, stated that the Committee had denied the request and as Chairman of the Joint Committee on Sewerage & Street Improvement, Maj Embrey stated that the Committee would report fully at an early day.

Capt McCracken, Chairman of the Light Committee stated said Committee had not advertised for bids for Gas Coal as is done each year because of the general strike in the Coal regions, but had bought such coal in car load lots instead of advertising for bids as usual be endorsed and that said Committee be authorized to continue buying gas coal in car load lots until the existing strike in the coal fields is settled, and Mr Dannehl moved to amend by "approving action of the Light Committee so far in buying coal in car load lots but that the Committee proceed forthwith to advertise for bids for coal" A recorded vote being called for on said amendment, was had with the following result;

A petition signed by some fifty or more citizens praying that steps be taken at once to investigate the condition of the Electric Light Plant and remedy defective lighting was read, and on motion of Col Cole received and ordered to be filed.

Col Cole presented a petition of Dr J G king Mr W T Leavell asking that a sewer be laid on Prince Edward "from the termination of the present line &c &c to the line at the corner of Commerce and Prince

Edward Streets" said petitioners to pay cost of same, and Col Cole stated that the work had been done and paid for by said parties and asked that the action of the Committee be confirmed which on motion was done; Col Cole having stated that the petition identical with that Dr Rosebro and Mr Yates which been promptly granted.

On motion of Col Cole, the rules were suspended and the following amendment to Section 46 of the License Tax Ordinance passed April 17<sup>th</sup> 1902

Be it enacted and ordained by the Common Council of the City of Fredericksburg, Virginia, that section 46 of an ordinance imposing License taxes in the City of Fredericksburg for support of the City Government, the payment of interest on the City debt and for other expenses and providing for the collection thereof, passed April 17, 1902, be amended and re-enacted so as to read as follows Section 46. The specific license on every circus and on the exhibition of a menagerie, fifty dollars (\$50) per day; on outside shows whether attached thereto or not five dollars (\$5) each per day, and on every circus parade in the City of Fredericksburg, whether a free show or not, fifty dollars (\$50), without the prepayment of which [Page 26] the Mayor shall not issue a permit for such parade; provided that when in any case, a license tax and herein provided shall have been paid on a circus not tax shall be required or exacted on the parade of said circus.

The specific license tax on every show, or exhibition or of trained animals, athletic or acrobatic performances in a tent twenty dollars (\$20) per day and on every parade in the City of Fredericksburg whether a free show or not, of every or exhibition of trained animals, athletic or acrobatic performances twenty dollars (\$20) without the prepayment of which the Mayor shall not issue permit for such parade, provided that when and in any case a license tax as herein provided shall have been paid on each show or exhibition of trained animals, athletic or acrobatic performances in a tent, no tax shall be required or exacted on such parade."

And on motion of Capt McCracken the same was adopted.

Col Cole on behalf of the R V A & M Society asked permission for said Association to use the Street Sprinklers of the City during the Fair on the 23<sup>rd</sup>, 24<sup>th</sup>, & 25<sup>th</sup> Instant which was granted on motion

Col Cole stated that quite a number of members of the Grand Army of the Republic were expected to visit this city during the week beginning October  $6^{th}$  next and moved

That a committee of 3 from the Council and 3 from the Citizens be appointed by the Mayor to arrange for the convenience of said visitors, which was adopted.

Resolved that the Finance Committee be instructed to destroy the three blank forms of bonds No. 23 for \$500; No. 11 for \$100 and No. 14 for \$1000 which were found in the custody of the Treasurer and are supposed to be these sample bonds which were sent by the lithographer and also to destroy the coupons on the \$20,000 of Street [Page 46] Improvement bonds recently sold, said coupons embracing all from the date of the bonds to the 1<sup>st</sup> day of October 1902, which resolution was adopted.

Col Cole presented the bill of Mr St G R Fitzhugh the attorney for the City for services to December 1<sup>st</sup> 1902 amounting to \$380.00 which on motion was ordered to be paid.

Col Cole then made the following report

The undersigned Finance Committee of the Council respectfully report that the Joint Committee on Street Improvement have in accordance with resolutions of the Council purchased all the pipes and other material necessary for the renewing of the Gas pipes on the Streets to be paved, and said Gas pipes are being laid, and that the bills for the same which have been audited by your Committee amount approximately to the sum of \$2150.00 and the cost of laying the same approximately \$850.00 Your Committee asks authority to borrow temporarily the amount necessary to pay this indebtedness of the City, the amount not to exceed \$3000.00.

This Loan can be secured for six months if necessary without interest in view of the fact that the proceeds of the paving bonds is on deposit in one of the Banks of this city.

E D Cole, W S Embrey, T McCracken, Finance Committee

The above report was accompanied by a letter from the Conway, Gordon & Garnett National proffering the loan on said terms, namely without interest and on motion of Mr Wroten the said report and letter were received and ordered to be filed and Mr Dannehl offered the following.

It appearing from the report of the Finance Committee that the City is indebted in approximately the sum of \$3000.00 for gas pipe and other materials and for labor to renew the worn out gas pipes on the blacks in the City to be paved and the funds in the Treasury not otherwise appropriated being inadequate to pay this indebtedness, the Finance Committee is authorized and directed to borrow a sum of money not to exceed \$3000.00 and to execute for the City a proper evidence of indebtedness the same not to be negotiable and to be without interest in accordance with the offer of the Conway, Gordon & Garnett National Bank, said loan to be made on such time as the Finance Committee shall deem expedient not to exceed six months, and they shall apply said sum of money to the payment of the aforesaid indebtedness and to no other [Page 47] "purpose." And a recorded vote being called for on said resolution was had as follows

For Messrs Cole, Wroten, Dannehl, Rowe, Embrey, Revere, Chancellor, Wallace = 8 Against no one and the resolution was declared adopted.

I approve the foregoing resolution M G Willis, Mayor (Capt McCracken came in)

## Mr Chancellor offered the following

Whereas James Goodrick & wife have notified the Council of their willingness to accept the amount offered them respectively for their respective parcels of land needed for the opening of the new streets, to wit \$100 to James Goodrick and \$200 to his wife, provided the City will remove the dwelling house standing on Mrs Goodrick's lot from the parcel of land to be taken to the adjoining lot belonging to the said James Goodrick, in such manner that the said house shall be in the same condition after removal as it is at present

Resolved, that this offer be and the same is accepted and so soon as a copy of this paper is signed by said Goodrick and wife, the condemnation proceedings against them shall be dismissed and the Street Committee shall cause said dwelling house to be removed as aforesaid at the expense of the City, and when that is done the Street Committee shall draw a warrant on the Treasurer in favor of James Goodrick for \$100.00 and in favor of his wife for \$200.00 upon their tendering a proper deed for said lots conveying a good and unencumbered title to the same to the City.

The Finance Committee in lieu of removal by the City are authorized to pay to said Goodrick the sum of \$50.00 and allow him to incur the expense of said removal which was adopted.

Maj Embrey, Chairman of Street Committee asked that \$400.00 be placed to the credit of said Committee which on motion of Mr Wroten was so ordered.

Mr. Dannehl, Chairman of Ordinance Committee gave notice that said Committee would report an ordinance regulating plumbing at the next regular meeting of the Council.

Capt McCracken, Chairman of Light Committee pursuant to resolution passed on November 20<sup>th</sup> last reported that said Committee did not deem it advisable to contract for [Page 48] yearly supply of coal at this time.

Mayor reported that the Police officers had done their duty.

Col Cole asked permission to use some of the Fire Hose of the City to put water used in filling up the gas pipe trench. The use of water being necessary for proper performing of said work, which on motion of Mr Wroten was granted.

Mr Chancellor moved to proceed to the election of Superintendent of City Water Works, which was adopted, and on motion of Mr Chancellor the salary of said Officer was fixed at the same amount as this year viz; \$900.00

Whereupon the application for said office of Capt S J Quinn and a ballot being had he was declared unanimously elected Superintendent of the City Water Works for the year 1903.

And

Capt McCracken moved to proceed to the election of Superintendent of the City Gas Works, which was carried and Capt McCracken moved that the salary of said officer be fixed at same amount as last year viz; \$700.00 which was carried.

Whereupon Capt McCracken nominated Mr William Fitzpatrick and a ballot being had he was declared unanimously elected Superintendent of the City Gas Works for the year 1903.

And on motion of Mr Wroten the Council adjourned
