Fredericksburg Council Minutes 1871

At a called Meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber Saturday evening January 7th 1871

Present L B Rose, Mayor

Geo W Eve, J H Myer, P McCracken, J T Knight, J J Young, Recorder, H S Doggett, J A Sener The Minutes of the last meeting were read and approved

Mr Sener, from the Committee appointed at the Meeting of the Council under the resolution of Dr Wallace, reported verbally that examination has been made and so far back as 1854, they could find that no privilege or privileges had been granted to Mess'rs Scott & Herndon, J F Scott or Scott & Bowering to the use of any of the Streets of the Town

Present: J G Wallace, W C Morrison, W P Conway

Dr Wallace submitted the following which was adopted;

Whereas a Gen'l Ordinance was adopted, repealing all previous Ordinances respecting the use of Streets and obstructions thereto by any party or parties, Resolved that the case of Mess'rs Scott & Bowering and the other parties come within the provision of said Ordinance

A Bill of C Murphy amounting to \$2.00 for hauling gravel was read and ordered to be paid

Mr Norberry appeared before the Council by Permission in reference to the payment of his taxes, and asking that a deduction be made as he was prepared to pay and tendered payment to the Collector within the time allowed by the Ordinance granting an abatement.

On motion moved and seconded "The case of Mr Norberry was referred to the Finance Committee for investigation and settlement [Page 580]

Mr Conway, Chairman of the Finance Comm'e, Reported verbally, That the interest of the Corporation in the House & Lot on Caroline Street occupied by [blank] had been sold pursuant to advertisement by auctioneer F Johnston for \$5600 in Corporation Bonds. Mr Wm H Fitzhugh becoming purchaser and having the privilege of furnishing the Bonds within the month of January; He also reported that the House occupied by Mr Green was not sold, the limit not being obtained \$5300 being on Corporation Bonds being the highest bid

Mr Conway submitted the following which was unanimously adopted

Resolved, That so much of the resolution adopted by the Council on 22^{nd} November last, as refers to the limit fixed upon the interest of the Corporation in the House & Lot occupied by Mr J L Green be reconsidered and that a Committee of three of the Council be appointed by the Mayor to attend the sale of said property on 12^{th} Inst and confer and obtain as to the price to be accepted for same The Mayor appointed Mess'rs Conway, Sener & Doggett as the Committee

The Mayor reported verbally that the Police Officers had performed their duties faithfully during the last quarter

On Motion ordered that the Treasurer pay their salaries to the 1st Jan'y 1871

My Conway asked and obtained leave to retire

Absent: Mr Conway

Mr Eve suggested that the Council go into the election of Overseers of the Poor and moved the number be fixed at six which was carried

The following persons were nominated as Overseers of the Poor and unanimously elected Dr R B Rennolds, A E Samuel, Thomas Griffin, A P Rowe, M McDonnell, Robt' T Knox

Mr Eve moved that the thanks of the Council be tendered to the present Overseers of the Poor who have tendered their resignation and are about retiring from office, for the faithful manner in which their duties have been performed: Carried unanimously

On Motion, Mr McCracken, Resolved that all fines against members under 23rd Rule to the present time be removed

The Council then adjourned

On motion, Mr Sener, Ordered that the slate taken from the Court House roof be placed in the hands of the Pub Property Committee for disposal

Mr Conway, Chairman of the Committee appointed to superintend the sale of the House & Lot in the occupancy of J L Green, reported verbally that the property was put up and the highest bid offered was \$5000 in Corporation Bonds, and the price offered being below the price offered at a former sale the Committee deemed it prudent to withdraw the property for the present.

On Motion Dr Wallace, Resolved, That the same Committee be appointed with full powers to sell publicly or privately the interest of the Corporation in the House & Lot occupied by J L Green on such terms as in their discretion they may deem best

Mr Eve offered the following

Resolved by the Mayor and Common Council of the Town of Fredericksburg that our Senator & Delegate in the Legislature be requested to use all efforts to procure the Charter now applied for, for a Rail Road from Richmond to Alexandria, provided that such Charter shall require the Road to pass through Fredericksburg and also provided that the charges for local freight and travel shall not be greater than the Charges for through freight and travel

Mr Conway called for the Ayes & Nayes and the vote being taken the resolution was adopted Ayes Sener, Wallace, Eve, Gravatt, Doggett, Myer, McCracken Nayes Conway

The office of Surveyor of the Corporation being vacant by the failure of Col Braxton to qualify, Mr Wm Slaughter was nominated and unanimously elected Surveyor of the Corporation in place of Col Braxton failing to qualify. And the Clerk was directed to inform Mr Slaughter of his election

The Mayor read a petition from John E Tacket, Pres't Washington Woolen Mills Co asking that the property of the Co for the past two years be [Page 582] be assessed upon the basis of the State Assessment of the present year

Mr Tackett being present he was on Motion allowed to be heard upon the subject of his petition On motion, Mr Eve, Resolved that the application of Mr Tackett be referred to the Finance Committee with the request that they report at as early a day as possible

An account of Hart & Hayes for Carpenters Risk of Ins on Court House amt'g to \$40.00 was read and ordered to be paid

On Motion Mr Conway, Resolved, That A K Phillips, W R Mason, & Wm J Hart be requested to have such correspondence with Hon Lewis McKenzie our Representative in Congress as will lead to an appropriation by Congress for the cleaning out of the Rappahannock River in accordance with the Memorial presented by the Citizens of Fredericksburg for that purpose

On Motion Mr McCracken, Ordered that the Treasurer be directed to pay to L M Mills late Com'r Revenue the sum of one hundred dollars on acct of his services as Com'r Revenue

Mr Tackett was by permission heard on the part of Mr Russell of the Paper Mill Co asking that permission be given to the use of a part of the Street near the Rail Road Bridge, for the purpose of sinking a trunk or pipes to carry off the waste water from the Paper Mill

On Motion, Mr Eve, The application of Mr Tackett was referred to the Street Committee for examination and report

On Motion Mr Conway, the Mayor was requested to call on the newly elected Overseers of the Poor and ascertain who and how many of their number will serve
The Council then adjourned

Mr Wm A Little being present requested to be heard on the part of L M Mills late Com'r Revenue in reference to the claim of said Mills for his salary as Com'r and on motion Mr Little was allowed to be heard

After the remarks of Mr Little Mr J B Sener being present was on motion was allowed to be heard on the part of Mr Quinn the present Com'r

On Motion, Mr Conway, Ordered that the Treasurer be and he is hereby directed to pay to L M Mills the balance of his salary amounting to one hundred and fifty dollars deducting therefrom any indebtedness of

said Mills to the Corporation, it appearing to the Council that Mr Mills has completed the Com'r Books for 1870

The Mayor in conformity to the resolution passed at the last Council stated that he had called on the different parties elected as Overseers of the Poor and out of the number elected A P Rowe, A E Samuel, M McDonnell consented to serve and it remained for the Council to elect three Overseers in place of R B Rennolds, R T Knox, & Thos Griffin declined.

Abraham Cox, Wm H Smith and Geo Mullen were nominated and unanimously elected as Overseers of the Poor in place of Rennolds, Knox & Griffin declining to serve
The Council then adjourned

At a called meeting of the Common Council of the Town of Fredericksburg held at the Council Chamber Tuesday evening Feb'y 2nd 1871

Mr Mason being present he was on Motion, permitted to be heard in a presentation to [Page 584] the object for which the council was convened

Mr J B Sener being present was on Motion heard on the subject before the Council On Motion, Dr Wallace, Resolved, That so much of the resolution adopted Jan'y 24th 1871 requesting A K Phillips, W R Mason & W T Hart to correspond with Hon Lewis McKenzie in reference to an appropriation by Congress for the improvement of the navigation of the Rappahannock River be rescinded and that W R Mason, J MCracken & Jas B Sener be requested to proceed to Washington and use all efforts to procure an appropriation from Congress for the improvement of the Navigation of the Rappahannock River, and that the sum of seventy five dollars be and is hereby appropriated to defray their expenses. And the Treasurer is directed to pay the sum appropriated upon the order of the Chairman of said Committee

On Motion, Mr Eve, Resolved That the Committee be directed to request our former Townsman Jno T Rollow to co-operate with them in the accomplishment of the object of their mission to Washington

On Motion, Dr Wallace

It is ordered that L B Rose, Mayor of this Corporation do write to W H Fitzhugh or to such person as he shall designate all the right title and interest of the Corporation of Fredericksburg Va. (upon his paying over to the Treasurer of the Corporation and exhibiting his receipts thereof bonds of the Corporation of the face value of Five thousand and Six hundred Dollars in the House and Lot on Main or Caroline Street formerly occupied by Simon Hirsh, and sold by order of the Council passed November 22nd 1870 The Council on Motion, Mr Eve, adjourned until Monday ensuing next 7 O'clock

At an adjourned meeting of the Common Council of the Town of Fred'burg held at the Council Chamber Monday evening Feb'y 6th 1871

Mr W R Mason, Chairman of the Committee appointed by the Council to proceed to Washington to look after the interest of the Town with respect to the procuring an appropriation by Congress for the improvement of the Navigation of the Rappahannock River, appeared before the Council and made a statement of the progress of the Committee. Mr McCracken, one of the Committee also made a statement in reference to the object of their Mission

Mr Sener, Chairman of the Street Committee to whom was referred the application of Mr Russell of the Paper Mill Co, reported that the Committee had examined the subject and would recommend that the party have the privilege of sinking a wood trunk subject to such conditions as may be imposed by the Council

On Motion, Mr Eve, Resolved That the Fredericksburg Water Power Co and lessees of the Paper Mill Co and the Representative of the estate of John L Marye, dec'd having requested the Council to grant permission for the construction of an underground Trunk under Sophia Street and thence along the descent of Prussia Street to the River in order to serve as a waste way for the surplus of waste water discharged from the Paper Mill, the Council doth hereby grant permission for said work to be done, Provided, that the Owner or Owners of such work shall keep it in a safe condition, so as not to obstruct or endanger the passage of the Streets, and whenever repairs are required to said work, such repairs shall be considered under the supervision of the Street Committee and subject to the approval of the Council

Dr Wallace from the Finance Committee asked in consequence of the absence of the Chairman of the Committee for further time to report upon the application of Mr Tackett referred to them; granted

Mr Gravatt asked and obtained leave to retire. Absent Geo Gravatt

On Motion, Mr Eve, Ordered, That section 1, Chapter XXXVII (37) of the Ordinance concerning Overseers of the Poor be so amended that the word "two" be inserted in place of the word "six" in second line and that the word "July be inserted in place of the works "March or April" in the same line so as to read: "There shall be appointed annually by the Council in the Month of July two Overseers of the Poor for the Town of Fredericksburg who shall remain in office until the next annual appointment unless sooner removed by the Council."

Mr Sener Offered the following, Resolved that one hundred and fifty dollars [Page 586] per annum from the 1st Jan'y 1871 be fixed as the salary of the Overseers of the Poor. This sum to include the salary of the two appointees.

Dr Wallace moved to substitute One Hundred dollars per annum in place of one hundred and fifty, which motion be seconded and the vote taken it was lost. The question then recurring upon Mr Sener's Resolution, and the vote taken by Ayes & Nayes it was carried as follows Ayes Eve, Sener, Young, Doggett, Myer, Morrison, McCracken 7 Nayes Wallace

Mr Doggett asked and obtained leave to retire: Absent Mr Doggett

Dr Wallace submitted the following which was adopted

Whereas a vacancy occurs in the office of Overseers of the Poor by reason of the parties recently elected to serve in such Capacity. Resolved that E Carter and E L Heinichen be and they are hereby appointed as Overseers of the Poor until the 1st day of July next

Mr Eve offered the following resolution which was adopted

Resolved That the Mayor be requested if he deems it necessary to call a public meeting of the Citizens, on Monday Night next to consider the recent action of the Council on the subject of and all matters of interest of the Town in reference to Rail Roads

The Council then adjourned

At a called meeting of the Common Council of the Town of Fredericksburg held at the Council Chambers Friday evening Feb'y 17th 1871

The Mayor stated that the Council had been convened at the instance of prominent Citizens looking to the interest of the Town in the question of a Charter for a Rail Road from Washington to Richmond now in prospect of passage by the Legislature and to take into consideration the propriety of sending a Committee to Richmond to endeavor to procure such an amendment to the proposed Charter as will require Fredericksburg to be included as one of the points for the establishment of the Company Work Shops Present J G Wallace

Mess'rs J B Sener and M Slaughter being present were on motion permitted to be heard on the subject for which the Council was called both urging the [Page 587] appointment and sending a Committee to Richmond

Mr Eve, submitted the following: Resolved That the Mayor be direct to send a Telegram to our Senator and Delegate in the Legislature requesting that they urge the location of W & R Company Work Shops at Fredericksburg by an amendment to the Charter of said Company now under consideration by that body Mr Sener moved as a substitute for Mr Eve's Resolution, That a committee of two be appointed to proceed to Richmond at once to confer and co-operate with our Senator and Delegate and use their best efforts to procure an amendment to the Charter of the Washington & Richmond Rail Road Co requiring that Fredericksburg be included as one of the points of location of the Company's Work Shops. Dr Wallace offered the following as an amendment to Mr Sener's substitute, Resolved That the Senator & Delegate from this Town be requested to use their influence to have inserted in the Charter of the Washington & Richmond Rail Road a provision that the Work Shops of the Company shall be located in the Town of Fredericksburg, City of Richmond, or Manchester at their option and otherwise use their best exertion to procure the passage of this measure. Resolved that the Mayor be instructed to inform our Senator & Delegate of this resolution at his earliest time

The vote being taken upon the amendment of Dr Wallace by Ayes & Nayes it was lost

The Mayor appointed Mess'rs M Slaughter, R W N Noland, A A Little as the Committee The Council then adjourned [Page 588]

Mr Conway, Chairman of the Finance Committee asked for further time to report upon the app'n of Mr Tackett—granted

A petition signed by a member of Citizens of the lower end of Town that a pump be placed in their vicinity for the convenience and comfort of the people in that locality

On Motion Mr Conway, The petition was referred to the Pump Committee to be reported upon at the next meeting of the Council.

Mr J B Sener was present and on motion was permitted to be heard on behalf of Mr Pittman for an abatement of taxes on certain property excessively (in his opinion) assessed

On Motion Mr Conway, Resolved that the assessment upon the property referred to by Mr Sener being the House & lot next to L J Huffman on Princess Ann Street be reduced to the assessment made by the Corpo Court, viz be \$1000 and that the Collector of Taxes be directed to abate in the settlement of the Tax on said property in the sum of \$500 of the valuation thereof for the past five years, including the year 1870.

Mr Sener submitted the following which was adopted

Whereas Mess'r Russell and others by resolution adopted on 6th Feb'y 1871 were granted certain privileges. Resolved That unless the parties complete the work set forth on the application and for which they obtained the privilege asked for within the next ninety days that the same privilege be revoked Dr Wallace asked and obtained leave to retire; Absent Dr Wallace [Page 589]

On Motion, Resolved That the Mayor be requested to have the Globes for the Street Lamps taken down and removed to a place of safety

The Council then adjourned

The Committee of Finance of the Council of the Town of Fredericksburg beg leave to report as follows on the application of Jno E Tackett president of the Washington Manufacturing Co to have remitted a portion of the taxes for the years 1869 & 1870 on the Washington Mills in said Corporation

The Washington Mills were assessed at the sum of Sixty five thousand dollars which your committee believe to be an excessive valuation, and your Committee on inspection that the Assessor has now fixed the value of said property at the sum of Twenty five thousand dollars and although your Committee might differ with the Assessor on the value he has placed on the said property, yet the committee recommend the abatement of the Taxes for the said years 1869, 1870 for the difference of the said amounts day \$40,000 and recommend that the Council authorized and direct the Collector of Taxes to act accordingly Signed W P Conway, Chrmn by order of Committee, March 7th 1871

On Motion Mr McCracken, Ordered that the Collector of Taxes be directed and authorized to deduct from the taxes of John E Tackett, President of the Washington Woolen Mills Co the excess of Taxes over and above the valuation of \$25000 on the Washington Mills in this Corporation for the years 1869 & 1870 and receive in full discharge of the Taxes of said years the amount of such Taxes as based upon said valuation of said property to Wit, Twenty-five Thousand Dollars

Mr Conway, Chairman of the Finance Committee reported upon the claim of C W Edrington Sergeant, and on Motion Mr Eve the report was received and the claim [Page 590] of Mr Edrington was referred to the Overseers of the Poor

The Mayor submitted the report of the Committee appointed by the Council to proceed to Washington and procure an appropriation from Congress for the improvement of the Navigation of the Rappahannock River, which was read and on motion Dr Wallace, was directed to be filed.

Dr Wallace submitted the following which was unanimously adopted

Whereas the Common Council by resolution did appoint Mess'rs W R Mason, P McCracken James B Sener a Committee to visit Washington and obtain from the Congress of the United States an appropriation to remove the bars from the Rappahannock River and Whereas said Committee have performed the duties of that office in a most satisfactory manner; Resolved by the Common Council that the Committee be request to continue their efforts as far as possible in having the work executed at once and Resolved further that the thanks of the Council are eminently due and are hereby tendered to Mess'rs

Mason, McCracken & Sener for the zeal exhibited by them in pressing the work and the success attending their labors

The following bills of the Ledger Office, one amt'g to \$2.00 & the other to \$3.00 were read and ordered to be paid


On motion, Mr Conway, the treasurer is direct to pay to J B Sener the sum of five dollars for writing desk for the Mayor to J B Ficklen

The Mayor presented a plot and survey of a lot sold for taxes and purchased by Chas E Bragdon, the lot owned by Jos Bragdon's Est and it appearing to the Council that the survey is made by the Surveyor of the Corporation in accordance with Section 7, Chap 40 of the Ordinances of the Corporation.

On Motion, Mr Eve, It is ordered that said plat & survey be recorded

On Motion, Mr Conway, Resolved that all monies arising from the sale of the slate taken from the Court House be appropriated toward putting repairs and preservation of the building in the discretion of the Committee

The Council then adjourned

Mr Conway presented a paper prepared by M Slaughter in reference to the interest of the Corporation in the Fred'bg & Gordonsville Rail Road Co which paper was read and is in the following words Whereas the right and privileges granted November 14th 1866 by the undersigned private Stockholders in the Fredericksburg Gordonsville Rail Road Company on the terms and conditions authorized by an Act of the General Assembly of Virginia passed January 10th 1866 have been forfeit by the failure to complete the said Rail Road within the time provided by said act and agreement, and Whereas the General Assembly of Virginia passed an Act March 21st 1871, To amend and re-enact the Act passed January 10th 1866, entitled an Act releasing the State's interest on the Fredericksburg & Gordonsville Rail Road on certain conditions authorized the President and Directors of the Fredericksburg and Gordonsville Rail Road Company to sell the States interest in said Road provided the said Road is completed within three years from the first day January 1871 and the State is released from the deferred part of her subscription thereon



An ordinance imposing a License tax upon sample merchants, passed May 30th 1871

Section I. Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that there shall be levied and collected from every person selling or offering to sell by sample, representation, or otherwise any wines, ardent spirits, malt liquors or any mixtures of any of them a license tax of ninety dollars. From every person selling or offering to sell by Sample Card description or reproduction any goods, wares, or merchandise (other than liquor) a license tax of forty dollars.

Section II. and be it further ordained, that hereafter it shall be unlawful for any person to sell or offer to sell anywhere within the limits of the Corporation by sample, representation, or otherwise any wines, ardent spirits, malt liquors, or any mixture of any of them, or any goods, wares or merchandise without first obtaining a license therefore; and any person or persons so found selling or offering to sell shall forfeit and pay not less than the amount of the license tax for each offence, to be recovered by law and it is made the duty of the police officers to see to the execution of this ordinance and they shall be allowed one half of all fines recovered under and in virtue hereof.

Section III. And be it further ordained that if any person or persons offend against Section 2nd of this ordinance and fail to pay the fine imposed in violation thereof, he or they shall be imprisoned and held in Custody for thirty days.

Section IV. And be it further ordained that all [Page 21] persons obtaining a license under this ordinance shall first exhibit evidence of authority to sell under the Law of the State of Virginia, and pay over to the Treasurer the amount of license tax and exhibit his receipt therefore to the Mayor, who is authorized to issue the license.

Section V. And it is further ordained that this ordinance shall be in force from its passage.

An ordinance imposing a license tax for peddling

Section I. Be it ordained by the Mayor and Common Council of the Town of Fredericksburg, that there shall be levied from every person for the privilege of peddling and bartering a license tax of Seventy five dollars.

Section II. And be it further ordained that hereafter it shall be unlawful for any person to carry from place to place within the limits of the Corporation any goods, wares, or merchandise, and offer to sell or barter or sell or barter the same without first obtaining a license therefore, and any person or persons so found offering to sell or barter, or selling, or bartering, shall forfeit and pay not less than the license tax for each offense, to be recovered by law; and it is made the duty of the police officers to see to the execution of this ordinance and they shall be allowed one half of all fines recovered under and in virtue hereof

Section III. And be it further ordained, that if any person or persons offend against Section Second of this ordinance and fail to pay the fine [Page 22] imposed in violation thereof, he or they shall be imprisoned and held in custody for thirty days.

Section IV. And be it further ordained that all persons obtaining license under this ordinance shall first exhibit evidence of authority to sell or barter under the laws of the State of Virginia, and pay over to the Treasurer the amount of the license tax, and exhibit his receipt therefore to the Mayor who is authorized to issue the license.

- 7. One third of the taxes so assessed by this bill shall be paid to the Collector of taxes in National Currency of the United States, and the remaining two-thirds in past due coupons or past due interest on the registered Bonds of the City of Fredericksburg; or the Tax payer may at his option pay the said two thirds of his taxes in National Currency of the United States at the rate of Sixty Cents in the dollar.
- 8. A deduction of five per cent shall be allowed to such persons as shall pay their taxes on or before the 15th day of October next, and of three percent to such persons as shall pay their taxes on or before the 15th day of November next.
- 9. Upon all tax bills remaining unpaid after the 15th day of November next, there shall be added five per cent and interest thereon (that is on said tax bills and per centum) until the same is paid [Page 42]
- 10. All taxes remaining unpaid shall be liable to be distrained for on and after the 15th day of November 1871.

The Committee appointed at the last meeting upon the petition of the Citizens, asking for the organization of a Hook and Ladder and Bucket Company was on Motion allowed further time to make their report The following bills were read and ordered to be paid, Viz

A A Little, amt'g to \$10.00 C W Edrington amt'g to 6.00

The Mayor stated that in conversation with Mr John Howison, District Superintendent of Public Schools and in examination of the law, it was found necessary for the Council to adopt such measures as would conform to the requirement of the Act of the Gen'l Assembly of Virginia

Mr Conway submitted the following which was unanimously adopted,

Be it ordained by the Mayor and Common Council of the Town of Fredericksburg [Page 75]

- 1. That in compliance with an Act of the General Assembly of Virginia, the Town of Fredericksburg be consolidated into one public school district; and that the schools of said District be under the authority and management of the present Board of School Trustees, consisting of Edwin Carter, Landon J Huffman, and John J Young
- 2. That the Treasurer of the Town be directed to take charge of all the funds appropriated to said schools, and disburse the same by order of said board according to law, and the regulations of the State Board of Education
- 3rd That John J Young, whose term of office (as a member of said board) expires on the 15th of this month, be and he is hereby recommended to the State Board of Education for re-appointment.
- 4th That copies of this order be furnished to John Howison, Superintendent of Public Schools for this Town, that he may transmit ones to the State Board of Education in Richmond and another to the Clerk of the Hustings Court for Record.

The Mayor stated that Mr E Carter of the Board of Trustees had called his attention to the uncomfortable state of one of the rooms in the South Wing of the Court House used as a public school and asked that some action be taken make it more comfortable, on Motion,

The subject was referred to the Public Property Committee

Mr McCracken, called the attention of the Council to the necessity of having a magazine erected to the storage of gun powder, on Motion [Page 76] the subject was referred to the Public Property Committee with direction that probable costs of building a Magazine be ascertained and report a next meeting of this Council

The Council then adjourned L B Rose, Mayor [Page 77]

Mr Mason, from the Committee appointed by the Council to take into consideration the petition for the organization of a Hook & Ladder and Bucket Company made a verbal report and submitted letters from certain parties as to the cost of equipment, on Motion, Mr Little, the following resolution was adopted unanimously

Resolved that the report of the Committee be read and that the subject be referred to a committee composed of the Mayor, J W Sener, W H Russell, and Benj Bowering with instructions to consider and report upon the best apparatus and the cost and with whom it will be best to contract for the same and all other matters connected therewith.

The Mayor being compelled to retire, called the Recorder to the Chair: Absent L B Rose, Mayor

My Mason, Chrmn of the Public Property Committee made a verbal report to the effect that the cost of building had not been ascertained but he supposed that the cost would be about \$300 and suggested that as the Corporation was without a magazine for the deposit of Gun Powered, Chap 36 of the Gen'l Ordinance of the Corpo be repealed

Whereupon Dr Wallace submitted the following which was seconded,

1. Be it ordained by the Common Council of the Town of Fredericksburg that it shall not be lawful for any Merchant or other person to have within their Stores, dwellings, or lots at any one time more than one hundred pounds of gun powder.

On Conviction of a violation of this ordinance before any Justice of the Peace, the person violating the same shall be fined five dollars and the one dollar for each day that the offense be continued

2. Be it ordained that Chap 36 of the Gen'l Ordinances be and the same is hereby repealed [Page 79]

Mr Hurkamp moved that the ordinance be laid on the table which being seconded and the vote taken by Ayes & Nayes, the motion was carried by the following vote

Ayes Conway, Little, Bowering, Hurkamp, Doggett, McCracken, & Sener 7

On Motion of Mr Hurkamp

Resolved, that a Committee of three of the Council be appointed to ascertain if any party can be found to build a Magazine for the reception of Powder brought into town, on his own account, and if not that the same committee be instructed to ascertain the cost of building same at the expense of the town and report at the next meeting

The Recorder appointed Mess'rs Bowering, Russell, McCracken as the Committee

Mr Little called the attention of the Council to the advertisement by the Farmers Land Trust Co of New York for the Sale of the Fred'g & Gordonsville R Road under a certain Mortgage and also stated what action the Directors of said company here had taken, and suggested that the Council take such steps as in their judgment was best to protect the interest of the Corporation in said Company

When Mr Conway submitted the following resolution, which was adopted

Resolved, that this Council approve [page 80] and endorse the Resolution of the Board of Directors of the Fredericksburg and Gordonsville Rail Road Co passed at their meeting on the 15th November 1871, and desire thus to express our conviction that the interest of this Corporation in the Stock of said Company will not be transferred to anyone except upon the terms of the Completion of said Road to Orange Ct House in accordance with the resolution of the Council to transfer said stock on said terms passed on the 31st day of March, 1871.

The board then adjourned [Page 80]

Whereas the Farmers Loan & Trust Co of New York as Trustee under a certain pretended deed of Mortgage bearing date November 1869 has advertised for sale all and singular the property interests and franchises of the Fredericksburg & Gordonsville Rail Road Company of Virginia said sale to take place at 12 O'clock noon on the 28th day of December 1871 at the Exchange Sales Rooms No 111, Broadway in the City of New York and

Whereas said pretended deed of Mortgage was executed without any legal authority and Whereas the same is fraudulent, null and void as against the rights and interests of the City of Fredericksburg as a Stockholder in said Rail Road Company;

Therefore be it Resolved.

That We, the Common Council of the City of Fredericksburg do hereby enter our most solemn protest against such proposed sale as illegal, null and void

Resolved further that the said Farmers Land and Trust Co of New York will be held liable to this Corporation for any injury or damage to its interests as a Stockholder by reason of such sale, Resolved that a copy of these resolutions be served upon said Farmers Loan and Trust Company The following is the vote upon the resolution

Your Committee appointed at the last meeting of the Council to ascertain if any Citizen could be found willing to erect at his own expense a Magazine suitable for the storage of Gun Powder beg leave to report, That after several interviews with Mr John T Knight he has agreed to erect a fire proof building of a size not less than 12x13 feet suitable for the purpose named upon the Condition that all the Gun Powder above the quantity of 30^{lb} allowed to be kept by each Merchant [Page 83] shall be stored with him and that he shall receive for said storage twenty-five cents pr Keg as mentioned in our present ordinance.

The Mayor appointed Mr G W Shepherd a member of the Committee on Pumps in place of Mr W C Morrison, resigned.
